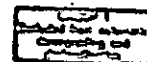

1. RWINBEING HAS ANNOUNCED TERMINATION ORIT PARTICIPATION JOINT PROGRAM PANAMA PENDING REVIEW OF SITUATION. ALSO PANS SUSPEND CTRP AFFILIATION. WISKES AVOID OR MINIMIZE TROUBLES FROM SANTIAGO O'DONNELL WHO CIRCULARIZED, APPARENTLY TO ALL ORIT EXEC COMMITTEE MEMBERS AND I.T.S., HIS DEMAND FOR INVESTIGATION OF PROGRAM FOR WHICH HE BLAMES IUP AND RINLEPTOME.
