1. RE SUBJECT PARA 1-C OF REF, WISH KNOW NATURE AND EXTENT DEGRIP RELATIONSHIP WITH SUBJ AT THIS POINT AND REASONS WHY DEGRIP FEELS SUBJ IS CONVINCED CUBANO. HQS INTERESTED IN ESTABLISHING S/W LINK WITH SUBJ BECAUSE OF TIES WITH TARGET MILITARY PERSONALITIES.

2. REQUEST HQS REVIEW SUBJ WITH DEGRIP AS THOROUGHLY AS POSSIBLE INCLUDING LIKELIHOOD SUBJ WOULD ACCEPT CLANDESTINE ROLE AND WITH WHAT GROUP OR ORG HE WOULD MOST LIKELY COOPERATE. WOULD APPRECIATE VIEWS ON HOW WE CAN RECRUIT SUBJ AND ESTABLISH SECURE COMMO LINK WITH MINIMUM EXPOSURE DEGRIP.
