1. IN ADDITION TO WAVE TRACCS, FOLLOWING FROM MADRID SOURCE
 QUSEF.1 OSMA 14927 WHO KNEW SUBJ WELL IS OF INTEREST. SUBJ IS
 PROBABLY THE MOST KNOWLEDGEABLE CONSULAR OFFICER IN THE SERVICE AND
 IS PROUD OF FACT THAT HE RECEIVES MAIL WORLDWIDE & ASKING HIS ADVICE
 ON CONSULAR PROCEDURES. HE VERY ORDERLY AND DOES EVERYTHING EXACTLY
 BY THE BOOK, BEING SO LEGALISTIC THAT HE GOT ON SOURCE'S NERVES. HE
 NEVER TRUSTED BY 26 OF JULY MEMBERS. SOURCE DOES NOT CONSIDER HIM
 COMMUNIST BUT "JUST OLD MAN WITH TWO SMALL CHILDREN AFRAID OF LOSING
 HIS JOB" HE IS SPECIAL FRIEND OF CELIA GILLOWA WHO ALSO ONCE WORKED
 AS HIS SECRETARY. HAS A DAUGHTER IN NEW YORK AND LAWYER EDW IN BARANA
 BY FIRST WIFE. SECOND WIFE IS MEXICAN BY WEDD HAS TWO SMALL DAUGHTERS.
