BELIEVE TO WANT HE NOT CONTACT FORMER FRIENDS OR ACQUAINTANCES
UNTI HE HAS BEEN ON SCENE LONG ENOUGH HAVE THOROUGHLY TESTED
LOCAL SITUATION.

2. REQUEST YOU STRESS SECURITY WITH THIS AGENT IN FINAL
BRIEFING POINTING OUT HAZARDS CONNECTED WITH PHONE CALLS, MEETINGS,
LOOSE TALKS RE ACQUAINTANCES.

3. FYI: AGENT AND AMTIF COMPLEXES BOTE TREATED BY
RECENT EVENTS AND DESIGNET/1 GAVE LEADS INTO BOTH AREAS.

4. SERIOUSNESS OF SITUATION NEED NOT DETER AGENT IF HE
PROCEEDS PROPER AS ITALIAN BUSINESSMAN AND STICKS TO COVER
STORY. DESIGNET/1 MAY BE ABLE GIVE US VARIABLE INFO RE SITUATION
CURRENT ASSETS BUT HE MUST PROCEED SLOWLY IN ORDER BE EFFECTIVE.
