This letter is in response to your letter to the Director, dated January 19, 1977, requesting information pursuant to Brady v. Maryland concerning Mr. Gerald Patrick Hemming's alleged employment with this Agency.

Mr. Hemming has been a voluntary informant for this Agency, having, on several occasions, voluntarily provided information to the Agency. An acknowledgment to this effect was provided the Department of Justice by this Agency's General Counsel in a letter dated February 15, 1965.

Our records do not reflect that Gerald Patrick Hemming was ever employed by the Central Intelligence Agency in any capacity, or that he was ever used as an agent or in similar capacity. Mr. Hemming did submit an application for employment with the Agency in January 1962. He was informed in June 1962 that there were no positions available for him within the Agency.



Mr. Hemming has, as you may know, recently submitted a request to this Agency for data, under the terms of the Privacy Act of 1974.
