2. THE AGREEMENT IS SUBJECT TO APPROVAL BY DIRECTORS AND STOCKHOLDERS WHO MUST APPROVE A NEW PREFERRED STOCK ISSUE TO BE INCLUDED IN THE PURCHASE PRICE.
