CHECKING OF ASIO FILES REVEALS THAT ON 9 AUG 1962 AMB SEBALD RECEIVED CALL WHICH MAY WELL HAVE BEEN FROM SAME

EMB REPORT THIS CALL FOLLOWS:

"AT 2055 HOURS ON 9 JUGUST 1960 THE MARINE GUARD TELEPHONED

AMB SEBALD TO SAY THAT HE HAD A MAN ON THE CHANCERY LINE WHO

REFUSED TO GIVE HIS NAME BUT WISHED SPEAK TO AMB.

REPRODUCTION BY OTHER THAN THE ISSUING OFFICE IS PROHIBITED

AMB TOOK THE CALL THE MAN SAID THAT HE WAS "FROM ACROSS THE KINGSTON HOTEL". (SOVIET CHANCERY). HE THEN SAID CLEARLY
THAT THE "TWO MEN YOU ARE LOOKING FOR ARE IN MOSCOW". HE WENT
ON TO SAY THAT HIS BOSS, KURDIUKOV, WAS HAVING SECRET CONFERENCES
IN MOSCOW.

" AMB SEBALD ASKED FOR THE CALLER'S NAME, BUT THE CALLER REPLIED "I HAVE NOT BEEN HERE LONG AND I DO NOT WISH TO WORK LONGER IN THIS PLACE. CAN I TELEPHONE YOU SOME TIME?"

" AMB SEBALD REPLIED "YES" IF THE AMB COULD BE OF ANY
HELP.




