STATION MEMO CHRONOS FROM JULY 1963 THRU MARCH 1964 CONTAIN NO MEMOS CONCERNING REF CASE. WE ASSUME THAT BECAUSE OF SENSITIVITY OF CASE, MEMO CHRONO COPY NOT KEPT. MICROFICHER FILES ON AMERICAN VISITORS TO SOVIET EMBASSY FROM JULY 1961 THRU DEC 1965 ARE ALSO NEGATIVE. MICROFICHE FILE ON FOREIGN CONTACTS OF CUBAN EMBASSY NOT HELPFUL BECAUSE IT ONLY GOES BACK TO JULY 1967.
