SUBJECT: New Release of JFK Assassination Records

1. This memorandum is to advise you of a scheduled release of additional CIA records related to the JFK assassination.

2. On 1 September 1994, we plan to release to the National Archives approximately 71,000 pages of JFK records that are printed out copies of microfilmed documents. These records were microfilmed in 1979-80 and added to the files that the House Select Committee on Assassinations ordered sequestered at CIA. This will bring to 211,000 the total number of pages released by CIA under the JFK Assassination Records Collection Act of 1992.

3. We are also reviewing some 10,000 pages originated by other agencies, which will eventually be released after coordination by those agencies. In addition, we are reviewing some 20,000 pages originated by Congressional staff during the investigation of the assassination, which are to be processed by the National Archives before they can be made available to the public.

4. All documents held by CIA that are possibly related to the assassination are to be provided to the Review Board that was appointed earlier this year by the President. This includes those records that appear to qualify for withholding under provisions of the Act relating to privacy, foreign relations, relevancy, and sources and methods. The Review Board will make the final determination as to possible release of these records.
