- b. On 22 July 1963 a Sr. Fernando G. CALDERON appeared at the MBFINCH receptionist area and asked by name to speak with the COS. When interviewed by the COS. CALDERON said he had a group of trained investigators which could be put at COS' disposal. He also provided a memorandum setting out what his group could do and pay and equipment they would need. Jeremy K. BENADUM was asked to check CALDERON's background. It was determined that he had at one time been an apprentice DFS (Direction Federal de Seguridad) agent and had worked with LIVESTOCK-3. COS advised CALDERON that there was no interest in his proposition.
- c. On 7 August 1963 the EE case officer requested identification copies of the identification photographs of Yugoslav Official Nikola ZIC, Counselor of the Yugoslav Embassy; and two Cuch officials: Lubomir BLAZIK and Jana KANKOVSKA. Joremy K. BENADUM was asked to obtain these photographs from Relaciones via LITEMPO-4.
- d. On 14 August 1963 (MRID-0237), Jeremy K. BENADUM was asked to find out what difficulties were being encountered by Indalecie FERNANDEZ Moran with Mexican Immigration officials.

### 2. Liaisea

- a. On 6 August 1963 the Station passed a blind memorandum on Vasile Leslie Ladislav WINKLER to LITEMPO-2 for investigative action.
- b. On 13 August 1963 the Station passed a blind memorandum on Jose Manuel SANTAMARIA Mendez (with aliases) to LITEMPO-2 for investigative action.
- c. On 18 September 1963 Oliver G. GALBOND and the COS called on LITEMPO-2 and talked with him for ferty-five minutes. LITEMPO-2 thanked GALBOND for KUBARK assistance to them and expressed the desire that the mutual cooperation can continue with the next administration. LITEMPO-2 asked GALBOND if he could furnish the names of terrorists and communists from Venesuela and other Latin American countries who might be likely to travel to or through Mexico. GALBOND promised to furnish as many of these names as possible with appropriate background data.
- d. Also during this reporting period. COS made numerous calls on LITEMPO assets in an effort to arrange for a sensitive political asylum case. The case is still pending.

#### b. Passport Camera

One of the two passport cameras given to the LITEMPO personnel was called back to the Station for a rigid testing by the Station KURIOT technician since the film centinued to jam without a warning to the operator, causing him to continue running the camera even though the film was not being exposed. LITEMPO-2 advised GALBOND and the COS that he could not permit a larger, more conspicuous camera at the airport. The camera in use at the present time seems to be operating without difficulty. The Air France coverage has not yet been added but should be added in the near future.

#### 4. Personnel

- a. In view of the overall budget cut, the Station re-estimated the financial obligations for this project as reported in the Project Renewal request (HMMA-2229 dated 1 Oct 63). Permission has been obtained to soil MV-2285. No agents have yet been terminated but a closer review is being made of the production of LITEMPO-6 and LITEMPO-7.
