1. All materials listed, referred to and/or described in the enclosure to the November 9, 1961, memorandum from S. B. Donohoe to W. C. Sullivan, captioned "The Cuban Situation."
2. All materials identified, described and/or referred to in the November 8, 1961, memorandum from A. E. Belmont to Mr. Tolson, captioned "Cuban Situation," which are not encompassed by item #1 above.
3. All memoranda or other materials reflecting or concerning the November 8, 1961, "discussion" between the Attorney General and the FBI Director, which is referred to in the first paragraph of the Director's November 9, 1961, memorandum to the Attorney General, captioned "Cuban Situation," and in the first paragraph of Mr. Belmont's November 8, 1961, memorandum to Mr. Tolson, captioned "Cuban Situation."
