GUS ALEX, AKA. AR. DAILY SUMMARY.

MEETING HELD EVENING OCTOBER 5 LAST AT MGM LOUNGE, HOODLUM HANGOUT, CICERO, ILLINOIS IN ATTENDANCE WERE CG 6884-PC, GAMBLER FRANK AURELLI, GUS ALEX, AND NICK KOKENAS, OWNER MGM LOUNGE.

PURPOSE OF MEETING TO RESOLVE PAYMENT OF OVERDUE GAMBLING DEBTS TO FRANK AURELLI. ONE DEBT OF \$4,000 OWED BY ONE (FNU) SANTUCCI WHO IS UNABLE TO PAY AURELLI. SANTUCCI HAS BEEN THREATENED BY AURELLI TO COME UP WITH MONEY OR ELSE. SANTUCCI "REACHED OUT" TO ANGELO PETITI AND DONALD ANGELINI, WELL-KNOWN HOODLUMS, TO INTERCEDE.

SECOND DEBT OF \$1,500 OWED BY ONE AL GARBER WHO "REACHED OUT" TO JOSEPH FERRIOLA, LIEUTENANT OF FIORE BUCCIERI. FERRIOLA INSTRUCTED AURELLI TO FORGET ABOUT DEBT; HOWEVER, AURELLI WENT TO DOMINIC SENESE, BROTHER-IN-LAW OF ANTHONY ACCARDO, WHO SUGGESTED THIS MATTER BE ADJUDICATED BY HOODLUM ATTORNEY JOSEPH BULGER. HOWEVER, AURELLI, THROUGH CLOSE FRIENDSHIP WITH NICK KOKENAS, TOLD STORY TO GUS ALEX, WHO STARTED MAKING PHONE CALLS. ALEX CALLED HOODLUM LEONARD PATRICK AND JOSEPH BULGER AND SUBSEQUENTLY TOLD AURELLI LAST NIGHT THAT EVERYTHING HAD BEEN TAKEN CARE OF AND THAT HE WOULD
