CG SIX FOUR THREE THREE-C ADVISED THAT A MEMORIAL SERVICE WAS HELD FOR LOUIS ARGER AT ELEVEN AM NOVEMBER SEVEN LAST AT ST. ANDREW'S GREEK ORTHODOX CHURCH ON CHICAGO'S NORTH SIDE. ALEX ATTENDED WITH HENRY SUSK, PONTIAC DEALER, AND REPORTEDLY WERE INSEPARABLE DURING SERVICE; HOWEVER, THEY DID NOT ATTEND LUNCHEON FOLLOWING. ARGER WAS ALEX'S REPRESENTATIVE IN THE STATE STREET ARCADE AND STRIP SHOWS UNTIL HIS RECENT DEATH. ALSO ATTENDING SERVICE AND SUBSEQUENT LUNCHEON WERE ALEX'S BROTHERS SAM AND JAMES AND THEIR WIVES, LES KRUSE, HARRY MARCUS, STRIP JOINT OPERATOR, JAMES ELIPOULIOUS, GAMBLING JOINT OPERATOR, AND LOUIS ARGER'S FAMILY. LUNCHEON HELD AT MILLIONAIRES CLUB AT FIFTY TWO HUNDRED NORTH BROADWAY. SAM ALEX APPEARED VERY CONGENIAL THROUGHOUT SERVICE. INFORMANT WAS TOLD THAT ALEX'S OLDEST BROTHER, JAMES, REPORTEDLY HAS BIGGEST INDUSTRIAL LAUNDRY OPERATIONS IN THE COUNTRY AT PRESENT TIME, AND WILL ATTEMPT TO OBTAIN FURTHER INFORMATION RE THIS BUSINESS.
