Concerning JAMES K. COGSWELL, mentioned in the details of the enclosed report, it should be noted that this individual has been interviewed on 2 or 3 occasions by the NYO and COGSWELL is closely associated with the Movimiento Revolucionario del Pueblo (MRP) and closely associated with JOAQUIN GODOY of the MRP. COGSWELL used to reside in Cuba and was closely associated with individuals who eventually formed the MRP. COGSWELL has tried to interest people in New York regarding the activities of the MRP and has also put advertisements in the New York papers, particularly the "New York Times", for financial contributions for the MRP which were to be sent to Miami, Florida.
