CIA has advised that during the interview of a recently defected Cuban intelligence officer, it was learned that one Santiago Perez, described as connected with the "illegal department" of the Cuban Intelligence Service, was in Mexico City during the period 3/21-23/64. Perez was allegedly planning to travel to Canada soon after 3/23/64 using a diplomatic passport. (S)(U)

Legat, Ottawa, is requested to determine through sources if Perez entered Canada during the period 3/23-30/64, since it was suggested by CIA that Perez might be identical to "Solo," the individual the subject was to contact in Canada on or about 3/29/64. If records indicate Perez did enter Canada during the pertinent period, request your sources to furnish all available data concerning him. (S)

For future guidance, you are also requested to determine from your sources whether or not Canadian authorities obtain photographs of individuals who are issued diplomatic visas to enter Canada. (S)

You may advise the Royal Canadian Mounted Police (RCMP) that the Bureau is currently making efforts to develop information regarding Saker Lenni. This information will be made available to RCMP upon receipt. (S)

NOTE:

Subject is a Cuban agent in Miami. He traveled to Canada in March, 1964, for a meet with an individual known to us as "Rolo." We have not identified "Rolo" to date. Information received from CIA developed through CIA interview of defector, Vladimir Rodriguez Lahera. Possibility exists that Santiago Perez [and Chafir Romero Saker Zenni], the latter having been in Canada during pertinent period, are identical or that either may be "Rolo." (S)
London is currently developing information on Saker Zenni, and RCMP has requested to be advised re him. RCMP cooperated in coverage of proposed meet in Canada 3/64. (S)
