Reference is made to your communication dated December 5, 1962, your reference S/3568, requesting information concerning the captioned individual. (C)

We have ascertained that the correct name of this individual is Manuel Marcos Luis Pelaez y Galindo. This individual was born on April 25, 1939, in Cuba and entered the United States as a visitor on March 24, 1961.

We learned in December, 1962, that Dr. Manuel Pelaez visited the offices in Miami, Florida, of the Movimiento Democrata Cristiano which has been stated to be an anticommunist organization. Dr. Pelaez was identified as a member of the Christian Democratic Action Center located in New York City. (97-4110-45)
