On November 20, 1963, MM T-1, another Government agency which conducts intelligence investigations, advised that the following information had been received from a member of a group of Cuban emigres trained in the techniques of information collection, which group has provided useful reports for over two years: (S-1) (X)(u)

On November 2, 1963, a meeting was held by the Movimiento Democrata Cristiano (MDC), during which Laureano Batista Falla made an analysis of the MDC's military potential. Batista concluded that the potential is almost nil, because no ship could move out from the Miami River without encountering problems. In addition, Batista said the MDC does not have sufficient financial resources to move to Central America. Laureano Batista Falla is the military leader of the MDC: (S-1) (X)(u)

On December 16, 1963, Laureano Batista Falla, interviewed at MDC headquarters, 1732 N. W. 7th Street, advised
