[A SOURCE IN MEXICAN IMMIGRATION WHO HAS FURNISHED RELIABLE INFORMATION IN THE PAST ADVISED THAT THE ASSISTANT SECRETARY OF GOVERNMENT RECEIVED A REPORT THAT SUBJECT HAD RETURNED TO CUERNAVACA AND INSTRUCTED THAT INVESTIGATION BE CONDUCTED TO DETERMINE IF THERE WAS ANY TRUTH TO THIS REPORT.] (S)(u)

MEXICAN IMMIGRATION IS INVESTIGATING THE REPORT BUT CONSIDERS THAT SUBJECT HAS NOT RETURNED TO CUERNAVACA BASED ON INVESTIGATION TO DATE. (S)(u)

DEA, MEXICO CITY, ALSO RELAYED A REPORT THAT SUBJECT HAD RETURNED TO CUERNAVACA BUT HAD NO DOCUMENTATION OR CORROBORATION FOR THIS REPORT. (S)(u)

SUBJECT OBVIOUSLY WAS IN CHICAGO DECEMBER 17, 1974. (S)(u)

IT HAD BEEN REPORTED THAT THESE WERE FILED BY THE ATTORNEY JORGE CASTILLO BUT HIS IDENTITY DOES NOT APPEAR ON THESE DOCUMENTS (S)(u)

ABOVE QUOTED SOURCE ADVISED THAT A NUMBER OF OFFICIALS OF MEXICAN IMMIGRATION ARE AWARE THAT CASTILLO WAS THE ATTORNEY FOR THE SUBJECT. HOWEVER, HE DOUBTED THAT ANY OF THESE OFFICERS WOULD BE PERMITTED TO TESTIFY AS TO THIS INFORMATION. (S)(u)

HE NOTED THAT CASTILLO CAME TO THE OFFICES OF MEXICAN IMMIGRATION IN REPRESENTATION OF THE SUBJECT AT THE TIME OF HIS DEPRIVATION (S)(u)

SUBJECT'S IMMIGRATION FILE IS RESTRICTED BUT SOURCE IS ATTEMPTING TO REVIEW IT TO DETERMINE IF CASTILLO APPEARS ANYWHERE THEREIN AS ATTORNEY OF RECORD. (S)(u)
