AGREEMENT

With respect to the meeting of Betsey Wright ("Client") and her attorney, Alan M. Cohen, Esq., with the Office of the Independent Counsel, Kenneth W. Starr, and representatives of the Federal Bureau of Investigation to be held at the Office of the Independent Counsel in Washington, D.C. on July 26 and July 28, 1995 ("the meeting"), the following understandings exist:

(1) Should any prosecution be brought against Client by this Office, the Government will not offer in evidence in its case-in-chief, or in connection with any sentencing proceeding for the purpose of determining an appropriate sentence, any statements made by Client at the meeting, except in a prosecution for false statements, obstruction of justice or perjury.

(2) Notwithstanding item (1) above: (a) the Government may use information derived directly or indirectly from the meeting for the purpose of obtaining leads to other evidence, which evidence may be used in any prosecution of Client by the Government; and (b) the Government may use statements made by Client at the meeting and all evidence obtained directly or indirectly therefrom for the purpose of cross-examination should Client testify, or to rebut any evidence offered by or on behalf of Client in connection with the trial and/or sentencing, should any prosecution of Client be undertaken.

(3) Statements made by Client at the meeting shall not in any way be deemed, construed, or argued to constitute a waiver of Client's privilege against self-incrimination with respect to any matters raised at the meeting or at any time in the future.

(4) This Agreement is limited to the statements made by Client at the meeting and does not apply to any oral, written or recorded statements made by Client at any other time. No understandings, promises, agreements and/or conditions have been entered into with respect to the meeting other than those set forth in this Agreement and none will be entered into unless in writing and signed by all parties.
