BRAUN paged LIVINGSTONE later, but he did not return her page. BRAUN left a message with the White House switchboard.

BRAUN recalled that FOSTER's pager was turned off when they found it. ROLLA took possession of the pager.

BRAUN released the decedent's White House identification to a Secret Service Agent that night. The Secret Service Agent asked for and received a copy of the U.S. Park Police report regarding the initial death investigation. The name and identification number of the Secret Service Agent is located on the chain of custody, noting that the identification was turned over to him.

BRAUN left the U.S. Park Police office at approximately 7:00 a.m. on July 21. BRAUN stated that there was no longer any reason for her to stay in the office, as she had talked to the medical examiner on the phone and he was not planning on doing the autopsy until July 22.

The case was subsequently assigned to Detective MARKLAND. Captain HUME became involved in the investigation because of its high profile nature.

BRAUN was unsure of how her business card got mixed up in the medical examiner's file of this case. BRAUN stated that she was not present at the autopsy since it was done on July 21; BRAUN was at home. BRAUN stated that she had given her business card to Dr. BEYER in May of 1993 during a training period. BRAUN had talked to BEYER on the phone on the morning of July 21, and he may have assumed that she was handling the case.

It was not until after Medical Examiner DONALD D. HAUT arrived at the death scene that ROLLA rolled the decedent's body in order to inspect the apparent exit wound. When ROLLA rolled the body he observed new, wet blood pouring out of the nose and possibly the mouth of the decedent. ROLLA also observed a pool of blood, approximately 4-inches across, which had been under the head and neck area. ROLLA also observed the back of the shirt was soaked with blood from the collar to the waist. From the time ROLLA arrived at the death scene no one rolled the body until he (ROLLA) rolled the body in the presence of HAUT.

It is ROLLA's belief that it is not possible for the body to have been moved to the location at Fort Marcy Park because, as he discovered when he rolled the body, a large amount of blood would have spilled out of the decedent's nose and mouth. ROLLA searched the area surrounding the body and he did not see any blood trails in the area.

ROLLA was shown an autopsy photograph #156E, which depicts FOSTER's clothed body on the autopsy table. ROLLA stated the yellowish stain depicted on FOSTER's shirt in the right chest area was not present when he saw the body at the death scene.

ROLLA recalls lifting one of FOSTER'S arms above his head in order to gain enough leverage to roll the body over. When ROLLA did this, the body slid down the berm a little. ROLLA recalls one of the decedent's arms was raised above his head making it appear as though the decedent was attempting to climb back up the berm. ROLLA also recalls discussing with USPP Investigator RENEE APT the need to photograph the body in this position. When ROLLA was deposed before the US Senate Committee on Banking, Housing and Urban Affairs (Senate Deposition) on 07/21/94, (pages 90, 91 and 92) he believed and testified he had taken photographs of the back of FOSTER's body which must have disappeared from the case file. However, now that ROLLA has had the opportunity to study the photographs he and BRAUN took that day, including the emulsion numbers on the backs of the photographs, he believes BRAUN must have already taken the camera to the parking lot before he (ROLLA) rolled the body. ROLLA recalls intending to take pictures of the back of the decedent including the exit wound and blood stains on the shirt and ground because it would have been important evidence. However, ROLLA did not actually take any such photographs.

ROLLA put on a pair of gloves and lifted the decedent's left hand finding it to be warm and not rigid with slight lividity on the lower side of the arm. ROLLA observed no apparent wounds on the face, neck or head. Based on the blood trails coming out of the decedent's mouth and nose and the blood on his shoulder and on the ground under the back of decedent's head and neck (which he observed without rolling the body) ROLLA assumed that an exit wound would be in the back of the decedent's head.

ROLLA checked the decedent's pockets with gloves on. He patted down the back pockets by feeling under the decedent's hips but he did not feel anything in them. With respect to the front pockets, ROLLA put his hands into the pockets, however, it was difficult for him to get his hands all the way in, so he felt around the outside of the pockets instead. ROLLA believes the inside of the decedent's right front pocket was wrapped around the front of decedent's leg toward his groin. ROLLA'S search of the decedent's pockets missed the keys which he observed USPP Officer CHERYL BRAUN find later in the right, front pants pocket of the decedent when she searched the pockets again in the Fairfax County Hospital Morgue. ROLLA was embarrassed by the fact that he had missed the keys.

Since no keys to the decedent's vehicle had been located in either the search of the body or the car, ROLLA and BRAUN had left Fort Marcy Park and driven directly to Fairfax County Hospital, where the body had been transferred, in order to determine whether ROLLA had overlooked the keys. ROLLA does not now recall the exact time they left Ft. Marcy, but the trip to Fairfax Hospital took approximately 20 minutes.

When they arrived at Fairfax Hospital they went to the Hospital Security Staff who took BRAUN and ROLLA directly to the morgue. The body was still contained in the body bag. BRAUN put on gloves, unzipped the body bag and found the keys in the decedent's right, front pants pocket.

ROBERT KITT BROWNING (DOB:) Safety and Security Officer, Fairfax Hospital; (703) 698-3180, was advised of the identity of the interviewing and the purpose for the interview. BROWNING was interviewed in the presence of ROBIN LANDRY of the Fairfax Hospital Risk Management Department. BROWNING provided the following information:

BROWNING has worked at Fairfax Hospital as a Safety and Security Officer was approximately 3 1/2 years. BROWNING was working the 3- 11:30 p.m. shift on the evening of FOSTER'S death.

BROWNING received a call to open the morgue for an incoming body. After regular hours, there are two sets of keys to the morgue. One set is kept by the Communications Center, the other set is kept by the Safety and Security Shift Supervisor. ERIK PETERSON was the shift supervisor that night. BROWNING obtained the morgue keys from the Communications Center, and opened the morgue for Fairfax County Ambulance #1; Paramedics Ashford and Harrison. They placed the body in the morgue refrigerator. The body was contained in a black "body bag". BROWNING had no conversation with ASHFORD or HARRISON, and did not observe FOSTER'S body at that time. BROWNING wrote down information from a tag on the outside of the body bag to record in their logbook. If BROWNING had been given any personal effects, he would have also recorded that. BROWNING reviewed the logbook and noted that no personal effects were recorded. The whole process took approximately 5 to 10 minutes.

At approximately 9:12 p.m. (as noted in the logbook), BROWNING met Investigators BRAUN and ROLLA at the morgue. BROWNING opened the morgue for them. BRAUN and ROLLA opened the body bag containing FOSTER'S body. BROWNING got a quick look at the body. BROWNING described FOSTER as having a large or tall build, not very old, and having dark hair. BROWNING did not know what BRAUN and ROLLA were doing with the body. BROWNING considered it routine for law enforcement officers to examine bodies at the morgue. BROWNING stated that they were in the morgue for approximately 5 to 10 minutes. BROWNING locked the

morgue after BRAUN and ROLLA exited. BROWNING did not recall talking with the investigators, and did not remember seeing any thing in their hands when they left.

BROWNING reiterated that the whole incident seemed very routine.

ERIK JAMES PETERSON (DOB:) Supervisor, Fairfax Hospital Safety and Security Department; (703) 698-3180, was advised of the identity of the interviewing agent, and the purpose for the interview. PETERSON was interviewed in the presence of ROBIN LANDRY of the Fairfax Hospital Risk Management Department. PETERSON provided the following information:

PETERSON was working a 3 to 11:30 p.m. shift on the evening of VINCENT FOSTER'S death. From 5 p.m. to 7a.m. the following morning, the hospital Safety and Security Officers are responsible for opening the hospital morgue. The Safety and Security shift supervisor maintains a set of keys to the morgue.

At approximately 10:30 p.m. that evening, PETERSON received a radio call to respond to the Emergency Department and see the Nursing Supervisor regarding accompanying some people to view a body at the morgue. The Nursing Supervisor that evening was CHARLOTTE EWING-PREBALL. The individuals identified themselves as being from the White House; CHIEF OF SECURITY CRAIG LIVINGSTONE and WILLIAM KENNEDY. PETERSON walked with them to the morgue. PETERSON did not recall OFFICER DAVE TIPTON from FAIRFAX COUNTY P.D. being present. PETERSON did not recall seeing LIVINGSTONE or KENNEDY use any telephones, including cellular phones. PETERSON opened the morgue to allow the laboratory technicians access to the body. LIVINGSTONE and KENNEDY viewed the body through the morgue window. The body did not appear to be "cleaned up". PETERSON stated that Medical Examiner cases are viewed "as is". The viewing lasted approximately 15 to 20 minutes. PETERSON did not recall any particular reaction or conversation during this time. PETERSON stated that the procedure was "routine". The Nursing Supervisor walked with LIVINGSTONE and KENNEDY back to the EMERGENCY DEPARTMENT.

At approximately 11p.m., OFFICER TIPTON, who was the FAIRFAX COUNTY POLICE OFFICER on duty at the hospital that evening, wanted access to the morgue. TIPTON told PETERSON that he wanted to "check the body". PETERSON met TIPTON and ORENSTEIN, an emergency room physician, at the morgue. PETERSON

PETERSON also recalled hearing TIPTON mention something about "powder burns". TIPTON and ORENSTEIN were in the morgue for approximately 10 minutes. PETERSON could recall nothing particularly unusual about the body. PETERSON noticed a large amount of blood on the decedent's shirt. PETERSON was not aware of any of the facts of the case at that time.

At approximately 1a.m., CHERYL BRAUN of the U.S. PARK POLICE provided PETERSON with her business card for the Medical Examiner's Office. PETERSON placed the card with the decedent.

Subsequent to the interview, PETERSON provided a photocopy of his personal notes pertaining to the incident.

Detective ROLLA went directly to the hospital security office. A security officer escorted them to the hospital morgue. BRAUN recalled FOSTER's body was in a body bag. BRAUN unzipped the bag, reached inside, and pulled the right front trouser pocket inside out. When BRAUN did this, a "big wad" of keys came out. Neither BRAUN or Detective ROLLA searched the body further.

BRAUN has no knowledge of there being any volunteer workers in Fort Marcy Park on July 20, 1993. BRAUN recalled that enroute to the park, she had ordered the park gate closed to protect the death scene. BRAUN could not recall seeing any nonofficial people anywhere in the park, with the exception of a couple named DOODY and FEIST, whose vehicle was parked at the far end of the parking lot.

BRAUN could not recall seeing anything at the death scene that caused her to suspect, or even think, that FOSTER might have died elsewhere and his body moved to this location after his death.

ambulance and the coroner may have gotten there at the same time. BRAUN stated that APT and ROLLA were still at the location of the body.

APT left the death scene with SIMONELLO, BRAUN left the death scene with ROLLA.

BRAUN stated that the only person she saw touch the body was ROLLA. ROLLA had to roll the body slightly so that he could check the decedent's pockets for the keys and any identification. BRAUN stated that the body was not touched until after all pictures were taken.

On their way to the hospital to attempt to retrieve the keys from the decedent's pockets, BRAUN received a call on her cell phone from Lieutenant GAVIN. GAVIN stated that an individual named DAVID WATKINS, who was a close friend of the decedent's, wanted to go with BRAUN and ROLLA to notify the decedent's family.

BRAUN and ROLLA then went to the Fairfax Hospital and located the keys to the decedent's vehicle in his pockets. A hospital security person brought them down to the hospital morgue, where she opened the body bag. BRAUN stated there was a lot of blood in the bottom of the bag. BRAUN located two sets of keys in the front right pocket of the decedent.

BRAUN and ROLLA then went to DAVID WATKINS residence. On the way to the residence, they received another cellular call from GAVIN. Individuals named LIVINGSTONE and KENNEDY wanted to view the decedent's body at the hospital. BRAUN stated that it would be ok as long as they did not touch the body.

BRAUN and ROLLA picked up WATKINS at his residence. WATKINS' wife followed them in their personal car. BRAUN and ROLLA asked WATKINS about FOSTER's motive for suicide. At that time, WATKINS told them that FOSTER was extremely depressed over the "Travelgate" matter.

TIPTON then relayed this information to the two individuals who were in the emergency room. TIPTON stated that he recalled these individuals' names as KENNEDY and LIVINGSTONE. Major HINES told TIPTON to telephone this individual. TIPTON then called the lieutenant back at the U.S. Park Police Communications Center and talked with him on the phone. The lieutenant told TIPTON that these individuals would be allowed access to view the decedent's body. However, the lieutenant told TIPTON to not let them touch the body or take anything from the body.

TIPTON then escorted the two individuals to the Fairfax Hospital morgue, along with a Fairfax Hospital security officer and a nurse supervisor whose first name is "CRISTY". Upon arrival at the morgue area, a Fairfax Hospital Laboratory Technician retrieved the decedent's body from out of the morgue freezer. LIVINGSTONE and KENNEDY viewed the decedent's body from behind a glass partition. The laboratory technician pulled the curtain back on the glass partition, and exposed the head of the decedent in the body bag. KENNEDY became extremely upset. TIPTON recalls KENNEDY crying and providing KENNEDY with tissues. TIPTON recalled KENNEDY asking "Why?" LIVINGSTONE appeared more business-like. LIVINGSTONE did not appear to get emotionally upset. While escorting LIVINGSTONE and KENNEDY from the morgue area, KENNEDY punched a locker because he was so emotionally distraught. TIPTON recalled LIVINGSTONE having a cell phone and that he was constantly making telephone calls. Additionally, TIPTON stated that LIVINGSTONE and KENNEDY used the hospital phones in the emergency room police office and the hospital phone in the consultation room of the emergency room. From about February, 1993 until December, 1993, he was employed as a Medical Technician by the Office of the Chief Medical Examiner, Northern Virginia District, Fairfax, Virginia. He worked for and under the supervision of DR. JAMES C. BEYER.

Prior to the interview, he was allowed to review the Report of Autopsy pertaining to VINCENT FOSTER and to view several photographs taken during the autopsy. He stated he recalled assisting DR. BEYER during this autopsy.

He was not aware of the identity or the importance of FOSTER at the beginning of the autopsy. However, he was told by DR. BEYER that this was a very high profile case and that they needed to take their time and be very thorough. There was no pressure to hurry the autopsy and to the best of his recollection, it was conducted in the normal manner.

As to persons present during the autopsy, he advised the usual procedure was to list the doctor conducting the autopsy and any "outsiders". It was not the usual practice to list the technician. He recalled there were three (3) to five (5) "outsiders" present during this particular autopsy however he was not introduced to any of them and he did not recall hearing any of their names.

FOSTER's body was undressed by DR. BEYER and himself. After removal, each item of clothing was visually inspected by DR. BEYER and then placed in a plastic bag. The usual procedure was to place all items of clothing into the same bag unless a particular garment contained a hole or tear from the weapon causing the death. Then that particular piece of clothing was placed in a separate plastic bag. His best recollection of this

autopsy was that all of the items of clothing were placed in the same plastic bag since the wound was in the head.

He recalled at the time of FOSTER's autopsy, the laboratory had just received a new X-Ray machine and that it was not functioning properly. Some times it would expose the film and some times it would not. He recalls moving the machine over FOSTER's body in the usual procedure and taking the X-Ray. They did not know until near the end of the autopsy that the machine did not expose the film.

Photographs taken during the autopsy were taken by DR. BEYER. He could not now recall just how many photographs were taken but mentioned the photographs he has observed today accurately depict the body as he recalls it that day. He identified the black male in one of the photographs as being himself.

He recalled seeing a dark area on the webbing and along the thumb and forefinger of FOSTER's right hand. He did not know if this was just a dirt smudge or if it was gun powder but DR. BEYER photographed it. He could not now recall seeing this same type dark matter on the left hand but observed in the autopsy report that there was. He could not explain why DR. BEYER did not photograph the left hand.

He could not recall seeing an indentation on FOSTER's right thumb nor could he recall there being any discussion concerning it during the autopsy.

He said the usual practice during an autopsy such as this one, was for fingerprints to be taken. He had no clear recollection of whether or not fingerprints were actually taken during this autopsy or who took them but would assume the body was fingerprinted.

He recalled that DR. BEYER inserted a probe through the path of the bullet before the skull was opened and that photographs were taken. DR. BEYER did not appear to meet any resistance as he inserted the probe and he recalls that DR. BEYER made some comment that the bullet path was clear.

After the brain was removed and visually inspected, he recalls DR. BEYER did dissect it with cuts of approximately one-

eighth inch thickness. He specifically recalls this because he sharpened the knife prior to the autopsy and recalls asking DR. BEYER if he had done it right and if the knife was sharp enough. He recalled there were no bullet fragments located inside the brain.

He recalled they could not locate the missing skull fragments from the exit wound. They even searched the body bag used to transport FOSTER but found nothing.

During an autopsy, blood is not normally drained for weighing and measurement. If there is blood in the chest cavity, it will be removed, measured and weighed. That was not the situation during this particular autopsy.

He did not see evidence of any other type of injury anywhere on FOSTER's body. He was shown a photograph of a dark spot on the right side of FOSTER's neck area which he identified as dried or smeared blood.

He concluded by saying there was nothing about the autopsy of FOSTER that was unusual or caused him any concern. He described it as just a routine autopsy.

Prior to this interview, BURGESS said he had not been contacted by anyone for interview regarding this matter.

On 7/21/93 Sgt. Rule, I.D.Tech's Johnson and Hill, and the undersigned responded to the officer of the Medical Examiner in Fairfax Va. At this time we met with Dr. Byer. After briefing him with the available information surrounding the crime scene and the victim he started the autopsy on the victim. Prior to our arrival the victim's tongue had been removed as well as parts of the soft tissue from the pallet. Dr. Byer stated that there was evidence of gunpowder residue on the soft tissue but not on the tongue.

Dr. Byer pointed out what he thought to be gunpowder residue on the right hand forefinger of the victim. I supplied him with a picture of the crime scene in which the suspected residue was evident.

During the autopsy Dr. Byer noted that the bullet trajectory was "upward and backward" exiting in the center line of the back of the head. Dr. Byer stated that X-rays indicated that there was no evidence of bullet fragments in the head.

Dr. Byer stated that it appeared that the victim had eaten a "large" meal which he believed to have occurred within 2-3 hours prior to death. He was unable to state positively what type of food was consumed but stated the it might have been meat and potatoes.

The cause of death was determined to be "perforated gunshot wound in and out". The point of entry was in the back of the mouth with the exit in the back of the head. Autopsy concluded at 1105 hrs.

Hair and blood samples as well as fingerprints were taken from the victim by Dr. Byer and turned over to I.D.Tech Johnson. In addition, I.D. took custody of the victim's clothing.

maintained that this search of the decedent's pockets took place after both he and Identification Technician Peter Simonello (USPP) took photographs of the decedent's body and the death scene area. In this regard, Investigator Rolla reviewed a series of polaroid photographs supplied by the USPP and advised that these polaroid photographs were a true and accurate representation of his observations of the decedent's body and the death scene at Fort Marcy Park on July 20, 1993.

In regards to the above noted polaroid photographs, which Rolla stated were a combination of the photographs he and Sergeant Edwards took at the scene, his attention was drawn to a transfer-like pattern of blood forming a straight lower margin at the right side of the decedent's neck and chin. Investigator Rolla advised that this blood pattern did give him some concern but believed that this blood pattern could possibly have occurred as a result of the decedent's head twisting or jerking at the time of death or for that matter could have resulted from activities performed by EMT personnel when they were checking for vital signs. Investigator Rolla reiterated that during the period he was at the death scene, he did not touch the body or observe anybody else touch the body prior to the completion of all death scene photography.

In addition to the above functions performed by Investigator Rolla, he advised that he physically checked the surrounding area of the death scene, which failed to reflect any footprints, tire tracks, or any trampled vegetation. He did advise however, that approximately 15 feet to the right of the 2nd cannon in an open area, he did observe an empty bottle of what he thought was wine cooler, with the bottle shaped similar to a Mystic shaped soft drink. To the best of his recollection, the label on the bottle was faded, was empty of any contents and appeared to have been at the location for a extensive period of time.

According to Investigator Rolla, at approximately 7:45 pm, Fairfax County Coroner, Dr. Donald Haut, arrived at the death scene and examined the decedent. Rolla recalls rolling the decedent's body over at which time he observed an extensive amount of blood on the back of the decedent's shirt and on the back side of his head. Additionally he advised that he physically felt the exit wound at the rear of the decedent's head noting that it was extremely soft and mushy. He further observed what he thought was urine on the decedent's trousers in the

On 04/17/96, Detective JOHN C. ROLLA, United States Park Police (USPP), Investigations Branch, Annocostia Station, telephone number (202)690-5050, was interviewed by Special Agent JAMES T. CLEMENTE, Federal Bureau of Investigation. Also present for this interview were Consultant R. JEFFERY GREENE and Associate Counsel STEPHEN C. PARKER, Office of the Independent Counsel (OIC). After having been advised of the identity of the interviewers and the nature of the interview, ROLLA provided, in part and in substance, the following information:

Upon arriving at Fort Marcy Park (Ft. Marcy) ROLLA was briefed in the parking lot by USPP Officer FRANZ FERSTL. FERSTL pointed out the car and the suit jacket laying folded on the front passenger seat, stating that they appeared to belong to the decedent found in the park. While ROLLA was viewing the car and the jacket, he noticed that the car door lock pegs were in the up/unlocked position. ROLLA then proceeded into Ft. Marcy and up to the second cannon where the body was located.

Upon arrival at the location of the body ROLLA was advised that there was a revolver in the decedent's right hand. ROLLA could not see the revolver until he straddled the body and leaned over looking closely at the right side. It was very difficult to see the revolver because foliage surrounded the body, the revolver was right next to the decedent's leg and the decedent's hand covered most of the revolver. ROLLA looked for, but did not see, any evidence of trampling of the foliage, or any signs of a struggle in the area surrounding the body.

ROLLA discovered a pair of prescription glasses at the foot of the berm on which the body was found. ROLLA also noticed an empty wine cooler bottle laying on the level ground inside the fort, approximately 15 feet east of the second cannon. ROLLA disregarded this bottle because the label was faded and there appeared to be dried mud in the bottle.

weapon shown in the photograph is in the same approximate position as he remembers seeing the weapon at the death scene. From this photograph, ARTHUR can see that the weapon depicted is obviously a revolver, but his impression on the scene was that the weapon was a semi-automatic weapon.

Based on the photograph of the gun in FOSTER's hand, the gunshot residue on FOSTER's hand, plus other forensic information, ARTHUR commented "My memory is, I saw a semi-automatic, however, I must have been mistaken." }

ARTHUR recalled when his crew arrived at Fort Marcy Park, they had not been given a specific location for the body. The only information provided to them was that there was a body by a cannon. The crew split up to search for the body and he accompanied two others down a trail from the southeast corner of the parking lot. The only people they saw were a man and a woman sitting on a hillside to the left of the trail.

() After following the trail to the bridge where the trail crosses under the George Washington Memorial Parkway, they returned to the parking lot. They were then directed up into the northeast corner of the park to the death scene.

ARTHUR did not see anyone working on the trails in the park and could not recall seeing any unidentified persons in the park, except the couple previously described. ARTHUR recalled searching the area north of the death scene and he did not see any other person(s) such as two men getting dressed or anyone running from the death scene.

ARTHUR prepared a hand drawn sketch of the park showing the location where the body of FOSTER was found. ARTHUR initialed and dated his hand drawn sketch, which is being retained and made a part of the file.

JAMES ATWATER IACONE was interviewed about his recollection of events which occurred on July 20, 1993 in Fort Marcy Park, Virginia in relation to the death of VINCENT W. FOSTER, Jr. IACONE, who was born on [REDACTED] is employed by the Fairfax County Fire and Rescue Department (FCFRD), Fairfax County, Virginia, as a Fire Lieutenant-Suppression and is assigned to FCFRD Fire Station 34, 10511 Rosehaven Street, Oakton, Virginia 22030, telephone (703) 591-0273. After IACONE was advised of the official identities of the interviewing agents and the nature of the interview, he provided the following information:

IACONE had never been to Fort Marcy Park prior to his response there in relation to the death of FOSTER on July 20, 1993. He may have driven in to the entrance of the park in the past in order to turn around, but he had never before been inside the park.

On July 20, 1993, IACONE was assigned as the officer on FCFRD unit Engine 1 when it was dispatched with another FCFRD unit, Medic 1, to Fort Marcy Park. When IACONE and other FCFRD personnel arrived at the park, there was no one at the park to direct them to FOSTER's body. IACONE walked over and examined a map of the park which was posted at the entrance to the park's parking lot. The map depicted two major trails within the park so IACONE, as the incident commander, decided to split up his personnel into two groups so that they might locate the patient more quickly. IACONE assigned a Cardiac Care Technician to each of the two groups so that their training and skills would be immediately available to the patient. The other members of IACONE's group were RALPH PISANI, JENNIFER WACHA and RICK ANTHONY.

IACONE and his group began walking down a trail leading to Pimmit Run. IACONE observed two people in the woods off to the left of the trail as he walked downhill. These two people were located to the left of two large trees, and one of the people was sitting on top of the other person.

IACONE's group arrived at Pimmit Run near the bridge which carries the George Washington Memorial Parkway over Pimmit Run. When IACONE and the members of the group were unable to locate a victim, they began to turn around and walk back up the trail toward the parking lot. Prior to going down the trail, IACONE had contacted the Fairfax County Public Safety Communications Center by radio and requested that the units on the scene at Fort Marcy Park be assigned to an alternate radio channel. On the way back up the trail from Pimmit Run, IACONE was notified via radio by Sergeant GEORGE GONZALEZ, who was with the other group of FCFRD personnel, that a body had been found. As IACONE and his group continued walking up the trail toward the parking lot, IACONE again observed the same two people he had seen previously still at the same location in the woods. No one in IACONE's group had conversation with the two people in the woods, and the two people did not inquire why the FCFRD personnel were in the woods.

When IACONE and his group reached the parking lot, IACONE returned to the map in an effort to visualize where GONZALES and TODD HALL, the members of the other group, were located. IACONE and the other members of his group walked together and arrived at FOSTER's body as a group. Officers of the United States Park Police (USPP) had arrived at the location of the body and had secured the scene.

IACONE recalls that FOSTER's body was lying on a trail with FOSTER's head on the uphill portion of the trail. The body was in a supine position, and FOSTER's hands were at his side. FOSTER was wearing a white shirt, necktie, dark trousers and dark shoes. IACONE does not recall if the shoes were tie shoes or loafers. FOSTER's head was straight in line with his body.

IACONE did not observe any eyeglasses, papers, bottles or other litter on the ground in the vicinity of the body.

IACONE may have checked FOSTER's right carotid artery for a pulse, but he does not have an exact recollection of doing so. If IACONE did feel for a pulse, he was standing to FOSTER's right side when he did so. Although IACONE recalls that FOSTER's face appeared pale, he does not know whether FOSTER's body was cold or warm, and he does not know if lividity was present. IACONE did not move FOSTER's body and he did not see anyone else move the body while he was at the scene. The Fairfax County Medical Examiner did not arrive at the scene while IACONE was

there.

IACONE recalls observing a silver or chrome-colored revolver in FOSTER's right hand. The gun may have appeared silver-colored because of sunlight reflecting off the gun.

At this point in the interview, IACONE was shown a photograph which had been taken by a USPP official on July 20, 1993 and which depicted a handgun in FOSTER's right hand. Even after viewing this photograph, IACONE advised the interviewers that he still recalled the handgun he had observed on July 20, 1993 as being silver-colored.

At no time did IACONE observe the back of FOSTER's head, shirt or trousers.

IACONE does not recall observing any blood on FOSTER's face, but he believes that there may have been blood on the face and he does not now recall it.

TODD HALL, another of the FCFRD personnel, observed a suit jacket in a car displaying Arkansas registration plates in the parking lot at the park. The jacket in the car appeared to match the trousers worn by FOSTER. The car itself was a dark red Honda whose color was almost a maroon shade but was not quite that dark a color.

During the course of the interview, IACONE was asked to show the interviewers the route he had followed inside the park on July 20, 1993. IACONE was also asked to draw handwritten sketches of the Fort Marcy Park parking lot and the area surrounding FOSTER's body as these locations had appeared on that date. IACONE's map of the parking lot depicts the positions of FCFRD units Medic 1 and Engine 1 as they were parked in the lot. The remaining unmarked rectangle on the map depicts the location where IACONE observed the Honda automobile displaying Arkansas registration plates.

IACONE was also asked to review a copy of a narrative report relating to the FOSTER incident which had been typed on the FCFRD reporting system. IACONE reviewed this one page document and identified it as a copy of the report he had prepared following his return to the firehouse on July 20, 1993.

GONZALEZ was shown polaroid photograph marked 85C15. GONZALEZ's recollection is that FOSTER's right hand was closer to his body than depicted in this photograph. GONZALEZ could only recall seeing the cylinder of the weapon and not the gun barrel. GONZALEZ has no recollection of seeing the trigger guard around FOSTER's right thumb. However, GONZALEZ states the remaining circumstances depicted in this photograph are as he recalls them from July 20, 1993. }

When the FCFRD crew left the death scene and returned to the parking lot, GONZALEZ instructed his crew members to check the doors of the vehicle that appeared to belong to the victim. GONZALEZ recalls his primary concern and interest was the clothing inside this vehicle. GONZALEZ wanted to see if the suit coat he observed in this vehicle matched the trousers worn by the victim. GONZALEZ did not actually observe any of the crew members attempt to open the doors of this vehicle.

GONZALEZ has a vague recollection of observing a necktie hanging from the rear view mirror inside the vehicle.

GONZALEZ recalls seeing something which he initially thought to be a briefcase/attache case in this vehicle. GONZALEZ was shown the canvas tote bag which was recovered from FOSTER's vehicle by the USPP. GONZALEZ acknowledged that this bag might have been what he saw in the vehicle and originally thought was a briefcase/attache case.

SHARON L. BOWMAN and her attorney JAMES HAMILTON of the law firm of Swidler & Berlin, Washington, D.C., participated in a telephonic interview regarding .38 caliber cartridges located by BOWMAN in Hope, Arkansas. The purpose of the interview was to determine how BOWMAN came into possession of the aforementioned cartridges and to determine the logistics of having the cartridges turned over to the custody of the Office of the Independent Counsel (OIC).

On November 28, 1994, BOWMAN was in Hope, Arkansas visiting the home of her mother. She returned to Little Rock on Tuesday, November 29, 1994. She traveled to Hope with her daughter. While at her mother's home, BOWMAN continued the task of going through articles at her mother's home that were related to the death of her father VINCENT W. FOSTER, SR. and her brother VINCENT W. FOSTER, JR. FOSTER, JR., was the former Deputy Counsel to the President, who died on July 20, 1993.

BOWMAN initially began the task of going through things at her mother's home circa, August, 1994. Of the things that BOWMAN began to look through during her August visit, a number of articles were placed in a sack for future review. BOWMAN left the sack in Little Rock upon her departure.

A number of loose handgun cartridges were among articles placed in the sack. The cartridges were located in a closet within her mother's residence located in Hope. The cartridges were in a drawer in the closet or on top of the built-in chest of drawers in the closet.

On November 29, 1994, BOWMAN took the shells that she had located last August and brought them to her home in Little Rock, Arkansas. In August, 1994, the shells were placed in a watch box that contained a mixture of cartridges. In addition to a number of .38 caliber cartridges, the box contained several much smaller cartridges. Upon initially finding the cartridges and placing them in the watch box circa August 1994, BOWMAN placed the watch box in the previously described sack. BOWMAN

noted that although she saw the bullets back in August, she did not examine them and did not realize the possible investigative significance of the cartridges.

On Tuesday, November 29, 1994, BOWMAN first realized the possible significance of the .38 caliber cartridges. BOWMAN did note that of the cartridges located in the watch box, she added one other bullet from another drawer in the residence but this cartridge was not a .38 caliber cartridge.

BOWMAN noted that there is one dresser at her mother's residence that she has not looked in. This dresser is also built into a closet in the house. The closet is in a bathroom in her mother's residence. She believes it contains handkerchiefs, socks and other assorted items.

BOWMAN could not recall the last time that her brother VINCENT FOSTER, JR. last visited the home of their mother. BOWMAN was aware that at some point FOSTER, JR. and his son BRUGH, had traveled to Hope, Arkansas in order to go through FOSTER, SR.'s things subsequent to the Senior FOSTER's death.

BOWMAN's mother resides at 1021 West 14th Street, Hope, Arkansas 71801. According to BOWMAN there were no further cartridges located in the closet from which the aforementioned cartridges were located.

ALICE MAE FOSTER, the mother of VINCENT WALKER FOSTER, JR. was interviewed at her residence in Hope, Arkansas, with Deputy Independent Counsel MARK TUOHEY and Associate Independent Counsel BRETT KAVANAUGH, and in the presence of SHARON BOWMAN. Mrs. FOSTER was advised of the identities of the interviewing agent and attorneys, and the purpose for the interview. Mrs. FOSTER provided the following information:

- Prior to her son's moving to Washington, D.C., Mrs. FOSTER saw VINCENT FOSTER often. Mrs. FOSTER's husband died of lung cancer in 1991. VINCENT FOSTER was very supportive of his parents. VINCENT maintained a furnished apartment for them in Little Rock, and was very attentive; no matter the inconvenience to him.

Mrs. FOSTER characterized her son as considerate, family-oriented, and self-sacrificing. VINCENT FOSTER's family was his source of recreation.

VINCENT FOSTER was in Michigan on business when his father died. His father's death was deeply disturbing to VINCENT FOSTER, particularly since he was not present at the end.

Mrs. FOSTER stated that she is unfamiliar with firearms, and did not fully realize the number of guns that were kept at her residence by her deceased husband. Mrs. FOSTER stated that she was aware of a handgun that was kept in the top drawer of a table by her husband's bed. Mrs. FOSTER described the handgun as a revolver. Mrs. FOSTER stated that she was never comfortable with guns. Her husband purchased a gun for her, but she was not at all interested in it. Mrs. FOSTER recalls her husband leaving a gun on a table in the house when her grandchildren were small. This frightened her, and she communicated her fear to her husband.

Her husband was terminally ill and bedridden for a period of time in 1991. A friend of his who was also terminally ill, committed suicide by shooting himself. Mrs. FOSTER was

concerned that her husband might also commit suicide. Mrs. FOSTER had all of the handguns in the house placed in a box and put in a closet.

Subsequent to her husband's death, VINCENT FOSTER came to her and told her that his father had told him that he could have the guns. Mrs. FOSTER gave VINCENT FOSTER the box of handguns.

Mrs. FOSTER was shown a revolver which was recovered from the hand of VINCENT FOSTER subsequent to his death at Fort Marcy Park. Mrs. FOSTER was unable to identify the gun, and could not say whether the gun belonged to her husband. Mrs. FOSTER's husband had a membership in a hunting cabin at Yellowcreek, Arkansas. He would go there occasionally with his friends. Mrs. FOSTER never accompanied them to the cabin to hunt or shoot.

Mrs. FOSTER recalled that at one time, her husband told her that he had obtained a permit for the gun. Mrs. FOSTER recalled that the conversation regarding the permit would have occurred in Hope, Arkansas during the 1950s or 60s.

Mrs. FOSTER was unaware of any family photos depicting the gun.

Mrs. FOSTER is aware that her son VINCENT accepted an appointment with the CLINTON administration to become the Deputy White House Counsel, not the White House Counsel. VINCENT FOSTER told her that he did not want the publicity that would accompany the position as the White House Counsel. At the time of his appointment, Mrs. FOSTER was very happy and proud of her son; now she stated that she wishes that he hadn't accepted the appointment. Mrs. FOSTER believes that her son would be alive today if he had not accepted the position at the White House. Mrs. FOSTER is sure that her son was deeply disturbed about the publicity he received in The Wall Street Journal articles.

Mrs. FOSTER is unaware of her son receiving any previous treatment for depression. Dr. LARRY WATKINS was his personal doctor.

Mrs. FOSTER last talked to VINCENT a day or two prior to his death. She had attempted to contact him during the weekend prior to his death; he returned her call and told her

to accept the position at the White House. Mrs. FOSTER recalls that it was at least half the pay of his previous position at the Rose Law Firm. VINCENT FOSTER did not like going into debt.

Mrs. FOSTER could not specifically recall receiving any letters from VINCENT FOSTER subsequent to his death. Mrs. FOSTER attempted to locate any letters, specifically a letter transferring oil or mineral rights on a property to her. Mrs. FOSTER was unable to locate any such letter.

Mrs. FOSTER married VINCENT WALKER FOSTER, SR. in 1937. They lived with her mother in Hope, Arkansas. Mrs. FOSTER recalls her husband having a handgun at that time. VINCENT WALKER FOSTER, SR. was involved in the oil business and traveled extensively throughout the United States. Additionally, VINCENT WALKER FOSTER, SR. was in the Navy in World War II, and was stationed at Alameda Naval Station in California.

During the interview, Mrs. FOSTER introduced her housekeeper, ARLENE REED, to the interviewing agent and attorneys. REED has been employed by the FOSTER's for approximately 40-45 years. REED is very familiar with VINCENT WALKER, SR. and JR. REED recalls seeing a handgun in the bedside table drawer immediately adjacent to VINCENT WALKER, SR.'s bed. REED was subsequently shown the previously identified revolver. REED was unable to identify the revolver as the handgun that she observed in the bedside table drawer.

Subsequent to the interview, Mrs. FOSTER showed the interviewing agent a photocopy of a codicil, which was a part of VINCENT WALKER FOSTER, SR.'s will. The codicil listed numerous personal items that were to be given to specific individuals at the time of VINCENT FOSTER, SR.'s death. The dates on the codicil were noted to be 8/10/88, 10/12/90 and 6/19/91. The first two pages of the codicil were identified by Mrs. FOSTER to be written in VINCENT FOSTER, SR.'s handwriting. The second two pages of the codicil were identified by Mrs. FOSTER as being written in ALLISON BETHUNE's handwriting. BETHUNE is Mrs. FOSTER's granddaughter; the daughter of SHIELA and BERYL ANTHONY. The codicil identifies the following guns which were to be left to the following individuals:

BERYL ANTHONY-Ithaca 10 gage auto shotgun
LEE-20 gage auto shotgun, which is currently in
VINCE's possession.

Washington, FOSTER saw the gun and commented on it. LISA FOSTER had not had a prior conversation with FOSTER about bringing a gun to Washington, D.C., but she argued with FOSTER when the gun was unpacked. LISA FOSTER told FOSTER that she did not want any guns in her house in Washington.

LISA FOSTER is not aware of any photographs which may be kept in Arkansas which would depict the guns owned by FOSTER's late father. She is only aware of snapshots of family members going hunting.

LISA FOSTER is not aware of any records from the elder MR. FOSTER's estate which might describe the firearms he had owned. She is aware of a handwritten note from the elder MR. FOSTER regarding the disposition of his property after he passed away. According to this note, all of the elder MR. FOSTER's guns were left to FOSTER and a diamond was left to LISA FOSTER. After the funeral for FOSTER's father, FOSTER went down to his father's house and retrieved the guns. LISA FOSTER believes that there were approximately three to five handguns included in the guns retrieved by her husband. She believes that her husband obtained all of the guns which were left by FOSTER's father.

LISA FOSTER does not know where her husband kept the guns left to him by his father while the FOSTERS were still living in Little Rock.

LISA FOSTER believes that the shotguns from the estate of the elder MR. FOSTER are currently in the possession of her brother-in-law, who is the husband of her sister. SHARON BOWMAN, FOSTER's sister, has one handgun. LISA FOSTER believes that BERYL ANTHONY has one of the handguns from the estate here in Washington, D.C., but she has not asked ANTHONY that specific question.

FOSTER himself did not like guns. FOSTER's father had given guns to LISA FOSTER's sons, which displeased LISA FOSTER. LISA FOSTER also knows that FOSTER kept a gun in a closet in their home in Washington, D.C. LISA FOSTER was aware of the location of one gun inside her residence in Washington and she found that gun still in its usual location on the night of July 20, 1993. The gun which she found on that date was not the silver gun which she had earlier found in the trunk in Little Rock. LISA FOSTER believes that the gun found at Fort Marcy Park

NANCY HERNREICH'S birthday was that week. LISA knew HERNREICH from ARKANSAS. LISA did not personally know MARSHA SCOTT.

LISA FOSTER stated that FOSTER was a perfectionist. A good example of this was the speech he wrote for the University of Arkansas Law School Commencement. FOSTER wrote and rewrote the speech. He made corrections to it and rewrote it again. Then he corrected his corrections.

LISA FOSTER stated that it was normal for FOSTER to take the onions off of his hamburgers.

After LISA FOSTER had been notified of her husband's death, she retrieved a handgun that was stored on a shelf in her closet, under her sweatshirts. The handgun was in an old leather "case". There were other handguns in the closet in LAURA FOSTER'S room. The handguns were placed there when they unpacked after the move. LISA thought that one of the handguns was silver. LISA FOSTER stated that she is completely unfamiliar with the guns, and had no interest in them, other than to try and convince FOSTER to get them out of the house. LISA FOSTER stated that she may have gone into LAURA'S closet to look for the guns after FOSTER'S death. LISA may have said that they (the guns) were not there.

LISA FOSTER does not recall looking for a note after FOSTER'S death, but she may have. LISA FOSTER is unable to specifically recall many of the events immediately after FOSTER'S death.

LISA FOSTER does not personally know CRAIG LIVINGSTONE.

The day after FOSTER'S death, LISA spoke with BERNIE NUSSBAUM. He told her that he should have let him (FOSTER) quit, or forced him to quit. LISA told NUSSBAUM that FOSTER would have killed himself anyway.

LISA FOSTER had no knowledge of the existence of the note until she returned to D.C., subsequent to FOSTER'S funeral. NUSSBAUM telephoned her, and told her about it.

LISA FOSTER stated that she is unfamiliar with FOSTER'S clients. LISA had no knowledge of SYSTEMATICS or AL-TEL.

Although LISA FOSTER did not view or read the note on the day that FOSTER appeared to be energized by her remarks, she is confident that the comments written in the note were written on that same day. LISA FOSTER knows that FOSTER was upset about the Federal Bureau of Investigation (FBI) being called in regarding the Travel Office matter, but she does not believe that FOSTER believed that the FBI had lied. People know that representatives of the media were getting deals through the White House Travel Office. LISA FOSTER is aware that people knew of these deals, but she herself knew nothing about FOSTER's remarks in the note pertaining to the Republicans or the usher's office. LISA FOSTER believes that FOSTER was concerned about excessive costs being incurred by the usher's office, but FOSTER never discussed these matters with her.

On Tuesday night, July 13, 1993, FOSTER spoke with LISA FOSTER about resigning. LISA FOSTER encouraged him to stay in his position in the White House Counsel's office. LISA FOSTER is aware of the whereabouts of some ammunition which was kept at the FOSTER residence in Little Rock prior to her husband's death. She recalls finding a number of shotgun shells in the top drawer of her dresser. She also recalls that there were a number of shotgun shells kept in a closet. In searching her house, LISA FOSTER found a number of 20 gauge and 12 gauge shotgun shells, some .22 caliber ammunition, and possibly some small handgun ammunition. LISA FOSTER does not recall seeing any such ammunition at her house in Washington, D.C.

Interview: Lisa Foster

On 7/29/93 at approximately 1610 hours Lisa Foster, wife of Vincent W. Foster, was interviewed at the law offices of Swidler & Berlin, 3000 K Street, Northwest, Washington, D.C. The interview was conducted by Detective Peter W. Markland and Captain Charles Hume. Mrs. Foster was represented by Mr. James Hamilton. Also present, at Mrs. Foster's request, was Mr. Beryl Anthony and Mr. John Sloan.

Mr. Hamilton prefaced the interview by stating that there would be no waiver of the attorney-client privilege between himself and Lisa Foster. Prior to any disclosure of this report Mr. Hamilton requests that he be consulted. Lisa Foster then provided the following information:

-Lisa and the rest of the family were in Washington, D.C. in November 1992 and again around Easter 1993. They remained in Arkansas the remainder of the time because of school year considerations. Mr. Foster lived apart from his wife and family until June of this year when the family moved to Washington to join him.

-Pressures associated with his role at the White House were physically affecting Mr. Foster adversely. Specifically citing not being able to sleep well and telling his sister, Sheila Anthony, that he was not feeling well and was experiencing high blood pressure.

-The criticism of the President in the news media, the Travel Office investigation, the scrutiny by the press of the people from Arkansas, and even the stress of the family move to Washington in June all seemed to Lisa Foster to have a cumulative effect on Vincent Foster. He "took it all personally" and once stated to her "How did I get myself into this?".

-Vincent Foster historically dealt very well with stressful situations but was used to being in charge and in control of situations while in Arkansas, control that he lost when he took the position at the White House. He also lost the outlets for stress with the family life that he enjoyed while in Arkansas. Lisa and he talked about this and had begun an effort to rectify the situation by taking time out for themselves. They had just traveled to the eastern shore and, although it had not gone particularly well, discussed that things would take time and not change overnight.

-Vincent Foster had an extreme loyalty to the Clinton Administration and was trying to protect it. He felt he had personally failed and talked to Lisa about quitting, however, would not return to Arkansas (because of the personal humiliation he felt). Lisa Foster felt that something physical came over Vincent quickly.

-Mr. Foster's sister, Sheila Anthony, had recently provided him with the names of three psychiatrists in the event he should seek their care. It is not known whether or not he contacted any of these doctors. The Foster's family doctor, Larry Watkins, was contacted in Arkansas and he prescribed an anti-depressant, Trazodone 50 mg., for Mr. Foster. Lisa and Vincent discussed the prescription and Mr. Foster decided to start with the lowest possible dosage. Vincent Foster took one 50 mg. tablet of Trazodone on the evening of 7/19/93.

-The last time Lisa Foster saw her husband was on the morning of July 20th at approximately 08:30 A.M. when he left for work driving the Honda. She left the house shortly thereafter for an appointment and does not know whether or not he returned to the residence that afternoon. Her son may have been in the basement during the early afternoon but it would be possible for Vincent Foster to enter and exit the residence without the son realizing his presence. On that particular morning Vincent Foster's mood seemed better than it had been "in a while".

-The torn note produced by the White House counsel's office was viewed by Lisa Foster on 7/26/93 at the White House. She stated that it was, indeed, Mr. Foster's handwriting. She also stated that she had counseled him to write down his concerns and he probably did so in preparation for any upcoming investigation into his activities and decision making processes. It is Lisa Foster's opinion that the note was written 1-1½ weeks before his death. *** (Mrs. Foster and Mr. Hamilton have requested that the document be turned over to the custody of the family at the conclusion of this investigation.)

-Mrs. Foster stated that she was used to a number of guns being present at her home in Arkansas due to the different lifestyle there. She was presented with a photograph of the weapon found with Mr. Foster's body but was unable to identify it. She suggested that her sister-in law, Sharon Bowman, may be able to identify the weapon. Mrs. Bowman is an outdoors type person and would have a better knowledge of firearms owned.

At this point in the interview, LISA FOSTER was asked to examine a pair of eyeglasses which had been found in Fort Marcy Park on July 20, 1993. LISA FOSTER held the glasses, examined them, and then stated that the eyeglasses appeared to be those of her husband. LISA FOSTER noted that the tips of the stems of the eyeglasses had bite marks on them, which was an observation consistent with one of her husband's habits. FOSTER had frequently chewed on the tips of his eyeglasses as a nervous habit.

LISA FOSTER then examined a revolver which had been brought to the interview by the interviewing agents. FOSTER examined the revolver, which had also been found at Fort Marcy Park on July 20, 1993, and stated that she believed it may be a gun which she formerly saw in her residence in Little Rock, Arkansas.

LISA FOSTER then examined a photocopy of a handwritten note which has previously been identified as having been written by her late husband. LISA FOSTER believes that the original note was written on or about July 11, 1993. LISA FOSTER is not entirely certain of this date and believes that the note was written sometime during the period between July 4 and July 20, 1993. She believes that the note was written by FOSTER in their Washington residence on a day when there were a number of young people in her house. Her son was working as a Senate aide and there were a number of other aides visiting him on that day. LISA FOSTER invited FOSTER to go with her to the store, but he declined to accompany her. FOSTER was upstairs in bed, alternately trying to sleep and work. LISA FOSTER suggested to FOSTER that he write down everything that "they" did wrong. She suggested to FOSTER that he go on the offensive and not continue to take responsibility for every mistake which was made in the White House. FOSTER agreed with LISA FOSTER's suggestion, and he sat up in bed and appeared energized. FOSTER told LISA FOSTER that he had not resigned yet, and he said that he had already written his opening argument in his defense. LISA FOSTER believes that the torn note which was found was actually FOSTER's opening argument in the event he had to testify before Congress.

SA CLEMENTE then showed FOSTER the gun that was found on July 20, 1993 in VINCE FOSTER, JR.'s hand at Fort Marcy Park. LISA FOSTER then asked if she could touch the gun, which she did, after which she stated, "I don't know what all the mystery is about, I swear this is the gun that I unpacked." VINCE FOSTER, JR. had a footlocker he was planing to bring with him to Washington, D.C., but he never got around to packing it. When LISA FOSTER went to Washington, D.C., she took what was in the footlocker, boxed it and brought it to Washington with her. VINCE FOSTER, JR. had a gun and three hardcover books, one of which was "THE MAKING OF A PRESIDENT", in the footlocker. LISA FOSTER then stated, "I swear it was this gun, only it looked lighter in the front part. I thought it had a black handle and the front was silver."

FOSTER described the gun from the footlocker as looking like a "cowboy" gun, not "squared-off" like the other gun that they had in the house at the time. LISA FOSTER recalls that when she and VINCENT FOSTER, III were in the basement unpacking the boxes they had moved from Little Rock to Washington, D.C., VINCE FOSTER, III found the gun and said, "Oh shit, what is this doing here." LISA FOSTER didn't pay much attention to the gun because she is as afraid of guns as she is of snakes. LISA FOSTER seems to remember the front of the gun looking lighter. However, when the light plays off of the gun a certain way, it does seem silvery to her. LISA FOSTER stated that if she had been asked to draw a picture of the gun, it would have looked just like this one.

At this point, LISA FOSTER left the room and on her own volition telephoned VINCENT FOSTER, III at his office in Atlanta, Georgia and returned saying that VINCENT FOSTER, III remembers unpacking a Colt, but LISA FOSTER does not know the difference between a semi-automatic and a revolver and therefore did not ask her son to describe the type of Colt he unpacked. LISA FOSTER recalls telling VINCE FOSTER, JR. several times to get rid of the guns while they were living in Washington, D.C. LISA FOSTER also recalls that VINCE FOSTER, JR. got mad because she had mentioned the guns in front of their children. LISA FOSTER believes that VINCE FOSTER, JR. took a gun or guns from his father's office to keep them from his mother in case she got depressed after the death of her husband.

BERYL ANTHONY ultimately arrived at the house. BILL KENNEDY and his assistant, who was a big, heavy set guy, were there and the assistant stayed outside. HUBBELL recalls seeing BILL KENNEDY's wife, GAIL KENNEDY, at the house because GAIL KENNEDY has a daughter the same age as HUBBELL's child. Senator DAVID PRYOR and his wife, BARBARA PRYOR, were at the house. Senator PRYOR was responsible for having a doctor come to the house to provide care to the FOSTER family. SYDNEY PROBST was at the house and may have been there with SHEILA ANTHONY and SHARON BOWMAN. PROBST now lives in WDC.

President CLINTON was at the house as were BRUCE LINDSEY, MICKEY KANTOR and KANTOR's wife, HEIDI SCHULMAN. HUBBELL does not recall seeing DEBORAH COYLE or NANCY HERNREICH at the house. The doctor who had been summoned by Senator PRYOR gave some medication to LISA FOSTER at some point.

The USPP investigators seemed sure of their identification of FOSTER as the decedent.

LISA FOSTER was very distraught that evening. Shortly after HUBBELL arrived at the house, LISA FOSTER went into a closet in her bedroom and looked for something. HUBBELL does not recall if LAURA FOSTER or SUZIE HUBBELL was present at that time. LISA FOSTER looked on a shelf at the top of the closet and found a handgun, possibly among the sweaters on the shelf. LISA FOSTER then advised that a gun was missing and one other gun was still in the closet. HUBBELL saw an older looking handgun with a square-shaped handle which holds a clip in the bedroom closet of the FOSTER house. HUBBELL believes the gun was unloaded since there was no clip in the handle. HUBBELL is not familiar with handguns. HUBBELL was scared about this gun being in the FOSTER house, especially after such a traumatic incident. After LISA FOSTER left the bedroom, HUBBELL retrieved the pistol and gave it to BERYL ANTHONY and asked him to keep it. LISA FOSTER was later

On 11/30/95 WEBSTER L. HUBBELL was interviewed by SA JAMES T. CLEMENTE, FBI and CI COY A. COPELAND, OIC. Also present for the interview was HUBBELL's lawyer, LAURA SHORES. After having been advised of the identity of the interviewers and the nature of the interview, HUBBELL provided, in part and in substance, the following information:

On July 20, 1993, after HUBBELL was notified of the death of VINCENT W. FOSTER, JR., HUBBELL was at the FOSTER residence. At some point early on that night HUBBELL and LISA FOSTER were upstairs in the FOSTER's bedroom, and LISA FOSTER was talking about the discussions she and VINCENT FOSTER, JR. had over the preceding few days. HUBBELL recalls telling LISA FOSTER that he didn't even know that VINCENT FOSTER, JR. had a gun. LISA FOSTER then responded, "Let's look and see if they are still there." LISA FOSTER then walked directly to the closet in the bedroom and began searching the shelf. HUBBELL stood beside LISA FOSTER as she reached up with her hands and felt for a gun underneath some blankets or sweaters. FOSTER then pulled out a "squared-off" type gun in an Army green-type holster. HUBBELL does not recall whether the holster had a flap or was secured in some way. LISA FOSTER said, "This isn't it," she then added, "Looks like the other one is not here." LISA FOSTER proceeded to look for another gun in the closet. Together, HUBBELL and LISA FOSTER did a thorough search of the closet shelf, possibly removing everything from the shelf. HUBBELL recalls LISA FOSTER saying, at some point, that VINCE FOSTER, JR. did have guns that his father had left to him. LISA FOSTER further stated that they had brought the guns with them to Washington, D.C.

At some point, HUBBELL had the "squared-off" gun in his hand and he noticed that there was no magazine in the bottom of the handle. He describes the gun as all steel and either dark grey or black in color. HUBBELL had the strong impression that the "other gun" that he and LISA FOSTER were looking for was one that LISA FOSTER was more familiar with. However, HUBBELL does not recall whether or not LISA FOSTER had described the other gun to him.

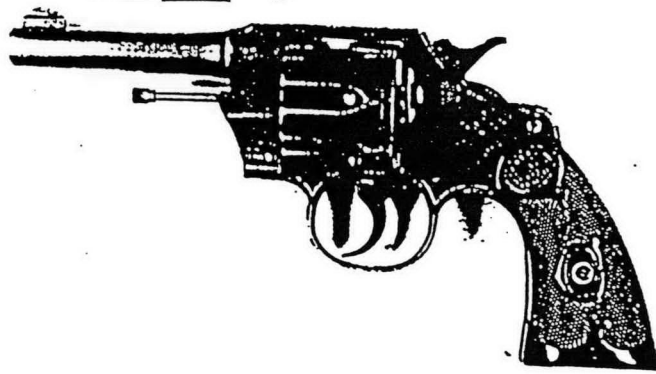

SHEILA FOSTER ANTHONY was interviewed at the United States Department of Justice, Washington, D.C., where she serves as Assistant Attorney General for Legislative Affairs. JAMES HAMILTON, who is associated with the law firm of Swidler & Berlin, Washington, D.C., and who is representing the FOSTER family, was present during the interview. Also participating in the interview were MARK STEIN and CARL STICH, Associate-Counsel with the Office of the Independent Counsel, Washington, D.C. After ANTHONY was advised of the official identities of the interviewing agents and that the interview pertained to the circumstances of the death of her brother, VINCENT W. FOSTER, JR., on July 20, 1993, she furnished the following information:

Among the duties of the Office of the Assistant Attorney General for Legislative Affairs are the clearance of bills before they are forwarded to the Office of Management and Budget and a role in the selection of nominees for positions as United States Attorneys, United States Marshals and Federal Judges. ANTHONY's office also corresponds with Congress and assists in attempting to advance legislation which is regarded as important to members of Congress.

ANTHONY has not been interviewed previously by either the United States Park Police (USPP) or the Federal Bureau of Investigation (FBI) regarding the death of her brother.

ANTHONY has no personal knowledge regarding the gun which was found with the body of VINCENT W. FOSTER, JR. ANTHONY's father, VINCENT W. FOSTER, owned a number of handguns, rifles and shotguns. The elder MR. FOSTER was very ill with cancer approximately two years ago, and he eventually died as a result of the disease in June 1991. Prior to his death, the elder MR. FOSTER had hinted to other family members that he might use a weapon to take his own life. Either VINCENT FOSTER, JR. or ANTHONY's sister, SHARON BOWMAN, or possibly both of them removed the guns owned by the elder MR. FOSTER from his home in Hope, Arkansas. ANTHONY recalls that the guns were removed from the house sometime during the period of March to May 1991, but

finding of suicide in the case. VINCENT FOSTER, III expressed complete confidence in the thoroughness and professionalism of the FBI investigation, and stated that he was convinced and satisfied that his father had taken his own life.

VINCENT FOSTER, III stated that he knew that his father had an old .38 caliber revolver. He had seen it unpacked in their residence in D.C. His father told him that he had received it from his father (VINCENT FOSTER, SR.). VINCENT FOSTER, III was subsequently shown the .38 caliber Colt revolver which was found in the hand of VINCENT FOSTER, JR. at the time of his death. VINCENT FOSTER, III was unable to identify the gun as the one that he had previously seen, and stated that he was not sure if it was the same weapon. VINCENT FOSTER, III recalls his father previously saying something about keeping the gun for protection in "the big city." VINCENT FOSTER, JR. thought that it would be in his best interest to have an attorney for this incident. VINCENT FOSTER, JR. was upset about the media coverage regarding the firing of the Travel Office staff. Additionally, he thought that BILL KENNEDY had received a "bad deal" regarding his contact with the FBI.

VINCENT FOSTER, III stated that he had heard rumors about a letter from Senator DOLE, but did not know any specific information about this letter.

VINCENT FOSTER, III stated that he had no knowledge of any family financial problems, or of his father having any health problems. Money did not seem to be a problem, the children had a trust fund for their college tuitions.

VINCENT FOSTER, III recalled that his father had taken a day off from work at some point immediately prior to his death. However, he could recall no specific information regarding what prompted his father to take the day off or what actual day it was.

whatever they wanted, regardless of the truth. VINCENT FOSTER was angry with the way BILL KENNEDY was portrayed in the media during the Travel Office matter. KENNEDY had called the FBI for advice on the Travel Office situation, not to demand an investigation.

BRUGH FOSTER did not recall being in the family's Honda sedan the weekend before his father's death. BRUGH FOSTER does not smoke, but his brother VINCENT FOSTER, III does.

On July 20, 1993, the day of his father's death, BRUGH FOSTER woke up at approximately 11:00 a.m., and subsequently got out of bed at approximately 1:00 p.m. BRUGH FOSTER's mother, LISA FOSTER, came home, and he went with her to the MCLARTY's house. BRUGH FOSTER stated that they were gone between 2:00 and 3:00 p.m. in the afternoon, possibly earlier. BRUGH FOSTER stated that it is possible that during that time period, his father could have returned to their house. However, BRUGH FOSTER stated that he has no direct knowledge of his father returning to the house.

During the unpacking from the move to D.C., BRUGH FOSTER observed one or two handguns in a shoe box, along with a number of loose bullets. BRUGH FOSTER stated that these items came from his grandfather's house. BRUGH FOSTER described his grandfather's handguns as a small pearl-handled gun, and one or two revolvers. His grandfather left one of the guns to BRUGH FOSTER. This gun is now with his Aunt Sharon. The gun was given to her prior to them moving to D.C. BRUGH FOSTER is aware that his mother asked his father to put the guns in a lock box. BRUGH FOSTER thinks that his father placed them in a closet. In any event, BRUGH FOSTER did not see any of the guns again after that day. After his father's death, BRUGH FOSTER found a magazine with one bullet loaded in it. BRUGH FOSTER stated that he was previously shown a handgun, but does not recall what it looked like. The handgun was shown to him for identification purposes by an FBI Agent who had travelled to Little Rock.

BRUGH FOSTER recalled his father talking of purchasing a boat when they returned to Arkansas after he was done with his job here. BRUGH FOSTER admitted that he had previous doubts concerning his father's intent to commit suicide because of these conversations. However, BRUGH FOSTER stated that he has recently accepted that his father did indeed commit suicide. BRUGH FOSTER stated that he has taken a psychology course and learned of some

death when the U.S. Park Police officers came to their home. It was fairly late in the evening, but LAURA thought that her father was still at the White House watching the President on the Larry King Show.

LAURA FOSTER could not recall any conversations regarding her father leaving a suicide note, nor any recollection of anyone in the residence looking for guns in the house on the evening of her father's death. LAURA FOSTER did recall conversations regarding the concerns relating to contacting her grandmother in Hope, Arkansas; and locating and notifying her brothers.

LAURA FOSTER stated that she never saw more than one handgun in the house. LAURA recalled someone unpacking the handgun at the house when they initially moved to D.C. The day after her father's death, she found a "cartridge" in her closet. In describing the "cartridge", it was apparent that LAURA FOSTER was describing a pistol magazine. LAURA FOSTER stated that she gave the "cartridge" to her mother. LAURA FOSTER never saw any other weapons in their D.C. home, however, she did recall seeing rifles in their Little Rock residence.

LAURA FOSTER stated that she has no doubt that her father died as a result of a self-inflicted gunshot wound, and that it was a suicide. LAURA FOSTER believes that her father may have been suffering from some type of chemical imbalance that had caused him to become temporarily insane. Otherwise, he would not have been able to intentionally leave his family.

LAURA FOSTER stated that her father was always very intense about his work. She recalled that in 1992, her father was concerned that their own telephone was being tapped. He subsequently changed their home telephone number. Additionally, her father was concerned about telephone calls from the media regarding an alleged affair with HILLARY CLINTON. VINCE FOSTER told LAURA that these media reports were not true.

LAURA FOSTER did not think that her father was at any time concerned for his personal safety, and did not feel the need to keep a weapon with him.

LAURA FOSTER stated that the last time she personally used the Honda sedan was prior to July 4, 1993.

Office Personnel Interviews

The following two people were interviewed at the West Wing of the White House by Detective Markland and Special Agent Salter on 7/22/93. The information provided by these two individuals was brief.

Tom Castleton (Staff Assistant) @ 1000 hours:

Mr. Castleton stated that he worked on 7/20/93 and remembers that Mr. Foster ate lunch at the office, although he could not place the time. Mr. Castleton was present when Mr. Foster left the office after eating lunch and said "So Long". Mr. Foster did not respond and seemed to Mr. Castleton to be "In his own world", focused, disturbed.

Linda Tripp (Executive Assistant) @ 1150 hours:

Ms. Tripp stated that she began her workday on 7/20/93 at 0800 hours. Mr. Foster's demeanor seemed normal to her, however, she had no personal dealings with him on that day.

Ms. Tripp makes it a habit to notice what the staff members are taking with them when they leave the office in order to determine for herself how long she may expect them to be away from the office. Ms. Tripp was absolutely certain that Mr. Foster did not carry anything in the way of a briefcase, bag, umbrella, etc... out of the office.

On Thursday, August 22, 1993, Detective Pete Markland and I responded to the White house to meet with Special Agents Scott Salter and Dennis Condon of the FBI to conduct interviews. The purpose of the interviews were to reconstruct the final hours of Vincent Foster's life.

Myself and Special Agent Condon interviewed Ms. Betsy L. Pond; Staff Assistant to Bernard Nussbaum, Chief Counsel for the White House. The interview took place in an office that was unoccupied for the day. Present in the room during the entire interview were Clifford Sloan; associate counsel to Nussbaum, and Paul Imbordino; assistant Special Agent in Charge, Office of Protective Operation, U.S. Secret Service. Clifford Sloan took notes throughout the interview. During the interview Bernard Nussbaum burst into the room and demanded "is everything all right?"

We started the interview at approximately 0900 hours. Ms. Pond got in to work at around 0900 hours on Tuesday, July 20th. Usually there is a staff meeting of the counsel's office from 0900 to 0945 hours each morning that Vincent Foster would attend. She assumed he was at the staff meeting as she didn't see him when she arrived at work. She first recalled seeing him outside in the Rose Garden. The President was nominating Judge Freeh at the ceremony as the new director of the FBI.

She doesn't recall Vincent Foster having any visitors on Tuesday. The first conversation she had with him was about lunch around 1200-1230 hours. He said he would eat at his desk. He ordered a medium rare cheeseburger, french fries and coke. She and Linda Tripp went to the cafeteria and ordered his lunch. She recalled there were M & M's on the tray with the food because Linda wanted them. He sat on his sofa and ate lunch in his office.

At around 1300 hours he came out of the office and stated "I'll be back, there are M & M's left in my office". Ms. Pond recalled that she and Linda were in the office when he left. She wasn't sure if Tom was in the office or not. Tom Castleton is a young college graduate working in the office. There was nothing unusual about his emotional state. In fact, over the last several weeks she did not notice any changes, either physically or emotionally. She noticed no weight lost. She was unaware of him taking any medication or seeing any doctors. I asked here would she be surprised if I found out he was seeing a psychiatrist. She said yes. She was not aware of any depression problems. She had no information whether he owned any weapons.

Ms. Pond said she left work at approximately 1845-1850 hours on Tuesday; but, before she left at around 1820 or so, Maggie Williams (Mrs. Clinton's Chief of Staff) called for Vincent. She paged Vincent and left the White House number for him to call. She recalled no other phone messages for Vincent.

She learned about Vincent's death from messages on her home answering machine around 0500-0600 hours on Wednesday, July 21. She came into work at 0700 hours and was the first person in. The door to Vincent's office was closed when she arrived at work. She believed that Tom Castleton or Bernard Nussbaum were the last persons out of the complex on Tuesday and one of them would have closed the door to Vincent's office. She went into his office and "squashed" the papers together that were on his desk. She realized that she shouldn't have touched the papers as soon as she did it but probably did it out of habit.

When I questioned her if she had been told how to respond to our questions, she stated that Clifford Sloan (who was present during our interview) and Steve Neuwirth, both associate counselors, had called them all together on Wednesday evening and told them they would be questioned by the police and for them to tell the truth.

Office Personnel Interviews

The following two people were interviewed at the West Wing of the White House by Detective Markland and Special Agent Salter on 7/22/93. The information provided by these two individuals was brief.

Tom Castleton (Staff Assistant) @ 1000 hours:

Mr. Castleton stated that he worked on 7/20/93 and remembers that Mr. Foster ate lunch at the office, although he could not place the time. Mr. Castleton was present when Mr. Foster left the office after eating lunch and said "So Long". Mr. Foster did not respond and seemed to Mr. Castleton to be "In his own world", focused, disturbed.

Linda Tripp (Executive Assistant) @ 1150 hours:

Ms. Tripp stated that she began her workday on 7/20/93 at 0800 hours. Mr. Foster's demeanor seemed normal to her, however, she had no personal dealings with him on that day.

Ms. Tripp makes it a habit to notice what the staff members are taking with them when they leave the office in order to determine for herself how long she may expect them to be away from the office. Ms. Tripp was absolutely certain that Mr. Foster did not carry anything in the way of a briefcase, bag, umbrella, etc... out of the office.

Castleton advised that he last saw Vincent Foster at approximately 1:00 pm on July 20, 1993. He said that Foster had asked Linda Tripp, another Special Assistant in the Counsel's office to pick up lunch for him and bring it to his office. He then sat at the coffee table in his office, ate his sandwich, then took his briefcase and his suit jacket and left the office saying "I'll be back later". Castleton said that it was his belief that Foster was going to a meeting or an appointment. He said that he assumed this because Foster usually did not take his suit jacket when he was going anywhere else within The White House. He also said that Foster seemed to be in good spirits when he left the office. Mr. Castleton said that primarily because of the lunch hour, he (Castleton) and Linda Tripp were the only two persons in the office at the time Foster departed.

Thomas Castleton stated that he knows of no problems of any sort that Vincent Foster had that would have caused him to take his life. He said that he cannot recall Foster mentioning any physical ailments or pain and the only thing physical he can recall was that he either heard Foster say or heard someone else in the office comment that he was losing weight.

Castleton was asked how he felt about Vincent Foster and responded that he "looked up to him" and that he felt that Foster was a "model lawyer". He explained that Foster was restrained, not impulsive, professional, careful, very bright and reflective, and a man who cared greatly for his family. Castleton said that he recalls meeting Foster's wife on one occasion when Foster brought her into the office and introduced her to the workers in the Nussbaum/Foster suite. He said that while he could "just tell" that Foster's family was important to him, he did not feel that he could offer a substantial opinion regarding Foster's relationship with his wife, having only met her one time.

Thomas Castleton said that he does not recall Foster ever discussing any hobbies or leisure time activities although he does recall that Foster took a "short vacation" about a week before his death.

Mr. Castleton was asked who most often visited Foster in his office. He responded that Webb Hubbell, Cliff Sloan, and Steve Neuwirth were seen in Foster's office on a fairly regular basis. He said that he saw Hillary Clinton in Foster's office approximately four times during the five weeks he was employed

John S. Skyles, Officer, Uniform Division, United States Secret Service (USSS) was interviewed in the Office of the Special Counsel, 1001 Pennsylvania Avenue, NW. Officer Skyles was advised as to the identity of the interviewing agent and of the nature of the interview. He then provided the following information:

His office is located at 1310 L Street NW and his telephone number is 202-395-2020. He has been employed by USSS for 19 years, the last 6 of which have been at The White House compound. He is normally assigned to USSS guard post "E-4" (west lobby) which is located at the first floor front entrance to the west wing of The White House. He was so employed on July 20, 1993, the day of Vincent Foster, Jr.'s death.

Officer Skyles stated that he first learned of Vincent Foster's death through a late evening television news broadcast on July 20, 1993. He stated that he had not known Vincent Foster either professionally or personally but that he knew Foster to be a White House staffer, knew his title, and easily recognized him when he saw him on The White House compound. He explained that he easily recognized Foster because he had seen him enter and exit The White House west wing on numerous occasions when he (Skyles) was on duty.

On July 20, 1993, Officer Skyles worked the 6:30 am through 3:00 pm shift at post E-4. He described this as a rather routine day about which he could recall noticing nothing out of the ordinary. He advised that numerous White House staffers came and went through post E-4 on July 20 but that he could recall few specifics about these individuals. He advised, however, when he learned of Vincent Foster's death late on the evening of July 20, he remembered that he had seen Foster leaving the west wing of The White House through entrance E-4 earlier that day. Skyles said that he was approximately two thirds of the way through his shift on July 20 when he saw Foster leaving The White House. He said that while he cannot recall exactly when he saw Foster, he does distinctly recall that it was "about lunchtime". He said

that as Foster walked pass the guard desk at entrance E-4 he (Skyles) asked Foster, "How are you doing sir"? He said that Foster replied, "Hello-fine" and nodded his head to Skyles with what Skyles remembers as a "half smile". Officer Skyles said that he remembers this encounter in detail because when he heard that Foster had died via suicide he distinctly recalled that Foster did not appear to be at all depressed or preoccupied as he walked by. He said that he was therefore quite surprised to hear that Foster had committed suicide. Officer Skyles said, to the best of his recollection, that Foster was wearing a gray suit when he saw him on July 20. He said that he could not recall if Foster was wearing his suit jacket or not and that he does not recall Foster carrying anything in his hands such as a briefcase. Officer Skyles stated that this was the last time that he saw Vincent Foster.

Officer Skyles said that he worked the 6:30 am to 3:00 pm shift on post E-4 on July 21, 1993. He said that this was a rather routine, ordinary shift except that he overheard parts of several conversations between White House staff members that day about Vincent Foster's death, their grief, and their disbelief that he could be dead. He said that he can not recall, however, any specifics as to who was engaged in these conversations or exactly what was being said.

decedent's pockets. ROLLA and BRAUN later retrieved the keys from the decedent's pockets at Fairfax Hospital. ROLLA removed the decedent's rings, pager, and watch from the body prior to the coroner's arrival. ROLLA noted that the decedent's pager was turned off, which to him indicated suicidal intent. ROLLA remarked that he does not think that he moved the body at all to check the decedent's back pockets.

ROLLA returned to the parking lot area where he observed the decedent's coat folded on the seat of the vehicle. Inside the fold was a White House identification. ROLLA stated that he also may have popped open the trunk to look inside. ROLLA recalls that there were books, cards, and letters inside the trunk. Additionally, ROLLA stated that there were items in the car that made it seem that the vehicle did not belong to the decedent. ROLLA stated that he did not observe any briefcase in the vehicle at all.

ROLLA was shown a photograph which was taken during a search of the decedent's vehicle at the U.S. Park Police impoundment lot on the following day. ROLLA looked at a picture taken of the glove compartment of the vehicle which contained a pot holder mit. ROLLA stated that he recalled the mit in the glove compartment. The mit was of such a size that the decedent's revolver could have fit into it. ROLLA looked at a photograph taken of the front seat of the vehicle in which a small post-it sticker was located. ROLLA stated that he did not recall seeing the note on the seat.

BRAUN returned the White House credentials to the U.S. Secret Service later in the evening. The pager remained with the decedent's personal property, which was subsequently returned to the decedent's family through an individual named CLIFF SLOAN. ROLLA stated that he photocopied everything that was contained in the wallet prior to releasing it. ROLLA recalled locating a money machine receipt for \$300 from several days prior, and a note with three doctors names on it.

ROLLA went to the decedent's residence with BRAUN, and a friend of the decedent's named DAVID WATKINS. WATKINS' wife followed in their car.

ROLLA had previously telephoned LIVINGSTONE and KENNEDY on BRAUN's car phone, per the request of Lieutenant GAVIN. These individuals had requested to see the decedent's body at the

SIMONELLO recalls giving his polaroid camera to Investigator ROLLA to use to make "back-up" photographs. SIMONELLO is not aware how many polaroid photographs Investigator ROLLA took nor could he recall whether or not he provided an additional film pack to Investigator ROLLA.

SIMONELLO recalls his first impression when he observed the death scene was that someone had to have moved the head. SIMONELLO did not move the body at any time nor did he observe anyone else move it. SIMONELLO's original impression was based on his seeing the blood transfer stain on the right cheek of the body.

SIMONELLO recalls the body was lying on what appeared to be a footpath and there was a lot of vegetation on both sides of the body. SIMONELLO does not recall there being noticeable trampling of the vegetation. At least no more than you would expect from two Emergency Medical Technicians (EMTs) being there examining the body. SIMONELLO could not recall seeing a wine cooler bottle anywhere near the death scene.

SIMONELLO has no recollection of the presence of anyone at the death scene that he did not know personally or otherwise there in an official capacity. SIMONELLO described "official capacity" as EMTs or the Medical Examiner.

After photographing the death scene, SIMONELLO returned to the parking lot area. SIMONELLO recalls he had a few frames of film left on the roll of film in his 35mm camera and that he used these remaining frames photographing the vehicle believed to be that of the decedent. SIMONELLO also recalls there was someone else taking photographs of the vehicle but he could not now recall who this was.

SIMONELLO has no knowledge of how entry was gained to the vehicle. SIMONELLO did not use a "slim jim" to open the vehicle door nor was he aware of anyone else using one. SIMONELLO was under the impression that the vehicle was unlocked.

SIMONELLO is uncertain as to his memory of observing a map and a birthday card in the vehicle at Fort Marsey Park. SIMONELLO explained he later observed all of the evidence in his office and it is possible he is confusing just what he saw where. SIMONELLO is certain there was no briefcase in the vehicle. SIMONELLO has no recollection of photographing any papers or an

compartment of the decedent's vehicle. SMITH stated that he does not specifically recall the mit, however, the photograph is one that he would have taken. SMITH stated that he did not seize the mit, as it is not listed on the vehicle inventory sheet. SMITH stated that he probably had no reason to take the mit, as it did not appear related to the suicide investigation.

SMITH had no recollection of a canvas bag in the vehicle. SMITH did not recall taking a picture of any canvas bag in the vehicle. SMITH was then shown a picture of a canvas bag in the back of the decedent's vehicle. SMITH stated that this is a photograph that he would have taken, however, he did not recall the bag. SMITH stated that he did not take this bag, as it is not noted on the inventory sheet. SMITH stated that he probably didn't take it because there was nothing inside of it.

SMITH stated that the pictures in U.S. Park Police cases are developed at their lab, the negatives stay there at the lab in case they need to make duplicates. The photos were sent directly back to him. SMITH reviewed the photographs and then would have put them into the mobile crime laboratory file for this case, which is noted to be 166-93. All latent fingerprints, pictures, and mobile crime laboratory reports are contained in this file. SMITH reviewed all of the photographs that he took in this case. SMITH stated that he hasn't seen them in a while. SMITH does not recall specifically what he did with these photos when they were provided to him after development, however, SMITH stated that he would have put them into the U.S. Park Police Mobile Crime Laboratory file, as was his custom.

SMITH processed the decedent's gun for latent fingerprints. SMITH stated that he used fingerprint powder to attempt to develop latents on the gun. No latents were developed. SMITH took polaroid and 35mm photographs of the gun. SMITH was shown all of the photographs of the gun, and identified the photos that he recalls specifically taking. SMITH was unable to identify some of the photos. SMITH stated that he is unsure of exactly how many photos he took, or of what exact parts of the gun he photographed. SMITH stated that some of the pictures may have been taken by SIMONELLO. SMITH stated that three black and white polaroid photographs were taken with the U.S. Park Police MP-4 camera.

SMITH stated that there was no leather briefcase inside of the decedent's car when he processed it and inventoried it on

7/21/93. Any personal property belonging to the decedent would have been taken out of the car.

After leaving the scene of the body, IACONE recalls he walked back to the parking lot where he observed a small grayish compact automobile parked facing into the park. IACONE observed a dark colored jacket on a hanger in the left rear area (behind the driver's seat) hanging on a hook. At the time IACONE looked into the vehicle there were no U. S. Park Police or other FCFRD EMTs present with the exception of TODD HALL. In an effort to determine if the suit coat in the vehicle matched the decedent's pants he had observed minutes earlier, IACONE attempted to open the left rear passenger door of the automobile. IACONE intended to check for identification in the suit jacket, however, he found the car door was locked. IACONE stated he is not certain "but he thinks TODD HALL attempted to open one of the doors" of the vehicle. IACONE, however it was also locked.

IACONE did not see a road map, a birthday card or wine cooler bottles inside the vehicle. IACONE did not see a briefcase inside the vehicle, nor does he recall any mention of anyone else seeing a briefcase in the vehicle. IACONE stated that when he looked inside the vehicle he saw what he believed to be numerous cassettes tapes in the center console area of the front of the vehicle. IACONE was physically present at the vehicle for approximately one minute.

In his earlier interview conducted on 4/27/94, IACONE reported seeing the decedent clad in a tie at the death scene. IACONE now states he is not sure whether the decedent was wearing a necktie when he (IACONE) saw the decedent on July 20, 1993 in Fort Marcy Park.

HALL noted that ARTHUR and GONZALEZ accompanied him on the medic unit.

Back in the parking lot, HALL heard JAY IACONE make a remark regarding the victim. IACONE said the victim must have been one of CLINTON's buddies from Arkansas. HALL noted that the aforementioned vehicle with the suit coat and briefcase bore Arkansas tags. By this point in time, the rest of the EMS personnel were gathered in the vicinity of the vehicle bearing the Arkansas license tags. It was noted that USPP officers were also on scene.

HALL remembers the dispatch regarding FOSTER being received at approximately 6:00 or 7:00 p.m. The weather that day was described as being hot.

HALL was not coached or given any instructions regarding how he should respond when contacted by investigators regarding FOSTER's death.

area. GONZALEZ indicated a dark circular apparent blood stain depicted in the area of FOSTER'S jaw line (photograph 85C11) as the "wound" he was referring to in this testimony.

GONZALEZ was shown polaroid photograph marked 85C15. GONZALEZ's recollection is that FOSTER's right hand was closer to his body than depicted in this photograph. GONZALEZ could only recall seeing the cylinder of the weapon and not the gun barrel. GONZALEZ has no recollection of seeing the trigger guard around FOSTER's right thumb. However, GONZALEZ states the remaining circumstances depicted in this photograph are as he recalls them from July 20, 1993.

When the FCFRD crew left the death scene and returned to the parking lot, GONZALEZ instructed his crew members to check the doors of the vehicle that appeared to belong to the victim. GONZALEZ recalls his primary concern and interest was the clothing inside this vehicle. GONZALEZ wanted to see if the suit coat he observed in this vehicle matched the trousers worn by the victim. GONZALEZ did not actually observe any of the crew members attempt to open the doors of this vehicle.

GONZALEZ has a vague recollection of observing a necktie hanging from the rear view mirror inside the vehicle.

GONZALEZ recalls seeing something which he initially thought to be a briefcase/attache case in this vehicle. GONZALEZ was shown the canvas tote bag which was recovered from FOSTER's vehicle by the USPP. GONZALEZ acknowledged that this bag might have been what he saw in the vehicle and originally thought was a briefcase/attache case.

individual, but also believed he was "big and burly" and could have been wearing bluejeans.

Ms. Doody advised that while with Mr. Feist in the wooded area South of the Fort Marcy parking area, she failed to observe any other individuals or activities and denied hearing any sounds or noises which could be construed as a gunshot. She did state, however, hearing emergency vehicles which were apparently entering the parking lot of Fort Marcy, but neither she nor Mr. Feist paid any attention to these vehicles. Furthermore, she advised that she was unaware of any activity in either the parking area or the Northern section of the park, until both she and Mr. Feist were located by a uniformed U.S. Park Police officer who directed them to the Fort Marcy Park parking area, where they were subsequently interviewed by U.S. Park Police officials.

In an effort to sharpen her memory of her observations on July 20, 1993, the interviewing agents related to Ms. Doody the observations she provided to U.S. Park Police officials on July 20th. In recalling this particular interview, Ms. Doody stated that she is positive that her initial comments that a vehicle that she observed as a light-colored older model pulling in next to the Honda was untrue. She maintained that the only vehicle she recalls that was positioned between her vehicle and the Honda previously described was the white van or truck which arrived shortly after she parked her vehicle.

Mrs. Doody further advised that the vehicle she was driving on July 20, 1993 was a 1992 4-door white Nissan Stanza with Maryland license plates and this vehicle had a light blue interior. Furthermore, she advised that the only distinguishing external characteristic of this vehicle was the presence on the right rear bumper of a Maryland State Police sticker, yellow in color, with the notation "BAD Against Drugs."

In regards to the contents of the vehicle, it was Ms. Doody's opinion that on either the front floor or the back seat floor was a can of beer and either 1 or 2 bottles of wine coolers. Ms. Doody stated that she believes the bottles of wine coolers were separate and not contained in either a 4- or 6-pack container.

the investigation of FOSTER's death. CANAVIT believes he spoke to USPP Lieutenant GAVIN when he called USPP. CANAVIT did not know GAVIN from before, and he is not certain that GAVIN is the name of the USPP official with whom he spoke. GAVIN advised that FOSTER'S death was being investigated as a suspected suicide. CANAVIT asked if the USPP had recovered a White House pass or any papers which might be of interest to the protective intelligence squad. In particular, CANAVIT wanted to know if any sensitive documents, such as a copy of the president's schedule, had been found with FOSTER. CANAVIT's concern was that any such documents could contribute to a breach of the security measures used to protect the First Family. CANAVIT was advised by USPP that no such documents had been found with FOSTER.

CANAVIT later learned that FOSTER's White House pass had been turned over to USSS officials during the shift which followed the shift on which CANAVIT worked. From speaking later with USSS agents assigned to work that later shift, CANAVIT learned that these agents had received FOSTER's White House pass and had spoken to GAVIN from USPP. CANAVIT believes that FOSTER's key to a secure telephone may have been on the chain with FOSTER's White House pass and may have also been returned to USSS at the same time. Based on the naming of GAVIN by the other USSS agents as their point of contact at USSS, CANAVIT believes that GAVIN is also the name of the USPP official with whom he spoke.

CANAVIT did not assign or send anyone to go over to Fort Marcy Park, where FOSTER's body had been found.

CANAVIT does not recall what time he received the call from MARBLE.

(At this point in the interview, the interviewing agent advised CANAVIT that MARBLE's report reflected that CANAVIT was notified at 9:56 p.m.) CANAVIT stated that the time noted by MARBLE sounded correct.

All of the USSS officials reflected on MARBLE's memo as having been notified of FOSTER's death were USSS headquarters personnel. CANAVIT probably telephoned and advised WALT SHEPPARD of FOSTER's death. SHEPPARD was the Assistant to the Special Agent in Charge of the USSS Washington Field Office. It was close to shift change when CANAVIT reached SHEPPARD, and CANAVIT

There were two telephones in FOSTER's office and, GORHAM believes, the main telephone number for FOSTER was (202) 456-6611. GORHAM does not recall how many telephone lines were connected to FOSTER's telephones. Neither GORHAM nor FOSTER used electronic mail (e-mail) because it was not available on GORHAM's computer, which was not on a network. GORHAM does not recall if e-mail was available on the computers of BETSY POND, LINDA TRIPP, or TOM CASTLETON.

GORHAM only saw FOSTER using one briefcase and she never saw him with any other briefcase. FOSTER's briefcase was dark navy blue and had two leather handles which opened, giving access to the storage compartment.

GORHAM used both computer calendars and handwritten calendars to keep track of FOSTER's schedule. The computer calendar displayed an entire month at one time on the screen. In addition, FOSTER maintained his own calendar book, which had a navy blue leather cover and was approximately six inches by seven inches in size. GORHAM maintained a standard government-issue spiral notebook calendar for FOSTER.

GORHAM is only aware of FOSTER having one pager. On Friday, July 16, 1993, FOSTER needed a Skypager because he was going away for the weekend. GORHAM was actually the person who believed FOSTER needed the Skypager because she was not certain FOSTER's normal pager would operate outside the WDC metropolitan area. FOSTER became rather agitated when GORHAM was unable to quickly obtain a Skypager for his use, but FOSTER eventually obtained a Skypager that Friday prior to his departure.

GORHAM is not aware of either FOSTER or NUSSBAUM having a mobile telephone.

FOSTER had a burn bag and a trash can for normal trash in his office. GORHAM does not recall observing any other receptacles in FOSTER's office. She believes FOSTER did use his burn bag. Burn bags were typically collected from the offices either in late afternoon or overnight. The burn bags were collected by officers from an agency, but GORHAM does not recall which agency had jurisdiction over the burn bags. GORHAM does not recall if the burn bag in FOSTER's office was collected on the afternoon of July 20, 1993. going away every weekend until he started feeling better.

The following day (the day of his death), FOSTER didn't jog. He told LISA that it took too long to cool off afterwards.

LISA FOSTER did not think that FOSTER was aware of WEBB HUBBELL'S problems. LISA stated that FOSTER may not have committed suicide if he knew that HUBBELL may have needed him. Also, LISA did not think that FOSTER would have accepted his position at the White House if he knew of HUBBELL'S problems. FOSTER would have wanted to stay at the ROSE LAW FIRM to do what he could for HUBBELL.

The night before his death, FOSTER came home from work a little earlier than usual. However, he received a telephone call from the President. LISA recalled seeing a "smirk" on FOSTER'S face as he spoke with the President. Afterward, FOSTER told LISA that the President had wanted him to return to the White House to watch a movie with him and HUBBELL. FOSTER put his arm around LISA and told her that he told the President no. FOSTER did not say what the movie was, or who else was there besides HUBBELL. It was not uncommon for the President to invite friends to see movies at the White House; usually 10 to 12 people would be present for a show, which usually took place on Saturday evenings.

LISA FOSTER wanted FOSTER to be more "normal"; to take more time for himself and his family.

LISA FOSTER had no knowledge of any appointment that FOSTER had with the President for the day following his death.

On the day of VINCENT FOSTER'S death, he did not kiss LISA goodbye when he left for work. LISA recalled FOSTER standing very stiffly with his briefcase just prior to leaving. FOSTER didn't turn around to say goodbye, he simply walked out. LISA considered this somewhat odd, but given his behavior during the past month, LISA simply dismissed it to FOSTER being uptight about work.

LISA FOSTER was shown a dark brown leather briefcase, which was obtained from VINCENT FOSTER'S office. LISA identified the briefcase as the same one that FOSTER had when he left their residence on the day of his death.

VINCENT FOSTER, III recalled his father bringing the family together to brief them on some of the problems that he was having at work, and how the next few months might be difficult for him and the family. His father had told them that some of the things that might happen could be very unpleasant for the family.

VINCE FOSTER, III could not recall his father ever mentioning Whitewater, Madison Guaranty Savings and Loan, or Capital Management Services. Additionally, he could not recall his father ever being concerned about the family's telephones being tapped. He did recall his father talking with him at one point regarding purchasing a sail boat. VINCENT FOSTER, III knew that this was just "wishful thinking," and that his father did not have any actual plans to purchase the boat.

VINCENT FOSTER, III's mother spoke to him about helping her cheer his father up. His mother was concerned about the pressure VINCENT FOSTER, JR. was under at work and how it was affecting him. As a result, VINCENT FOSTER, III stated that he may have called his father during the afternoon of Tuesday, July 20th, to see if he wanted to go to an Orioles game with him.

The evening of his father's death, at the FOSTER residence, VINCENT FOSTER, III recalled seeing the President, WEBB HUBBELL, MACK MCLARTY, and possibly DAVID WATKINS.

VINCE FOSTER, III did not specifically recall driving the family's Honda sedan on Sunday, but stated that he may have. The beer cans and other items in the vehicle were probably his. He stated that he kept the car at college, as well as used it the weekend prior to his father's death.

VINCE FOSTER, III was subsequently shown a green oven mitt that was obtained from the glove compartment of the Honda sedan subsequent to his father's death. VINCE FOSTER, III identified the oven mitt as belonging to his mother. He had no specific information regarding the mitt or how it ended up in the glove compartment in the car. He stated that he, as well as his brother, eat sunflower seeds.

VINCENT FOSTER, JR. had an old "beat-up" leather briefcase. He carried the briefcase to work with him every morning. VINCENT FOSTER, III did not know of any other briefcases that his father kept.

ROGER LEE PERRY, Arkansas State Trooper, was advised of the identity of the interviewing agent and the purpose for the interview. PERRY provided the following information:

PERRY was working at the Arkansas Governor's Mansion during the time of VINCENT FOSTER'S death. PERRY received a telephone call from Helen Dickey at the White House sometime between 4 p.m. and 7:30 p.m. Central Standard Time. Dickey told PERRY that VINCE FOSTER had left work, went out to his car in the parking lot, and shot himself in the head. PERRY was unsure of DICKEY'S exact words, but he had the impression that FOSTER had committed suicide in his car parked at the White House. PERRY wrote the message down at the time of the call, but no longer has the written memo. PERRY relayed DICKEY'S message to Governor TUCKER, who called the White House for more details. TUCKER found out that DICKEY had bad information; FOSTER actually committed suicide at FT. MARCY PARK. PERRY did not know who TUCKER spoke to at the White House.

PERRY stated that DICKEY was hysterical when she called, and that he was not surprised that she had incorrect information. PERRY did not know how DICKEY learned of FOSTER'S death.

ROGER LEE PERRY, Corporal, Arkansas State Police, white male, home address [REDACTED] home telephone [REDACTED] was interviewed at the Arkansas State Police Troop "A" Headquarters, 3701 West Roosevelt Road, telephone 501-296-1860. After being advised of the official identities of the interviewers and the nature of the interview, furnished the following information:

He has been employed by the Arkansas State Police for the past twenty (20) years. On July 20, 1993, he was assigned to the Governor's Security Detail at the governor's mansion. On that day, he worked a 6:30 AM to 10:30 PM shift. There are two troopers on duty each regular shift. On July 20, 1993, his specific assignment was to be the driver for Governor JIM GUY TUCKER. He recalls Governor TUCKER was not feeling well that day and they left the capitol to return to the mansion at about 3:30 PM.

If the governor plans to stay in the mansion all evening, it was the usual practice for one of the assigned troopers to go home early. Since the governor was not feeling well and had told PERRY he (TUCKER) was remaining at home all evening, when PERRY returned to the guard shack at the front gate of the mansion, he told the other trooper he could leave early. He estimated his arrival at the guard shack to have been about 4:30 PM and after the departure of the other trooper, he continued his shift alone.

He explained all incoming telephone calls to the governor's mansion are answered at the guard shack and then transferred to the proper person. Most outgoing telephone calls are also made through the guard shack, however, the mansion telephones have the capability of bypassing the guard shack if the person making the call so desires. In the past meticulous logs were maintained of all telephone calls going through the guard shack switchboard. A log was also maintained on all visitors to the mansion listing the name of the visitor as well as arrival and departure times. These logs were discontinued

during the time BILL CLINTON was governor.

He recalls after the departure of the other guard at approximately 4:30 PM and sometime before approximately 7:30 PM, he received a telephone call at the guard shack from HELEN DICKEY. He has known HELEN DICKEY for many years as she was the baby sitter for the CLINTON's when they occupied the governor's mansion. DICKEY did not want to talk to anyone in particular but apparently just wanted to let the governor and/or the staff know that VINCE FOSTER had just shot himself. DICKEY sounded very upset. Her conversation was very disjointed and it was hard to understand just what she was saying. During the call, he made notes of what she was saying so he could pass the message on correctly, however his original notes have since been thrown away. From what DICKEY told him, it was his understanding that VINCE FOSTER had left his office after work and shot himself while seated in his car in the White House parking lot.

Their conversation only lasted a few minutes and immediately after he hung up the telephone, he called into the mansion. His call was answered by BETTY TUCKER, who after hearing the message, repeated it to JIM GUY TUCKER. He heard BETTY TUCKER repeat the message to JIM GUY TUCKER. BETTY TUCKER told him he (JIM GUY TUCKER) would call the White House and get the details.

He recalled that someone inside the mansion made a series of telephone calls that did not go through the guard shack switchboard. These telephone calls were over a period of approximately two (2) hours.

After he hung up the telephone after telling the TUCKERS about VINCE FOSTER, he telephoned LARRY PATTERSON, another trooper who had been assigned to the security detail, LYNN DAVIS, his attorney and ROBIN PERRY, his present wife but at that time his girlfriend. All of these calls were local calls.

He recalled the telephone numbers into the governor's mansion as being 501-376-6884, 501-376-6885, 501-371-1480 plus one or two other lines with a 374 prefix.

After his relief came on duty just before 10:30 PM, he stayed around for a few minutes to brief his relief about what had gone on during his shift and to tell him about the telephone call he had received from HELEN DICKEY.

During the time he was briefing his relief, he received a telephone call on the intercom system from JIM GUY TUCKER who told him the information he had previously received from HELEN DICKEY was incorrect and that VINCE FOSTER had actually shot himself in Fort Marcy Park. TUCKER did not tell him who at the White House he had spoken with.

When the sequence of events around the time of the telephone call from HELEN DICKEY were discussed, starting at about 10:30 PM and working backwards, taking into consideration the time span of the telephone calls made from inside the governor's mansion, PERRY conceded he could possibly be mistaken about the time the call from DICKEY was received. The call could have been as late as 8:30 PM, Arkansas time. However, he still felt his best recollection was that the call was received sometime between 4:30 PM and 7:30 PM.

He has been employed by the Arkansas State Police for approximately twenty (20) years. Prior to he current assignment, he was assigned to the Governor's Security Detail at the governor's mansion from 1987 through 1993. During this assignment he worked with Trooper ROGER PERRY.

On the evening of July 20, 1993, he received a telephone call from PERRY advising him that PERRY had just received a telephone call at the governor's mansion from HELEN DICKEY who told him (PERRY) that VINCE FOSTER had just gotten off work, walked out to the parking lot and blew his brains out.

He placed the time of this telephone call at approximately 6:00 PM. He arrived at the time by explaining that he works a 7:30 AM to 4:30 PM shift and that he had been home only a short period of time when PERRY called him.

He wears a trooper uniform during his work shift and drives a state police vehicle home each day. He does not stop off for drinks, dinner or out of the way shopping enroute home. He occasionally will stop at the grocery store or the dry cleaners enroute home. He did not recall watching television, reading or eating dinner prior to PERRY's telephone call. If he stopped at the grocery store or dry cleaners, he would have written a check for his purchase. He agreed to search his check register for July 20, 1993 to see if there would have been any reason he would have arrived home later than his normal arrival time.

While working on the governor's security detail, he occasionally was assigned to the guard shack at the front

HELEN DICKEY was advised of the identities of the interviewing Agents and the nature of the interview. DICKEY provided the following information:

DICKEY is absolutely certain that she did not learn of the death of VINCENT FOSTER until close to 10:00 p.m. eastern time on 7/20/93. She is confident of the approximate time she was notified because at the time she was watching President CLINTON being interviewed on the LARRY KING LIVE show. She was watching the show on a television located in the solarium on the third floor of the White House. She knows the show was almost over because KING asked the President if he could continue for an additional thirty minutes and the President responded that he could stay. Following a break in the show, KING came back on and stated the President was not going to be able to continue the interview.

DICKEY was asked if the LARRY KING Show is one-half hour or an hour in length. She stated the show lasted for one hour and the hour was almost up when she learned of FOSTER's death. It is even possible that the show had just ended. She was asked how CLINTON could remain for an additional thirty minutes if the hour show was completed. She responded that she does not know. She speculated that possibly the interview was going to continue as part of CNN coverage.

Shortly after LARRY KING said the President could not continue the interview, JOHN FANNING, who is a White House Doorman, entered the solarium. FANNING told DICKEY that VINCE FOSTER's body had been found (dead) and he did not want her to hear about it on the news. DICKEY told FANNING "that's not funny," to which FANNING responded he was not kidding. DICKEY does not recall asking FANNING how FOSTER was killed. However, she said FANNING must have told her it was a suicide because she told her mother and father (whom she called shortly thereafter) that FOSTER had killed himself. FANNING did not tell DICKEY how he became aware of FOSTER's death. DICKEY can not recall whether FANNING said FOSTER's body was found in a park.

HELEN HALTON DICKY was interviewed in a conference room in the offices of the Office of the Independent Counsel (OIC), 1001 Pennsylvania Avenue, N.W., Suite 490 North, Washington, D.C. After being advised of the official identities of the interviewing agents and the nature of the interview, DICKY provided the following information:

DICKY lived on Stonewall Road in Little Rock, Arkansas next door to the family of VINCENT W. FOSTER, Jr. when she was a youngster. Through her mother, ROBYN DICKY, HELEN DICKY has known President BILL CLINTON and First Lady HILLARY RODHAM CLINTON for approximately fifteen years. ROBYN DICKY managed the governor's mansion in Little Rock when Mr. CLINTON was governor there. ROBYN DICKY is currently Deputy Social Secretary at the White House, where her telephone number is (202) 456-7462.

In 1991, the CLINTONs asked DICKY to provide child care for their daughter CHELSEA during Mr. CLINTON's campaign for the Democratic nomination for president. DICKY agreed to serve as a child care provider although it required her to miss her final semester at the University of Arkansas. DICKY later completed her course work through correspondence school and received her degree from the University of Arkansas.

Once President CLINTON took office on January 20, 1993, DICKY moved into the White House, where she continues to live in the residence portion with the CLINTON family. DICKY continues to serve as a governess for CHELSEA CLINTON although there has been less need for DICKY's services as CHELSEA CLINTON has grown older. DICKY intends to move out of the White House soon, but she will continue to provide child care to CHELSEA CLINTON.

DICKY had limited contact with Deputy White House Counsel VINCENT FOSTER during the weeks prior to his death because their positions did not cause them to have contact. DICKY saw FOSTER on the morning of July 20, 1993 on the colonnade at the White House and they exchanged greetings.

BOXER and her friend were somewhere on the third floor making BOXER's wedding plans. BOXER was the fiancée (now wife) of TONY RODHAM.

Upon hearing this from FANNING, DICKEY was extremely distraught. She went down to the second floor kitchen looking for President CLINTON. She explained that CLINTON was somewhere in the White House because the LARRY KING interview had been conducted on the ground floor. She recalls that the only person in the kitchen was a Butler named RICARDO (last name unknown). RICARDO was also known as SAM. RICARDO had not yet heard about FOSTER's death. She finally located someone who told her that CLINTON was with MACK MCLARTY who was informing him about FOSTER's death.

When DICKEY returned to the second floor kitchen she found President CLINTON, GEORGE STEPHANOPOULOS, MARK GEARIN, and a fourth person whose identity she cannot recall. CLINTON told DICKEY that FOSTER had shot himself in a park and instructed her to go to the FOSTER residence.

DICKEY then went back to the third floor and used a hallway phone to make three calls. As previously stated, it is possible but not likely that she made these calls before talking to CLINTON. She estimates that these calls were made 15-20 minutes after she called her mother and father. The calls were placed to ANNE STOCK (DICKEY's boss) and ANN MCCOY at their homes in Virginia and to the Arkansas Governor's mansion. STOCK was

the White House Social Secretary and MCCOY was the Deputy Social Secretary. The last call she made was to the Governor's mansion in Little Rock. She went through the White House operator to place these calls because she did not remember the telephone numbers of STOCK and MCCOY. She does not know why she went through the operator to call the Governor's mansion.

-DICKY's calls to STOCK and MCCOY were short and she basically told them about FOSTER's death. She called the Arkansas Governor's mansion because she wanted JIM GUY TUCKER and the Governor's Security personnel to know about FOSTER. She was well acquainted with the Governor's Security Squad members since she had been around the Governor's office for many years.

DICKY estimates she placed her call to the Governor's mansion at approximately 10:30 p.m. eastern time on 7/20/93. She is certain the call was not made before 10:20 p.m. eastern time and is reasonably sure it was not made after 10:40 p.m. eastern time. She is certain the call to the Governor's mansion was the last of the three calls she made from the third floor hallway telephone.

Her call to the Governor's mansion was answered in the Guard's shack by ROGER PERRY. Their conversation was very brief, she estimates two minutes in length. She told PERRY that she just wanted them to know that VINCE FOSTER had shot himself in a park. These may not be her exact words but she is certain she said that FOSTER shot himself and she is certain she said it occurred in a park. She definitely did not say he was killed in a parking lot. She was still upset at the time she talked to PERRY; however, she had settled down somewhat by this point and was not hysterical.

DICKY was asked to identify guests staying at the White House in the days immediately following FOSTER's death. On July 21, 1993, HELEN and JOHN SLOAN stayed on the third floor of the White House. She explained that the SLOANS were close friends of the FOSTER family. BILL and SUSAN WOODYARD and JERRY and STEPHANIE ATCHLEY were also present in the White House on July 21, 1993. DICKY believes that one of these couples also spent the night. The WOODYARDS and the ATCHLEYS are both friends of the FOSTER family and both are from Little Rock. DICKY cannot recall who stayed in the White House in the days following July 21, 1993.

On 5/21/96, JOHN EDWARD FANNING, White House Doorman, work telephone (202) 456-2650, date of birth [redacted] Social Security Account Number [redacted] home [redacted] home telephone [redacted]

was interviewed by Criminal Investigator (CI) COY A. COPELAND, Office of the Independent Counsel (OIC) and Special Agent JAMES T. CLEMENTE, Federal Bureau of Investigation. After having been advised of the official identities of the interviewers and the nature of the interview, FANNING provided, in part and in substance, the following information:

On 7/20/93, FANNING worked a 1:30 pm through 10:30 pm shift. However, since it is his responsibility as Doorman to remain on duty at the White House until the President retires for the night, FANNING worked over-time until approximately 12:00 midnight on that night.

Just after President BILL CLINTON ended his interview on "LARRY KING LIVE," FANNING took CLINTON up in the elevator from the ground floor library to the second floor of the White House residence. Shortly thereafter, FANNING rode the elevator to the ground floor to answer an elevator call from MACK McLARTY. It was at this time that FANNING learned of the death of VINCENT W. FOSTER, JR., from MACK McLARTY. FANNING noticed that McLARTY was not as sociable as he usually was, so FANNING asked McLARTY what was wrong. FANNING recalls McLARTY responded in substance, "JOHN I have some bad news, a friend of the President's has just committed suicide. And I need to inform him he's dead. You have to make sure no one goes to the second floor to disturb him until I tell him." FANNING thought he heard McLARTY say it was VINCE NEIL who killed himself.

After leaving McLARTY on the second floor, FANNING proceeded to the third floor of the residence to find HELEN DICKEY who was in the solarium watching the "LARRY KING LIVE" show on television. FANNING had planned to enlist DICKEY'S support in keeping people from disturbing the President on the second floor while McLARTY informed him of the death.

FANNING recalls telling DICKEY, "MACK said a close friend of the President committed suicide. VINCE NEIL or something." DICKEY responded, "You mean VINCE FOSTER?" FANNING replied, "Yes, that's it." FANNING estimates the time he informed DICKEY was between 10:00 pm and 10:05 pm. FANNING recalls they were still discussing this when the "CNN" or "FOX 5" 10:00 pm news began reporting that FOSTER, an aide of President Clinton, had been found dead. FANNING estimates the time he and DICKEY saw this on the news was between 10:00 pm and 10:10 pm.

FANNING firmly believes he was the first to inform DICKEY of the news of FOSTER'S death because of her extreme reaction to the news. FANNING recalls DICKEY becoming hysterical when she realized that it was VINCENT FOSTER, JR., who was dead. The news hit DICKEY like a brick. She jumped up from her seat and began running around crying and screaming. DICKEY then ran down the stairs to the second floor, which was exactly what McLARTY told FANNING to prevent.

FANNING was upset that he had unwittingly broken the news of FOSTER'S death to DICKEY without knowing she was a close friend of FOSTER'S. FANNING had not anticipated DICKEY'S extreme reaction. FANNING then located NICOLE BOXER RODHAM and her friend whose name FANNING does not recall, and asked them to help calm DICKEY down. These two women held DICKEY and succeeded in calming her.

Later at approximately 10:20 pm to 10:25 pm, DICKEY came down to the Ushers' Office to make at least one telephone call to a family member. FANNING believes the call was made to DICKEY'S mother because Mrs. ROBYN DICKEY arrived at the White House shortly thereafter and continued to calm HELEN DICKEY. At approximately 10:50 pm to 10:55 pm, the DICKEY'S both left the White House on their way to the FOSTER residence.

FANNING does not know when or if DICKEY called the Arkansas Governor's Mansion on the night of 7/20/93.

At approximately 10:30 pm, FANNING picked up CLINTON and McLARTY on the second floor of the residence and took them down in the elevator to the ground floor. FANNING believes CLINTON was on his way to announced FOSTER'S death to the West Wing White House Staff in the Map Room at that time. FANNING further believes DICKEY was on the third floor of the residence at the time.

FANNING did not know FOSTER personally, however, he may have met FOSTER occasionally while transporting him on the elevator.
