DURING THE ADMINISTRATION OF
JOHN ADAMS, 1797-1801

On the 3 rolls of this microfilm publication are reproduced the unbound records of the Department of State consisting of letters of application and recommendation for Federal office during the administration of John Adams, 1797-1801. There are, however, some letters that relate to other subjects, and a few that concern requests for dismissal of Federal employees.

Most of the letters were addressed to the President or the Secretary of State, but some were addressed to Members of Congress, Cabinet officers other than the Secretary of State, State and local officials, and private citizens prominent in public affairs who referred them to the State Department. Many letters refer to appointments outside the jurisdiction of the Department of State, particularly to positions in the Departments of the Treasury and War.

There are letters from many well-known men of the Revolutionary and early Federal periods, including Alexander Hamilton, George Washington, Thomas Jefferson, and James Madison. Among the letters is one dated April 11, 1798, from General Washington to Mr. Hugh West, in which he expressed his view on recommending people for public office, as follows: "When I left the chair of government, I resolved not to intermeddle in any appointment From this determination I have not departed." Another letter of special interest is one dated December 25, 1797, from Judge Francis W. Dana of the Massachusetts Supreme Court to Abigail Adams. In recommending John Hobby for a Federal position, Dana referred to his own reasons for declining an offer from the President to serve on the special commission to France that eventually consisted of Elbridge Gerry, John Marshall, and Charles C. Pinckney.

The letters reproduced in this microfilm publication reflect the contemporary popular concept of the necessary qualifications for office. Among these are background and experience, military service during the Revolutionary War, incumbency in office, economic need, and political orientation.

The records are part of the series of Application and Recommendations for Office, 1797-1901, which was maintained by the Department of State. They are arranged for the most part by Presidential administration and thereunder alphabetically by the surname of the applicant or the person recommended. Enclosures are filmed after the letter with which they were enclosed.

During the Presidency of John Adams no separate organizational units existed within the Department of State as the staff was small. In 1834, however, the Home Bureau of the Department was established and it received custody of the Letters of Application and Recommendation. These records were successively in the custody of the Clerk of Appointments and Commissions, 1846-70; the Bureau of Pardons and Commissions, 1870-95; the Appointment Clerk, 1895-98; the Bureau of Appointments, 1898-1924; and the Appointment Section in the Chief Clerk's Office, 1924-39. On January 11, 1939, they were transferred to the National Archives.

The records reproduced in this microcopy are among the Appointment Records that are part of a body of records in the National Archives designated as Record Group 59, General Records of the Department of State.

In the same record group in the National Archives are additional records relating to appointments to Federal office, 1789-1956. Among them are Senate Confirmations and Rejections of Presidential Nominations, 1797-1932, Oaths of Office, 1799-1932, and copies of commissions issued to departmental and Foreign Service personnel and other Federal officials, 1789-1910.

Other record groups that contain documents relating to appointments are Record Group 130, Records of the White House Office; Record Group 107, Records of the Office of the Secretary of War; Record Group 94, Records of The Adjutant General's Office; Record Group 48, Records of the Office of the Secretary of the Interior; Record Group 40, General Records of the Department of Commerce; and Record Group 28, Records of the Post Office Department. Among the appointment records in Record Group 60, General Records of the Department of Justice, are Records Relating to the Appointment of Federal Judges, Attorneys, and Marshals for the Territories and States of Oregon, 1853-1903 (Microcopy 224), and Washington, 1853-1902 (Microcopy 198).

Of interest to users of this microfilm publication may be an article by Gaillard Hunt, "Office-Seeking During the Administration of John Adams," in the American Historical Review, 2:241-261 (Jan. 1897).

The Letters of Application and Recommendation for the Washington administration are in the Manuscript Division of the Library of Congress where they were deposited by the State Department in 1909. They are described in Gaillard Hunt, Calendar of Applications and Recommendations for Office During the Presidency of George Washington (Washington, 1901).

LIST OF APPLICANTS OR PERSONS RECOMMENDED

Each entry gives the name of the applicant, appropriate cross-references to other applicants, the date span of documents and their enclosures, and the number of documents that contain a reference to the applicant or applicants. The term "document" as used in this microcopy may be either an individual letter with no enclosures or a letter of transmittal with its enclosures.
