# The Dissolution of James Earl Ray

Something seems to be moving in the long-stagnated Martin Luther King murder case, though it's still hard to tell what is happening exactly, or why, or what it may come to.

The killer of record, recall, is James Earl Ray, who has spent four out of the last five years and the last 14 months solid in solitary confinement at the Tennessee state pen in Nashville. He lives in a six-by-five foot concrete room with a concrete slab door and a slot for food with no exercise or sun and only the legal minimum of contact with the outer world.

Ray was apprehended in a London airport under circumstances strongly suggesting a set up. First he denied his guilt. Then he confessed to having done it. He was convicted as a lone assassin and sentenced to 99 years. In prison he reversed himself and began claiming strenuously that he had been maneuvered and

used by a larger conspiracy.

His story seems no doubt all too familiar. It is the kind of piteous tale desperate felons invent as they disappear into the pit. But that doesn't make it necessarily untrue, since suckerdom is still everything it used to be and more, a permanent human fate. There is evidence that Oswald and Sirhan were suckers. Why not Ray too?

Ray says his downfall began in 1967 when he was for some reason allowed to escape the Missouri state prison where he was then serving time. He made way to Montreal and found and entered the city's community of smalltime runaway American hoods like himself. He was soon contacted by a Cuban who called himself Raoul with a proposition involving steady work and easy money.

Operating always with finely detailed instructions, Raoul sent Ray on several missions, to

Mexico, mainly he says involving dope. After a few of these relatively innocuous runs, possibly when the fox was satisfied of the rabbits obedience! Raoul gave Ray the specific instructions — to buy a certain rifle, to arrive in Memphis on a certain day by a certain route, to check in at a certain rooming house at a certain hour, to be waiting in a white Mustang at a certain time and place — which Ray now says he followed step by step into the trap being set for him by the real killers of King.

Ray's first lawyer, Arthur Hanes, a former mayor of Birmingham and before that an agent of the CIA, left the case four days before Ray's court appearance. It was his public view that Ray was duped into the King assassination either by the CIA or by agents of Red Cuba or Red China, motives attributable to a putative King

assassin covering so wide an ideological span.

After Hanes came Percy Foreman, who had made something of a reputation for himself fighting the civil rights movement through the southern courts. Ray says he afterwards gave Foreman leads that would have established the truth of his conspiracy theory. Foreman says he turned these leads over to another Ray lawyer, Z.T. Osborne, who first was disbarred and then died and got no known results.

After Foreman came Washington attorney Bernard Fensterwald, whom this column tirelessly reminds is the founder of the Committee to Investigate Assassinations as well as counsel to Watergatesman James McCord, this last being a detail of special meaning for me because I propounded the theory that McCord was a secret agent among the Hunt-Liddy Plumbers, and that his purpose

was to break their game up, and Nixon's, by exposing it precisely as he did.

In any event, followers of the Ray case were alarmed by the news breaking over the holidays that Ray is to be moved to the Federal Hospital Prison in Springfield, Mo., an establishment long infamous in legend as a lobotomart, a kind of souped-up, high technology Devil's Island US-style where the sort of things that happened to whatshisname in *Clockwork Orange* happen to real-life whatshisnames like maybe James Earl Ray.

Ray's legal moves to keep out of Springfield (handled by Nashville lawyers) had been rebuffed the day before by the Cincinnati federal court which Fensterwald is trying to get to lift Ray's original confession and let the case go to trial on the basis of an innocent plea and a conspiracy-theory defense.

Fensterwald's position is that Tennessee officials want Ray off their hands because as long as he keeps trying to tell the true story of the King killing he has to be kept isolated. He wonders if they are not at the same time trying to break him. Tennessee prison officials justify their treatment of Ray on the grounds (a) that he's an escape artist and (b) that his security could not be guaranteed if he were exposed to the prison population. The escape thing just doesn't wash, but there might be something to the security angle: Ray might be just as inviting a target to those who loved King as to those who actually did the killing. But neither of these excuses explains why the prison wants to make Ray as miserable as possible. Fensterwald's explanation on the other hand covers the angles and has the feel of a likely truth: "They want to get him in a condition where he can't defend himself if his case ever does come to trial."

Did that not imply, I asked, that the conspiracy to cover up the truth about King extended into the Tennessee prison system? "The people responsible for the murder of King are still alive and free someplace," he answered, "and I assume that if they can arrange a murder like that, they can arrange other things, and you can make of that what you will."

Then what did Fensterwald intend to do? "If I have something to do with it," he promised, "and I do, Ray will never go to Springfield."

We'll have to see about that. Ray is a prisoner of the state of Tennessee and cannot legally be turned over to the federal prison system without a special act by the Tennessee legislature, and as Justice Department spokesman Jed Swift told me over the phone last Thursday, that may take a month or two. "It won't happen next week." Fensterwald would not discuss his plans, if any exist, for keeping it from happening next month.

If it does happen, one fears not only for Ray, whose lot is hardly a happy one even at Tennessee, but also for the knowledge of the truth of King's death that he might so easily take with him if the surgeons and the electronics specialists of Springfield ever unsheath their various arts and crafts to dissolve totally his memory and will.

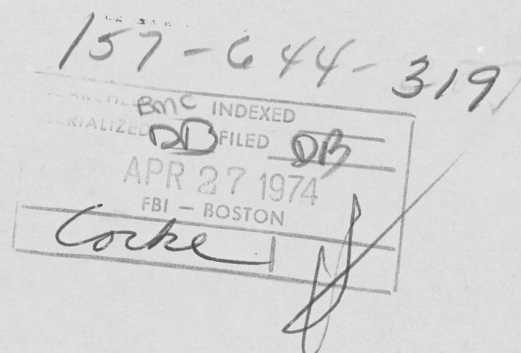

George McMillan, 12 Hilliard Street, Cambridge, Massachusetts, telephonically advised a representative of the Federal Bureau of Investigation (FBI), Boston, Massachusetts, on April 27, 1974, that he is an author of material on James Earl Ray; however, he declined to be interviewed. He said that James Earl Ray's attorney, Bernard Fensterwald, Jr., habitually makes wild accusations and he, McMillan, did not feel any response was warranted. McMillan noted he has written letters to "Jack," described by him as being John Larry Ray, brother of James Earl Ray. McMillan said he had a second reason for not wishing to be interviewed, stating that correspondence between himself and John Larry Ray concerned a suit in Federal Court by McMillan to gain access to John Larry Ray, currently an inmate at Federal Prison, Marion, Illinois. This suit is presently on appeal to the United States Supreme Court, according to McMillan.

Two hours later on the same date, April 27, 1974, McMillan telephonically requested he be contacted on April 29, 1974, to arrange for interview.

On April 29, 1974, McMillan was telephonically contacted by a representative of the FBI. McMillan stated he had decided to consult with an attorney prior to interview and desired to have an attorney present if interviewed. He said he would contact the Boston Division of the FBI in several days.

On April 29, 1974, McMillan telephonically advised he was willing to be interviewed May 2, 1974, in the presence and in the office of his attorney, John T. Williams, of the Boston law firm of Hausserman, Davison and Shattuck.

On April 30, 1974, McMillan telephonically cancelled his appointment. He stated he was willing to have Attorney Williams interviewed in his behalf, but he did not wish to be present himself. He said he was leaving the Boston area immediately to spend three or four days in Tennessee. He volunteered that he had not reviewed any FBI files and had only hearsay knowledge of any such review by other authors.

On April 30, 1974, Attorney John T. Williams telephonically advised he had talked with McMillan several hours earlier, at which time McMillan was willing to be interviewed personally. Williams stated he knows only that McMillan did not review FBI files. He added he would contact the Boston Division of the FBI concerning possible interview, after conferring with McMillan upon McMillan's return from Tennessee.

On May 8, 1974, Attorney Williams telephonically advised that his client, George McMillan, would be in Boston on May 10, 1974, and available for interview in Williams' office on that date.

On May 10, 1974, George McMillan was interviewed by Special Agents Kenneth L. Hansen and John N. Onellotte in the office of his attorney, John T. Williams, of the firm Hausserman, Davison and Shattuck, 1 Boston Place, Boston, in the presence of Williams.

McMillan advised he has never seen or had access to any FBI files, or portions thereof, concerning the James Earl Ray case or any other case. He said no FBI personnel, anywhere, ever indicated they would make such material available to him. He recalled he once visited the office of former FBI Assistant Director Tom Bishop at FBI Headquarters, Washington, D.C., to request material for his book on James Earl Ray; however, Mr. Bishop, who was then handling press relations, told McMillan he could not give him anything regarding that case.

McMillan further advised that the Tennessee State Attorney-General's Office in Memphis was in possession of what was commonly referred to as "FBI files" in order to

conduct its prosecution of James Earl Ray. McMillan said he heard rumors from sources in Memphis, whose identity he does not recall, that those files were made available to authors Gerold Frank and William Huie by either state or county officials or personnel. McMillan added these were merely rumors of unknown origin and he possessed no specific information as to whether either Frank or Huie had access to the files.

McMillan stated the aforementioned rumors led him to believe he could have the FBI files made available to him. McMillan was asked if any state or local official or personnel in Tennessee ever offered to make the FBI files available to him. McMillan replied by saying that he refuses to answer that question.

McMillan went on to relate he has been attempting to compile material regarding James Earl Ray in order to determine a personal motive for the assassination of Dr. Martin Luther King, Jr., so as to disprove theories that a conspiracy may have been involved. He said he was previously retained by the Columbia Broadcasting System (CBS) and Time Magazine, Inc., to conduct a study of Lee Harvey Oswald in connection with the assassination of former United States President John F. Kennedy and that study led him to the conclusion Oswald acted on his own and there was no conspiracy involved.

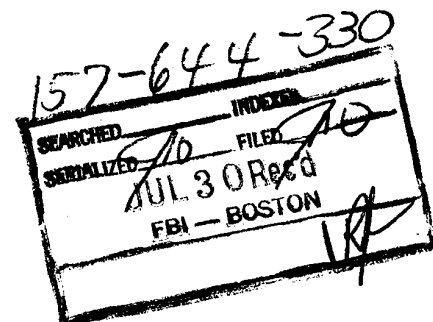

SUBJECT: HOUSE SELECT COMMITTEE ON ASSASSINATIONS

The Bureau by Teletype dated 11/26/76 advised that the House of Representatives created a Select Committee on Assassinations to investigate the deaths of JOHN F. KENNEDY and MARTIN LUTHER KING, Jr. This Committee and the Office of Legislative Affairs, Department of Justice, have reached an agreement stipulating that all Committee requests for access to FBI files and personnel will be made in writing to the Office of Legislative Affairs.

If any Agent is contacted by a member of this Committee, he is to politely advise him to direct his inquiry to the Office of Legislative Affairs of the Department of Justice or to FBIHQ, Attention Congressional Inquiry Unit, General Investigative Division.

For your further information, in the event personnel are contacted for purpose of interview or testimony, refer to Director's letter, No. 1-75, dated May 28, 1975, captioned: "MEMORANDUM TO ALL EMPLOYEES; RE: INTERVIEWS OF FBI EMPLOYEES." This memorandum details employee responsibility regarding disclosure of information as outlined in the Code of Federal Regulations, and the FBI employee agreement, which require appropriate authority before furnishing information, testimony or record material.

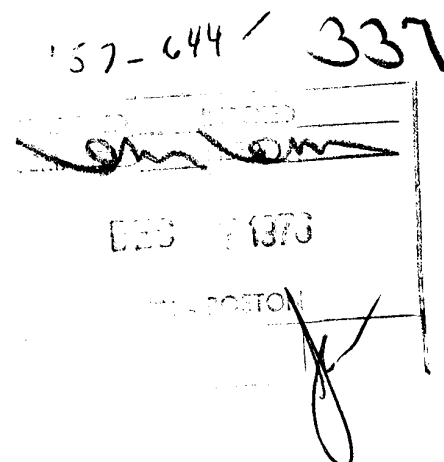
