Enclosed herewith for each office are two copies of an artist's conception of purported subject who murdered MARTIN LUTHER KING, Jr.

Attached drawings were made available evening of 4/16/68 by Mr. EDWARD MC CLELLIN, Executive Director, NAACP, 431 S. Dearborn Street, Room 1317, telephone 939-5365, Chicago (racial liaison source of the Chicago Office) and OTIS RAPHEL, artist for the Chicago Police Department (PD). MC CLELLAN advised RAPHEL prepared the drawings based on impressions conveyed to him by Rev. CLIFFORD ROYCE, also known as "Mr. Psychic", 32 N. State Street, 10th Abor, Chicago. MC CLELIAN advised that ROYCE purportedly possesses extra sensory perception and has a "batting average of about 94.6%" in his predictions and psychic impressions. ROYCE in advising MC CLELLAN and RAPHEL of his impressions of the assassination of MARTIN LUTHER KING, Jr., stated he feels the assassin is currently in the vicinity of New Orleans. He described the assassin as being approximately $5'10\frac{1}{2}"$ tall, 158-165 pounds, brown hair, light brown eyes, extremely small waist, 24-26 years of age, and feels subject at one time and possibly currently has homosexual tendencies. Further, that at one time the assassin was the subject of psychiatric treatment for which he was institutionalized and that the assassin was born in Georgia and received psychiatric treatment in Mississippi, or else was born in Mississippi and treated in Georgia. RCYCE also receives impressions that following the assassination, the murderer originally stopped at a motel approximately 30 miles west of Memphis on a main highway. The motel is in a run-down condition, described by ROYCE as being more or less a truck stop of approximately 15 units and ROYCE envisions a number of trees adjacent to the motel. According to ROYCE, this motel is located outside of a town and the assassin in this case has a "B" in his name and his name has no more than 6 letters. ROYCE's impression is that the assassing stopped at this motel after the murder of KING.





OTIS RAPHEL advised that approximately one year ago, Rev. ROYCE had asked to see him at which time ROYCE requested RAPHEL to draw the picture of a woman he visualized. ROYCE proceeded to describe the woman whom he felt would in the not to distant future, marry a particular person. According to RAPHEL approximately 6 months later the man in question married a woman not previously known to ROYCE but who looked exactly like the sketch drawn by RAPHEL based on impressions of ROYCE 6 months previous to the marriage.

It may be noted that MC CLELLAN was formerly the commanding officer of the Chicago PD Human Relations Unit, and in 1966 when he commanded and was later a part of this unit during the marches staged by MARTIN LUTHER KING in Chicago, MC CLELLAN spent a good deal of his time in maintaining contact with KING and at times serving as his in effect "body guard". MC CLELLAN in furnishing this information and the artist's drawings advised he desired to make this information available since he wished to leave no stone unturned in doing everyting possible to identify and apprehend the murderer of KING.

Enclosed sketch is being furnished to the Bureau and the interested offices in view of the source from which it was received. Any action taken on this sketch is being left to the discretion of the Bureau and the office of crigin.

JOHNNY VARNEY, Apt. 12, 815 Ponce de Leon Ave., telephone #876-2344, advised that 5 p.m. 4/19/68 that he was having dinner on or about 3/15/68 at Bradshaw's Restaurant, across the street from the Clairmont Hotel, Ponce de Leon Ave. when an individual unknown to him engaged him in conversation.

This individual had on his person a .38 caliber revolver and made the statement that he is an escapee from prison, has already killed one person, and has one more to go.

VARNEY said that he has not seen any photograph of GALT as he has not had an opportunity to read the newspaper in the past few days, but after reading the issue of 4/19/68 the above events appear to be significant to him. He said that the unidentified individual had stated that he was at that time registered at the Clarmont Hotel.

VARNEY said he would be at his residence until about 7 p.m. on 4/19/68 and would then be going to the wrestling matches. He said that he would like to see a photograph of GALT in an effort to determine if this is the person to whom he was talking on or about 3/15/68.

Additional information revealed by the unidentified individual was to the effect that he owned a white Mustang.

DORA MC DONALD, Dr. MARTIN LUTHER KING, JR. 's former secretary, was interviewed today at SCLC headquarters, Auburn Ave. by SAs ARTHUR L. MURTAGH and JOHN M. PALFI.

Miss MC DONALD was asked to furnish any information that she might have related to the recent death of Dr. KING and also to make contact with other SCLC pople who were in Memphis with Dr. KING and make arrangements to set up interviews with the interviewing Agents should any of them feel that they could furnish any information concerning this matter.

Miss MC DONALD expressed her appreciation in the Bureau's intensive interest in this matter and said she would cooperate in any manner possible.

Miss MC DONALD said there was one item which she thought might be pertinent but that she got this information secondhand.

She said that JULIUS GRIFFIN, a former SCLC employee who is now working in Detroit, called her from Detroit the day before Dry KING's death and advised her that he had information that six members of an organization known as Breakthrough were en route from Detroit to Memphis. GRIFFIN told MC DONALD he did not know whether the six men were armed or not.

Miss MC DONADD said that Breakthrough is an extreme Nazi or neo-nazi white racist organization in Detroit and that about two weeks before the death of Dr. KING, some representative of this group harassed Dr KING while he was making a speech at Grock Point, Mich.

Miss MC DONALD said that GRIFFIN came to Atlanta following the death of Dr. KING and he has been helping out in SCLC work since that time but that she believes he plans to return to Detroit, Miss MC DOALD did not have a current address for GRIFFIN in Detroit but stated that GRIFFIN is out of town today on a retreat and that she believes he may return to Detroit this evening. She stated she would advise the interviewing Agents of his whereabouts as soon as she could determine them.

Miss MC DONALD was advised that all of the SCIC officials who were with Dr. KING in Memphis at the time of his death are now out of town today on a retreat but that they are expected back tomorrow. Miss MC DONALD stated that she would stay in close contact with the interviewing Agents and cooperate completely in assisting the Bureau.

Enclosed under separate cover are two brochures published for the Locksmithing Institute, Little Falls, N. J., which brochures contain descriptive information and a layout photo of various items furnished to correspondents. Also enclosed is one "Professional Locksmithing and Keymaking Kit" also provided by the Locksmithing Institute, Little Falls, N. J.

On 4/18/68, Mr. BOYD GILLEN, Assistant to GEORGE DURYEA, Director, Locksmithing Institute, Little Falls, N. J., advised, in the absence of DURYEA, that the Locksmithing Institute furnishes to each correspondent a kit containing various pieces of equipment for the first assignment in the course. The first assignment in each course encompasses lessons one through five, and the equipment and various tools are separated in manilla envelopes according to lesson.

GILLEN made available a duplicate kit such as the one which would have been sent to ERIC STARVO GALT. He advised that any blank keys or pre-cut keys that may have the appearance of being heat treated have in all probability been subjected to an open flame in order to create a carbon deposit along the edge of the blank. Thus, when the blank is inserted in a lock and withdrawn, bare spots would appear where the notches within the lock were to be found.

GILLEN advised that any piece of blue steel possibly from the described kit may be a gauge device for the measurement of keys and would be approximately 2" long and ½" wide. However, this gauge if fully intact should have a sharpe point thereon. He advised that he had no information as to why any gauge would be blunted unless it had been broken.

At approximately 11:05 AM, 4-19-68, Officer J. Tackette, Cobb County PD, Marietta, Ga., telephonically advised that the Kennesaw PD, Kennesaw, Ga., had a hitchhiker in custody who was stopped as he was walking in the median strip on U.S. 41 in Kennesaw, Ga. Tackett stated that the man was carrying a U.S. Merchant Marine Identification card # Z 713627 and gave the name GUY VIGNOLI and bore a resemblance to ERIC STARVO GALT.

At 11:20 AM this date COP E.H. HOLLINGSWORTH, Kennesaw PD and Officer J. R. PATTERSON, Cobb County PD, were contacted on US 41 near Rock Crusher Hill, Kennesaw, Ga., where they were questioning a truck driver identified as GUY-TANO (NMN) VIGNOZI who was standing beside his tractor and trailer. HOLLING-SWORTH advised that at about 10:15 AM one JERRY BEEME, 1105 WINDSOR Pkwy, Atlanta, Ga., phone 255-5375, a student at Kennesaw College, Kennesaw, Ga., had entered the Kennesaw PD and said he had picked up a hithhiker at the exit of U.S Interstate 75 and US 41, Marietta, Ga., and had let the male hitchhiker out of his car on Ga. 78, behind the FORDES MOTEL, Kennesaw, Ga., at about 10:00AM. BEENE stated that he believed the man might be identical to ERIC STARVO GALT whose picture he had seen in the Atlanta papers.

HOLLINGSWORTH advised that he then contacted the Cobb County PD and their cars went to the area of Bordes Motel, US 41, at which time a Cobb County PD car driven by Officer J.R. PATTERSON saw a man walking in the median strip along US 41 near the motel.

GUYTANO VIGNOLI, RD #2, Valley Inn, Monongahela, Pa., was approached and was given a Waiver of Rights form which he read and signed. He was informed of the reason he had been questioned by Officer Patterson and COP Hollingsworth. VIGNOLI voluntarily agreed to accompany Officer Patterson and COP Hollingsworth to the Kennesaw PD for further questioning, he further volunteered to be fingerprinted and photographed. His voluntary agreements were witnessed by Officer Patterson. VIGNOLI drove his tractor and trailer to the vicinity of the Bar W Bar Restaurant, US 41, Kennesaw, Ga., where he parked the unit and was driven by Officer Patterson to the Kennesaw PD.

VIGNOLI voluntarily accompanied Officer Patterson to Kennesaw Junior College, Kennesaw, Ga., where he was physically observed by student JERRY BEENE who advised that VIGNOLI was not the individual he had given a hitchhike to as mentioned above. VIGNOLI was then returned to the location of his truck on US 41 and he drove off.

JERRY BEENE, 1105 Windsor Pkwy, Atlanta, Ga., phone 255-5375, a Sociology Student at Kennesaw Junior College, Kennesaw, Ga., advised that between 9:30 AM and 9:45 AM, 4-19-68, he had picked up a hitchiker at the exit of Interstate 75 on US41 in Marietta, Ga., and had driven him to Ga. 78, behind FORDES MOTEL, Kennesaw, Ga., where he had let the man out so he could continue hitchhiking on US41. After letting the man out BEENE remembered the photo of ERIC STARVO GALT in the Atlanta newspapers and believing this hitchhiker very close in description to GALT had driven to the Kennesaw PD and reported his belief to COP Hollingsworth. BEENE then drove to classes at Kennesaw Junior College.

BEENE described the man he had picked up as W/M, 25, 5'10" to 6', 170-180, clean shaven, wearing a brown fine checked plaid shirt and gold colored hop sack type levis, hair brown worn in short Princeton Cut. The hitchhiker was wearing no other clothing that could be described by BEENE, but he added the man was carrying a large grocery type brown paper sack. The man gave him no name and said he was enroute to Topeka, Kansas, to see his sister. When BEENE said he attended

Kennesaw Junior College, the man asked him if they had a band there. The only other recollections BEENE had was that the man mentioned going to Chattanooga, Tenn., and then intended to stop at Nashwille, Tenn., and that he smoked Camel cigarettes.

Investigation in the vicinity of FORDES MOTEL, U.S. 41, Kennesaw, Ga., failed to locate the hitchhiker described. It was noted that GA 78 runs directly behind this motel almost parralel with US 41.

MRS. SHIRLEY DUNCAN, Owner, Fordes Motel, US 41, Kennesaw, Ga., advised that she had observed a man carrying a brown paper sack get out of a car on GA 78 and walk through the motel property to US 41 where he stood attempting to get a ride from a passing car. She stated she saw the man at about 10:00 AM and he appeared to be very slim amd much shorter than six feet. She could not recall the clothing he was wearing. She last saw him walking North on US 41 on the shoulder of the road.

MR. F.B. DUNCAN, father of the owner of FORDES Motel, US 41, KennesawGa., advised on 4-19-68 that he had observed a man walk through the motel property at about 10:00 AM and walk North on US 41. He stated the man had a brown paper sack but could not recall the clothing he was wearing. DUNCAN was shown a photo of ERIC STARVO GALT but stated he could not identify the man he had seen as GALT.

MRS. SHIRLEY DUNCAN was also shown a photo of GALT but stated she could not identify the man she had seen as GALT.

The following were contacted at FORDES Motel but advised that they had not seen the hitchhiker: HERBERT B. VERTICAN and MRS. EDITH KELLY.

It is being noted that VIGNOLI when observed by Officer Patterson, Cobb County PD, was wearing very similar clothing as that described to COP Hollingsworth by JERRY BEENE

The Philadelphia Office telephonically advised this date that LAWRENCE HENRY, RAM, had originally intended to travel to Memphis on 4/5/68, but had changed his plans and was presently in Philadelphia.

GEORGE WOODS, a prominent Negro disc jockey from the Philadel phia area, and an individual active in Philadelphia politics and the civil rights movement there, reportedly purchased two tickets on Delta Flight 347 from Philadelphia to Atlanta leaving Philadelphia at 2:35 PM 4/8/68, and that WOODS scheduled to reurn to Philadelphia on Delta 342 on 4/10/68. Tickets purchased by WOODS were originally for himself and his wife but WOODS' wife's ticket is reportedly going to be used by LAWRENCE HENRY.

MATTEE ADAMS, CI of the Philadelphia Office, is aware of the above, and will notify the Atlanta Office of HENRY's activities in Atlanta. BEN GAS, code name for a Radal Informant of the Philadelphia Office, who had originally traveled to Memphis to cover HENRY's activities there, is unaware of the above information and Philadelphia was making the above known to Atlanta in order to brief GAS when he contacts CHUCK HARDING upon his arrival in Atlanta.

Philadelphia Office further advised that caution should be used in approaching GEORGE WOODS in that it would not be unreasonable to assume based on WOODS' former attitude that he would report any actions by a Special Agent to the local news media in an unfavorable manner.


