On 4/25/68 JIM FLOYD WATSON, Cab Driver Number 47564, United Cabs Company, Atlanta, Georgia, advised that he had dropped a passenger at the Central Paramount Theatre, 104 Whitehall Street, Atlanta, at approximately 11:25 a.m. this date and that the passenger resembled the description and photograph of JAMES EARL RAY. WATSON stated he had picked this passenger up at the Airport Terminal and driven him directly to the above theatre upon his request. The individual had no baggage and was dressed in a light brown or tan sports coat with dark slacks and believed to be wearing a sports shirt open at the collar. He was believed to be about 5' 10", color of his eyes were unnoted, however his hair was light brown and closely cropped.

According to WATSON the subject was extremely nervous when he paid for the cab and he noticed him approach the theatre window in a very nervous manner. Subject wore no hat.

WATSON was subsequently accompanied to the Central Paramount Theatre by SAs DONALD P. BURGESS and O. RICHARD HAMILTON and the individual who he had previously described was located. This individual proved to be CHARLES BRYAN MC CORMICK, 1502 Park Avenue, La Grange, Georgia. MC CORMICK indicated that he was unemployed and in Atlanta looking for employment and that he had been employed until 4/24/68 by the Deering Millican Company, Hillside Mill, La Grange, Georgia. He was described as 5' 8", 150 pounds,

Age 25, DOB [redacted] at Chambers, Georgia, light brown hair, very closely cropped in a blunt cut, blue eyes, no visible scars and marks. He was wearing a light tan sport coat, medium dark slacks, and a shirt and tie. MC CORMICK was extremely nervous and agitated and advised that he had been discharged from the Air Force as an epileptic. A subsequent phone call to MC CORMICK's employer, Deering Millican Company, La Grange, Georgia, disclosed that MC CORMICK had been in fact discharged from their employ on 4/24/68 and had been employed by that firm since 12/66. It is to be noted that although MC CORMICK claims to weigh 150 pounds he is a very slight and short individual and believed to be smaller than indicated on his DL and Selective Service card.

MC CORMICK also exhibited a general discharge from U. S. Air Force in his name. MC CORMICK is married to BRENDA MC CORMICK, same address and same employment and has 2½ year old child. Inasmuch as the UNSUB was positively identified as ROBERT BRYAN MC CORMICK no further investigation was conducted.

FEDERAL BUREAU OF INVESTIGATION

Date April 24, 1968

ROBERT EVANS, 591 Parkway Drive, N.E., Atlanta, Georgia, was interviewed at the Crown Filling Station, directly across from the SCLC Headquarters on Auburn Avenue in Atlanta, and he advised he recalls seeing two white men using a phone booth at the station on the day before Dr. MARTIN LUTHER KING, JR. was killed in Memphis, Tennessee. Mr. EVANS said that he would place the time that he witnessed these individuals in the phone booth at between 3:00 and 4:00 p.m. He stated he was playing checkers at the station, sitting almost in front of the phone booths used by the men, but that he cannot remember the identity of the person with whom he was playing checkers. He said he recalls seeing these men at the phone booth and one man seemed to be writing something on a pad and the other man was making one or more telephone calls.

EVANS said that during the time these men were in the phone booth, someone in the group around the station stated, "There goes Dr. KING." He said that the two men in the booth came out, walked across the driveway to nearly the center of the driveway, and looked at Dr. KING as he was walking down Hilliard Street from the South side of Auburn Avenue, where he apparently had parked his car across Auburn Avenue. KING entered the most westerly entrance of the SCLC Headquarters.

EVANS said that as he observed these men watching Dr. KING, the thought crossed his mind that they must not know Dr. KING, since his appearance in that area would not have created much interest because most of the people in the area knew who he was. He said he also thought to himself as he saw Dr. KING walking across the street that Dr. KING was probably getting ready to go to Memphis, because he knew Dr. KING was to be in Memphis the following day.

EVANS said that he would attempt to try to recall who was in the group at the filling station when this incident took place, but that he did not think he would be able to remember their identities.

EVANS added he believes ALDEN ALLEN is one of the persons who were at the station at the time of this incident, but he is not sure.

EVANS furnished the following description of the two individuals:

(1) A white male, age 30, 5 feet 10 inches to 6 feet tall, 140 to 150 pounds, wore a hat. EVANS said he could furnish no additional information concerning this individual.

(2) A white male, 5 feet 8 inches tall, to 5 feet 9 inches tall, 140 pounds, hair light brown. EVANS said he could furnish no additional information concerning this individual.

EVANS said he noted that when the men left the station they walked first in an easterly direction which would be toward downtown, and then turned at about the edge of the filling station lot at Auburn Avenue and went in a westerly direction on Auburn Avenue, walking out of sight. EVANS was sure he did not see these individuals get into a car or see a car in the filling station parking lot appearing to be connected with them.

BAKER, Business Agent, both of the Painters Local #226 located at 540 Vine Street, Chattanooga, Tennessee. Both advised they could not recall anyone including past and present members of Painters Local #226 who resembles the photograph or description of RAY.

Mr. BAKER advised that even though Painters Local #226 has jurisdiction of Dalton, Georgia, painters only three active members of this local are located in Dalton and Whitfield County, Georgia. All other painters are non-union. He suggested the largest number of painters represented at any one place in Dalton, Georgia, would be the North Georgia Decorating Company, (FNU) LEMMONDS, General Manager and Owner. This is a known contractor who regularly employs 12 - 14 painters.

KNEW KING SUSPECT
Raymond Curtis

Pal Links Ray to King 'Bounty'

DALTON, Ga. (UPI)—A prison buddy of James Ray (Eric Galt) said Tuesday that when Ray heard there was a "million-dollar bounty" on Dr. Martin Luther King Jr., he smiled and said "I'll collect it."

Ray, a 40-year-old fugitive from the Missouri State penitentiary, is accused by the FBI

of conspiracy in assassinating King in Memphis on April 4.

In the Dalton jail, Raymond Curtis, 40, awaiting appeal on a murder sentence, said he has known Ray in the Kansas City jail, in the federal prison at Leavenworth, Kan., and in the state prison at Jefferson City, Mo.

He described Ray as likeable, addicted to "dope," a "loner" and a man concerned only with money.

On the day President John F. Kennedy was assassinated—Nov. 22, 1963 — Curtis said he, Ray, and about 150 other prisoners were in an exercise yard when they heard the news.

He said Ray remarked "Well, somebody made a pretty penny on that."

About a week later, Curtis said, he and Ray were in the yards when "a new man just in off the street" told them "the businessmen's association has a million dollar bounty out for Martin Luther King."

Ray smiled, Curtis recalled, and said "If there's a million dollars out for King, I believe if I ever get out I'll collect it."

Curtis said he never figured out what the "new man" meant by the "businessmen's association." He said he couldn't remember who the man was.

"I didn't think much about it at the time. In prison, you hear all sorts of hellacious ideas," said Curtis, a tall, rawboned man.

Authorities in Jefferson City confirmed that Curtis and Ray were in prison at the same time. Authorities in Dalton said the

FBI had interviewed Curtis on Sunday and again Monday night. The FBI refused comment on the matter.

Curtis said Ray told him "he always carried a gun. He was always interested in money," Curtis said, but never mentioned racial matters.

"He never made no statements of any kind in a group," Curtis said. "He was a loner."

Ray couldn't "make a long conversation unless he was planning something," said Curtis. "If he was planning something, you could bet they'd be thorough plans." Ray, he said, master-minded things "that would be small things outside, but were pretty big jobs in prison"—such as the theft of eggs and drugs and cigarettes.

He said Ray told him that if he ever wanted to kill someone, he would buy a gun under a false name, and have everything ready for an escape. "He used to talk a lot about escaping to New Zealand, Brazil and Argentina," Curtis said.

"I wouldn't consider him dangerous," Curtis said. "He didn't look for trouble."

"Of course, I'm not saying he wouldn't shoot you if you ran up on him now."

Curtis said he first met Ray in 1955, when he was serving time for bank robbery, and Ray for forging postal money orders, in the Kansas City jail. He said they were transferred to Leavenworth, where Ray "played a lot of miniature golf."

They met again when Curtis was sent to Jefferson City on a 10-year armed robbery conviction.

"He was there with a 20-year bid when I got there. I wouldn't say he was a friend," Curtis said. "A friend in a penitentiary is different than a friend on the street. But I was about as close to him as anybody in Jeff City."

Curtis said he was hospitalized for six weeks with hepatitis and "he came to see me just about every day."

Asked about Ray's habits, Curtis said "he talked about beer—he liked beer, I knew that." He said he never heard him talk about dancing, but that he "did a lot of weight-lifting" at Jefferson City.

"I never heard him do much cussing. I just saw him get mad once and that was in a poker game. He liked to play poker. His favorite game was lowball."

"He talked about having lots of women. None special. He'd pick 'em up and leave 'em," Curtis said.

"You could pick him out of a crowd of 2,000 men in the prison yard. He would be off to himself walking and his mind would be somewhere else."

Curtis, convicted of shotgunning a man in the holdup of a poker game here last year, said when he heard of King's death he did not connect it with Ray because he didn't know Ray had escaped prison.

If others were in the plot with Ray, Curtis said, Ray "would go to his grave with the secret."

"From what he said, I would consider he was an expert with a gun. I never heard him talk about a brother," Curtis said.

HE DESCRIBED Ray as likeable, addicted to "dope," a "loner" and a man concerned only with money.

On the day President Kennedy was assassinated—Nov. 23, 1963—Curtis said he, Ray, and about 150 other prisoners were in an exercise yard when they heard the news.

He said Ray remarked "Well, somebody made a pretty penny on that."

About a week later, Curtis said, he and Ray were in the yard when "a new man just in off the street" told them "the Businessmen's Association has a million-dollar bounty out for Martin Luther King."

RAY SMILED, Curtis recalled, and said "If there's a million dollars out for King, I believe if I ever get out I'll collect it."

Curtis said he never figured out what the "new man" meant by the "Businessmen's Association." He said he couldn't remember who the man was.

"I didn't think much about it at the time. In Prison, you hear all sorts of hellacious ideas," said Curtis, a tall, raw-boned man.

Authorities in Jefferson City confirmed that Curtis and Ray were in prison at the same time. Authorities in Dalton said the FBI had interviewed Curtis on Sunday and again Monday night. It refused comment on the matter.

CURTIS SAID Ray told him "he always carried a gun. He was always interested in money," Curtis said, but never mentioned racial matters.

"He never made no statements of any kind in a group," Curtis said. "He was a loner."

Ray couldn't "make a long conversation unless he was planning something," said Curtis.

"If he was planning something, you could bet they'd be thorough plans." Ray, he said, masterminded things "that would be small things outside, but were pretty big jobs in prison"—such as the theft of eggs and drugs and cigarettes.

HE SAID Ray told him that if he ever wanted to kill someone, he would buy a gun under a false name, and have everything ready for an escape.

"He used to talk a lot about escaping to New Zealand, Brazil and Argentina," Curtis said.

"I would consider him dangerous," Curtis said. "He didn't look for trouble."

"Of course, I'm not saying he wouldn't shoot you if you ran up on him now."

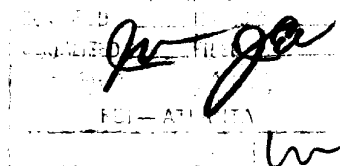

James Earl Ray, with known aliases of Eric Starvo Galt, W. C. Herron, Harvey Lowmyer, James McBride, James O'Connor, James Walton, James Walyon, John Willard, "Jim", is being sought by the FBI and charged with a civil rights conspiracy in which the victim was shot and killed and interstate flight - robbery.

According to FBI Director J. Edgar Hoover, Ray, who is 40 years of age, was reported missing from the Missouri State Penitentiary at Jefferson City, Missouri, since April 22, 1967, where he had been received on March 17, 1966, to serve a 30-year sentence following his conviction for armed robbery.

Ray has a known arrest record dating back to 1948, which includes a conviction for burglary in Los Angeles, California, in 1948; armed robbery in Chicago, Illinois, in 1958; and forging United States Postal Money Orders in Missouri in 1964.

Ray had served in the U. S. Army from February, 1946, to December, 1948, at which time he was given a general discharge. He is a white male, born [redacted] [redacted] in Illinois (not confirmed), is approximately 5'10", weight 163 to 174 pounds, has blue eyes, brown hair, has a small scar on the center of his forehead and a scar on the palm of his right hand.

Ray is a drifter and has been employed as a baker, laborer and color matcher.

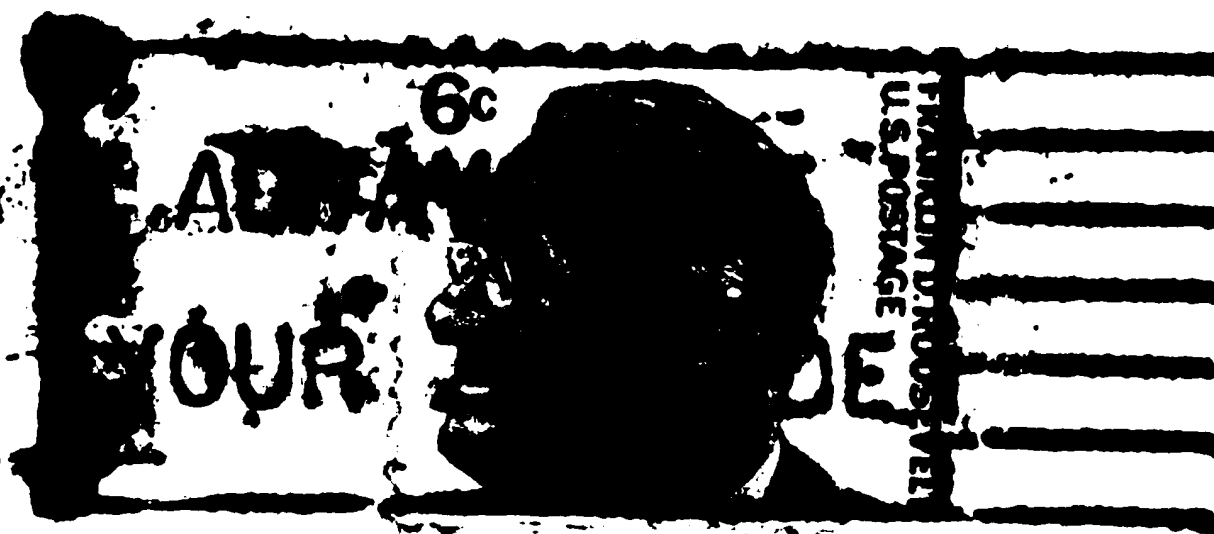
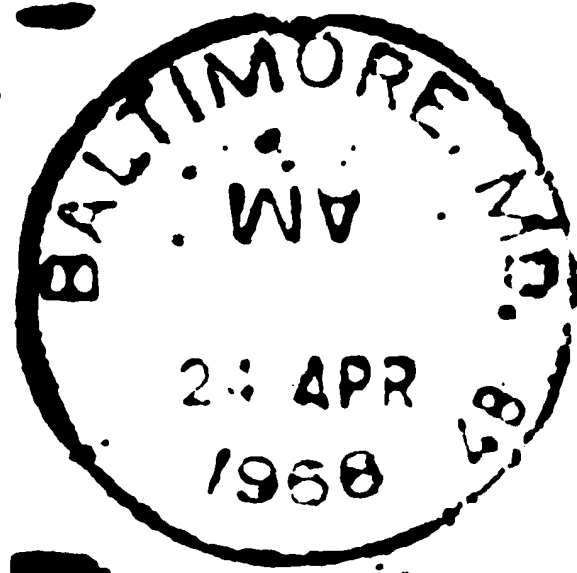

On 4/25/68, in response to a call from Lt. JIMMY HELMS of the Atlanta Police Department, SA's JAMES JOSEPH DOLAN and WILLIAM J. WATRY went to the Atlanta Police Department at 5:00 p.m., to contact Lt. HELMS who was interviewing an individual who refused to identify himself. This individual who admitted residing at 280-A Georgia Avenue, SE, Atlanta, furnished the following information:

The individual furnishing the information who, hereafter, is being referred to as informant, stated that he had been drinking earlier that afternoon in a tavern two and one-half blocks east of Peachtree on the south side of Ponce de Leon Avenue, at about 1:30 p.m. There was another individual at the end of the bar who subsequently called the informant over to where the other individual was drinking. The other individual did not mention any name but stated "You know I am the one who miffed out MARTIN LUTHER KING". They sat drinking for 30 or 40 minutes more and then returned to the Unknown Subject's room in the Park Hotel at Cain and Ivy Streets where they went by Checker Cab 28. En route to the hotel, the Unknown individual inquired of the driver what the fare would be to go to Memphis and the driver inquired from his dispatcher and learned that the Memphis fare would be \$50. The unidentified individual made no further reference to going to Memphis. When they got to the Park Hotel, they got out of the taxicab and went to a room on one of the upper floors of the hotel that the informant believes to be either room number 247, 347, 227, or 327. This was about 2:30 p.m.

After they arrived in the room, the unidentified individual propositioned the informant to rob the Domino Lounge "tonight", which meant the night of 4/25/68. The informant agreed to be back to the hotel room at

7:00 p.m., on 4/25/68, at which time the unidentified individual was supposed to disclose more detailed plans for robbing the Domino Lounge. The unidentified individual claimed to have an automatic pistol but the informant never saw the gun.

As soon as the informant got out of the room, he went to the police department to report the above matter to Lt. JIMMY HELMS who in turn called the FBI.

The informant described the unidentified individual as follows:

The informant stated that he had never seen the unidentified individual prior to this time. He stated it would not jeopardize him in any way if the FBI Agents interviewing him were to go to the hotel to identify the individual referred to above.

On 4/25/68, SA's DOLAN and WATRY went to the Park Hotel and through the Desk Manager determined that an individual named JAMES ADAMS was renting room number 19. The desk man pointed out the room on the second floor

of the hotel and then the occupant of the room was aroused and allowed the Agents to enter and interview him. The occupant identified himself as JAMES HAYES ADAMS, age 41, who has numerous arrests with the Atlanta PD for drunkenness. His ex-wife, EVELYN ADAMS, lives at 1026 Collier Road in Atlanta and has phone number TR 2-8156. ADAMS admitted to having several arrests for drunkenness and admitted to having spend three separate hitches at Milledgeville State Hospital. He described himself as follows:

ADAMS denied making any statement concerning the killing of MARTIN LUTHER KING or robbing of the Domino Lounge.

ADAMS was recognized as being identical with an individual whose interview had taken place under similar circumstances when he said irresponsible things after a drinking orgy at a hotel that he was staying at on Mitchell Street in Atlanta. It was apparent to the interviewing agents that ADAMS bore no resemblance whatsoever to the fugitive RAY. ADAMS was cautioned against making such irresponsible remarks when he is drinking. It was obvious to the interviewing Agents that both ADAMS and the informant had been drinking quite heavily. There was a strong odor of liquor on their breaths when they were interviewed.

On 4/25/68, LLOYD JOURNIGAN, 3788 Captain Drive, Chamblee, Georgia, Telephone Number 451-9197, advised that he is self-employed at the Bonanza Sirloin Pit enterprise.

He furnished the following information:

In about the latter part of April of 1967, an individual who was a stranger to him and who identified himself as LEWIS DOWDA, aka "Whitey" Dowda, applied for employment at the Bonanza Sirloin Pit, Marietta, Georgia, where JOURNIGAN was then employed as manager. He does not know by what means DOWDA was aware of the employment opportunity, but assumes that it was in response to a newspaper ad which JOURNIGAN had run. DOWDA filled out an application form which is now in the possession of JOHN MC CABE, 34 12th Street, Atlanta, Georgia, who maintained the books for the Bonanza Sirloin Pit. DOWDA was employed as a cook and subsequently became Assistant Manager and was employed at this Bonanza Sirloin Pit in Marietta through the first week of October, 1967, except for a short period of time in September, when DOWDA was arrested by the FBI. DOWDA left voluntarily during the first week of October, claiming that he was sick and that when DOWDA did not return to his employment by November of 1967, JOURNIGAN decided that DOWDA was not going to resume employment.

JOURNIGAN subsequently sold out his interest in the Bonanza Sirloin Pit in Marietta, Georgia, and DOWDA

was re-hired by E. R. COLLINS at that same place for a period of about 30 days in January of 1968.

When DOWDA was first employed at the Bonanza Sirloin Pit in April of 1967, there was a young woman whose name was SHARON GRAHAM who was employed as a part-time worker there and who worked full time at the Telephone Company. GRAHAM and DOWDA started dating and subsequently married and JOURNIGAN was the best man in the wedding.

DOWDA, prior to this employment at the Bonanza Sirloin Pit, Marietta, was employed by the Henbrea Equipment Company, Marietta, and claimed to have come to Marietta from Missouri or Arkansas where he owned or worked in a restaurant. He also claimed to have been in the military service for five or six years and cooked while in the service.

The only individual with whom DOWDA was friendly was an individual known to JOURNIGAN only as "Dink", who was employed by TOM DURETTE, Owner of the Uniroyal Tire Company in Marietta, Georgia. DINK and DOWDA lived together prior to DOWDA's marriage with Mrs. (FNU) JOHNSON on West Dixie Street, Marietta. He described DINK as being a white male, 6'2" to 6'3", 240 lbs., 40 years of age, no upper or lower teeth.

He has no information as to the whereabouts of DINK and he has not seen him since prior to the first week of October, 1967. He last saw him on the night prior to DOWDA's terminating employment at the Bonanza Sirloin Pit when DINK told him that WHITEY DOWDA wanted DINK to help him rob the Bonanza Sirloin Pit. DINK informed JOURNIGAN that he declined to participate in this robbery and it was on the same night that DINK left Marietta. JOURNIGAN was not robbed at the Bonanza Sirloin Pit.

Some three to four weeks subsequent to DINK's informing him of WHITEY's plans for the robbery, JOURNIGAN received a telephone call from DINK, who said he was in Okla. and who inquired as to whether or not JOURNIGAN had been robbed. DINK also said that he would be on the way back to Marietta but never showed up.

DOWDA had no other friends to his, JOURNIGAN's knowledge, and did not correspond with any individual that he, JOURNIGAN, knows of. DOWDA never mentioned subject JAMES EARL RAY or any of RAY's aliases and he viewed photographs of subject with negative results.

He advised that DOWDA was not outspoken in his racial views and got along well with colored help when he worked at the Bonanza Sirlain Pit. When he worked he performed in a very satisfactory manner.

He advised that on many occasions, DOWDA would work long hours and would thereafter go out drinking and carousing for the rest of the night and would work with very little sleep. Based on this, JOURNIGAN figures that he was probably using "No-Doz" pills.

DOWDA kept talking about going to the Ozarks and Missouri because he had previously vacationed in these areas.

GBI Agent CATHY called at 12:40 pm today and advised as follows: Today at about 8:30 am a man driving a 1968 blue Chevy II Nova drove into the Pure Oil Station in Canton at Marietta and East Streets. He spent about 15 minutes in the rest room while there.

Employees of the station, JERRY GIBBS and ROGER EDWARDS, felt he looked something like subject RAY. D.L. "JR." EDWARDS, brother of ROGER EDWARDS and employee of Fulton Co. PWC, felt this man looked like RAY also. D.L. EDWARDS followed the car, lost it, and found it parked at Goldkist Poultry company behind a trailer. EDWARDS' brother in law is dock foreman at the company and he could not identify the car as belonging to anyone he knew.

Officer WOODS in Canton was notified and he notified CATHY. CATHY examined the car and determined he bore VIN 113698W230207, 1968 Ga. license 64D1202, and was a 1968 blue Chevy II Nova, 4 door, with rough interior. The seat covers on the front seat had been ripped off down to the springs and padding and covered with a yellow bedspread. The floor mats in front and rear had been taken out down to the metal. A partially addressed envelope lay in the front seat with addressee Virginia Roland, Box 121, notown given. A copy of 4-22-68 Atlanta Journal Constitution and a copy of Atlanta yellow pages telephone book and a black waist length man's jacket were found in the car. CATHY had a check made with Haralson County re tag and found it to be issued to LLOYD C. JOHNSON, Waco, Ga., for instant car.

On 4/26/68, Mr. RALPH BARBER, Deputy Director, Bureau of Narcotics and Dangerous Drugs, 1831 Peachtree Road, N.E., Atlanta, telephone 526-3111, was contacted with respect to captioned matter and he advised that they would alert their sources re information concerning subject JAMES EARL RAY.

BARBER advised there is very little amphetamine drug sale on the Atlanta market, however, there are periodic supplies which come to this country from Mexico. He pointed out that amphetamine drugs give a person the same reaction as cocaine, i.e., it causes them to have a compulsion to kill, delusions and somewhat of a feeling of being hunted or persecuted.

Regarding the 14th Street area, which is frequented by the "hippie element", he advised there is very little traffic in LSD and amphetamine drugs, however, this group has been using other dangerous drugs and their derivatives.

BARBER suggested that the proprietor of a book shop, name unrecalled, located on W. Peachtree, in the 900 block, which caters to the psychedelic element, be contacted since she is cooperating with the Federal Bureau of Narcotics, particularly SA RUSSELL JESSUP. He also stated this individual whose name he cannot recall, was arrested within the past several days by the Atlanta PD Vice Squad.

Will contact Agent JESSUP of the Federal Bureau of Narcotics and determine the feasibility of contacting this individual who operates the above-mentioned bookshop, and who is known to be a peddler of dangerous drugs.
