ReButel to Los Angeles, 4/26/68.

Referenced teletype advised HAROLD J. THOME, a possible mental case, had been attempting to have an audience with MARTIN LUTHER KING in Atlanta. He had reportedly threatened a neighbor in the past with a shotgun. The Bureau instructed that although subject RAY had been identified as the assailant, investigation should be conducted to determine if THOME might be implicated as a conspirator.

A review of Los Angeles files reflects HAROLD J. THOME had advised the Los Angeles Office on 4/19/67 he had observed a pickup truck and dune buggy in a ravine near Tujunga, California, and the occupants of the vehicles were apparently burying something. He brought this to the attention of the FBI because he thought it was of possible interest in the YOUNG kidnaping case.

In September, 1967, THOME's son, STEVEN THOME, 355 West Acacia, Glendale, California, was interviewed at the residence of his father, 10520 Hillhaven Street, Tujunga, and advised his father had written President JOHNSON and the Pope on numerous occasions, voicing opposition to the war in Vietnam. He stated his father had been arrested in the past for pulling a gun on police officers who were attempting to stop some hippies from marching through a canyon area.

In September, 1967, Mrs. HAROLD THOME, former wife of THOME, stated she did not know his current address, but said he had been confined to mental wards in various hospitals in the Los Angeles area. She said besides having a mental problem, she considered THOME an alcoholic.

On 1/4/67, TIM THOME, son of HAROLD J. THOME, advised this office his father was attempting to travel to Washington D. C. to see President JOHNSON.

Subsequent investigation of the dune buggy incident established the people working around the automobile were attempting to tow it out of an area in which it had been stuck and there was no apparent relationship to the Young kidnaping case.

The Atlanta Office advised that THOME had appeared at SCLC Headquarters, Atlanta on 11/6/67, insisting upon having an interview with MARTIN LUTHER KING for an unknown reason.

On 11/7/67, TIM THOME (above), advised his father had a history of mental difficulties, frequency of suicide and had been in and out of Camarillo State Mental Hospital.

On 9/14/67, KENNETH C. MERRYHEW, U. S. Secret Service, Los Angeles, advised his department had investigated HAROLD JAMES THOME after receipt of a letter he had written President JOHNSON at his ranch in Texas, dated 12/21/66. MERRYHEW stated the letter in essence warned President JOHNSON he was "in grave danger" and set forth THOME's opposition to the United States involvement in Vietnam. MERRYHEW stated the letter indicated THOME had written the President on two previous occasions. Mr. MERRYHEW stated the records of Camarillo State Hospital reflected THOME was a patient from 1/30/64 to 5/2/64 and from 10/2/64 to 12/10/65. He was classified as a schizophrenic paranoid, disorganized, troublesome and unapproved. No further investigation was conducted by Secret Service.

Los Angeles Police Department (LAPD) records reflect that on 3/13/66, THOME was arrested for threatening a neighbor with a gun. No disposition of this arrest was shown. On 6/4/67, THOME was arrested for drunk driving and at the time of arrest had a .410 shotgun on the dashboard of the car which was unloaded. No disposition for this arrest was shown.

On 4/30/68 AT 1873-R, a member of Crisp County Hunting and Fishing Club #99, UKA, and a Province officer, was contacted and the proposition of a so-called "bounty" or "contract" for the assassination of MARTIN LUTHER KING, JR., was discussed. Informant had previously been mailed a picture of JAMES EARL RAY and on this occasion was afforded an opportunity to examine glossy prints of RAY's photograph. He did not recognize him and had no information concerning him. In the informant's opinion, the proposition of the Klan being behind a "bounty" or "contract" is beyond reason. He has never heard of a "bounty" or "contract" for KING or for anyone else. He pointed out that as much as CALVIN CRAIG and ROBERT SHELTON loved money that the leadership of the Klan certainly would not be behind such a proposition. He knows of no one in the Klan in Georgia wealthy enough to have put up enough money to have made the risk worthwhile in the assassination of KING. In addition, he pointed out that if a Klansman or a group of Klansmen had decided to assassinate KING they would have done so for the sheer hatred of Negroes rather than for money. Informant promised to be on the continuous alert for information concerning the proposition and stated he would immediately contact reporting agent.

ROBERT SPRADLEY, 1084 Lakeview Drive, Jonesboro, Ga., 478-2671, called at 12:53 pm today and advised that he has been working at Mason School which is located behind the Artic Bear on Bankhead at Bolton. Today at about 12:35 pm he observed a man in the Artic Bear eating that he feels looks like subject RAY. This man was accompanied by another man and they mentioned they were waiting on a phone call.

The man SPRADLEY felt looks like RAY was 5'8", 165 lbs., dark black hair, greenish eyes, and was wearing a white shirt, green tie and green pants.

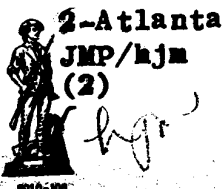

On 4/25/68, Mr. STEVEN CRAWFORD, Adult Probation Officer, Fulton Co. Probation Department, advised that AARON BENNER HOLCOMB had Mr. WILLIAM MEULLER as his probation officer. CRAWFORD stated that at the present time MEULLER was in court and was unable to be contacted at the present time. CRAWFORD advised that a review of HOLCOMB's file indicated that HOLCOMB did not report for his monthly visit to the Probation Office on 4/19/68 and that as a result, MEULLER had obtained a warrant for HOLCOMB's arrest charging him with providing false information to his probation office, in that he furnished that office a false address of 68 Rawson St., S.E., Apt. 48. CRAWFORD stated that should HOLCOMB report to his office in the next few days, he would contact the FBI and inform them of HOLCOMB's whereabouts.

On 4/25/68, it was noted that the address of 756 Woodson St., S.E. as given by HOLCOMB at the time of his arrest on 10/15/65 was a fictitious address.

On 4/25/68, Mrs. LINDA D. SULLIVAN, 718 Primrose St., advised that she is not familiar with the man named HOLCOMB nor did she remember him ever having lived at this address. She stated that she was unable to identify HOLCOMB from the picture presented to her.

On 4/25/68, Mr. AMOS A. BISHOP, maintenance man, Capitol Homes, was recontacted and he advised that he has not seen HOLCOMB since 4/17/68, the day on which he saw him three times in the area of Capitol Homes. BISHOP stated that HOLCOMB did not say where he was living but BISHOP believes that HOLCOMB

was residing in the Little Five Points area, near Moreland and Euclid Avenues. BISHOP added that should he meet with HOLCOMB again, he will try to detain him and notify the Atlanta Office of HOLCOMB's whereabouts.

On 4/29/68, the following postal carriers (Protect Identities) of the U.S. Post Office, Station E, 1087 Euclid Ave., NE, were contacted re any person along their routes by the name of HOLCOMB:

L.R. DANIEL, Post Route #0717, advised that several weeks ago, he had received mail directed to a WAYNE HOLCOMB, 1338 McLendon St., however, there was no apartment listed. DANIEL stated that there were presently 18 apartments in that building and that he was unable to deliver it to any individual, apartment number.

W.V. THOMPSON, Utility Carrier, advised that approximately one week ago, a woman on Euclid Terrace had asked for mail addressed to HOLCOMB. THOMPSON stated that he did not have at that time any mail addressed to HOLCOMB nor has he had any since. He stated that to the best of his knowledge, the woman resided in #429 or #443 Euclid Terrace and that these two buildings were boarding houses.

SYLVESTER WADE, Postal Route #0705, advised that the only HOLCOMB on his route has been residing at a rooming house located at 337 N. Highland Ave. He stated that to the best of his recollection he had been delivering mail to that address addressed to HOLCOMB for the past two months.

C. MORSE, Postal Route #0704, advised that to the best of his knowledge, he has no one on his route by the name of HOLCOMB.

On 5/2/68, Mrs. BERTHA BOWLES, Apartment #4, 337 Highland Ave., advised that she is the landlady of this apartment house. She stated that there was a family by the name of HOLCOMB residing in apartment #3. BOWLES stated that Mr. HOLCOMB appeared to be 40 years old, had a wife, and a small child living with him. After viewing the photo of AARON HOLCOMB, Mrs. BOWLES stated that she was certain that this was not the man that we were looking for.

Mrs. JUANITA DUTTON, 443 Euclid Terrace, Apt. #1, advised that she has lived in this apartment since the end of Jan. 1968. She stated since that time, a young man and a girl approximately 21 years of age and two children moved into apartment #2 next door. She stated that this man does not resemble the photo of HOLCOMB nor has she heard of any person named HOLCOMB in the area.

Mrs. DOROTHY PHILLIPS, 429 Euclid Terrace, Apt. #1, advised that this rooming house consist of four apartments and that she was almost totally unfamiliar with the occupants. She stated that the owner of the building was a Mr. SIM, however, she stated that she did not know his phone number nor address. Mrs. PHILLIPS stated that she personally pays her rent to Mrs. DORSEY, apartment #2, who acts as the landlord for the rooming house. Upon viewing the photo of HOLCOMB, she states she is totally unfamiliar with his face and that to the best of her recollection, this man has not resided in the immediate area.

Mrs. RUBY DORSEY, 429 Euclid Terrace, Apt. #2, advised that she is the landlord and that she collects rent for the premises for the owner, Mr. SIMS. Mrs. DORSEY produced a rent receipt book dated from 1/12/68 to the present. A review of this receipt book failed to indicate any party by the name of HOLCOMB residing here. Mrs. DORSEY upon viewing the photo of HOLCOMB, stated she has not seen this man in the general area at any time.

On 5/2/68, Mrs. WILLIE ADDISON, resident manager, 1338 Mc Lendon Ave., Apt. #4, advised that the only HOLCOMB that had resided in this building to the best of her knowledge was a Mr. WAYNE HOLCOMBE. Mrs. ADDISON described HOLCOMBE as being a man in his 40s and residing in one of the apartments with his wife. Upon viewing the photo of HOLCOMB, she stated that she has never seen this man in the general area and she is certain that he has never lived there since she has been resident manager.

Mrs. CHARLES MUNRO, 1338 McLendon Ave., Apt. #7, advised after viewing a photo of HOLCOMB that she has seen him at the Davis Standard Station on the corner of McLendon Ave. and Moreland Ave. She stated that it was approximately 12 noon when she saw HOLCOMB at the filling station approximately two week ago. MUNRO was unable to describe the automobile in which HOLCOMB was traveling or if he was with anyone in particular.

MUNRO added that she does not know the residence of NOLCOMB; however, she has seen him in the area quite a few times.

On 5/2/68, Mr. JIM DAVIS, Manager, Davis Standard Station, 1185 Euclid Ave., advised that NOLCOMB has been a frequent customer of his and that he usually "pals around" with a heavy set individual driving a 1957 Chrysler. DAVIS added that he most frequently sees NOLCOMB on Friday and Saturday nights and that he knows that NOLCOMB frequents the Redwood Lounge directly across the street.

On 5/2/68, Mrs. MARILYN SISSON, day manager, Redwood Lounge, 1172 Euclid Ave., advised that she is on duty at the lounge from 7:00 a.m. until 4:00 p.m. everyday. She stated that upon viewing the photo, she is unfamiliar with the man named NOLCOMB and that if he does frequent this lounge, she suggested that contact be made with MAY PHILLIPS or BILLY CASEY, night managers of the lounge. She stated that these persons are on duty at the lounge from 4:00 p.m. until 2:00 a.m. each night.

On 5/2/68, Mr. J.A. MAZERGAMES, owner, Inman Park Delicatessen, 420 Moreland Ave., N.E., advised he is unfamiliar with the name of NOLCOMB and that after viewing a photo of NOLCOMB, he stated that he believes the face to be familiar. MAZERGAMES added that he has many customers during the day and it is quite possible that this man came in to purchase some food or drink some beer.

Mr. N.E. NOLAN, owner, Nolan's American Station, 309 Moreland Ave., N.E., advised that to the best of his recollection, he has not seen NOLCOMB in the area as a customer or a resident. He stated that if NOLCOMB should come into the station, he would notify the Atlanta Office of his whereabouts.

On 5/2/68, STEVE ROSE, attendant, Beddingfield Phillips Station, 299 Moreland Ave., advised he is unfamiliar with the name of HOLCOMB. After viewing some photographs of HOLCOMB, ROSE stated that the photo resembles a person known to him as ED or EDDIE LNU. ROSE explained that he met EDDIE in Bradenton, Fla. while visiting with a friend. He stated that ED had lived at 11th St. East in Bradenton, and had since moved to the Atlanta area. ROSE advised that to best of his knowledge, ED was driving a 1955 Pontiac with 1968 Ga. tags.

He stated that this man had lived at a boarding house on Euclid Ave. across from the Moreland School and had supposedly married a girl by the name of LINDA EVANS, who resided with her mother in a boarding house on Seminole Ave. approximately two houses from Sinclair St. ROSE added that about five week ago, this man came into the station and asked for a map of each state that the station had available. ROSE stated the last time he had seen him was approximately three weeks ago.

On 5/2/68, Mrs. THOMAS DUKE, manager, 1073 Euclid Ave., advised that she has only one apartment that she rents out and that this apartment was currently empty. She stated that she had never heard of the name HOLCOMB nor had she seen anyone of his description in the area. She added that she would contact the Atlanta Office should she determine any information concerning HOLCOMB or his whereabouts.

Mr. W.S. EARP, manager, 1067 Euclid Ave., advised that he and his wife manage a six room boarding house at the above address. He stated that he currently has no HOLCOMBs residing there nor to the best of his recollection has he ever had anyone by that name residing in his apartments.

Upon viewing the photo, he stated that he has never seen anyone resembling that person in the area.

Mrs. LILLIAN SHIELDS, manager, 1059 Euclid Ave., advised that she currently rents three rooms of her house to outside persons. She stated that she has never heard of the name HOLCOMB nor has she ever seen anyone in the area resembling the photo shown to her.

On 5/2/68, Mrs. GLADYS MC CLURE, 474 Seminole Ave., advised that her daughter, LINDA EVANS, had married a man by the name of ED BENNETT approximately two years ago. She stated that BENNETT was presently age 21 and she produced a photo of BENNETT that did not resemble HOLCOMB. She stated that the BENNETTs are now residing on Moreland Ave. and are expecting their first child in Nov.

On 5/2/68, Mr. JOHN T. HOLCOMB, 515 Lynch St., N.W. advised that he is the father of AARON HOLCOMB, however, he has not seen him for sometime. He stated that occasionally his son will call him on the phone; however, he will never give his father his current residence. Mr. HOLCOMB stated that when his son was approximately 12 years old, both he and his wife agreed to send him to Milledgeville due to a head injury and he stated that his son spent a total of six years there. Mr. HOLCOMB stated that he felt that his son was definitely staying around the Memorial Dr. or Cherokee Ave. area. He stated that his son used to live in an apartment between Woodward Ave. and Bryant St. with a friend who was constantly in trouble with the police. He added that it is quite possible that his son would frequent the Little Five Points area since he had lived there on Colquitt Ave. in the 1100 block at a rooming house sometime ago.

HOLCOMB added that his son was supposed to be working cleaning up a golf course on the Northside of town; however, Mr. HOLCOMB could not be certain as to which golf course. HOLCOMB further advised that to the best of his knowledge, his son usually "hangs out" in front of the White Front Grocery, on Memorial Dr. located across from the cemetery. He advised that the best way to contact his son would be to meet him at that address.

On 5/2/68, Mrs. E. L. DENMON, manager, White Front Market, 415 Memorial Dr., after viewing the photo of HOLCOMB, advised that she sees the man about every afternoon at approximately 4:30 p.m. She stated that he usually spends most of the evening in front of her store "tying up one of the phone booths." She stated that he usually spends his time here by himself and that he makes numerous phone calls and have other people call him back. She stated she was uncertain of his residence; however, he might be living in the Woodward Ave. or Cherokee Ave. section which was directly behind the White Front Market.

On 5/2/68, at approximately 4:40 p.m. HOLCOMB was interviewed by SA JOHN M. PALFI in front of the White Front Market.

On 5/3/68, the writer telephonically contacted Mr. WILLIAM MEULLER, HOLCOMB's Probation Officer, and advised him of HOLCOMB's general whereabouts. MEULLER stated that he has a warrant for HOLCOMB's arrest and that he expected to pick him up this date in front of the White Front Market.

Based on the limited information supplied by Mr. SESSIONS concerning subject, no further investigation is being conducted. SESSIONS did state that the man he saw had black wavy hair. The last time he saw this person he was proceeding west on 12th St., and he did not see him enter any residence.

The following investigation has been conducted in an effort to locate persons known to JIMMIE D. GARNER who might have observed GARNER in the company of JAMES EARL RAY:

During a conversation with GARNER while he was in an intoxicated condition, he mentioned he obtained his whiskey after closing hours from the bellboys at the Peachtree Manor Hotel.

On 4/26/68, Bellboys JOHNNY OGLETREE, CHARLES E. HOLLIS, FRANK HURD and CLAUDE MINOR were contacted by the writer and SA O. RICHARD HAMILTON. All of the bellboys knew GARNER well, but none was able to recall ever having seen him in the company of an individual resembling the available photos of subject. Bellboy FRANK HURD recalled that on one Sunday, possibly 3/24/68, an unknown individual brought GARNER to the Peachtree Manor between 3:00 and 4:00 P.M. in a white auto. HURD did not get a look at the driver of this vehicle and was unable to further describe the car.

On 5/1/68, GARNETT DAVIS, 2211 Larchwood Drive, N.W., Atlanta, a former Bellboy at the Peachtree Manor, was interviewed but was unable to provide any pertinent information.

On 5/1/68, ANTHONY FLUTZ, a driver for the Atlanta Linen Co., was reinterviewed concerning the picking up of laundry at 113 - 14th Street, N.E., on 4/5/68. FLUTZ said he now recalls that on one occasion, possibly 4/5/68, he went to 113 - 14th Street, to wait for the individual who was collecting the laundry there. He is not sure whether this man was GARNER or someone helping him. He recalls that while waiting for the laundry in the hall, a white male, approximately 25 - 26 years of age, 5' 5", wearing a sports shirt and slacks, came out of a corridor leading back to the rooms and went out the front door. He could not be sure that this was 4/5/68, and it is noted the description offered does not fit the description of subject RAY.

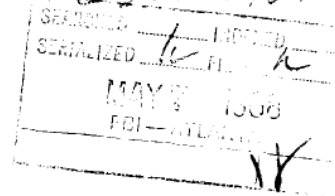

The following investigation was conducted by  
SA JAMES RICHARD FLICK on April 25, 1968 at Marietta,  
Georgia:

LEWIE RAYMOND DOWDA was interviewed at the  
Cobb County Jail, Marietta, Georgia, where he was incarcerated  
and provided the following information regarding JAMES  
EARL RAY:

DOWDA advised after the interview with agents  
on April 24, 1968, he recalled that he had also been  
employed by Liggett Lane (phonetic) Drug Company at Tenth  
and Peachtree Streets, Atlanta, Georgia. DOWDA advised  
he was employed there as the manager in the soda fountain  
department. DOWDA advised that he had learned previously  
that the subject, JAMES EARL RAY, had been seen in Atlanta  
and thought possibly he might have come looking for DOWDA.  
DOWDA stated he had no idea whether or not RAY might have  
been aware of his employment, but stated there was a possibility  
that he may have been. DOWDA continued he had been employed  
at Liggett Lane Drug Company around November or December  
of 1967. DOWDA stated during that time he worked under  
Dr. (First Name Unknown) CHOTAS, who was the General Manager  
of Liggett Lane Drug Stores and worked with EDITH (Last  
Name Unknown) who became the Manager of the soda fountain  
department after DOWDA left their employment. DOWDA advised  
if RAY had ever come into the Liggett Lane Drug Store  
looking for him these two persons would have been the persons  
most likely to have been contacted in this regard.

DOWDA stated he had never received any information  
that anyone similar to RAY had been seeking him but stated  
that there was a distinct possibility that this may have been  
true.

DOWDA further advised sometime after he had been  
arrested by agents in Marietta, Georgia, at the Bonanza  
Sirloin Pit, he had been advised by persons, who he could  
not recall that a long distance phone call had been made to  
the Bonanza Sirloin Pit in Marietta around November or

December, 1967, and was received at that time by either LLOYD JERINGAN or DAN AYERS (Phonetic). DOWDA advised that he was not certain which of these persons received this phone call but was advised that the person who called left no phone number and apparently did not identify himself to the person who received the telephone call. DOWDA advised he had no idea who the phone call may have been from and stated that he never did receive any further information about this call, nor was the call ever completed to him.

DOWDA stated as best he could recall the phone call might have originated in Oklahoma, but stated that neither he nor, as best he could recall, RAY had any mutual friends in that area.

O. A. HEMBREE, 2424 Sewell Mill Road, Marietta, Georgia, advised that LEWIE RAYMOND DOWDA had been employed by him as a tractor driver and all around assistant from March 8, 1968 to April 12, 1968. HEMBREE advised that during this time DOWDA had worked satisfactorily for him every day that they could have worked, weather permitting. HEMBREE advised the total duration of this time was approximately five weeks and stated that as best he could recall at no time did DOWDA ever leave this area. HEMBREE continued that on two or three occasions, DOWDA had worked on Saturdays, but had never worked on any Sundays during this time. HEMBREE advised there was no way to specifically determine the exact dates on which DOWDA worked, but provided the following dates on which DOWDA was paid and the amounts.

HEMBREE stated during this five or six week period, he had made two loans to DOWDA in two checks, one for \$30 and one for \$10. HEMBREE advised that if DOWDA were to have been employed five days per week, his checks would run approximately \$90 to \$115. HEMBREE advised that all of the checks indicate that DOWDA may not have possibly worked all five days of the week, but again stated that this was due to the weather, stating that in rainy-type weather it was impossible for them to work.

HEMBREE stated that DOWDA had been a satisfactory employee while working for him.

On 5/3/68 the records of the Walker County, Ga., Tax Office as furnished by Clerk RALPH AIKEN reflects that 1968 Georgia license 15J4423 was registered 3/29/68 to LEWIS SHEPPARD, JR., 808 Indian Avenue, Rossville, Ga., for 1953 Chrysler, VIN 70130084, purchased used 3/9/68. The date of the purchase of the vehicle or the Social Security Number of SHEPPARD is not indicated.

MR. AIKEN advised that the tax records of Walker County, Ga., reflect no record of LEWIS SHEPPARD, JR.

On the same date, Walker County, Ga., Sheriff RALPH JONES and Rossville, Ga., Police DOYLE HICKS, and Mayor PAUL ELLIS, advised they know of no one named LEWIS SHEPPARD, JR.

On 5/3/68 the records of the Credit Bureau of Chattanooga, as searched by Clerk NANCY REYNOLDS, revealed that the only SHEPPARD in her files with that spelling was SAMUEL LEWIS SHEPPARD, Route #2, Webb Road, Chattanooga, Tenn. Upon contact MR. SHEPPARD advised that he is retired, has never lived in Georgia, has never owned a 1953 Chrysler or 1960 Thunderbird, and never has owned a Georgia tag.

On 5/3/68 MR. GEORGE W. CRAWFORD, Custodian at the Rossville High School, advised that he resides at 808 Indian Avenue in Rossville, Ga., and has for the past 25 years. He stated he knows no one named LEWIS SHEPPARD, JR., advised he has never owned a 1953 Chrysler and stated that he knows of no one named SHEPPARD who has resided in that neighborhood.

On the same date GBI Agent PAUL GRIFFIN who resides at 801 Indian Avenue advised that he has never known anyone named SHEPPARD residing in that neighborhood.

On 5/3/68 the records of the Chattanooga, Tenn., PD as searched by Clerk KAREN HANNAH revealed the only record

He works at Mead Packaging Company, Marietta & Ashby, and a white man ~~xxx~~, SID COLLINS, who works there told him last night that on 4-2-68 his wife left home with a man that has been in prison. They took COLLINS' white Pontiac which was seen in Talladega, Ala., on 4-3-68. COLLINS and his wife are not now living together, but he did see her after above incident and mentioned that she and the man she was with must have had something to do with the assassination of MLK. He said she looked at him with an unusual expression, but did not reply.

JOHNSON (Negro) said he and COLLINS go ~~xxx~~ to work at 3:00 pm after which time JOHNSON can be called at TR5-2711 ext 414 until 5:00 pm then he can be called at TR5-5243. COLLINS has expressed an interest in talking to someone about possibility the man with his wife was RAY. JOHNSON said he can arrange a meeting with COLLINS for agents if desired.

COLLINS did live somewhere near Marietta, but now lives nearer his job.

HENRY advised that he was born Bruce, Mississippi, [redacted] and served in the U. S. Army for 16 years, ASN [redacted] and [redacted]. HENRY claimed that he is divorced and that his wife was EVELYN HENRY (address unknown). HENRY advised that his parents are Mr. and Mrs. E. C. HENRY, SR., Calhoun, Mississippi.
