Public phone booth with number 322-9343 a short distance away from rooming house where GALT stayed was checked on 4/11/68. T. CHANDLER JOSEY, State Security Agent, Southern Bell Telephone & Telegraph Company, Phoenix Building (protect identity) caused this number to be checked, and the pay station is officially listed as being located at 1130-26th Street, South, and is a non-published number listed to the City of Birmingham. This address, plus fact it is a non-published number listed to City of Birmingham, seemed to conflict with address stated by SA SHANAHAN, Niazuma Avenue and Highland Avenue corner. Request was made for verification of this number, and SA SCHWEIN physically checked the number, and found it to be at corner of Highland Avenue, at 26th Street, and across the street from Niazuma Avenue, and correct as originally stated.

Toll records were not available for August, and most of September, as they had been destroyed under phone company policy of destroying toll records over 6 months old. However, 4 toll tickets were found, two for dates in last of September, and two for month of October 1967. Numbers called in remote areas were then checked for identities of subscribers, and results of this check is summarized as follows:

Retel from Dallas 4/10/68. (lead to locate JAMES POUNDERS in Russellville re ERIC STARVO GALT)

On 4/11/68 Mrs. EARL POUNDERS, 311 Eastside Apts., Russellville, Ala. advised JAMES ALTON POUNDERS, W,M, born [redacted] is her son and she has not seen or heard from him since Dec. 1967. She explained that he has been out of the army for about 12 years and during those years he has had serious problems with his nerves, ulcers and he is also a diabetic. During the past 4 or 5 years he has been in the VA Hospital in Birmingham numerous times. He was in Bryce Hospital, Tuscaloosa, Ala. for about the month of Nov. 1967.

Mrs. POUNDERS advised that in early Dec. 1967 she heard from JAMES ALTON POUNDERS by phone and he claimed he was in Birmingham and had been working for about a week. He did not mention the type of job he had but she speculated he probably was working at a gas station. She knew of no relatives or friends he had in BH and speculated that he probably was living with someone he had met in the VA hospital. She mentioned that he drinks quite a lot and probably has been arrested in BH as a drunk. He is in very poor physical and mental condition. She said no one had called there for him and he had not brought any of his friends to her home. She said the artist's conception did not look familiar to her and she had never heard the name of GALT.

If it is considered pertinent to make further efforts to locate JAMES ALTON POUNDERS, W,M, born [redacted] to determine if he is acquainted with GALT will search BH PD, SO, Credit Bureau and VA Hospital records for leads which might be of value in locating him in BH.

Debris found on the face of the bolt of the Q72 rifle shows that this rifle has not been fired recently. The debris has been present for a considerable length of time and this weapon probably has not been fired since manufacture.

The Memphis Office submitted a .30-06 Springfield caliber Remington Model 760 rifle, Serial Number 461476, to the Laboratory in connection with this case. A Redfield telescope sight is mounted on this rifle. No marks were found on the telescope sight tube and, therefore, the telescope sight mount, Q73, cannot be associated with this sight tube, on the basis of a toolmark examination. Therefore, it was not possible to determine whether or not the telescope sight was ever on the telescope mount.

JOE STONE, Investigator, Alcohol & Tobacco Tax Unit, 1025 - 2121 Building, Birmingham, Alabama, advised on 4/10/68 that he had an informant who had telephoned him advising he had seen a rifle prior to the shooting of MARTIN LUTHER KING, JR., which might be the rifle involved in this shooting. He said he would make this informant available for interview by SA J. T. ARNETT. Mr. STONE advised that this informant had been contacted by him over a long period of time and had always furnished reliable information.

On 4/10/68, JOHN HADDON was introduced to SA J. T. ARNETT as the informant previously referred to by Mr. STONE.

JOHN HADDON, 808 Goldwire Way, S.W., Birmingham, Alabama, advised he operates Club 401-402 located on Ishkooda Road in the Powderly section of Birmingham. He stated that on either March 5 or 12, 1968, at about 4:30 p.m., he went to the Ensley Office of Birmingham Trust National Bank located at 707 - 20th Street, Ensley, where he observed a police officer and an unknown individual in the parking area of this bank building. He stated the man with the policeman had a rifle, which he apparently assembled, and he noticed that this rifle had a small scope about six inches in length. He noticed that this individual, whom he described as a white male, approximately 6' in height, wearing civilian clothes, medium weight, was demonstrating this rifle to this police officer. He said this rifle had a very shiny surface which looked like it was chrome-plated on the bottom of the receiver. He said this demonstration and handling of the rifle was in public view and anyone passing that area could have viewed the two men as they were examining this rifle.

HADDON stated the rifle was similar length as a carbine but did not appear to be a carbine. He advised the stock and form appeared to be large in size and was not similar to a pump action rifle.

He stated he was furnishing this information in view of the assassination of MARTIN LUTHER KING for any possible connection, as he did not know the type rifle that was used in the shooting. He stated that the policeman was standing in the parking area and might have been on duty at the bank, as this occurred on a Tuesday, either 3/5/68 or 3/12/68, and the bank on this day stays open until 6:00 p.m. He stated the barrel of this rifle was not blue in color but was more a gray color, although it did not appear to be a similar type finish as an Army carbine. He stated part of the bottom of the rifle was very shiny metal as it glittered in the sun, and the length of this shiny metal appeared to be fifteen or sixteen inches in length. He said he was never close enough to give an accurate description of the rifle.

In view of the date this occurred and description furnished of the gun, it does not appear that this gun could possibly have been connected with the weapon used in the shooting of MARTIN LUTHER KING, JR.

On the afternoon of 4/11/68, Mr. HUGH EGERTON, Postal Inspector, Birmingham, was further contacted by SA ANDREW M. SMITH concerning checks Mr. EGERTON is making at the request of the Birmingham Office. Mr. EGERTON was requested to furnish any information available as to a package mailed to ERIC GALT at 2608 Highland Avenue, South, Birmingham, during Sept., 1967, from Chicago. He was also advised that this package had been received at 2608 Highland Avenue, South, and returned to the sender. Mr. EGERTON was further requested to furnish any information available concerning a letter addressed to ERIC GALT, 2608 Highland Avenue, South, about 3 or 4 weeks ago and returned marked "Not here." It was understood that this was 3rd class mail.

Mr. EGERTON stated that with regard to the letter, ordinarily 3rd class mail, unless return postage was guaranteed, is destroyed immediately if not delivered. He said he had determined the Carrier's Route Book contained a notation as to GALT as of 10/28/67, "Moved, left no address." Under postal regulations, on the basis of this notation, the carrier would return all first class mail to the sender and other mail, where postage is guaranteed, would be returned to the sender. Mr. EGERTON desired to know whether there was any money paid on the package referred to above, and he was subsequently advised there was no money paid, that the package was received one day and the next day GALT made the statement that the merchandise was not what he wanted and that he was returning it to the sender.

Mr. EGERTON said he would begin a search of postal records in an effort to obtain information concerning the package.
