As of interest in connection with the investigation of ERIC S. GALT, I am attaching the following documents from our investigative file on "The Local Swinger", a correspondence club operating from P. O. Box 3802, Downey, Calif. 90242:

- (a) Copy of typewritten letter dated February 17, 1968, signed "Eric S. Galt" and directed via "The Local Swinger" to one Patricia K. Anderson, 2800 Glenview Avenue, Los Angeles.
- (b) Copy of Polaroid photograph of a subject purporting to be Eric S. Galt which was transmitted with the original of the letter cited in (a).

The letter and photograph were furnished to this Service by Patricia K. Anderson, who considered the letter objectionable, for our use in investigating "The Local Swinger" as a suspected medium through which obscene materials are transmitted and exchanged.


The address shown on (a) is the address of the St. Francis Hotel, which has been mentioned in press releases concerning Eric S. Galt. The telephone number shown on (a) is the desk telephone of the St. Francis Hotel. The Polaroid code number on the reverse of the photograph, of which (b) is a copy, indicates that the film was manufactured in August 1967.

Post Office Box 3802, Downey, was rented on January 31, 1968, by James O'Dowd, who supplied the business address 8115 East Imperial Highway and the telephone number 861-1926.

Our investigation of "The Local Swinger" is assigned to Inspector L. O. Poindexter, of our Los Angeles office, and it will be satisfactory to consult with him directly should any additional information concerning the enclosures be desired. Inspector Poindexter can be reached at 688-2161.

Date May 4, 1968

ANN L. MEYERS, 8115 East Imperial Highway, Downey, California, co-owner of The Local Swinger, along with JAMES E. O'DOWD, advised that the two began the operation in February 1968 for the purpose of mailing list of local swingers to those who desired such a list. She stated that they placed an advertisement in the Los Angeles Free Press, offering to send a list of local swingers to anyone who paid the price of \$1.00. In addition it was understood that for each letter sent to The Local Swinger, the sender would have to pay \$1.00.

MEYERS stated that about the middle of February 1968 they received a note from ERIC S. GALT, and also a dollar, and a request for a list of swingers. Shortly after they received what she believed were five letters being sent to five individuals who coded names appeared in their list. MEYERS stated that no record was kept of those who received these letters. She did recall that one PATRICIA SCHUBERT was the recipient of one such letter, but she did not know the other four. The \$5.00 for the five letters was in cash.

MEYERS viewed pictures of JAMES EARL RAY but stated that she had never seen RAY, or had never met the man who wrote under the name of ERIC S. GALT.

JAMES E. O'DOWD, 8115 East Imperial Highway, Downey, California, one of the co-owners of The Local Swinger, a correspondence club, stated that this club used Postoffice Box 3802, Downey, California for receipt of their mail.

O'DOWD stated that in about February 1968 he and ANN L. MEYERS started The Local Swinger by inserting an advertisement in the Los Angeles Free Press, offering to send a list of local swingers to anyone who sent in the amount of \$1.00. About the middle of February they received a note from ERIC S. GALT, along with \$1.00, asking for the list. Shortly thereafter they received five letters, along with \$5.00, these letters to be sent to individuals whose coded names appeared in The Local Swinger list. O'DOWD explained that each time a letter is sent on to another individual they charge \$1.00, and in this case he believed that five letters were sent. O'DOWD stated that they kept no records of the individuals who were to receive these letters, but he did recall that one was sent to PATRICIA SCHUBERT, and the other four to four other unknown individuals.

O'DOWD viewed photographs of JAMES EARL RAY but stated that he had never seen RAY, or had never met the man who wrote under the name of ERIC S. GALT.

O'DOWD reviewed his records and stated that he did not keep the note requesting that a list of swingers be sent to ERIC S. GALT, and he had no idea who GALT had contacted.

PATRICIA ANDERSON, 2800 Glenview Avenue, Los Angeles, California, advised that she first became aware of "The Local Swinger" when she received a letter dated February 17, 1968 from ERIC S. GALT which she considered obscene in content. She immediately turned this over to the Postoffice, as well as two others which she received from other persons.

PATRICIA ANDERSON stated that all communications to her came in her maiden name, PATRICIA SCHUBERT. She believes that her name might have been bought from a mailing list as she subscribes to magazines using this name. She has never subscribed to "The Local Swinger", has never written to pen pal clubs, or subscribed to "Los Angeles Free Press".

MRS. ANDERSON viewed a group of pictures of JAMES EARL RAY, but she stated that she never saw the man, nor did she ever try to communicate with GALT despite the fact that she received his phone number and address on the letter sent to her by GALT.

PATRICIA KATHLEEN ANDERSON stated that she was a secretary in the Claims Department, U.S. Fidelity & Casualty Company, Los Angeles, California, and resides with her aged mother and ill 54 year old brother at the residence. At the present time she is separated from her husband, LEE T. ANDERSON, 7942 East Hayne Place, Tuscon, Arizona.

In connection with the investigation of "The Local Swinger", Post Office Box 3802, Downey, California, a correspondence club, JAMES E. O'DOWD and ANN L. MEYERS, sponsors of the club advised on May 2, 1968 that they recall having sent a list of local swingers to ERIC S. GALT in February, 1968. They advised they had taken many of these names from the "Los Angeles Free Press", an avant garde newspaper. O'DOWD and MEYERS stated it has been their experience that many of these addresses are not accurate and some persons either send inaccurate addresses or send addresses of other individuals as a joke.

The following persons, identities supplied by O'DOWD and MEYERS, were contacted in an effort to determine if they had received any correspondence from ERIC S. GALT or JAMES EARL RAY. None of the following listed individuals recalled having received mail or contact through any media from ERIC S. GALT or JAMES EARL RAY. They all advised that he is unknown to them:

GENE TURNER, Accountant, employed by the Los Angeles "Free Press" at 938 North Fairfax, was interviewed at that address. He stated that the records of the "Free Press" indicate that a want ad was received in the "Free Press" office on January 30, 1968, from an individual identifying himself as ERIC S. GALT. Accompanying this advertisement was the sum of \$4.25. The records do not indicate in what form this money was received. The advertisement was made available by TURNER. It is typewritten, using red type in capital letters. It reads as follows:

"Single male Cauc. 36 yrs, 5-11, 170 lbs Digs Fr. Cult. desire's discreet meeting with passionate married female for mutual enjoyment, and/or female for swing session apt. furn. will ex. photo. Write ERIC S. 406 So. 2nd St. Alhambra, 91802."

Also in red typing below the above advertisement was a notation as follows:

"Return name and address, ERIC S. GALT. Same as above. Inclosed is M. O. for \$4.25, Run ad under 31 unit system. Thanks."

TURNER stated that this advertisement ran in the February 2-8, 1968, issue of the "Free Press." He stated that the address listed in the advertisement of 406 South Second Street, Alhambra, California, is an address of a mail forwarding service which is used quite frequently by persons placing advertisements in the "Free Press." TURNER made available copies of the February 2-8, 1968, issue of the "Free Press."

GALT requested mail received for him through HEDGPETH be forwarded to him at the St. Francis Hotel, 5533 Hollywood Boulevard, Los Angeles, California. HEDGPETH stated he had no record showing GALT ever having utilized this service.

NEIGHBORHOOD INVESTIGATION IN THE

The following investigation, in addition to that previously reported in this report, was conducted in the vicinity of the St. Francis Hotel, Los Angeles, California, in an effort to determine information regarding the associates of JAMES EARL RAY and his present whereabouts.

ALLAN O. THOMPSON, Manager, St. Francis Hotel 5533 Hollywood Boulevard, Los Angeles, California, was asked if there was a male Caucasian fitting the description of JAMES EARL RAY, also known as Eric Starvo Galt, in room 507. THOMPSON advised that there was no male occupant in that room. He said that this room has been occupied for several years, at least ten, by NAOMI MILNE, who is a Caucasian female employed as a nurse.

He said that this woman is allegedly from Australia. He said that she has few visitors.. She stated that he is well aware of the appearance of RAY, also known as Galt, and would notice him if he came into the hotel. He stated that no individual appearing like RAY has come into the hotel since RAY's departure on March 17, 1968.

JAMES E. MORRISON, Bartender, Rabbit's Foot Club, 5623 Hollywood Boulevard, Los Angeles, California, advised that he resides at 1911 Grace Avenue, Los Angeles, California. He was shown photographs of JAMES EARL RAY, and he advised this individual is identical with a customer who frequented the Rabbit's Foot Bar. He said that he recalled this individual because of his frequency as a customer at the bar. MORRISON stated that he became engaged in a political discussion with RAY concerning ROBERT F. KENNEDY and GEORGE WALLACE. He said that RAY became rather incensed and vehemently supported WALLACE. On one other occasion, MORRISON said that RAY had a discussion with a frequent female customer of the bar whose name was PAT GOODSELL. This discussion concerned Negroes and civil rights movement. MORRISON said that RAY became very involved in the argument and began dragging her towards the door saying, "I'll drop you off in Watts and we'll see how you like it there". MORRISON said that another customer who knew the girl, separated them. MORRISON said that subsequent to this event GOODSELL died through an overdose of some type of medicine. He said that she formerly resided at the Carlton Towers, an apartment complex, in the neighborhood. He described her as:

MORRISON said that RAY habitually drank vodka or screwdrivers. He said that he was a very quiet customer and it was unusual for him to become involved in an argument. MORRISON said that he believes he used the name "DOUG" while at the bar.

BO DEL MONTE, Bartender, Rabbit's Foot Club, 5623 Hollywood Boulevard, Los Angeles, California, advised that his home address is 1229 North Bronson, Los Angeles, California. He advised after observing photographs of JAMES EARL RAY, that RAY was identical to a customer who frequented the Rabbit's Foot Club, from approximately January until the middle of March 1968. He described RAY as wearing usually a dark suit, with a bow tie. He said that his appearance was that of a rural person from Alabama, who has just recently come to the "big city". He said that RAY wore his crew cut to long, or he was allowing his hair to grow.

DEL MONTE recalled the incident in which RAY became involved in a heated discussion with a Caucasian female and began dragging her towards the door of the bar saying, "I'll drop you off in Watts and we'll see how you like it there". DEL MONTE recalled that shortly after this incident a Negro patron of the Rabbit's Foot Club, and his date, were struck on the head by a rock or brick while in a nearby parking lot.

DEL MONTE acknowledge that RAY often spoke support for Governor WALLACE.

DEL MONTE said that RAY drank vodka straight or in screwdrivers. DEL MONTE said that RAY purchased a key for the key club, which is operated by the Rabbit's Foot Club. He stated that he believes RAY gave him the name "DOUG COLLINS", when he purchased his key. DEL MONTE said that the writing of this name was by himself, and RAY furnished no other information as to residence.

DONALD M. MURPHY, 1729 Huntley Drive, Los Angeles, California, was interviewed at "The Frolic Room", a cocktail lounge, owned and operated by him. He advised that he also owned both "Pampered Pup" walk-up eating stands located on North Western Avenue and Vine Street, Los Angeles, California, respectively. He advised that he leased this operation to CECIL PAYNE. He advised that this leasing operation is not a formalized agreement.

MURPHY was shown photographs of JAMES EARL RAY. He said that the individual portrayed is identical to a caucasian male that frequented the "Rabbit's Foot" bar and the "Sultan Room" at the St. Francis Hotel, a few months ago. MURPHY advised that he also saw this same individual at the "Pampered Pup" located at 1715 North Western Avenue. MURPHY said that he may have conversed with this individual on occasion during casual "bar chatter". He advised that if he did, he does not recall the nature of the conversation. MURPHY stated he does not recall the individual's name or any of his associates. He said that usually this individual was alone.

She said the individual portrayed is identical to a former occupant of the St. Francis Hotel. She stated that she collided with this individual a few months ago, when delivering a plate of biscuits to FLORENCE THOMPSON, who resides in room 424. She said that this individual appeared very concerned that he had injured her. DRUM said that she has no other knowledge of this individual or of his associates.

ALAN O. THOMPSON, Manager, St. Francis Hotel, advised that HARRY ELWOOD LUNSFORD, aka Woody, is known to him as a painter, who lived at the hotel for approximately one year. He advised that LUNSFORD worked intermittently at the St. Francis Hotel. THOMPSON said that LUNSFORD drinks alcoholic beverages excessively and frequently. He said in his opinion LUNSFORD has difficulty in recalling past events accurately. He advised "if LUNSFORD wasn't in a mental fog from turpentine fumes, he was from drinking". He said that LUNSFORD is sickly with a chronic stomach illness.

THOMPSON said the assistant manager at the St. Francis, who was fired in December, 1967, is, in fact, MARTIN GETZ. He advised that GETZ was hired by the hotel management on a temporary basis to administer the hotel operation during the absence of THOMPSON who was going to Oakland, California. He stated that GETZ's employment was terminated because of the return of THOMPSON to the St. Francis.

DAVID (LNU), as referred to by LUNSFORD, was identified by THOMPSON as DAVID P. BAILEY, Social Security Number [redacted] who formerly lived at 508 West Vines, Stowe, Pennsylvania and who provided a forwarding address as c/o R. N. BECK, 22 Belden Place, San Francisco, California, 94104. THOMPSON said that he does not recall the reason for the termination of BAILEY's employment at the St. Francis Hotel. BOB (LNU), as referred to by LUNSFORD, was identified by THOMPSON as being BOB EVANS. THOMPSON advised that EVANS resided at the hotel on an intermittent basis for approximately two years. He said that EVANS lived at the hotel during the time of LUNSFORD's residence but not during the time period of the residence of JAMES EARL RAY, aka Eric Starvo Galt.

The individual described by LUNSFORD as "a crippled old man who has lived at the hotel for approximately 15 years", could not be determined, in fact, by THOMPSON. He said there

are several elderly males residing at the hotel who are incapacitated for some reason or other. He advised that the individual best fitting this description is MURRY ROSENMAN. THOMPSON said ROSENMAN utilizes a cane and has lived at the hotel for approximately 15 years. He advised that any association between ROSENMAN and JAMES EARL RAY, aka Eric Starvo Galt, is unlikely.

THOMPSON, manager, St. Francis Hotel, 5533 Hollywood Boulevard, Los Angeles, California, advised that in his opinion, JAMES EARL RAY, also known as Eric Starvo Galt, frequently, perhaps generally, cooked his meals in his room at the St. Francis Hotel. He stated that this opinion is based upon the amount of food and the type of food left in the refrigerator at RAY's room in the St. Francis upon his departure and the residue left in and on the stove in his room.

FLORENCE THOMPSON, occupant, Room 424, St. Francis Hotel, 5533 Hollywood Boulevard, Los Angeles, California, was shown photographs of JAMES EARL RAY. After observing these photographs, she said that the individual portrayed was identical to a recent occupant of Room 403. She said that the photograph that she liked best was the one in which he was wearing sun glasses. She advised that the occupant of Room 403, ERIC GALT, habitually wore sun glasses. She also said that he was a neat dresser and normally wore dark suits.

THOMPSON said that she remembered JAMES EARL RAY, also known as Eric S. Galt, in that he always slammed the door to his room when entering or leaving. She said that she reported this to the desk of the St. Francis Hotel on one occasion. Because of his habit of slamming the door, she said she knew of his arrival and departure. She said he left the room about 7:30 AM and returned about 5:00 PM. She said because of this regularity, she believed him to be employed, but did not know of any specific employment.

THOMPSON said that she saw RAY with no male or female associates. She advised that she knew of him having no unusual habits. She remarked that must have eaten within his room, because of the frequency in which he carried groceries.

KATZWINKEL was then asked whether SUE HARRIS had ever made any obscene movies. She advised that one time HARRIS told her she had made a nude film with LOU. KATZWINKEL advised that LOU, whose last name she did not know, was one of several call-girls who worked for HARRIS.

According to KATZWINKEL, the film was made at HARRIS' apartment located on Orange Drive, in Hollywood, California and that LOU arranged the filming of it. It was at this same apartment that HARRIS was arrested by the Los Angeles Police Department for prostitution. LOU and some other girls were arrested along with her. KATZWINKEL stated she was very close to SUE HARRIS, and knows HARRIS kept records of all dates filled by herself, or by one of the girls working for her. She would not accept any dates from anyone unless they were known to her. These records contain the customer's name, which is always an alias; his description, phone number; residence; employment; the date the trick was turned; and how much money the customer paid. These records are kept in four books and on notebook paper. One book is a small address book, and another is a recipe book. These records are kept by HARRIS so as to give her an idea how much money has been earned and who her customers are.

In addition to the above KATZWINKEL advised she never made any obscene or nude films for HARRIS, nor did she believe that GINGER DAY ever did.
