# Memorandum

SUBJECT: MURKIN

Per conversation SA Williams.

On 4/18/68 Sgt. BILL PAYNE, Hickory, N.C. PD advised that RONNIE CHRISTENBURY had returned to Hickory and that he had been in company with JOHN POWELL. He said that Burke County authorities had been alerted to be on look out for POWELL for jumping court.

On 4/24/68 Mr. AVERY ERVIN, N.C. Probation Officer, Morganton, N.C. advised that POWELL had been with RONNIE CHRISTENBURY, and was reported back in the county. He said he had known POWELL for several years, had him on Probation and had observed him as Juvenile, knew his family and background, and that he could not be identical with or involved with subject RAY in this case.

On 4/24/68 Mr. HUGH HUTCHINS, Valdese, N.C. Police Department advised he is aware of POWELL'S status with regard to jumping court. He said POWELL is native to this city, has been here all the time since the police have had trouble with him regarding traffic violations, and is married to a local girl.

He said he does not resemble in any respect the photograph of subject RAY,

In view of determination that RAY is subject in this case, and true identity of POWELL is established, no further inquiry being made on POWELL.
