AEBY REPORTEDLY GAVE RAY THE IDEA OF ESCAPING IN A BREAD BOX FROM PENITENTIARY. AEBY AND RAY WERE TOGETHER RECEIVING BARBITUATES AND AMPHETAMINES. RAY WAS AWARE THAT SOME OF AEBY'S BROTHERS WERE INVOLVED IN NARCOTICS IN TEXAS. HE STATED ONE OF THE BROTHERS WAS ARRESTED IN DALLAS ON NARCOTICS CHARGE IN ABOUT SIXTYSIX. BELIEVED THIS BROTHER TO BE NAMED AUBREY AEBY. GUINAN STATED NEAL AEBY IS PRESENTLY ON STREETS AS HE RECEIVED POSTCARD FROM HIM TWO WEEKS AGO MAILED IN OKLAHOMA CITY, OKLA. GUINAN SAID HAD NO IDEA WHERE RAY MIGHT GO. HE LIKED BENNIES AND AMPHETAMINES AND COULD POSSIBLY CONTACT SOME OF THE AEBYS IN TEXAS. HE ALSO REMEMBERED RAY SPEAKING OF A BROTHER IN CHICAGO, ILL., WHO OWNED A BAR AND OF THE FACT HE WOULD LIKE TO GO TO CHICAGO ON RELEASE AND WORK AS BARTENDER FOR HIS BROTHER.

AEBY FURTHER STATED THAT IN SIXTYTHREE OR SIXTYFOUR RAY HAD A NERVOUS BREAKDOWN AT MISSOURI STATE PEN AND DEVELOPED A BAD STOMACH, WHICH RESULTED IN HIM NEEDING SPECIAL FOODS. AEBY ON NUMEROUS OCCASIONS WOULD COOK EGGS FOR RAY WHICH RAY ADORED, SO THAT HE WOULD NOT HAVE TO EAT THE PRISON FARE. HE STATED ALSO THAT WHILE IN MISSOURI STATE PEN, RAY QUIT SMOKING POSSIBLY, BECAUSE OF HIS BAD STOMACH. HE STATED ALSO THAT RAY LIKED TO TINKER WITH MECHANICAL THINGS AND ADVISED RAY EVEN BUILT AN AIR CONDITIONER OUT OF SPARE PARTS FOR HIS JAIL CELL AND ALSO LIKED TO REPAIR RADIOS, PARTS FOR WHICH HE WOULD OBTAIN FROM THE MACHINE SHOP. SA MORRISSEY called at 4:40 PM and advised he had observed STEIN And LOMAX arrived on Continental Flight 50; no one met them at the plane, and after making a telephone call they got into Eds Cab, license NFW 246. No fisure conducted; however, SAs WEIR and STEINMEYER and WHATLEY taking up discreet positions in downtown area in attempt to observe cab leave freeway.

I then called GARY DELAUN and asked if he had heard anything and he advised he had not, however, he would call AINSWORTH and see. DELAUN called me back at 5:00 PM, stated AINSWORTH had called and stated above had arrived but had emphatically told AINSWORTH they did not want DELAUN along since there were too many people getting in on the deal and they want to sell the story to Life or a national publication. AINSWORTH stated he would keep DELAUN advised of developments.

*KPV* ~~KMILLER~~ called from the telephone company and advised that a further check on ~~the~~ security had contacted public relations and been told that HUGH AINSWORTH had contacted them, told them he was hoping to find out a telephone that RAY had used and wondered ~~if~~ he could have a call traced. He said he did not want the FBI told but after he got the numer he would then tell the FBI because the FBI would not tell him if they learned it first. MILLER had told public relations that under no circumstances should the information be given out since it was a violation of their rules.

I suggested if AINSWORTH does call with the number that ~~the~~ public relations take the number and tell him they would check after making a check of the toll calls. He said this would be done.

DELAUN ~~also thought that~~ AINSWORTH was now, 5:05 PM, going to meet LOMAX and STEIN at the Chronicle. This is being covered.
