

At 11:00 AM this date, JOHN FORD, Legal Attache's Office, Mexico City, telephonically advised regarding information furnished San Antonio by Deputy Sheriff ANGEL STICKE GAULT regarding passengers on bus which left Nuevo Laredo on 4/6/68 that investigation thus far has developed that the bus company involved is called the Transportes Del Norte and the bus which left Nuevo Laredo is number 362. In Monterrey the passengers transferred to bus number 359 of the same company.

As regards the identity of the individual described by GAULT, Legat's Office has determined that the best possible suspect is one GRAHAM ROBERT SMITH, single, 22 years old, student, British passport from Houston, Texas. This information was obtained through tour records.

FORD advised that SMITH was seated one-half of the way back in the bus on the left side and the source (GAULT) was in the front of the bus on the right side. The source advised that suspect was alone and was somewhat nervous and read the Reader's Digest while on the trip. Source stated that suspect did not talk to anyone during the trip.

Source also advised that suspect got off at San Luis Potosi, which is a capital of a state in Mexico by the same name. This town is located west and south of Monterrey.

On 4/23/68 BRYAN CLARK, National Auto Theft Bureau (NATB), Dallas, Texas, advised SA MANNING CLEMENS of the Dallas Office that a check of his records reflects that no cars have been recovered in Texas since 4-4-68 which were stolen at Georgia which were insured by the insurance companies supporting NATB.

The 26 files of the San Antonio Division in which San Antonio is origin and which have been opened since 4/4/68 were reviewed with negative results concerning cars recovered which were stolen in Georgia with the following exception:
