

The following investigation was conducted by SA Carlos L. Kirby Jr. and SA B. Perkowski, Jr. at Galveston, Texas on 5/3/68:

Efforts were made to contact some-one at SH 4-5948 with negative results. The Galveston Criss-Cross, telephone and city directories listed no W.A. WDWARDS or SH 4-5948.

J.W. WILSON, Manager, Southwestern Bell Telephone Co. (PROTECT IDENTITY) advised SH 4-5948 listed to WILLIAM A. EDWARDS, 1702 - 64th. St., Galveston, who is employed as a geologist at U.S. Army Corps of Engineers, Galveston.

MR. WILLIAM A, EDWARDS, 1702 = 64th. Street, advised MARVIN HAGEDORN has occupied a room at their residence since about February, 1968. He stated HAGEDORN is employed as a engineer by General Management Corporation, 61st. and Broadway, Galveston. He stated his wife was suspicious of HAGEDORN. He stated in his opinion there is negesemblence between JAMES EARL RAY and HAGEDORN.

MRS. WILLIAM A. EDWARDS, 1702 - 64th. Street, was exhibited a photograph of JAMES EARL RAY and she stated RAY is definitely not identical to MARVIN HAGEDORN.

Management Corporation, 61st. and Broadway, advised MARVIN HAGEDORN has been employed as an engineer here since the latter part of February, 1968, and from latter part of February, 1968 to present date with exception at from 4/11/68 to 4/24/68 HAGEDORN has been on the job here six days a week, Monday through Saturday. He stated HAGEDORN was working on the job here on 4/4/68. He stated HAGEDORN is from Iowa and prior to his employment here was engaged in the contracting business in Iowa. PUCKETT was exhibited a photograph of JAMES EARL RAY and he stated HAGEDORN is definitely not identical to RAY.

GILBERT was exhibited a photograph of JAMES EARL RAY and he stated MARVIN HAGEDORN is definitely not identical to RAY.
