



She is presently operating as THERISA BROWN, 1548 B Street, telephone 358-9216, Sparks, Nevada, which is close to Reno, Nevada. She related the following story.

One day during the first ten days of April, 1968, a man came to her establishment at Sparks, Nevada. She gave him a reading for which he made a voluntary payment of \$150.00. His responses were such that she knew he previously had readings. While saying prayers for him, she placed her hands on the man and was certain he was wearing a money belt. She told him that

he was going to take a long trip, and he responded that it was true because he did intend to take a long trip. Another statement made by Mrs. BROWN was not clear. She claimed that the man said he had a hotel in San Francisco. He might have meant merely that he had a room at a hotel, or he might have meant that he owned a hotel.

According to informant, Mrs. BROWN continued her story by saying that about three or four days following the reading, she saw on television a picture of the person who allegedly shot MARTIN LUTHER KING, and Mrs. BROWN said she was positive that the man to whom she gave a reading was definitely identical with the man pictured on television.

Informant stated it is possible that Mrs. BROWN made up the whole story, which is common among gypsies, but if the story is true, informant is certain that Mrs. BROWN's identification of the picture was accurate because gypsies are exceptionally good at remembering faces when they want to remember.

Informant cautioned that if a direct approach is used for a contact with Mrs. BROWN, she will act just like any gypsy and will deny everything. Informant suggested that contact be made under a pretext that a report was received that a man of a certain description was seen entering and leaving her establishment.

Informant is certain that if that or other suitable pretext is used, Mrs. BROWN will cooperate and definitely say whether or not the story is true, and if true, she will without a doubt furnish complete details.
