VON KOSS said that he has been in business at the 16010 Crenshaw address since approximately May 1966, and that a search of his immediate records led to no information concerning a client known as ERIC S. GALT. VON KOSS said that he had no recollection of this name nor was he able to fit the name with any of his former clients.

According to VON KOSS, many of his clients desire to remain anonymous and often appear only for one or two consultations desired to build their self-confidence and endow them with the powers of auto-hypnotism. VON KOSS adviced that his home residence was 67 Beach Drive, Hermosa Beach, California, and that he has some minor business records at home which might reflect when and if GALT had ever been a client at the American Business Consultants. He advised that he would peruse these records, and if any material was located of assistance concerning GALT, such would be made available to the Los Angeles office of the FBI.

MARIE MARTIN, St. Francis Hotel, Room 201. 5533
Hollywood Boulevard, advised that she was nervous, excited, and confused during previous interviews. She stated she had been drinking excessively for an extended period of time prior to the previous interviews. She added that she was not intoxicated at the time of the interviews. She advised that subsequent to her prior interviews, she has reduced her intake of alcoholic beverages, and that her recollection of the events concerning her association with JAMES EARL RAY has improved.

She stated that she first met an individual who introduced himself as ERIC GALT, shortly after Thanksgiving of 1967, in late November or early December. This meeting took place at the Sultan Room at the St. Francis Hotel, where MARTIN was working as a cocktail waitress. About 9:00 p.m. in the evening GALT was sitting at the bar, and he offered to buy MARTIN a drink. GALT bought MARTIN a drink and ordered straight Vodka for himself. MARTIN carried on her conversation with GALT while waiting on other customers. MARTIN said she asked GALT if he would drive her home. GALT asked her where she lived, and she said New Orleans. GALT consented and asked when MARTIN wanted to leave. MARTIN replied, "Right after work tonight." MARTIN said she then explained to GALT that MARTIN's cousin RITA STEIN had two children in New Orleans, and RITA wanted someone to take her to New Orleans and bring them to Los Angeles. RITA STEIN was sitting at the bar a few seats away. MARTIN called RITA STEIN over, and she joined the conversation. MARTIN said she told RITA that this was her chance to get her kids. MARTIN said she had to wait on customers and only heard parts of RITA's conversation with GALT. MARTIN said she told GALT that she would not be traveling with him to New Orleans. RITA asked GALT if he would take her brother. CHARLES STEIN, to New Orleans to pick up the children instead of herself. GALT said he would take CHARLES if MARTIN, RITA and CHARLES would register to vote and list the American Independent Party as their party preference. A short while later, CHARLES STEIN arrived at the Sultan Room. RITA, CHARLES and MARTIN

LA 44-1574 all agreed to register as requested by GALT. About midnight CHARLES and RITA left and GALT remained in the Sultan Room and continued to drink Vodka. GALT remarked to MARTIN that this arrangement had better not be a "set-up". He said if it was he had a gun and would "hurt" CHARLES. The interview was interrupted at this point when an individual, who identified himself as Dr. GERALD I. FREDKOFF. arrived to examine MARTIN. Upon completion of the examination FREDKOFF returned to the hotel corridor outside of MARTIN's room. He advised that MARTIN's physical condition did not preclude further interview. He stated he was treating MARTIN for "pink eye". Prior to the examination, MARTIN was very nervous and her hands trembled considerably. After the examination, MARTIN appeared less nervous and her hands had stopped trembling. FREDKOFF advised he could disclose no information which would violate the doctor-patient relationship. GALT left the Sultan Room sometime between midnight and 2:00 a.m. Sometime earlier in the evening, GALT told MARTIN that he was from Birmingham, Alabama. After she left work at 2:00 a.m., MARTIN said she believes she went over to the residence of CHARLES and RITA STEIN, however, the events are not clear as she had been drinking heavily. MARTIN said she believes, that at this time, CHARLES told her that GALT had offered to pay all expenses for the trip to New Orleans. MARTIN said that about 10:00 a.m. the following morning, RITA came to her room at the St. Francis Hotel to summon her to register to vote. RITA and MARTIN met GALT and CHARLES in front of the St. Francis H tel. GALT had his car which was a Mustang. MARTIN said she knows it was a Mustang because she previously owned a forest-green Mustang and remarked about this fact to GALT. MARTIN said she cannot recall the color of GALT's automobile. MARTIN advised that the only time she was in GALT's car was the time he drove her and CHARLES and RITA STEIN to the voter registration office. The voter registration office was located on or near Lankershim Boulevard. MARTIN said that GALT, CHARLES STEIN, RITA STEIN, and herself all went into the voter registration office. MARTIN said her voter registration receipt has been subsequently misplaced. CHARLES and RITA also registered as requested by GALT. GALT sat in a chair nearby in the registration office and observed the registration. GALT conversed with no one in the registration office. MARTIN said GALT drove them back to - 2 -

the St. Francis Hotel after the registration, and at that time MARTIN gave GALT a box containing clothing, linens and other miscellaneous household articles to take to her mother at New Orleans. MARTIN said she planned to mail these items to her mother, LORRAINE CALLAWAY, 611 Bartholomew Street. New Orleans, however, when she learned GALT would make the trip to New Orleans, she asked him to take the box. GALT took the clothing and left the hotel with RITA and CHARLES.

About seven to nine days later, MARTIN said she saw GALT again in front of the St. Francis Hotel for the first time since his return from New Orleans. GALT asked MARTIN why she had not been to work, and MARTIN told him she had been sick. GALT asked MARTIN if she was short of money, and before she could reply, GALT pressed a \$20.00 bill into her hand and went into the Sultan Room. Later that evening in the Sultan Room, GALT related an incident which occurred on the trip somewhere in Arizona. The Mustang went into a skid and the bumper caught on some barbed wire from a fence, which stopped the skid. GALT told MARTIN that he stayed at some friend's house at New Orleans while on the trip. questioned GALT about where the friend's house was in New Orleans, and GALT said it was near the Chef Menteur Highway. GALT dropped CHARLES off at his sister's home in New Orleans. CHARLES' sister is MARIA STEIN, address unknown.

After his return from the New Orleans trip, GALT was a regular customer at the Sultan Room. She said departed Los Angeles sometime after he completed Bartender's School in March, 1968. On the day GALT left, he came to MARTIN's room at the St. Francis Hotel and offered to trade television sets. MARTIN traded her General Electric portable television to GALT for his Air console model television set. GALT also left \$20.00 on the table as part of the trade. said he wanted a portable set because it was easier to take along in his car on his trip South. MARTIN asked GALT if he would drop off another package in New Orleans for her, and he agreed. MARTIN gave GALT a box of phonograph records to drop off at the home of her mother, LORRAINE CALLAWAY in New Orleans. After GALT departed with the television set he returned and knocked on MARTIN's door again. MARTIN said she was in bed and asked what he wanted. GALT said he wanted to leave some weights with her to keep for him. MARTIN told GALT to leave


it outside of her door, and she would take it in later. short while later, the desk clerk at the St. Francis Hotel called her and directed her to remove barbells from the MARTIN said she brought the barbells into her room and stored it in the closet. MARTIN released the barbells to the interviewing agents. MARTIN said this was the last occasion on which she had contact with GALT. GALT mentioned no one who would accompany him on this trip. MARTIN advised that she has since contacted her mother and learned that GALT was at her home to deliver the box of phonograph records. She said that her mother was not home, and GALT left the records at the home of MARTIN's sister, THERESA. who also lives in New Orleans. MARTIN claimed not to know the last name of her sister THERESA, who was recently married. She declined to furnish the address of THERESA in New Orleans, but stated contact with THERESA could be arranged through her mother, LORRAINE CALLAWAY.

MARTIN advised that GALT related that one time while driving through a Negro section of Los Angeles, tomatoes and other objects were thrown at his car, which he attributed to his Alabama license plates on the Mustang. When MARTIN asked GALT if he was ever married, GALT did not reply. She said, that from his expression, he implied that he had been married. MARTIN advised that to her knowledge, GALT never had a girl friend at Los Angeles. She said that on one occasion, when intoxicated GALT solicited a date from HELENA (LNU), an older belly dancer of Greek descent, who has worked at the Seven Veils. HELENA declined. MARTIN said that on one other occasion GALT went dancing once with HELEN (LNU) who professed to be a horse stunt rider on the television program "Gunsmoke". She described HELEN as a Caucasian female, 5'6", 170 pounds.

MARTIN was asked if she knew a "JERI" or "DARRELL" who allegedly went on dates with GALT. She said that she knew a DARRELL (LNU) slightly. MARTIN said she believed DARRELL to be a lesbian-prostitute. She said an elderly man with a crippled leg pimped for her. MARTIN described DARRELL (LNU) as a Caucasian female, 5'2", 130 pounds, blue eyes and blonde hair.

MARTIN said that she had no intimate relations with GALT. She said that she had been arrested twice: once for

performing a lewd dance in a public place, and once for possession of marijuana. She acknowledged having used marijuana but not within the past few years.

Miss SUSAN CAMBIGUE, Associate Dance Instructor, Jeri Salkin Studio and Center for Child Study, 3221 De Witt Drive, was contacted at her place of employment, and after being advised of the identity of the interviewing agents, she was interviewed regarding the previous occupants of 3340 Floyd Terrace, which is located directly across an alley from the dance studio.

Miss CAMBIGUE advised that she really did not know too much about the people who had resided at 3340 Floyd Terrace, and the little she did know had been told to her by Mrs. JERI SALKIN, the owner of the dance studio. She advised that SALKIN was not in at the present time, but would return at about 12:00 p.m.

When asked if she had ever observed a white Ford Mustans parked in front of, or anywhere near, 3340 Floyd Terrace, Miss CAMBRIGUE advised she could not really recall ever having seen such an automobile parked at that address. She did state SALKIN might know something about such a car, or the people who lived at that address, because she talked with a woman who lived there, on several occasions.

Lieutenant T.J. After reviewing his records, Lieutenant CORNWALL made available one copy each of the LAPD Death Report, DR 55-05315, dated September 1, 1960; Vehicle Report, DR-0315'6, dated April 23, 1967.

The Vehicle Report pertains to a complaint filed by RITA ROSAS, which alleges the theft of her 1903 Volkswagen by EDWARD WYATT. Lieutenant CORNWALL advised a warrant is outstanding for WYATT's arrest, based upon this complaint.



Mrs. ALICE PRESBER, 444 Monterey, Laguna Beach, California, phone 497-1179, advised she is a registered nurse "not a nervous old woman". She said that prior to the assassination of MARTIN LUTHER KING on April 4, 1968, ERIC E. WINTER, 444 Plum Lane, Orange, California, had left the California area for an extended trip. At the time of the assassination WINTER was in the area of the southern states of the United States including Florida and Louisiana. She said this trip and the information thereof occurred prior to the release of ERIC STARVO GALT. She said the photographs of GALT which have been publicized are definitely not identical with WINTER.

She last saw WINTER during the last week of February 1968 at Laguna Beach, California, with his wife, MERIE WINTER. She has known the WINTERs for about five years. She believes they were married about 19 or 20 years ago. ERIC is about age 45 and his wife is in her early 60's. He is an alien from New Zealand and has been in the United States about 20 years. She said he is intelligent and studied to be a school teacher. However, she stated that he is very irrational in his behavior and "a racist" in regards to Negroes and Jews. She said he reportedly had used firearms in New Zealand and during World War II during which time he was a chauffeur and mechanic in the Army of New Zealand. She has no information or knowledge that he was involved in the assassination but she "had to tell someone about WINTER in the event he was involved".

In connection with his trip, she said at the time he was to commence this trip he had new clothes and luggage which was ususual for him. She believed the trip commenced about the weekend of March 2, 1962 or March 3, 1963. His wife requested Mrs. PRESBER on one occasion not to tell anyone he was on the trip and no real reason was given for this request. He evidentially never wrote to his wife during the trip. He was on this trip until about the early morning of April 8, 1968, when he returned to his residence in Orange, California. His wife has since said that he lost ten pounds while on this trip. The

Reportedly WINTER said that he intends to make \$3,000,000.00 this year and the purpose of the trip was to survey and check the business trend in the southern states regarding securities and financial analysis. Reportedly during the first week of the trip he visited friends from Dayton, Ohio, at an unknown location in Florida. Mrs. WINTER also has a sister, name unknown, near Clearwater, Florida. During his trip his wife mentioned that he had called her from Louisiana. There was also an indication that he might go to the Bahamas during his trip. She said she did not know where Mr. WINTER was on April 4, 1968, but she had no information specifically that he had been in Memphis, Tennessee, Atlanta, Georgia, or Birmingham, Alabama.

She continued that it is her personal opinion that he is a "racist". She said he also dislikes police authority and all forms of authority and discipline which might occasion this discipline and authority to himself. On one occasion at Dana Point, California, pier three or four years ago she said he started acting and talking in an irrational ranting manner regarding Negroes "should be done away with" and that "the Jews crewd everyone off the freeway". She said that the United States was in the hands "of commies" and that "Negroes will be commies because of their leaders" which she interperted at the time as meaning MARTIN LUTHER KING and similar Negro individuals. WINTER called Mrs. PRESEER on April 5, 1968 regarding a social engagement. During this time PRESBER mentioned the KING situation and Mrs. WINTER said she did not want to waste long distance telephone money talking about "a dirty nigger". She also mentioned at the time that Mr. WINTER would return home in a few days or so. Mr. WINTER has not been seen since he returned to California. said he is not an alcoholic and is obsessive in his own self-discipline. He is out nights attending school meetings, etc. She said that Mrs. WINTER does not his activities or finances although they are fairly well-to-do financially. Reportedly he lost a great deal of her money in the stock market. She also mentioned that there was some man in Albania who was connected with the United Nation forces after World War II. Mrs. WINTER reportedly met Mr. WINTER when they were both in Albania at that time. Reportedly they helped this Albanian medical student, name unknown, to depart from Albania. This individual reportedly is now practicing medicine in some southern state. Mrs. WINTER was connected with UNESCO and Mr. WINTER was a photographer in the United Nations when they met.

She added that she did not know of any employment for Mr. WINTER. Reportedly the income of Mrs. WINTER is from taking care of retarded children of wealthy people at the WINTER residence. She presumed that Mr. WINTER is also probably connected with this employment there as well. She said she could not furnish any additional information regarding this situation.

Mrs. ALICE PRESBER, 444 Monterey, Laguna Beach, California, phone 497-1179, advised she is a registered nurse "not a nervous old woman". She said that prior to the assassination of MARTIN LUTHER KING on April 4, 1968, ERIC E. WIMTER, 444 Plum Lane, Orange, California, had left the California area for an extended trip. At the time of the assassination WINTER was in the area of the southern states of the United States including Florida and Louisiana. She said this trip and the information thereof occurred prior to the release of ERIC STARVO GALT. She said the photographs of GALT which have been publicized are definitely not identical with WINTER.

She last saw WINTER during the last week of February 1968 at Laguna Beach, California, with his wife, MERIE WINTER. She has known the WINTERs for about five years. She believes they were married about 19 or 20 years ago. ERIC is about age 45 and his wife is in her early 60's. He is an alien from New Zealand and has been in the United States about 20 years. She said he is intelligent and studied to be a school teacher. However, she stated that he is very irrational in his behavior and "a racist" in regards to Negroes and Jews. She said he reportedly had used firearms in New Zealand and during World War II during which time he was a chauffeur and mechanic in the Army of New Zealand. She has no information or knowledge that he was involved in the assassination but she "had to tell someone about WINTER in the event he was involved".

In connection with his trip, she said at the time he was to commence this trip he had new clothes and luggage which was ususual for him. She believed the trip commenced about the weekend of March 2, 1962 or March 9, 1968. His wife requested Mrs. rRESBER on one occasion not to tell anyone he was on the trip and no real reason was given for this request. He evidentially never wrote to his wife during the trip. He was on this trip until about the early morning of April 8, 1968, when he returned to his residence in Orange, California. His wife has since said that he lost ten pounds while on this trip. The

trip was made by car, a white Buick. Reportedly WINTER said that he intends to make \$3,000,000.00 this year and the purpose of the trip was to survey and check the business trend in the southern states regarding securities and financial analysis. Reportedly during the first week of the trip he visited friends from Dayton, Chio, at an unknown location in Florida. Mrs. WINTER also has a sister, name unknown, near Clearwater, Florida. During his trip his wife mentioned that he had called her from Louisiana. There was also an indication that he might go to the Bahamas during his trip. She said she did not know where Mr. WINTER was on April 4, 1968, but she had no information specifically that he had been in Memphis, Tennessee, Atlanta, Georgia, or Birmingham, Alabama.

She continued that it is her personal opinion that he is a "racist". She said he also dislikes police authority and all forms of authority and discipline which might occasion this discipline and authority to himself. On one occasion at Dana Point, California, pier three or four years ago she said he started acting and talking in an irrational ranting manner regarding Negroes "should be done away with" and that "the Jews crowd everyone off the freeway". She said that the United States was in the hands "of commies" and that "Negroes will be commies because of their leaders" which she interperted at the time as meaning MARTIN LUTHER KING and similar Negro individuals. Mrs. WINTER called Mrs. PRISEER on April 5, 1968 regarding a social engagement. During this time PRESBER mentioned the KING situation and Mrs. WINTER said she did not want to waste long distance telephone money talking about "a dirty niggor". She also mentioned at the time that Mr. WINTER would return home in a few days or so. Mr. WINTER has not been seen since he returned to California. She said he is not an alcoholic and is obsessive in his own self-discipline. He is cut nights attending school meetings, etc. She said that Mrs. WINTER does not his activities or finances although they are fairly well-to-do financially. Reportedly he lost a great deal of her money in the stock market. She also mentioned that there was some man in Albania who was connected with the United Nation forces after World War II. Mrs. WINTER reportedly met Mr. WINTER when they were both in Albania at that time. Reportedly they helped this Albanian medical student, name unknown, to depart from Albania. This individual reportedly is now practicing medicine in some southern state. Mrs. WINTER was connected with UNESCO and Mr. WILTER was a photographer in the United Nations when they met.

She added that she did not know of any employment for Mr. WINTER. Reportedly the income of Mrs. WINTER is from taking care of retarded children of wealthy people at the WINTER residence. She presumed that Mr. WINTER is also probably connected with this employment there as well. She said she could not furnish any additional information regarding this situation.

She furnished the following physical description of ERIC E. WINTER:

He stated RITA ROSAS (STEIN) and her husband, STANLEY ROSAS, moved into 3340 Floyd Terrace sometime in 1956. About six months later STANLEY died. At approximately the time of STANLEY's death, CHARLES STEIN moved into 3340 Floyd Terrace to live with RITA. Shortly after CHARLES moved in 3340 Floyd Terrace it became sathering place for a large number of "hippies". Sometime around late November or early December, 1967, RITA and CHARLES moved to an address on Franklin Street in Los Angeles. RITA's mother visited her on several occasions while she lived at Floyd Terrace and on one occasion complained that, "all RITA wants is to party." She expressed dissatisfaction with the way RITA was raising the In the late summer or early fall of 1067, RITA's mother took two of the children to New Orleans. Sometime between the departure of RITA's mother for New Crleans and Thanksgiving, 1967. WILKINSON said he observed a white Mustang with out of state license plates parked in front of 3340 Floyd Terrace. WILKINSON observed the white Mustang two or three times over a three week period WILKINSON said that RAYMOND "FIDO" MURPHY, a neighbor, had expressed the opinion that the occupants of 3340 Floyd Terrace were involved in illegal drug activity. Mrs. JERI SALKIN, Co-owner, Jeri Salkin Studio and Center for Child Study, 3221 De Witt Drive, was contacted at her place of business, and after being advised of the identity of the interviewing agents she was interviewed regarding her knowledge of the previous occupants of 3340 Floyd Terrace.

Mrs. SALKIN advised that she opened her place of business on May 21, 1967. Prior to that time the building which houses her studio was under construction, and on many occasions during that period she would visit the construction site. During that period, and up until the latter part of December 1967, the residence at 3340 Floyd Terrace was occupied by a woman whose first name is RITA, but whose last name SALKIN could not recall, RITA's children, and RITA's brother, whose name SALKIN recalled as CHARLES STEIN.

SALKIN advised there were a lot of persons coming and going from the Floyd Terrace residence during the time she was at the studio. She mentioned that her dance studio is located immediately across the alley from 3340 Floyd Terrace. She is normally at the studio from about 12:00 noon to 5:00 or 5:30 P.M. According to SALKIN, most of the people visiting the Floyd Terrace residence were "hippies" and generally not very well dressed.

When asked if she had ever observed a white Ford Mustang parked at the Floyd Terrace residence, SALKIN stated that she could not recall having seen a white Mustang there, although she has seen a black and a wine-colored Mustang. She advised she owns a yellow Mustang and probably would be able to recall if she had ever seen a white Mustang parked there.

SALKIN stated that for a period of about six months RITA's mother from New Orleans stayed at 3340 Floyd Terrace but later returned to New Orleans. Also for a short period, just after SALKIN opened her dance studio, there was a man living with RITA who apparently was RITA's husband.

DAVID RICHARD BROWN, after being advised of the identity of SA ROBERT C. MARTIN, JR., and being advised of his rights by SA MARTIN, was advised that SA MARTIN wished to interview him concerning statements made by him, in which he stated that he had murdered MARTIN LUTHER KING. furnished the following information during interview at the San Bernardino County Jail, Parstow, California, in the presence of Detective DON HARDY:

BROWN admised that while he was being booked at the 'ail' he had made the remark in jest with the 'ailer that he was the one who di it meaning that he was the one who had murdered KING. He stated that prior to making that remark, he had been talling with BROGDON and the 'ailer about whether the 'iller had been caught or not and had remarked that there was a large reward for the killer. He stated that BRODGON then said in 'est that he was going to turn he (BROWN) in, and he then remarked to the 'ailer that "I did it". He stated that he and BROGDON, together with BRADY and PEREZ, were all drinking and he has no reason to make any such remarks.

He stated that he has been with the people with whom he was arrested since about Wednesday. April 3. 1968. He stated that he was in Sacramento at that time, and met all the others on 2nd Street, where he was drinking. He stated that he was not with them all the time, but was with them two or three times a day until they all left Sacramento together on April 5. 1968 by freight, and went to Fresno. He stated that they all stayed together in Fresno until they left and came to Barstow where they were arrested. He stated that he has no knowledge of the murder of MARTIN LUTHER KING, and has not been out of California for at least four or five months.

During interview and through observation, the following description was obtained of BROWN:

RAYMOND M. MURPHY, 3341 Floyd Terrace, advised that he is also known as Fido. He stated RITA ROSAS (STEIN) and her husband, STANLEY ROSAS, moved to 3340 Floyd Terrace in the early part of 1966. Several months later, STANLEY died and CHARLES STEIN moved in with RITA. CHARLES is RITA's brother. About the time CHARLES moved, traffic in and out of 3340 Floyd Terrace increased tremendously, and at times as many as 40 or 50 "hippie" type individuals would visit the residence in one day, at all hours. MURPHY advised that around Thanksgiving, 1967, on five or six occasions, he observed a white Ford Mustang parked in the alley near 3340 Floyd Terrace. Also he observed the Mustang parked in front of that address on one occasion in mid December, 1967. MURPHY stated he observed both Alabama and California license plates on this same vehicle. RITA moved out of 3340 Floyd Terrace in approximately late November of 1967, but CHARLES continued to live there for a few more weeks even after the utilities had been turned off.

MURPHY advised that in the early Spring of 1966, he became suspicious of the activity at 3340 Floyd Terrace. He began noting license numbers which he turned over to Detective D. K. STEWART of the Hollywood Division, Los Angeles Police Department. He stopped noting the license numbers about a year ago and kept no personal record of these numbers.

One night about ten months ago, Los Angeles Police officers came and took a White male away in a police car. MURPHY observed the police officers were also questioning a Negro female at the time of this incident, but she was not taken into custody.

During the past year, MURPHY advised that on occasions he observed people leaving 3340 Floyd Terrace in a stupor. On one occasion, MURPHY observed CHARLES standing over and watching two young men laying on the ground in what appeared to be a stupor.

MURPHY said that shortly after Christmas, 1967, he met two plain clothes police officers on the street in front of 3340 Floyd Terrace. He said the police officers inquired

LA 44-1574 concerning the whereabouts of RITA. He said the police officers mentioned they were trying to locate her for the New Orleans Police Department, who had a warrant for child neglect. MURPHY said that one time between July 15, 1967 and August 20, 1967, his wife IRIS MURPHY observed RITA run across the street and place a package in the trash can located in an alley behind a dancing school at 3221 De Witt Drive. RITA returned to 3340 Floyd Terrace, and a short while later a car pulled up, the occupant alighted and picked up the package and drove away. On one occasion, MURPHY said he observed RITA making a telephone call from a public coin box telephone booth located in the liquor store parking lot at 3331 Barham Boulevard. MURPHY showed the interviewing agents the telephone booth. telephone located in this booth had telephone number 464-9831. The telephone booth inside walls had the name "MIMI" printed on it. Also written on the walls were telephone numbers 763-9131 and 831-2311. MURPHY said he was of the opinion that there was some type of illegal drug activity at 3340 Floyd Terrace while CHARLES and RITA lived there. MURPHY observed several photographs and picked out a photograph of JAMES EARL RAY taken at Bartending School. MURPHY said he observed this individual leaving the white Mustang on one occasion and he was wearing a bow tie at that time, similar to the one in the photograph. MURPHY advised he found an envelope in the front yard of 3340 Floyd Terrace a couple of weeks ago which apparently had been laying in the yard for sometime. He said the envelope apparently came apart from exposure to the weather. The envelope contained an Auditor-Controller's General Warrant Number C 5546672, payable to ELIZABETH DE ROUEN, 3340 Floyd Terrace, Los Angeles. The warrant was for \$86.00 and the date was flegible. The envelope was postmarked February 29, 1968. 2025 RELEASE UNDER E.O. 14176

MURPHY adviced be also found another envelope in the pari which apparently same apart due to exposure to weather conditions. This envelope contained a bill for professional services from the law offices of PAVIL CARUSO, 400 South Beverly Trive, Los Ingeles. The bill was for 2000 and was addressed to HORERT DENINNO, 2340 Floyd Terrace. The envelope was postmarked February 8, 106:. MURPHY turned over the envelopes and the contents to the interviewing agents.

OSCAR BARNES, 907 Arbutus, Compton, California, telephone NE 5-1468, advised that last week on April 23, 1968, he talked to a man at a service station located on the west side of Alameda Street, about 110th Street, Los Angeles, while a tire was being repaired. The name of this man is unknown but he is a dark complexioned Negro, about 63 or 64 years of The death of MARTIN LUTHER KING, JR. came up and this man said that his daughter knew where the killer was. man said that the killer is living on the sixth floor of the Beverly Hilton Hotel according to his daughter, who is a maid there on the seventh floor. This man at the service station said that the man at the hotel had six or seven types of wigs in order to disguise himself. The man said that his daughter had talked to a maid on the sixth floor and that was where the daughter got the information. The man said that the maids had looked at the suspect's picture in the papers and thought it resembled the man at the hotel. The man at the service station said that one ear extended outward. The man at the station was reporting information he had obtained from his daughter.

BARNES said he did not know if the man at the hotel was dressed as a woman but he was said to be dressed very nice.

On April 29, 1968, MILDRED THOMAS was interviewed at the Beverly Hilton Hotel, Beverly Hills, California, where she is employed as a maid on the sixth floor. She advised that there has been a man occupying Room 622 for at least two weeks, name unknown, who lives alone in the room. He has two pieces of luggage which he keeps locked. She has seen him wearing wigs and has seen him with black hair and sometimes brown hair. He sometimes does not respond to knocks on the door and seems to be in all day leaving only long enough for the room to be made up. She said he uses makeup judging from the towels and sink. She said she had seen him but did not know of others who had. She said that he has little clothing hanging up but may have other clothing in the luggage. He has a nice brown suit. He washes his own shirts, underwear, and socks. She did not know his name, his work, or whether he had a car.

She described the man as follows:
