ATTEMPT BEING MADE TO IDENTIFY LONG DISTANCE CALLS PLACED BY TENANTS OF ROOMING HOUSE WHERE GALT RESIDED THRU TENANTS.

NIGHT OF APRIL EIGHTEEN SIXTYEIGHT SOURCE TELEPHONICALLY ADVISED AFTER VIEWING TV NEWS BROADCASTS AND NEWS ARTICLES WITHOUT ANY HESITANCY THAT PERSON BEING SOUGHT IN KING MURDER WAS FORMERLY EMPLOYED AS TELEPHONE ADVERTISING SOLICITOR IN APRIL OR MAY NINETEEN SIXTYSEVEN, ATLANTA USING NAME OF JOHN WILLARD. SOURCE ADVISED TWENTY DOLLARS WAS FORWARDED TO JOHN WILLARD AT HIS ADDRESS IN UNKNOWN CITY LOCATED IN LOUISIANA.

THREE CITIES ARE PROMINENT IN SOURCES MIND AS TO WHERE FUNDS WERE SENT WHICH ARE LAKE CHARLES, SHREVEPORT OR MONROE, LOUISIANA. WILLARD DURING SAME PERIOD WAS MOON LIGHTING AS PARTTIME BARTENDER. SOURCE ADVISED WILLARD QUIT SALES JOB AFTER TWO WEEKS AND SUBMITTED APPLICATIONS TO SEVERAL BARS AND RESTAURANTS ATLANTA FOR EMPLOYMENT. SOURCE ADVISED WILLARD WAS RECOMMENDED FOR SUCCESSFUL PAST SALES PERFORMANCE IN SIMILIAR CAPACITY IN LOUISIANA. SOURCE CAN NOT RECALL WHO RECOMMENDED WILLARD BUT WILL ENDEAVOR TO LEARN IDENTITY AND ADVISE.

WILLARD DESCRIBED BY SOURCE AS POSSIBLY OF RURAL BACKGROUND WITH ACCENT OR DIALECT HE DESCRIBES AS POSSIBLY "CAJON". HIS AVOCATION IN LIFE APPEARED TO BE A BARTENDER. A FELLOW EMPLOYEE OF WILLARD IDENTIFIED AS FRAN MURRAY AND BELIEVED RESIDENT PARK HOTEL, ATLANTA, WAS LESBIAN AGE FIFTY DASH SIXTY. ONE THING MURRAY HAD IN COMMON WITH WILLARD WAS THEIR MUTUAL INTEREST IN DANCING. THEY WERE OBSERVED SHOWING EACH OTHER NEW DANCE STEPS.

WILLARD WAS DESCRIBED AS NEAT, PROMPT, NEVER OBSERVED WHEN HE HAD BEEN DRINKING, ALWAYS WORE COAT, WHITE SHIRT AND BOW TIES. WARDROBE WHILE NOT EXTENSIVE DESCRIBED AS CONSERVATIVE, GOOD QUALITY CLOTHES, EXPENSIVE SHOES AND IN GOOD TASTE. USUALLY CARRIED OR WORE LIGHT TAN TRENCH COAT OR RAIN COAT. NEVER KNOWN TO OWN CAR. BOW TIES WORN DURING PERIOD WERE EITHER RED OR BLACK.

WHILE EMPLOYED UNDER NAME OF JOHN WILLARD USED NAME OF "BILL" WILLARD AS TOO MANY OTHERS HAD GIVEN NAME OF JOHN IN OFFICE. WILLARD HAD EXCELLANT TELEPHONE SALES PITCH REFLECTING PREVIOUS LENGTHY EMPLOYMENT IN THIS FIELD.

ON ONE OCCASION WILLARD ARRIVED AT WORK UNSHAVE. WHILE SHAVING WITH ELECTRIC RAZOR COMMENTED OUT LOUD "MAN I'M STARVO". FELLOW EMPLOYEE OVER HEARD AND SAID YOU MEAN YOUR STARVING DON'T YOU. WILLARD SAID I MEAN STARVO IN MORE WAYS THAN ONE AS THAT'S ONE OF MY NAMES.

WILLARD REPORTEDLY STAYED JEFFERSON HOTEL, ATLANTA. CHECK OF RECORDS DURING PERIOD REFLECTS ONLY ONE PERSON REGISTERED FROM LOUISIANA UNDER NAME GLEN WARD, FOUR NINE ONE SIX JEFFERSON AVE., NEW ORLEANS, FOR APRIL SIXTEEN AND SEVENTEEN SIXTYSEVEN.

WILLARD DESCRIBED AS MANNERLY, A GENTLEMAN AND SOMEWHAT VAIN IN APPEARANCE OF HAIR. HAIR DESCRIBED AS MEDIUM BROWN WAVY AND LAYS CLOSE TO SCALP GIVING IMPRESSION OF SHORT OR CREW CUT HAIR. WILLARD CONSTANTLY CRAVING FOR MONEY. NEVER MENTIONED FAMILY, PREVIOUS MILITARY SERVICE OR OTHER PERSONAL HISTORY.

SOURCE ENDEAVORING TO DETERMINE WILLARD'S RESIDENCE IN LOUISIANA PRIOR TO COMING ATLANTA FROM RECORDS. THIS INFO WILL BE AVAILABLE APRIL TWENTY NEXT.

CARE MUST BE UTILIZED IN PROTECTING IDENTITY OF SOURCE WHO IS COOPERATING SOMEWHAT RELUCTANTLY BECAUSE OF POLITICAL CONNECTION'S AND RAMIFICATIONS IN ALABAMA.

ATTORNEY GENERAL RAMSEY CLARK ANNOUNCED TODAY THAT THE FBI HAS IDENTIFIED JAMES EARL RAY, AN ESCAPEE FROM THE MISSOURI STATE PENITENTIARY, AS ERIC STARVO GALT, AGAINST WHOM A FEDERAL COMPLAINT WAS FILED LAST WEDNESDAY IN CONNECTION WITH THE FATAL SHOOTING OF THE REVEREND DR. MARTIN LUTHER KING, JR.

DIRECTOR J. EDGAR HOOVER SAID THAT A SYSTEMATIC AND EXHAUSTIVE SEARCH OF LATENT FINGERPRINTS UNCOVERED IN THE DR. KING CASE AGAINST THE FINGERPRINTS OF THE OVER 53,000 PERSONS FROM WHOM "WANTED NOTICES" HAVE BEEN POSTED IN THE FILES OF THE FBI'S IDENTIFICATION DIVISION LED TO THE DETERMINATION THAT GALT AND RAY ARE IDENTICAL.

MR. HOOVER SAID THAT RAY, WHO IS 40 YEARS OF AGE, WAS REPORTED MISSING FROM THE MISSOURI STATE PENITENTIARY AT JEFFERSON CITY, MISSOURI, SINCE APRIL 23, 1967. HE HAD BEEN RECEIVED AT THAT INSTITUTION ON MARCH 17, 1960, TO SERVE A 20-YEAR SENTENCE FOLLOWING CONVICTION IN ST. LOUIS FOR ARMED ROBBERY AND FOR OPERATING A MOTOR VEHICLE WITHOUT PERMISSION OF THE OWNER.

IN SEPTEMBER, 1966, WHILE SERVING THIS SENTENCE, HE WAS CONFINED FOR A TIME IN THE MAXIMUM SECURITY WARD AT THE STATE HOSPITAL AT FULTON, MISSOURI.

ACCORDING TO MR. HOOVER, RAY HAS A KNOWN ARREST RECORD DATING BACK TO 1949. PRIOR TO THE 1960 CONVICTION FOR WHICH HE RECEIVED THE 20-YEAR TERM, RAY HAD BEEN CONVICTED OF BURGLARY IN LOS ANGELES, CALIFORNIA, IN 1949; ARMED ROBBERY IN CHICAGO, ILLINOIS, IN 1952; AND FORGING UNITED STATES POSTAL MONEY ORDERS IN MISSOURI IN 1955.

HE HAS SERVED TERMS IN THE LOS ANGELES COUNTY JAIL IN 1949; IN STATE PRISONS AT JOLIET AND PONTIAC, ILLINOIS, IN 1952-54; AND IN THE FEDERAL PENITENTIARY AT LEAVENWORTH, KANSAS, IN 1955-58.

RAY WAS AN ENLISTED MAN IN THE UNITED STATES ARMY FROM FEBRUARY, 1946, TO DECEMBER, 1948, AT WHICH TIME HE WAS GIVEN A GENERAL DISCHARGE DUE TO INEPTNESS AND LACK OF ADAPTABILITY FOR MILITARY SERVICE. WHILE IN THE ARMY, HE RECEIVED A THREE-MONTH SENTENCE AT HARD LABOR FOR BEING DRUNK AND BREAKING ARREST.

MR. HOOVER SAID THAT DURING HIS CRIMINAL CAREER, RAY HAS ALSO USED THE NAMES OF JAMES MCBRIDE, JAMES WALTON, W. C. HERRON AND JAMES O'CONNER. HE IS A WHITE MALE; CLAIMS TO HAVE

BEEN BORN [REDACTED] IN ILLINOIS; IS APPROXIMATELY 5 FEET 10 INCHES TALL AND WEIGHS ABOUT 163 TO 174 POUNDS. HE HAS BLUE EYES AND BROWN HAIR. THERE IS A SMALL SCAR ON THE CENTER OF HIS FOREHEAD AND A SCAR ON THE PALM OF HIS RIGHT HAND.

RAY HAS CLAIMED THAT HE ATTENDED SCHOOL THROUGH THE 10TH GRADE IN ALTON, ILLINOIS. HE HAS HAD THE REPUTATION OF BEING A "DRIFTER" SINCE LEAVING SCHOOL. HIS VOCATIONAL EXPERIENCE INCLUDES WORKING AS A BAKER, LABORER AND COLOR MATCHER.

IN CONNECTION WITH HIS ESCAPE FROM THE MISSOURI STATE PENITENTIARY, AN FBI COMPLAINT WAS FILED IN JEFFERSON CITY, MISSOURI, ON JULY 20, 1967, CHARGING RAY WITH UNLAWFULLY FLEEING FROM THE STATE OF MISSOURI TO AVOID CONFINEMENT. HE HAS BEEN A FEDERAL FUGITIVE SINCE THEN.

RAY SHOULD BE CONSIDERED ARMED AND EXTREMELY DANGEROUS. ANYONE HAVING INFORMATION CONCERNING HIM SHOULD IMMEDIATELY CONTACT FBI HEADQUARTERS IN WASHINGTON, D. C., OR THE NEAREST FBI OFFICE.
