Lt. ARKIN, Intelligence Division, Memphis PD, telephonically advised SA LOWE at approximately 6:05 p.m. this date that information had been received that Rev. MARTIN LUTHER KING had been shot. ARKIN had no details other than the fact that KING had reportedly been shot at the Lorraine Motel by a well dressed white male who ran south on Main Street.

On receipt of this news, I telephonically contacted Night Duty Supervisor McGUIRE, Division #5, at Seat of Government. I furnished him with the above information and told him I had no details as to the seriousness of the shooting and had only the Memphis PD information on which to inform him.

On receipt of this information, I dispatched SA TETEN to the Homicide Bureau to maintain liaison with Homicide. On receipt of subsequent information from Lt. ARKIN that Dr. KING had been transported to St. Joseph Hospital, I dispatched SA BOYLE and SA HESTER to determine the seriousness of the shooting of Dr. KING.


At approximately 6:35 p.m., Assistant to the Director DeLOACH called and advised as follows:

He said he had already notified the Director and the Attorney General of the reported shooting of Dr. KING. Mr. DeLOACH said we are to enter the investigation immediately and in the event any request for information is received from newspapers or other sources we are to advise that we are investigating at the specific request of the Attorney General.

In addition, Mr. DeLOACH said that the Memphis Office should have a teletype in no later than 6 a.m. tomorrow advising results of our investigation. In the event additional personnel are needed I should make my request specifically to him, regardless of whether it is Agent or clerical personnel.

I told him I felt I would need additional personnel but I would further evaluate the situation and inform him later.

At 6:48 PM, SA JOE C. HESTER telephonically advised that he had been in contact with Dr. FREDERICK JOAIA at St. Joseph Hospital. Dr. JOAIA advised SA HESTER that the shot was fatal and that Dr. KING was dead at the moment. Dr. JOAIA did not explain any further.

He advised that the wound appeared to be in the right side of the neck and went through the major vessels and into the spinal cord.

The above information was telephonically furnished to Supervisor GEORGE C. MOORE, Seat of Government, at approximately 6:51 p.m. I told him these were all the details we had and requested he advise Assistant to the Director DeLOACH and Assistant Director SULLIVAN.

Immediately upon receipt of information that MARTIN LUTHER KING, JR., had been shot at the Lorraine Motel, this Agent set up liaison contact with Homicide Contact was maintained at the Homicide Bureau Bureau. until relieved by another Agent at which time this Agent accompanied police photographer to scene of shooting. arrival it was determined that Identification Division, MPD, had already taken photographs both at the point where Dr. KING had fallen and at the point where it was believed the perpetrator had fired the shot which struck KING. This Agent noted at the time Identification Division of the MPD had dusted the second floor rear bathroom at 422½ South Main St., the location from which the fatal shot is believed to have been fired and also apartment 5B, the apartment which the perpetrator is believed to have rented earlier in the afternoon. Agent accompanied Inspector MC ADEN to an area between buildings at the rear of 422 ½ South Main where plaster casts were taken of 2 footprints which may or may not be significant in this case. After making plaster casts of the footprints, this Agent accompanied police photographer to St. Joseph Hospital and then to the morgue at John Gaston Hospital where photographs were taken of Dr. KING to show the area and extent of the wound.

On leaving it was noted that Dr. FRANCISCO was taking color photographs of the body. At the time this Agent was at the morgue, no post-mortem examination had been authorized and it is not known if authorization will be given by Dr. KING's family at this time. Any such authorization will probably be sought from Dr. KING's brother who is in town in Memphis and was apparently in town at the time of the shooting.

At 10:55 P.M., 4/4/68, Inspector GRADY TINES, Inspectional Bureau, Memphis PD, advised the writer that Lt. ELI H. ARKIN was on the phone and had information he wanted to furnish both to him, TINES, and the FBI. Lt. ARKIN telephonically advised that at 10:45 P.M. he and Captain JAY RAY of the Inspectional Bureau contacted a white female informant who advised them that possibly the man they were looking for was a Klansman from Coving-She further advised that this individual was ton, Tenn. back in Covington at 9:45 P.M. She added that he may be staying at the house of another Klansman in Covington which is located either on Maple St. or Sherrod. The only other information she furnished was that this individual was a young member, approximately 25 to 26 years of age, and not very active in the Klan.

This information was furnished to SA MAHLON J. PRICE, who advised that the address on Maple St. in Covington might possibly refer to CHARLIE HAMIL, a Klan officer and the operator of Charlie's Pit Bar-B-Q on Highway 51 in Covington. It was also suggested that SCOTTIE LARRY SARTAIN, Mefile 157-916, fits the brief description given by the informant. SARTAIN when interviewed by PRICE was belligerent, made remarks to the effect that MARTIN LUTHER KING, JR., should be shot, and that he would "kill a nigger" if the "nigger" messed with him.

It was determined 525-3535 is the telephone number of the Veterans Cab Co., located at 704 Vance Ave.

Inasmuch as there were reports of numerous fires and other disturbances in that area, it was not recommended by the Memphis PD to venture into this area after dark, especially on 4/4/68.



WILLIAM HAYES, 1006 Esplanade, Memphis, Tenn., telephone #947-1838, employed at Kellogg, Memphis, Tenn., furnished the following information telephonically to SA FITZPATRICK:

HAYES advised that at approximately 7:00 P.M. this date he heard a broadcast reporting the assassination of MARTIN LUTHER KING, JR. HAYES advised that at this time a Medic ambulance with a siren was behind him apparently on its way to an emergency at a very high rate of speed on Lamar Avenue near Airways. HAYES advised that the Medic ambulance went through a red light and appeared to be traveling at a very high rate of speed.

HAYES advised that when he approached Parkway and Willett streets, he noticed this Medic ambulance parked by the railroad track at this location. He noticed two white males, neatly dressed, sitting in the ambulance on the south side of Parkway next to the railroad.

HAYES advised that he thought this very suspicious in view of the fact that this Medic ambulance had gone through a red light and had seemed to be traveling at a very high rate of speed and yet just a few blocks away appeared to be sitting on the south side of Parkway with the light on.

HAYES advised he did not get any license plate number and described this vehicle as a white Cadillac with "Medic" on it and a red dome light on top.

At approximately 8:15 P.M., 4/4/68, an individual identifying herself as Mrs. QUEENIE GRIFFIN, 1980 Quinn, Memphis, Tenn., phone #274-4292, telephonically contacted the Memphis Division and advised she desired to furnish the following information as possibly having some bearing on the shooting of Dr. KING:

She advised that during Dr. KING's first visit to the Clayborn Temple, Memphis, Tenn., she overheard a conversation and observed the actions of 3 men which aroused her suspicions. She advised part of the conversation which aroused her suspicions was as follows:

"Just as easy to get him as for them to get KENNEDY."

"Where is LARRY? Did he get it?"

"He got one and it's working pretty good."

"He is out front."

"Better get out of it."

She advised that one of these individuals claimed to be a reporter and had a note pad pretending to be writing on it; however, she was able to observe the pad and observed there was no writing on it. She advised these individuals took 2 pictures of KING and then 2 of them left immediately, the third one remaining sometime thereafter. She advised she followed the individuals leaving and observed them enter a white car believed to be a 1963-64 Pontiac bearing license (Tennessee) AP-9623.

At 9:59 PM, April 4, 1968, an individual communicated with me, who refused to give his name and talked as though he was intoxicated. He began the conversation by stating that I was recording the telephone call and talked in an incoherent I informed the caller that if he had any information to furnish, I would be glad to receive it. He again began to talk in an incoherent manner and indicated he had the information I repeated that I would be glad to accept any information he had to furnish. He then started to talk irrationally, at which time I interrupted him and told him that if he didn't have anything to furnish, I didn't have further time to talk to him. The caller then stated the person we wanted has a 1956 Oldsmobile, blue and white, and commented, "You find it and you have it." I asked for names and why we should be interested in the Olds. His comment was, "He is the guy with the rifle at the Memphis Lounge."

I asked for the caller's name. His reply was, "You know where I am, I'm in the Tennessee Hotel. He commented, "Room 235" but someone in the room corrected him, stating they were in Room 325 of the Tennessee Hotel. I asked another question, however, the caller stated, "I'll be gone before you get here." He then caused the telephone connection to be disconnected.

Inspector N. E. ZACHARY, Homicide Division, Memphis PD, furnished the following information regarding two individuals apprehended by the Memphis PD immediately following the assassination of MARTIN LUTHER KING, JR.:

ZACHARY advised that at approximately 6:50 P.M., 4/4/68, police had a call on Second and Pontotoc and upon arriving at this scene observed two white males changing clothes in a garage. The police report further states that there is no reason for these individuals to be in the area and upon questioning they maintained that they were law students and civil rights workers. These individuals were arrested by Officers B. E. LIGHTFOOT and R. O. ARM-STEAD.

ZACHARY described the individuals from the police reports as follows:

Subsequent check of the current Memphis City Directory disclosed that telephone #525-3535 indicates that this number belongs to Veteran Taxi located at 704 Vance Ave., Memphis, Tenn.

On 4/4/68 Mr. NEEDEM MORGAN, Dispatcher, Veteran Taxi Co., 704 Vance Ave., home address 12 W. Biscayne, furnished the following information telephonically to SA FITZPATRICK:

MORGAN advised that an individual identifying himself as JAMES E. CANTRELL and spelling his last name as CANTRELL first called CHARLIE HANSON, an employee of Veteran who turned over this call to Mr. MORGAN at approximately 7:30 P.M., 4/4/68.

MORGAN advised that this individual again stated his name was JAMES E. CANTRELL and that he wanted to talk about giving himself up as he stated he was the man who shot KING. MORGAN advised that this individual said he was sorry that he did it and also stated that he was drinking. This individual told MORGAN that he was calling from a phone booth on Bellevue and McLemore and would call MORGAN back in approximately 5 minutes from his home address at 1117 E. McLemore.



At approximately 6:15 P.M. SA's JOE C. HESTER and ROBERT F. BOYLE were directed to the Emergency Room of St. Joseph Hospital by SAC ROBERT G. JENSEN for the purpose of determining the extent of injuries received by Rev. MARTIN LUTHER KING, JR., as a result of the shooting occurring at the Lorraine Motel.

At approximately 6:45 P.M. it was determined from 2 physicians, names of whom will be supplied later, that Dr. KING was dead. One of the physicians indicated that the bullet entered KING's body through the right side of the neck and severed the spinal cord in addition to other vast damage in the same area.

Upon furnishing this information to the SAC, I then proceeded to  $422\frac{1}{2}$  South Main St. where it was determined from Mrs. BESSIE RUTH BREWER, resident manager of the apartments located at that address, that the individual believed to be responsible for the shooting of Rev. KING registered at the rooming house in Room 5B between 3:00 and 3:30 P.M. on 4/4/68. This individual furnished the name of JOHN WILLARD and was not observed to have any luggage with him at the time he rented the room. Mrs. BREWER gave a vague description of this individual and does not believe she would be able to recognize him if she saw him in the future.

Mrs. BREWER stated that WILLARD paid for a week-s room rent with a \$20 bill and 2 quarters and that she gave him change in the denominations of one \$10 bill and two \$1 bills.

At approximately 10:15 PM the night of April 4, 1968, ME 338-R called the writer, SA WILLIAM H. LAWRENCE, and stated he hesitated to furnish the name of the following suspect but due to the nature of the crime felt constrained to do so. He explained that for several years he, Informant, has had a working relationship on various accident investigations with RENFRO TURNER HAYS. He explained that on April 3, 1968, HAYS came to Informant's office and knowing that informant was closely connected with the current racial strife in Memphis insisted on being informed as to the Memphis residence of MARTIN LUTHER KING, JR., which at the time was the Lorraine Motel, 406 Mulberry. Informant was busy and had no time to talk with HAYS, although HAYS talked at length with informant's wife.

HAYS has recently been driving a late model white automobile, make and model unknown, and was last known to be living in a little white clapboard house just east of North Watkins, one or two blocks south of Jackson Avenue (this would probably be Faxon or Tutwiler). He lives with an older woman who is his landlady and has a private room in the front of the house.

Informant recalled that HAYS is a schizophrenic and has been in and out of mental institutions in West Tennessee for

several years. While HAYS is not known to be anti-Negro, due to his mental quirks and due to the fact he has been a private detective for years, engaging in all types of nefarious and questionable schemes, informant feels that HAYS would be capable of an assassination either through personal compulsion or for hire. He stated that of particular significance is the fact that HAYS is an avid student of all facets surrounding the assassination of the late President JOHN F. KENNEDY, having read numerous books and writings relative thereto, and can espound for hours on all possible ramifications of that assassination.

A review of Memphis file 170-831 reveals that HAYS as recently as 1966 attempted to join the Haywood, Tennessee Klavern, United Klans of America, for pay, and it was ascertained in 1966, confidentially, from Attorney RUSSELL X. THOMPSON, currently law partner of former Memphis Mayor WILLIAM B. INGRAM, who had hired HAYS on behalf of the West Tennessee Voters Project to join the KKK, which at that time was aiming much of its harrassment activities against the Project people.

HAYS in 1966 did volunteer information to this office concerning this activity but due to his previous mental history, efforts were not made to develop him as an informant. At that time HAYS seemed to have a considerable knowledge of firearms and furnished some information to this office to this effect concerning possible guns owned allegedly by some of the Klan members in Haywood County.

Memphis file 170-831 discloses that HAYS was arrested on a peace warrant by the Shelby County Sheriff's Office, June 28, 1960, Shelby Co. SO #20198, FBI #805 239 B. At that time he was described as 6 ft. tall, weighed 185 lbs., born Crawfordsville, Arkansas, brown eyes, black hair, medium complexion.

He was arrested by the Memphis PD, September 5, 1950, Memphis PD# 48556, on a charge of threatened breach of peace. At that time he was described as 6 ft.  $\frac{1}{2}$ ", 191 lbs. His father is R. W. RENFRO (deceased); mother, CORA HAYS, Norman St., Memphis, Tenn. He has fingerprint classification:

Photographs of HAYS are in the 1-A section of 170-831, taken by the PD and SO, respectively.

In furnishing any of this information to the Memphis PD, all due caution is to be taken to protect the identity of informant.

The writer immediately furnished this information to SA CYRIL F. BUSCH, who was at the Homicide Bureau of the Memphis PD. SA BUSCH stated he would converse with Inspector N. E. ZACHARY or one of his men and check to determine whether or not HAYS has a private detective license which would give any up-to-date address or photograph.

BUSCH was also reminded, based on information from Informant, that HAYS has also done considerable investigative work for Memphis Attorney JEROME HUFFMAN, in the 100 North Main Building.



The writer also obtained fingerprints from BESSIE RUTH BREWER, who rented room 5B to the above individual. The prints were sent to Washington with Agent carrying evidence.

JESSIE ORR, Investigator, American Airlines, was contacted at the Memphis Airport on the evening of 4/4/68, and he advised American Airlines received a call from an individual using the name STOKELY CARMICHAEL at Dallas, Texas, and wanted to make reservations for flight from Dallas to Memphis that evening scheduled to arrive Memphis 10:50 p.m. He was to be accompanied by E. HOLBERT, W. JOHNSON and T. SMITH. ORR advised the airlines would not make these reservations, and he personally took this flight and CARMICHAEL was not on it.



JACK DUMPHY, Exhibits Section, Bureau headquarters, telephonically informed at approximately 3:55 PM, April 5, 1968 that GEORGE MUMFORD, JR. and HORACE J. HEFFNER are departing Washington, D. C. at 12:40 AM, April 6, 1968, via Delta Airlines enroute to Memphis. They will make an artist's conception of the UNSUB and also will make diagrams of the area in the vicinity of the Lorraine Motel.

To assist the above men, an Agent should obtain from the city of Memphis city plans of the area or a good scaled map of the area at the motel.

It was agreed that a room with twin beds would be reserved for MUMFORD and HEFFNER at the Sheraton-Peabody Hotel. It was further agreed that there might be difficulty in obtaining public transportation to the hotel and that these men would be met by an Agent.

NOTE:

Subsequent to above call, Memphis received another call to cancel the reservation for above agents inasmuch as plans were changed. SA's MUMFORD and HEFFNER are to proceed to Birmingham.

At 10:15 a.m., 4/5/68 Mr. JERRY D. STRINGER who identified himself as an attorney for the Veterans Administration, and who also advised he works out of his home which is located at 4594 Marigold Lane, Memphis, Tennessee, telephone 392-1356, appeared at the Memphis FBI Office. Mr. STRINGER advised that as soon as he heard of the assassination of MARTIN LUTHER KING on 4/4/68 one ROBERT McCAMPBELL, aka PHOOCIE, came to his mind as the possible assassin. He added that he felt this way as he believes McCAMPBELL is capable of such an act and further because McCAMPBELL has been active with the KKK in the past.

STRINGER advised that McCAMPBELL has asked him to represent him on approximately three occasions in the past when he, STRINGER, was practicing law, in connection with McCAMPBELL's arrest concerning KKK activities.

He continued by saying that one of these occasions was when McCAMPBELL was arrested by the Shelby County Sheriff's Office for distributing KKK literature.

He further advised that he grew up with McCAMPBELL in south Memphis, but has not actually seen him in person in two or three years. He added that he also felt that McCAMPBELL might be somewhat mentally deranged which added to his belief that McCAMPBELL possibly could be involved in the shooting of Rev. KING. STRINGER added that the description of McCAMPBELL closely resembles that of the assassin as furnished to the public via various news media.

Possible Suspect-Assassination

Inspector Zachary, MPD, telephonically contacted FBI Office, Memphis to advise that his Dept. has been unable to eliminate John Hubert W illard in the killing of Dr. King.

He advised that Willard had registered at the boarding house across street from motel where King killed and that he has attempted to contact the Sheriff of DeSoto County, Miss., re Willard w ith negative results. Zachary advised that he and Agent O. V. Johnson had attempted to eliminate Willand last night without success. The MPD has only one record on a John Willard w ho was arrested here about 10 years ago and turned over to Sherill of Ponotoc County, Miss., on an arson charge. Willard stated at that time he had family in Nesbitt, Miss., father—Enos, mother—Mamie, wife—Barbara. He had no response from Sheriff DeSoto County re this family and could possibly have moved. Agent Johnson called a cousin of his in DeSoto County but unable to determine if Willard family still residing there.

Insp. Zachary asked if the FBI could attempt to chech out Willard and possibly eliminate him. He also expressed the desire that cooperation with FBI and MPD in this matter.

On 4/5/68, at 8:20 a.m., Mr. JAMES W. HARRIS, who requested his name be kept in confidence, 5436 San Marcos Drive, Nashville, Tennessee, telephone 833-3866, the manager of group insurance for the Connecticut General Life Insurance Co., 1808 West End Building, Nashville, telephone 244-5334, telephonically contacted the Nashville RA and furnished the following information:

HARRIS advised he worked and traveled with WILL E. STAFFORD, with the Connecticut General Life Insurance Co., for approximately two years during 1944 and 1945. HARRIS stated that STAFFORD at that time was residing with his wife and daughter (approximately 4 years of age) on Milbranch Road, Whitehaven, Tennessee. STAFFORD was outspoken re his hatred of Negroes and Dr. KING and STAFFORD felt the Negroes were destroying our country. STAFFORD became extremely emotional and upset when discussing integration and American patriotism.

STAFFORD was supposed to have been a member of the White Citizens Council and the John Birch Society in Memphis and had a great admiration for HITLER. STAFFORD believed that "someone should do something" to resolve the problems encountered with the Negroes.

STAFFORD was encountering marital difficulties with his wife due to his personality and HARRIS advised he does not know whether or not STAFFORD had consulted a psychiatrist or had been in a mental institution. He stated he does not believe STAFFORD has a police record.

STAFFORD's wife, unknown to HARRIS, was a school teacher in Memphis. STAFFORD graduated from Memphis State University during the latter part of the 1950's and was originally from Milan, Tennessee.

During the early 1960's, STAFFORD taught school in Arizona and due to his radical ideas he was kicked out of the school.

HARRIS stated that he saw STAFFORD in Memphis approximately three months ago; however, the last time he engaged in conversation with STAFFORD was approximately a year ago in Memphis.

HARRIS does not know what kind of a vehicle STAFFORD owns. He stated he felt STAFFORD should be considered a suspect in the murder of Dr. KING due to the reasons set out herein.

HARRIS advised that his name should be kept strictly confidential and the FBI should contact him very discreetly to avoid anyone knowing he had furnished any information to the FBI as he would fear his safety should STAFFORD learn he had furnished this information to the FBI.

At 9:27 a.m., 4/5/68 Mr. CHARLES EPPS, JR., 1517 East McLemore, Memphis, Tennessee, telephone 276-6128, telephonically advised that he is a Postal Clerk at the Main Office, Memphis, Tennessee, and works the 6:00 p.m. to 2:00 a.m. shift.

On Wednesday, 4/3/68 at approximately 11:00 p.m. while he was putting up mail he overheard a conversation among three white clerks who were discussing the situation in Memphis regarding the sanitation strike. The three clerks are J. M. GRIFFIN, JOHN DEAL, and J. R. SCOTT.

Mr. EPPS stated that during this discussion among the above three individuals, he overheard J. M. GRIFFIN and JOHN DEAL both say that they would like to kill MARTIN LUTHER KING.

Mr. EPPS further advised he believes GRIFFIN is from Mississippi and is possibly a Klansman, as sometime ago he heard GRIFFIN ask another Postal Clerk if he was going to the KKK rally which was scheduled to be held at the Rainbow Terrace on Lamar in Memphis, Tennessee. He added that this was approximately a year or two ago.

At approximately 10:00 p.m., 4/4/68, an individual identifying himself as BARNEY DuBOIS, Commercial Appeal, telephonically contacted the Memphis Office and advised that JAMES CHERRY, Advertising Director for Memphis Publishing Company, had furnished him the following information:

For the past 3-4 days, FRANK FLANIGAN, 1331 National, Memphis, Tenn., described as a WMA, age 50, 5'8", 180 pounds, stocky build, slightly bald, had persistently attempted to place an ad in the Commercial Appeal decrying KING's visit to Memphis. In the ad he intended to call KING a Communist.

When the ad was refused, FLANIGAN became bitter and stated he would picket the newspaper. FLANIGAN reportedly stated: "You are mistaken to take up for the Negroes'.

A check of the Memphis City Directory disclosed a listing for FRANK FLANIGAN, 1331 National Street, wife ANNA, employed Memphis Paving Company.

A review of the Memphis indices disclosed previous identical references including Memphis file 100-4098 and 62-0-11075.

In view of the fact that FLANIGAN'S description does not set the description of UNSUB in the shooting of Dr. KING and further in view of the information set forth from previous contacts concerning FLANIGAN'S "obsession", it is not felt this information warrants investigation or further action.

At 9:04 am, 4/6/68, MRS. FRANK LOHMEYER, 3023 Laurence Road, Memphis. Tennessee, called and furnished the following information to SA VAHRENWALD:

MRS. LOHMEYER was at the Voque Laundry-Cleaners, 2615 Overton Crossing Road, Memphis, Tennessee during the afternoon and early evening of 4/4/68. About 6:25pm on that date, a suspicious looking man came into the laundry to use the telephone. the laundry for approximately 15 manutes during which time he seemed to be using the telephone but also seemed to be listening to the comments of the people in the laundry concerning the assassination of DR. KING, which had justoccurred. While he was in the laundry, the man came over to MRS. LOHMEYER and asked her how he could get the information operator. She instructed him to dial 113, butshe considered his actions to be of a suspicious nature. She walked over by the telephone in an attempt to hear what the man was saying, but he spoke in low tones so she could not hear anything that was said.
