Mr. EARL ROGERS, Rogers Laundry, 1401 Paulsen, advised that this code was issued between 2/16/68 and 2/23/68 and that his duplicate of the laundry marking was returned to the customer on the customer's copy of this laundry bill. He stated that the "20" indicates lot 20, and that the "2" specifies the particular customer. He stated that the "R" is used for 12 loads of laundry and then changed to a new letter. He advised that he has one Thermo-Seal laundry marking machine which uses yellow tags. He stated that the color yellow has no particular significance in his operation.

It is requested that FBI Laboratory compare the enclosed laundry markings with the laundry markings located on clothes believed to belong to the subject.
