On the afternoon of May 24, 1968, you furnished me with information related from the Bureau with regard to an alleged connection between MURKIN subject JAMES EARL RAY and his possible involvement in the robbery of the Bank of Alton on July 13, 1967.

In discussion with SA JOSEPH DOBSON, SL office, it was determined that the informant was believed by interviewing agents in St. Louis to be a chronic liar and, therefore, I displayed clothing and the shotgun recovered three weeks subsequent to the robbery of the Bank of Alton to witnesses at the bank on Monday, May 27, 1968, which was the first opportunity I had to talk with employees since the bank was closed when the initial information was received on Friday.

Because of the implications involved connected RAY to the robbery of the Bank of Alton and because the physical evidence recovered three weeks subsequent to the bank robbery has never been definitely established as being utilized in the robbery of the Bank of Alton, I wished to be on firm ground in submitting the evidence for comparison insofar as at least a tentative identification by witnesses was concerned.

After recontacting witnesses, the evidence was transported to Springfield and appropriate communication was dictated on May 28, 1968 submitting the evidence to the Laboratory and setting out leads for the Memphis and St. Louis Divisions.




