 SPEECH OF MR. ROBERT F. KENNEDY AT CHULA VISTA, CALIFORNIA  
 INSTANT DATE, WAS APPROACHED BY A MAN WHO RESEMBLED JAMES  
EARL RAY. THIS INDIVIDUAL ASKED KEITH WHERE AND WHEN KENNEDY  
 WAS GOING TO SPEAK AGAIN. KEITH TOLD THIS INDIVIDUAL THAT HE  
 DID NOT KNOW. THIS INDIVIDUAL THEN ASKED HIM WHERE THERE  
 WAS A PLACE HE COULD EAT THAT HAD A TELEPHONE.

FOR INFORMATION, CONSIDERABLE PUBLICITY HAS BEEN  
 GIVEN TO JAMES EARL RAY IN LOCAL CHULA VISTA NEWSPAPER OVER  
 PAST WEEKEND. AS RESULT OF PUBLICITY, NUMEROUS CALLS OF  
 LOOK-A-LIKES HAVE BEEN RECEIVED, WITH NEGATIVE RESULTS.
