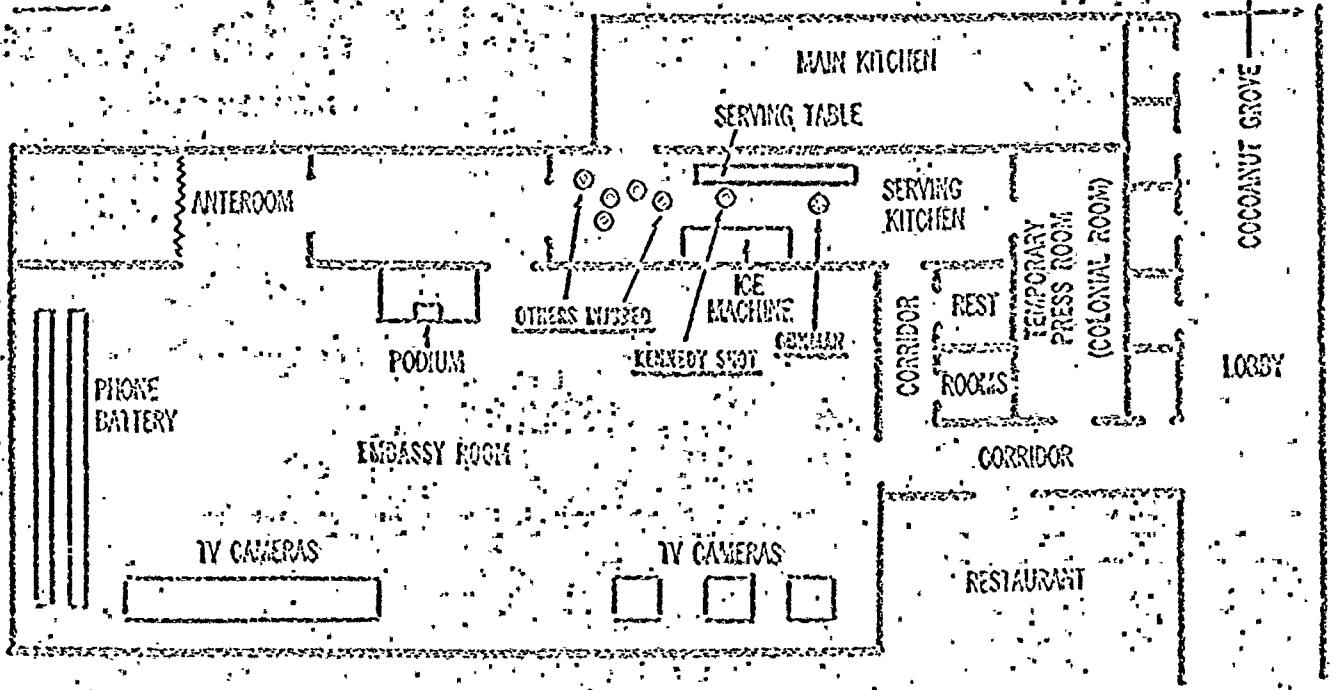


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

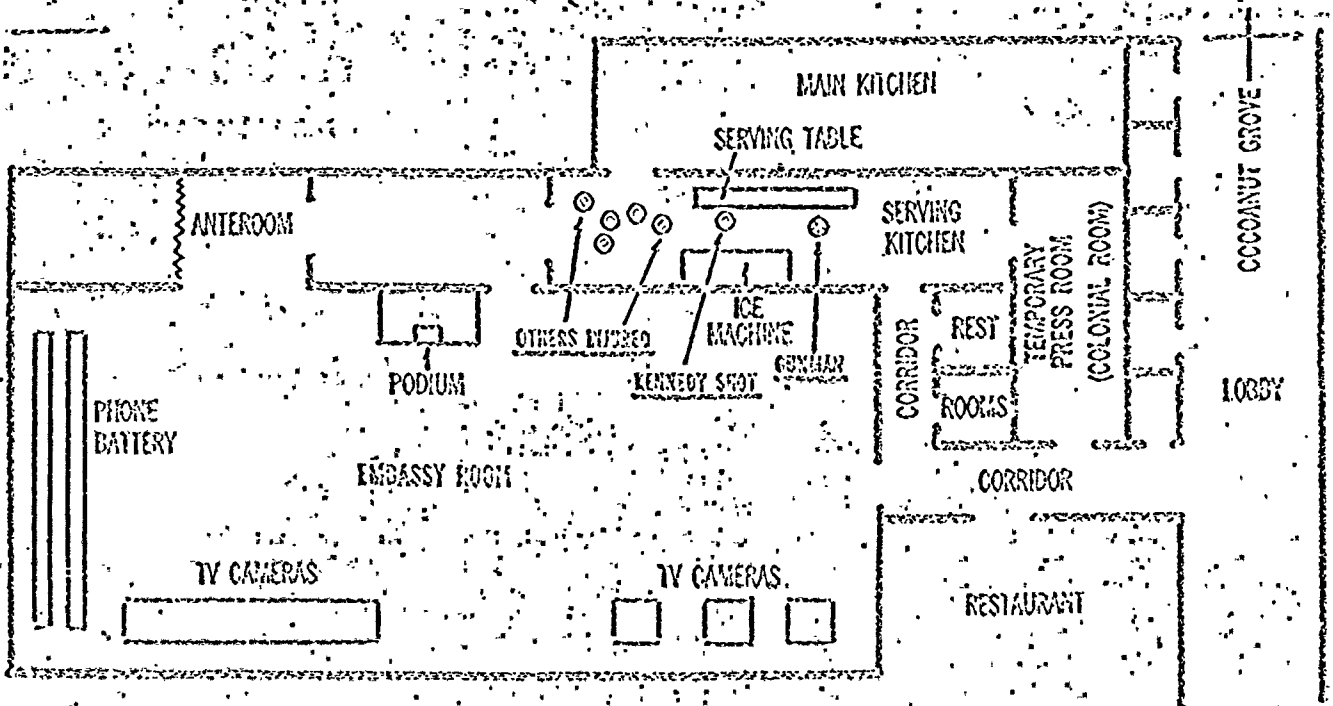


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

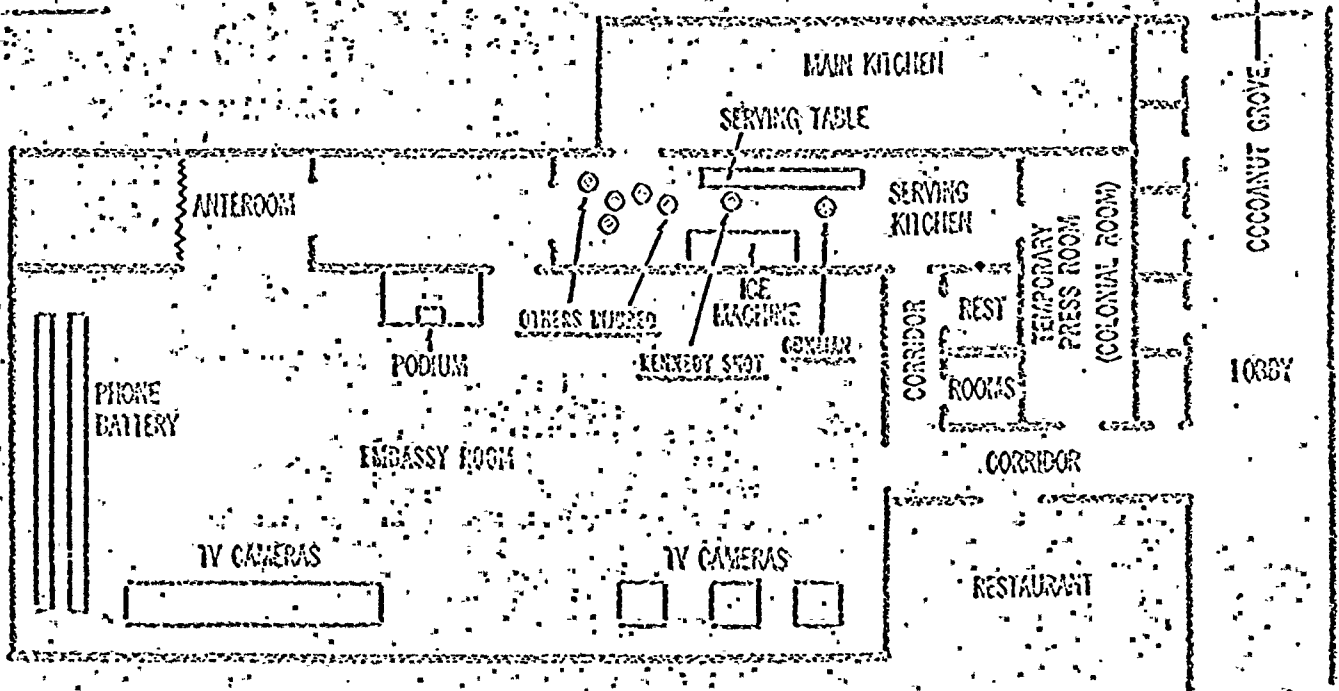


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

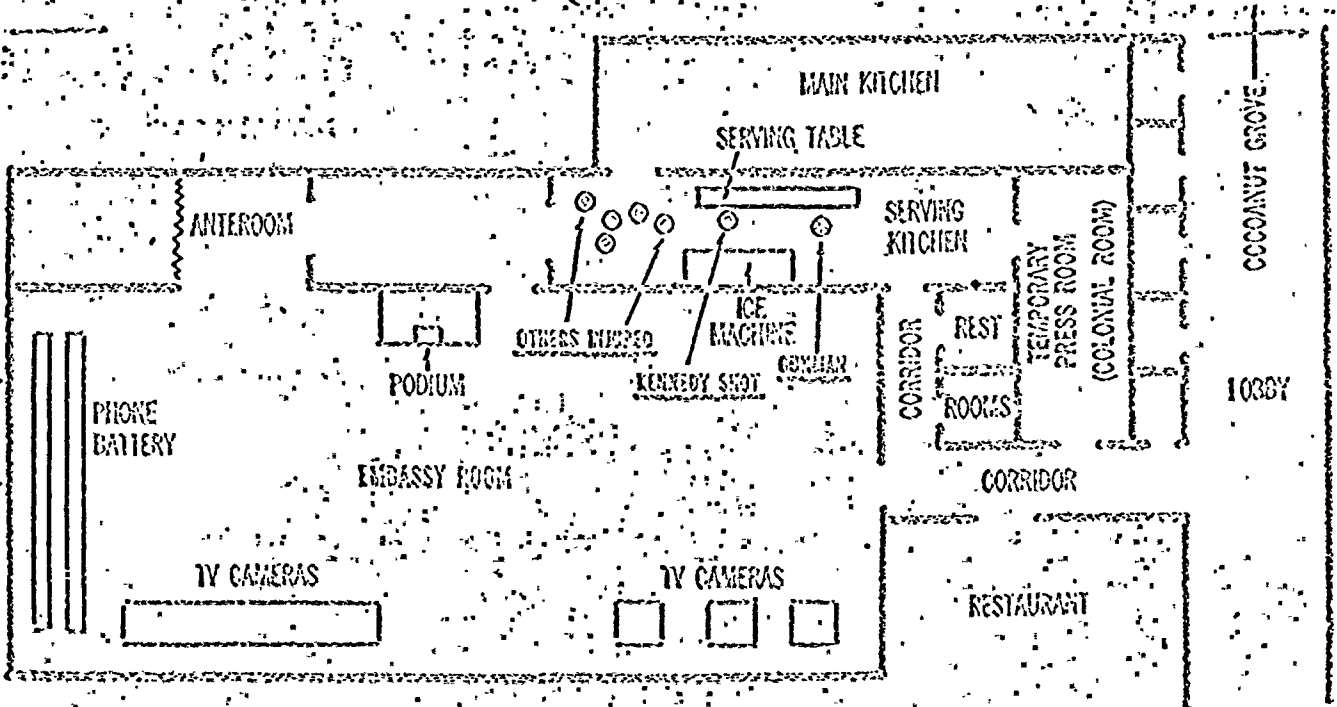


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

Mrs. Beth Fertik, Researcher and Assistant Producer, Columbia Broadcasting System (CBS), News Division, 524 West 57th Street, New York, New York stated that on the night of June 4-5, 1968, she was registered at the Ambassador Hotel, Los Angeles, California.

She was in the ballroom at the Ambassador Hotel during Senator Kennedy's speech and saw him leave the podium. Shortly thereafter, while standing in front of the podium, Mrs. Fertik heard a noise and thought it was firecrackers. Then there was screaming which was in women's high pitched voices. Fertik then thought that a lighting stand or platform may have fallen. She ran across the ballroom to a telephone and called her producer, Mr. Manitzas. While making the telephone call Mrs. Fertik learned of the shooting.

Mrs. Fertik did not see the shooting and she did not see Senator Kennedy or Sirhan Sirhan. During Senator Kennedy's speech, Mrs. Fertik saw nothing suspicious.

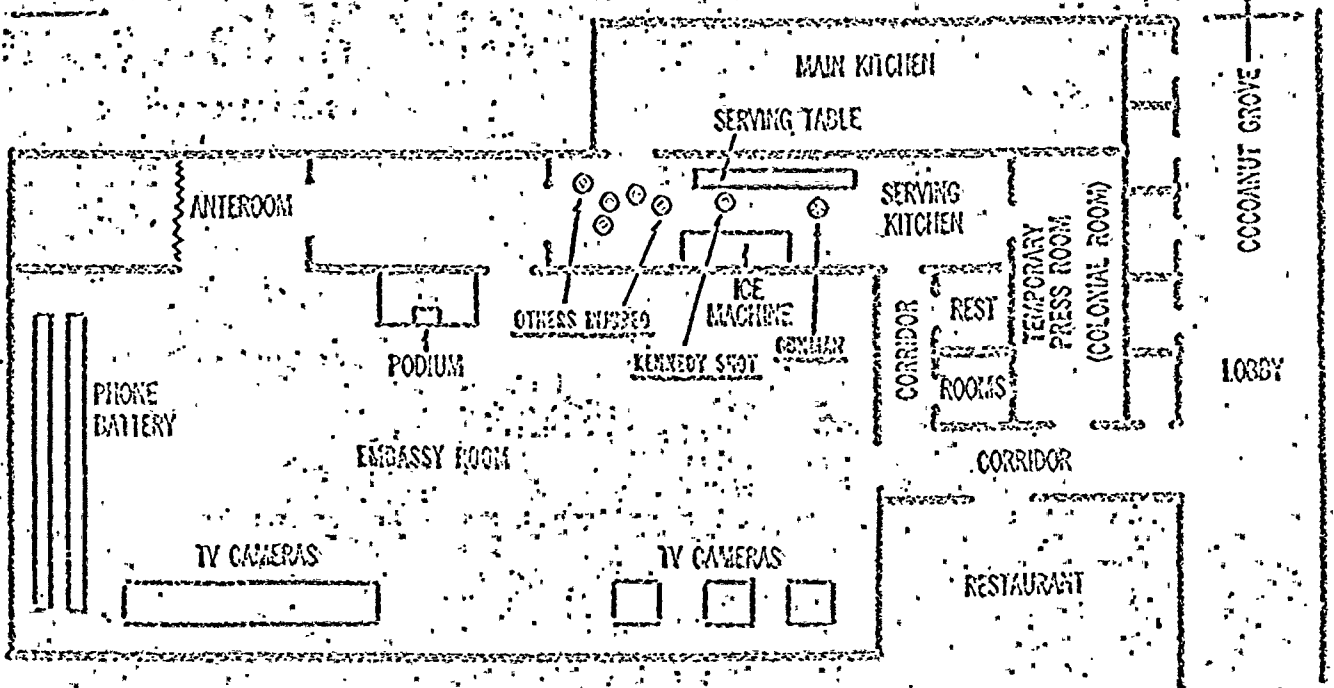


DIAGRAM OF SHOOTING SCENE—Sketch shows the doors leading from behind podium of Embassy

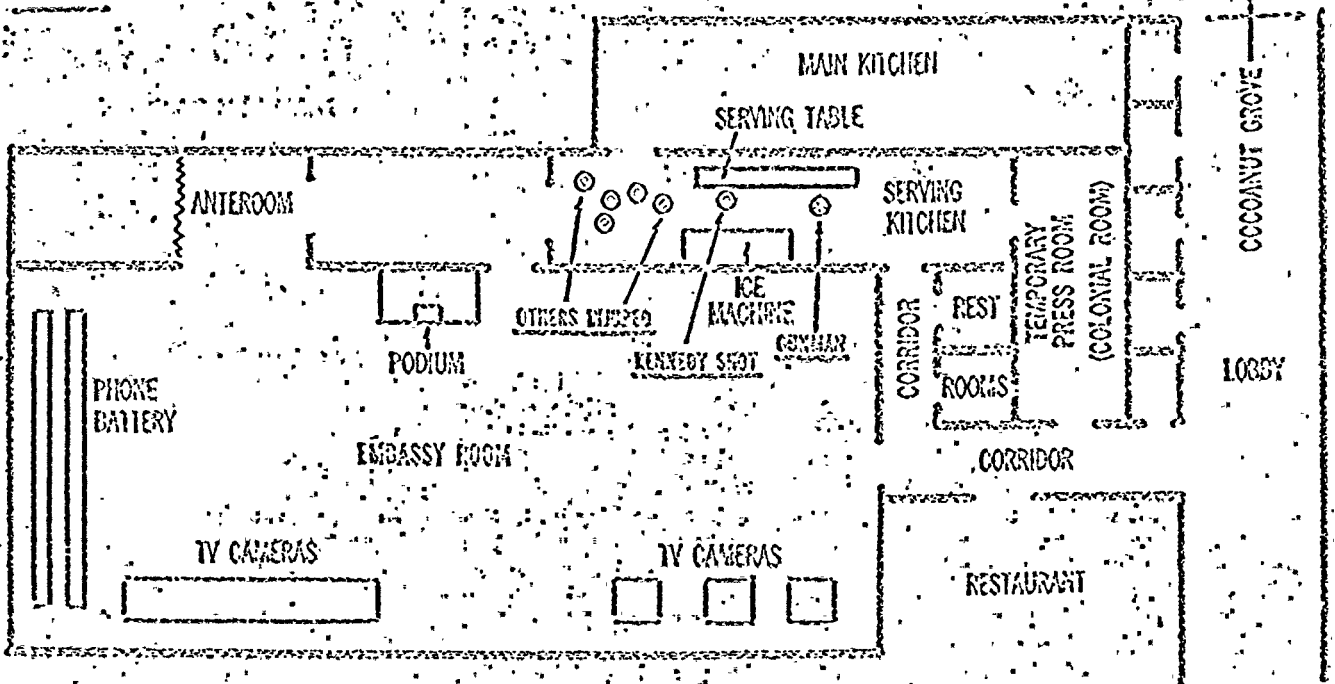


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

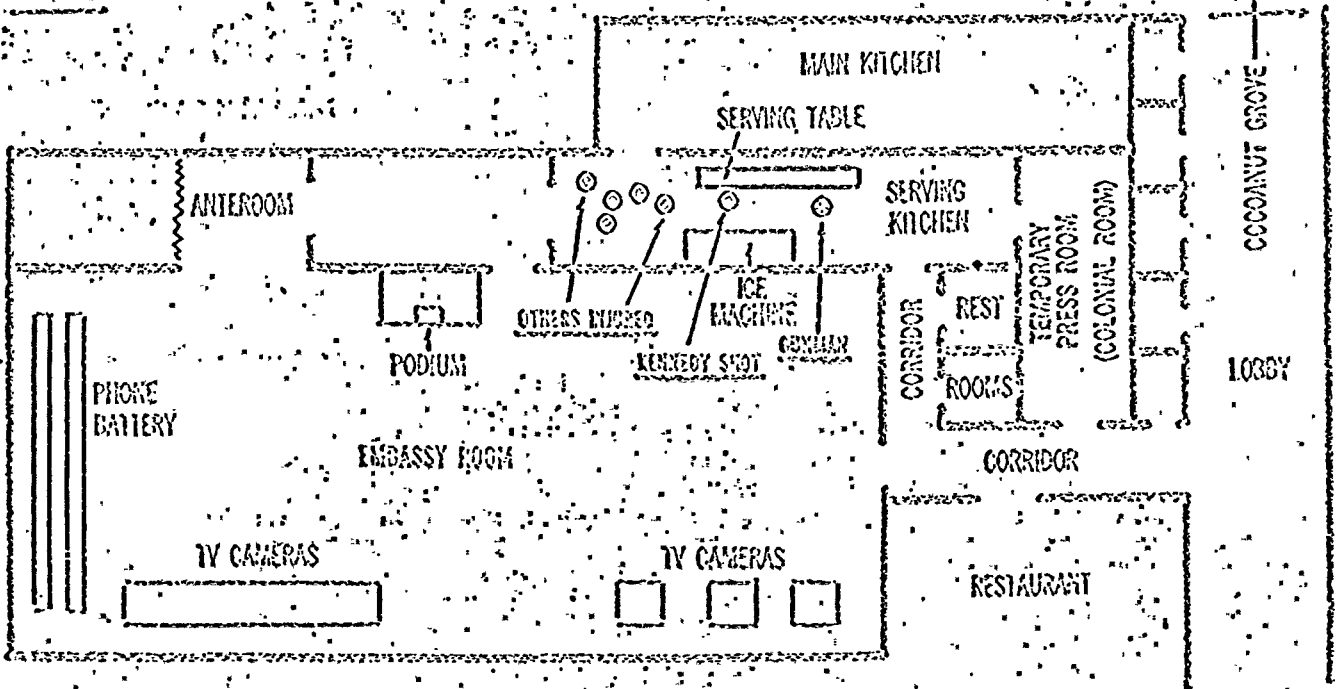


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

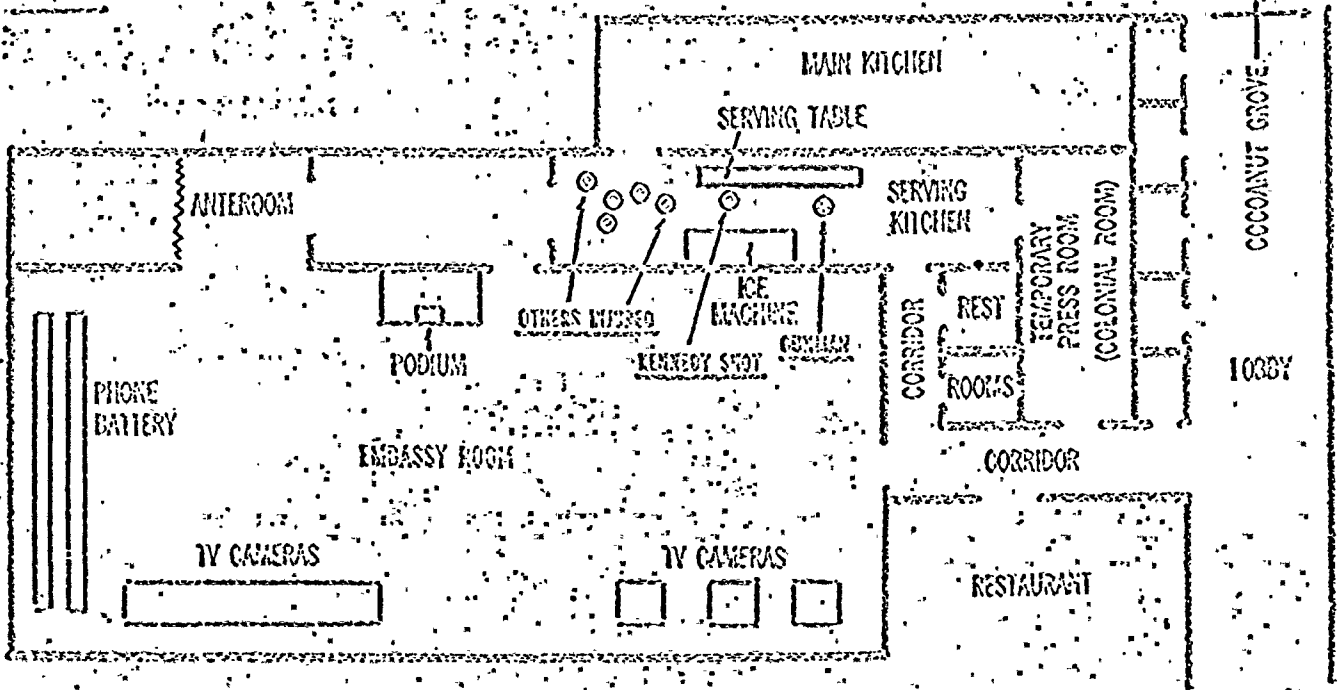


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

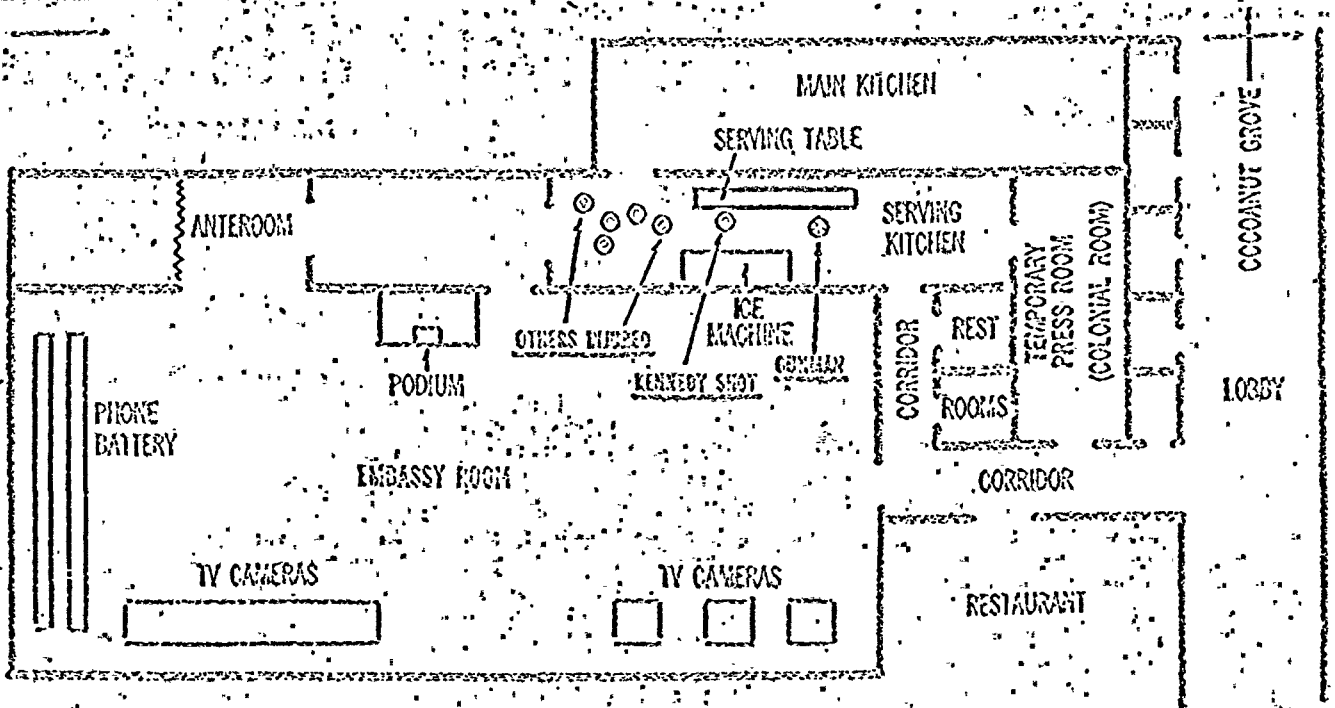


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium of Embassy

At 12:15 A.M. on 6/5/68, SIRHAN B. SIRHAN, at the conclusion of a victory rally by the late Senator ROBERT F. KENNEDY. (D-New York), in the kitchen area leading off the Embassy Ballroom shot and killed Senator KENNEDY, utilizing a .22 caliber revolver.
