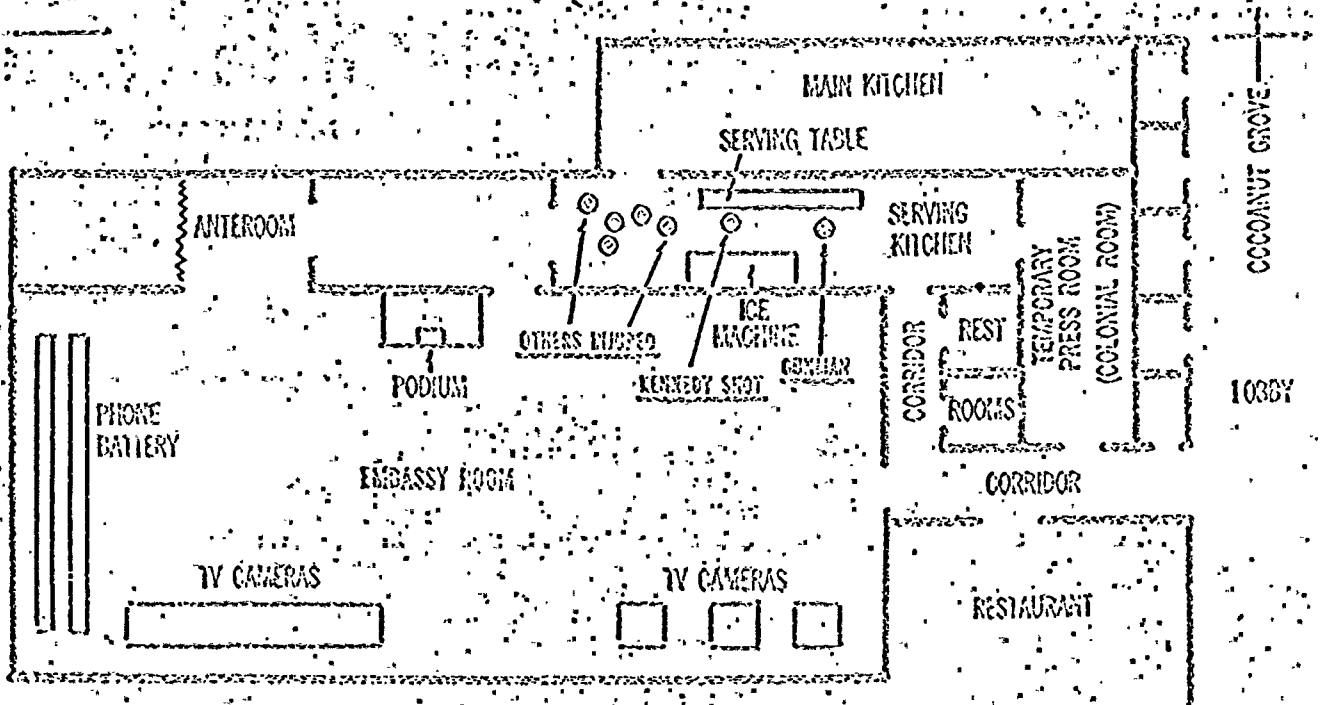


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium of Embassy



The only members of Manitzas' staff that he can recall having been near the scene of the shooting were cameraman Jim Wilson and his crew.

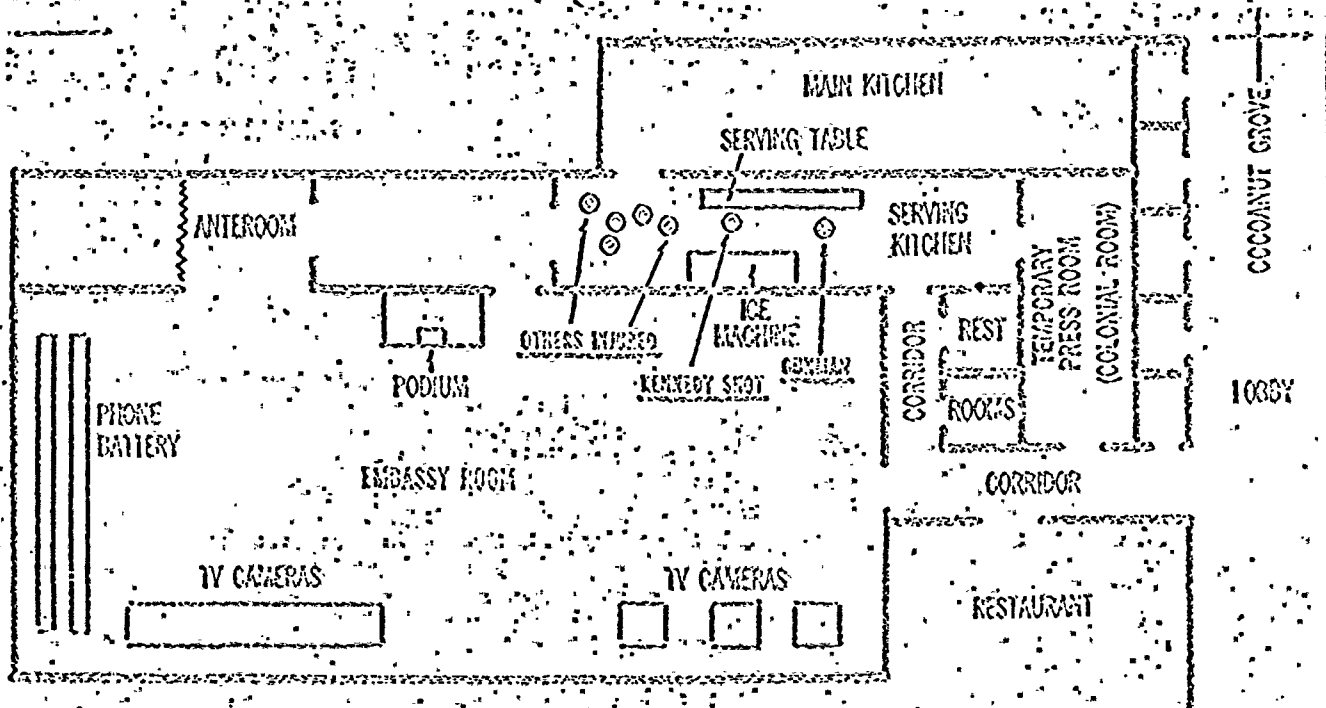


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

Mr. Marty Plissner, writer and associate producer, Columbia Broadcasting System (CBS), 524 West 57th Street, New York, N. Y., stated that on the night of June 4-5, 1968 he was registered at the Ambassador Hotel, Los Angeles, California.

During Senator Kennedy's speech, Plissner was in the ballroom about twenty feet away from Senator Kennedy. At the end of the speech, Plissner was in a hurry to get out of the ballroom and tried to go in the direction of Senator Kennedy. There was such a crowd in that area that Plissner headed in another direction and was evidently behind a pillar in the ballroom at the time of the shooting.

Plissner heard no shots but heard women screaming and someone say something such as "Is he alive?". Plissner then reasoned that there must have been a shooting.

Plissner was unable to get in the room where the shooting occurred and did not see the shooting, Senator Kennedy or Sirhan Sirhan.

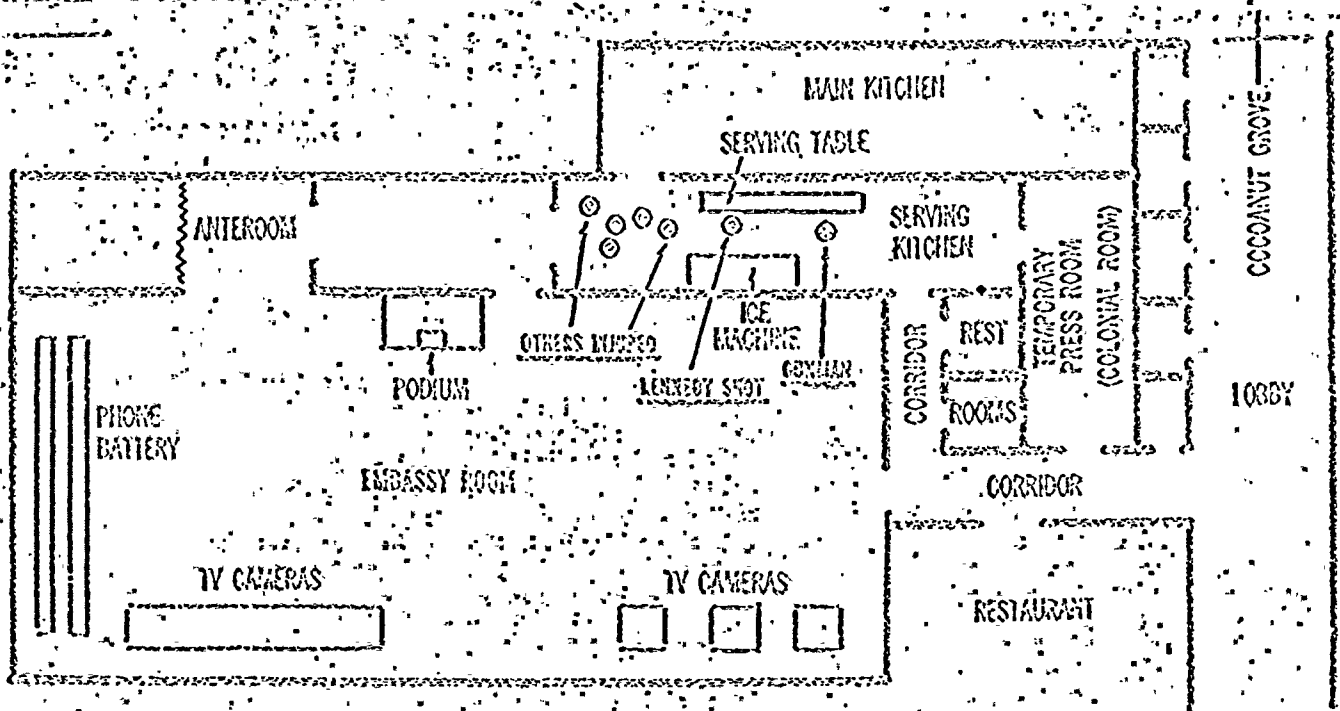


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium of Embassy

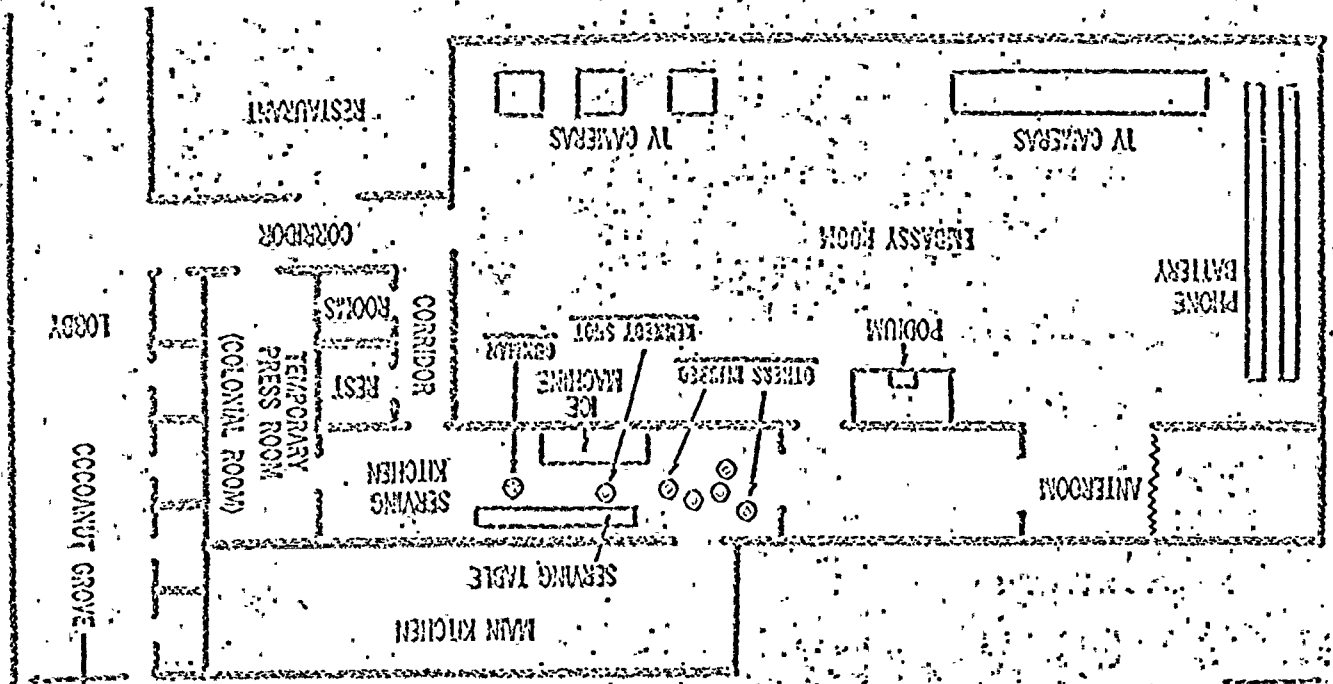

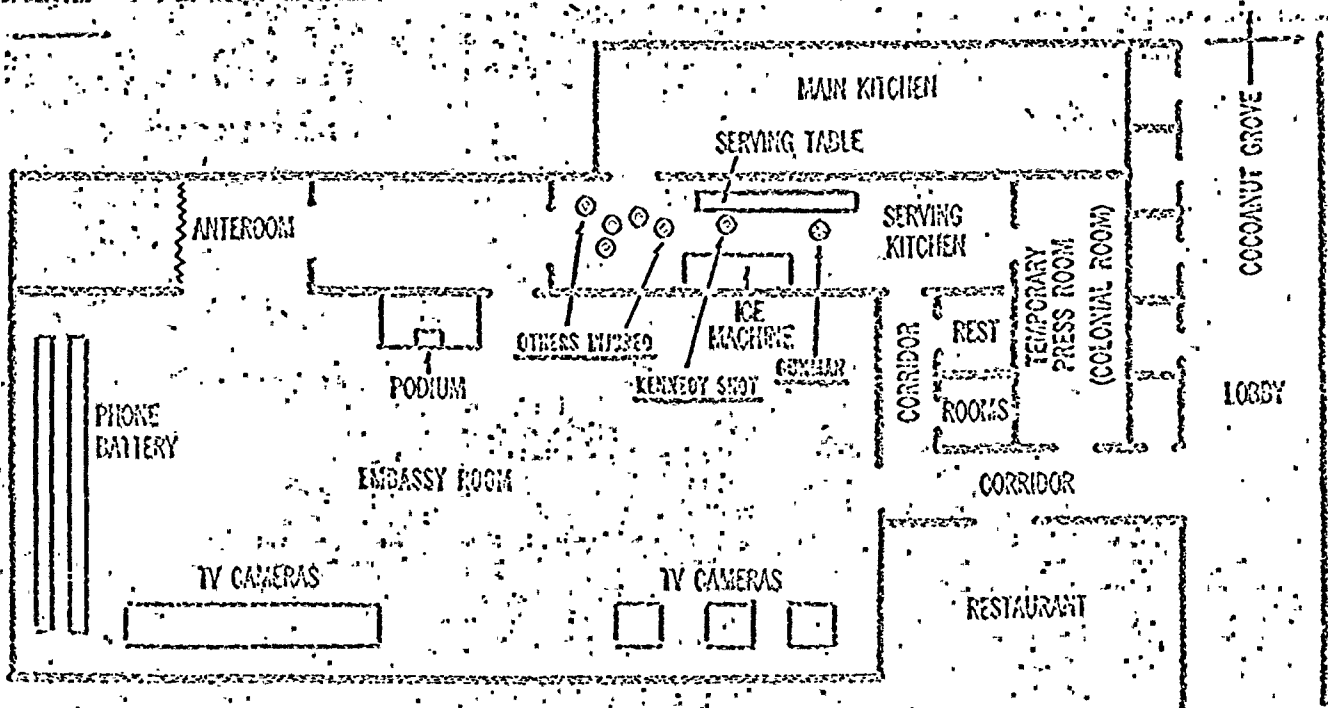


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

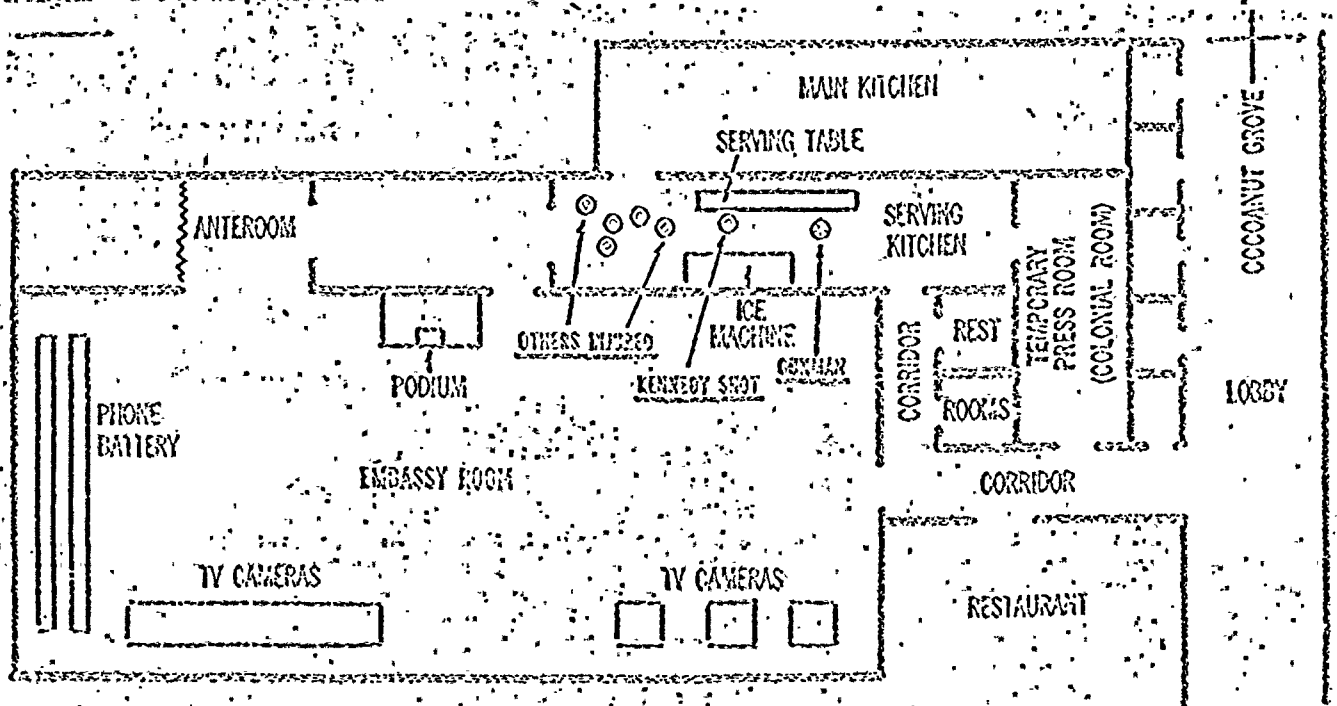


DIAGRAM OF SHOOTING SCENE—Sketch shows the doors leading from behind podium at Embassy

A few hours later, while she was in her room, she heard much noise and then she turned on the television set. It was from the television set that she learned of the shooting. She did not leave her room until the next morning.

Mrs. Wollenberger stated that she did not see the shooting; that she did not see Sirhan Sirhan and knows nothing of him; and that she knows nothing of the shooting.

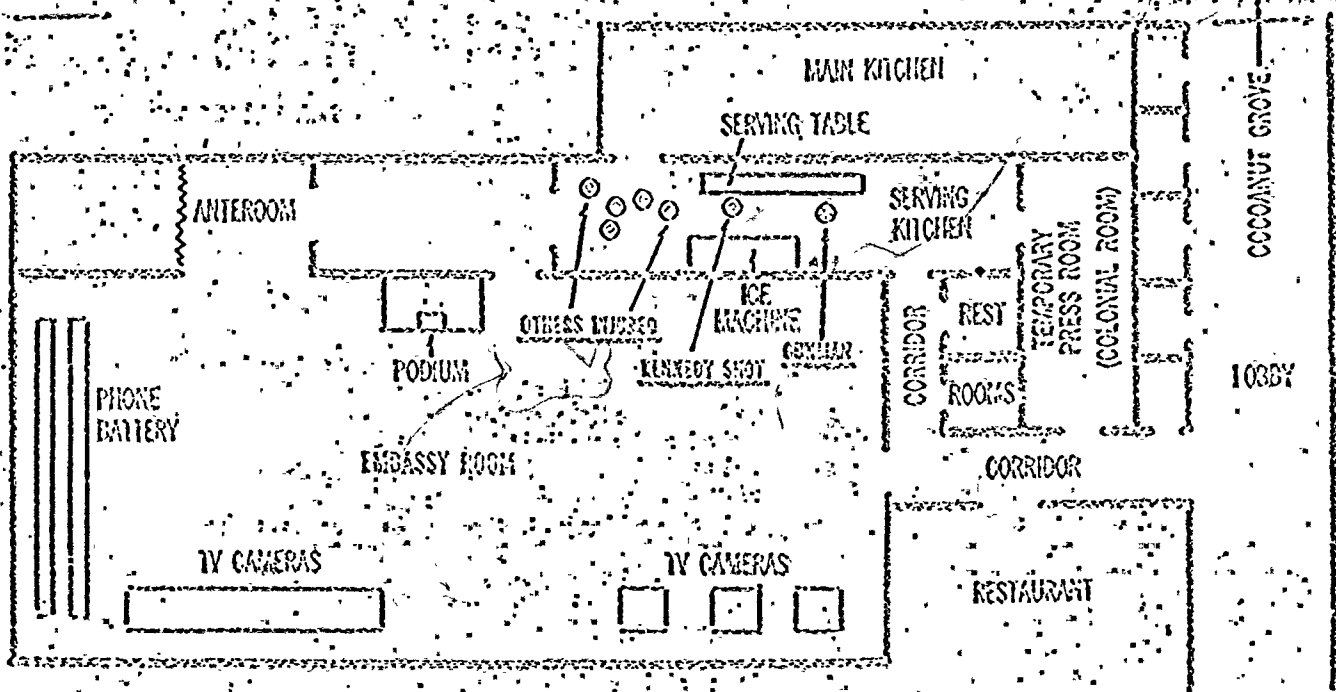


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy
