FIVE, FIVE TWO TO ~~FIVE FIVE~~ ^{FIVE FIVE} ONE TWENTY TO ONE FIFTY POUNDS, OF
MEXICAN DESCENT, ARTICULATE AND KNOWLEDGEABLE. THEY MET AT
FORT EUSTIS, VIRGINIA, IN ABOUT OCTOBER, SIXTY FIVE, WHERE
GARCIA ATTENDED TRANSPORTATION SCHOOL AS A TRANSPORTATION PARTS
SPECIALIST. THEY PARTED AS GOOD FRIENDS IN DECEMBER, SIXTY FIVE,

TOWN IN CALIFORNIA. THEREAFTER, GARCIA WAS SENT TO VIET NAM.

HUNTLEY WAS IN COMPANY OF KENNEDY AT THIS TIME. AS KENNEDY, HUNTLEY AND OTHER INDIVIDUALS LEFT THE PLATFORM IN THE BENSON BALLROOM, HUNTLEY WAS PROCEEDING IN FRONT OF KENNEDY ATTEMPTING TO CLEAR PASSAGEWAY FOR KENNEDY FROM PLATFORM TO KITCHEN OF BENSON HOTEL WHERE KENNEDY WOULD MAKE EXIT. DISTANCE FROM THE PLATFORM

TO THE KITCHEN DOOR WAS ABOUT FIFTEEN FEET.

AS GROUP PROCEEDED TO KITCHEN AND WHILE STILL IN BALLROOM, HUNTLEY SAW TWO INDIVIDUALS STANDING BETWEEN KENNEDY PARTY AND KITCHEN DOOR. THEY APPEARED TO SPEAK TO EACH OTHER AND INSTEAD OF STEPPING ASIDE THEY WALKED THROUGH THE KITCHEN DOOR. HE SAID AS HE CAME THROUGH THE KITCHEN DOOR HE PUSHED THE SHORTER OF THE TWO MEN FROM BEHIND AGAINST THE WALL AND TOLD HIM TO STAND STILL UNTIL THE PARTY GOT THROUGH. AS HE PLACED HIS HANDS AGAINST THE MAN'S BACK, HE FELT WHAT HE THINGS COULD POSSIBLY HAVE BEEN A WEAPON OR A WIDE THICK BELT. BY THIS TIME SENATOR KENNEDY HAD PASSED AND THEN HE TURNED AWAY TO AID REPRESENTATIVE EDITH GREEN, WHO WAS IN THE PARTY, TO KEEP HER FROM BEING PUSHED BY THE CROWD. HE BELIEVED THE MAN WHO WAS WITH THE MAN HE PUSHED HAD STEPPED OFF TO THE OTHER SIDE, AND HE DID NOT SEE HIM AGAIN.

HUNTLEY DESCRIBES THESE TWO INDIVIDUALS THAT HE OBSERVED IN PORTLAN

ONE, THE INDIVIDUAL HE PUSHED, WMA, TWENTYTHREE YEARS OF AGE, FIVE FEET FOUR, VERY HEAVY BUILD, ONE HUNDRED NINETY LBS., MEDIUM BROWN HAIR PARTED ON RIGHT SIDE AND FAIRLY LONG, VERY NEATLY TRIMMED, ROUND FULL FACE, CLEAR FAIR COMPLEXION, WELL DRESSED IN A BUSINESS SUIT, WEARING A RING WITH A MAROON STONE ON HIS LEFT HAND.

NO. TWO, WHO APPEARED TO POSSIBLY BE IN COMPANY WITH THE MAN HUNTLEY PUSHED, WMA, POSSIBLY OF POLYNESIAN DESCENT AND APPEARANCE, BUSHY WIRY BLACK HAIR, CUT SHORT AND COMBED STRAIGHT BACK, MEDIUM SLENDE BUILD, ONE HUNDRED FIFTY POUNDS, NARROW FACE, WEARING A TWEED SPORT COAT

HUNTLEY BELIEVES THAT HE WOULD BE ABLE TO RECOGNIZE THE INDIVIDUAL DESCRIBED HEREINBEFORE AS NO. ONE SHOULD BE SEE HIM AGAIN.

TELEPHONIC CONTACT HAS BEEN MADE WITH THE LOS ANGELES DIVISION WHICH IS FORWARDING PHOTOGRAPHS OF THE SUSPECT IN THIS MATTER TO PORTLAND. THE PHOTOGRAPHS WILL BE EXHIBITED TO HUNTLEY AS SOON AS RECEIVED AND BUREAU AND LOS ANGELES ADVISED.

TO JOIN POOR PEOPLE'S MARCH. RICE DESCRIBED DRIGGS AS MENTALLY UNSTABLE AND A RADICAL. LATER DRIGGS CONTACTED CHILICOTHE, OHIO PD AND REQUESTED HE BE CONTACTED BY FBI AGENT .

DRIGGS APPEARED CHILICOTHE, OHIO RA WITH A COLORED SLIDE OF ONE (FNU) SERHARND WHICH HE SAID WAS TAKEN AT A PARTY AT SERHARND'S HOME ON JULY FOUR, NINETEEN SIXTYFIVE. DRIGGS STATED AT THAT TIME HE, DRIGGS, WAS A MEMBER OF W.E.B. DUBOIS CLUB, NUMBER SEVEN DUDLEY ST., VENICE, CALIFORNIA. HE WITHDREW WHEN HE LEARNED CLUM COMMUNISTIC PARTY WAS BEING HELD AT SERHARND'S HOME FOR MEMBERS OF CLUB. DRIGGS STATED MANY PERSONS IN ATTENDANCE AT PARTY WERE "CARD CARRYING COMMUNISTS". HE DESCRIBED SERHARND AS A "VERY SERIOUS DEDICATED COMMUNIST" WITH A PRO-CHINESE PHILOSOPHY OF COMMUNISM. SERHARND EXPRESSED PHILOSOPHY AGAINST ISRAEL AND VIETNAM WAR. SERHARND HAD
