RE LOS ANGELES TEL JUNE SEVEN LAST REQUESTING INTERVIEW OF SIRHAN SPONSORS.

MRS. HALDOR LILLENAS (LOLA), FIVE TWO THREE TWO ROE AVE., MISSION, KS., INTERVIEWED THIS DATE AND ADVISED SHE AND HER LATE HUSBAND WERE SPONSORS FOR BISHARA SIRHAN AND FAMILY. TWO OLDEST CHILDREN OF SIRHAN FAMILY REMAINED IN JORDAN BECAUSE LILLENAS REFUSED TO SPONSOR THEM BECAUSE THEY WERE OF LEGAL AGE.

LILLENAS STATED SHE AND HER HUSBAND, WHO WAS AN ORDAINED MINISTER OF THE CHURCH OF THE NAZARENE, WENT ON A EUROPEAN VACATION IN NINETEEN FIFTYFIVE. WHILE VISITING IN JORDAN, BISHARA SIRHAN CONTACTED LILLENAS AND INQUIRED AS TO THE POSSIBILITY OF COMING TO THE U.S. LILLENAS DECIDED TO SPONSOR THE SIRHAN FAMILY AS THEIR INQUIRIES REFLECTED THE SIRHAN FAMILY TO BE A WORTHY CHRISTIAN FAMILY.

MR. LILLENAS, WORKING THROUGH CHURCH WORLD SERVICE AND THE FRIENDS ORGANIZATION, BECAME THE SPONSOR OF THE SIRHAN FAMILY, AND IN NOV., FIFTYSEVEN, SIRHAN CAME TO PASADENA, CALIF., AND LIVED IN THE LILLENAS HOME FOR ABOUT THREE MONTHS UNTIL SUITABLE HOUSING AND EMPLOYMENT COULD BE OBTAINED.

BISHARA SIRHAN LEFT HIS FAMILY IN FIFTYEIGHT AND RETURNED TO JORDAN BECAUSE HE FELT LIVING IN THE U.S. DID NOT ALLOW HIM TO CONTROL HIS FAMILY AS IN THE PAST. BISHARA SIRHAN WROTE LETTERS TO HIS WIFE REQUESTING HER TO RETURN TO JORDAN AND IF SHE REFUSED HE WOULD OBTAIN A DIVORCE. MRS. SIRHAN REFUSED TO RETURN TO JORDAN AND TOLD LILLENAS SINCE SHE HAD BEEN MARRIED IN THE GREEK ORTHODOX CHURCH, NO DIVORCE WOULD BE GRANTED TO HER HUSBAND.

LILLENAS ADVISED HER HUSBAND HAD HANDLED ALL THE RESPONSIBILITIES PERTAINING TO THE SIRHAN FAMILY AND AFTER MR. LILLENAS DIED IN FIFTYNINE SHE HAS HAD ONLY ONE CONTACT WITH THE SIRHAN FAMILY, IN ABOUT SIXTYTHREE WHEN AYDA SIRHAN, A DAUGHTER, DIED. AT THIS TIME, LILLENAS SAW ONLY MRS. SIRHAN AND SHE VISITED FOR ONLY FIFTEEN MINUTES. LILLENAS MOVED FROM PASADENA, CALIF., TO MISSION, KS., ABOUT THREE YEARS AGO AND HAS HAD NO CONTACT WITH THE SIRHAN FAMILY SINCE MOVING TO MISSION, KS.

DURING THE TIME LILLENAS KNEW SIRHAN, POLITICS WERE NEVER DISCUSSED AND THEY ALWAYS APPEARED TO BE A DEVOUT CHRISTIAN FAMILY. SIRHAN BISHARA SIRHAN WAS RECALLED AS A WELL BEHAVED, INDUSTRIOUS, AND OBEDIENT CHILD.

MANUEL M. AND AMPARIO SERRANO ONE NINE FOUR NINE WEST TWO SEVEN STREET, LORAIN, OHIO, PARENTS OF SANDRA SERRANO, ADVISED SHE TELLEPHONICALLY CONTACTED THEM ON SIX FOUR LAST AT APPROXIMATELY SIX PM EDT TO CONGRADULATE HER BROTHER UPON HIS GRADUATION FROM HIGH SCHOOL. SHE CALLED AGAIN AT TEN THIRTY PM EDT ON SAME DATE STATING SHE WAS AT KENNEDY'S CAMPAIGN HEADQUARTERS AND THAT KENNEDY WAS GOING TO WIN THE CALIFORNIA PRIMARY ELECTION.

SANDRA TELEPHONICALLY CONTACTED HER MOTHER BY COLLECT CALL AT APPROXIMATELY THREE THIRTY AM EDT ON SIX FIVE LAST AND WAS HYSTERICAL SHE SAID SOMETHING TO THE EFFECT THAT IT COST HER THREE DOLLARS TO GET THE TELEPHONE. SHE STATED THAT KENNEDY HAD BEEN SHOT AND WHEN HER MOTHER SAID "WHAT?" SHE REPEATED THE STATEMENT. SANDRA STATED SHE DID NOT KNOW IF KENNEDY WAS DEAD AND STATED HE HAD BEEN SHOT AFTER HIS SPEECH. SHE WAS HYSTERICAL DURING ENTIRE TELEPHONE CONVERSATION AND HER MOTHER WAS UNABLE TO RECALL HER MENTIONING ANYTHING ABOUT OBSERVING ANYONE CONNECTED WITH THE SHOOTING. BUT SHE KEPT REPEATING "WHY WOULD THEY DO ANYTHING LIKE THIS, HE WAS SUCH A GOOD MAN". SHE ASKED TO SPEAK WITH HER FATHER BUT HE

DECLINED AS HE WAS TOO UPSET UPON HEARING OF THE SHOOTING.

AT APPROXIMATELY EIGHT AM EDT ON SIX FIVE LAST SANDRA AGAIN TELLEPHONICALLY CONTACTED HER MOTHER AND AT THIS TIME STATED SHE HAD BEEN ON THE TERRACE AT THE AMBASSADOR HOTEL PRIOR TO KENNEDY'S SPEECH. AND SHE HAD SEEN TWO MEN AND A WOMAN WHOM SHE DESCRIBED ONLY AS THE MEN BEING MEXICAN DASH AMERICAN AND THE GIRL AS BEING WHITE.

SHE FURTHER STATED AFTER THE SHOOTING SHE OBSERVED JUST ONE OF THE MEN AND THE SAME GIRL RUNNING FROM THE HOTEL AREA. SHE DID NOT ELABORATE FURTHER NOR DID SHE FURIHER DESCRIBE THESE INDIVIDUALS.

MRS. SERRANO ADVISED SHE COULD RECALL NO FURTHER DETAILS OF THE CONVERSATIONS WITH HER DAUGHTER. AND SHE DID NOT MAKE NOIES DURING ANY OF THE CONVERSATIONS AS SHE DID NOT THINK IT IMPORTANT AT THE TIME.

PARENTS DESCRIBED SANDRA AS A GOOD GIRL, WHO DOES NOT SMOKE OR DRINK, AND WHO IS LEVEL HEADED, AS WELL AS MENTALY AND EMOTIONALY MATURE. SHE GRADUATED FROM HIGH SCHOOL IN LORAIN IN JUNE OFNINETEEN SIXTY SIX. MAINTAINING C+ AVERAGE. MAJORING IN BUSSINESS ADMINISTRATION SHE ATTENDED ONE SEMISTER OF LORAIN COUNTY COMMUNITY COLLEGE, AFTER

OTTO, TWO TWO SIX HUBBLE, HOUGHTON, MICH., WHO USED THE FIRST NAME OF LESLIE, HAD RECENTLY VISITED HIS OFFICE AND IN CONVERSATION INDICATED SHE HAD SERVED IN SOME UNDERCOVER CAPACITY FOR THE LOS ANGELES, CALIFORNIA PD RE NARCOTICS. HE SAID MR. AND MRS. OTTO CAME TO HOUGHTON ABOUT ONE YEAR AGO. HOWARD E. OTTO IS HOUGHTON COUNTY PATHOLOGIST AND MRS. OTTO APPEARS TO BE A "HIPPIE TYPE" WHO IS "ANTI EVERYTHING". MR OTTO WAS, FOR SEVERAL YEARS, FORMERLY EMPLOYED AS A PATHOLOGIST AT CEDARS OF LEBANON HOSPITAL IN LOS ANGELES OR PASADENA.
