QUOTED AS FOLLOWS:

"THE SEMI-OFFICIAL MIDDLE EAST NEWS AGENCY (MENA) REPORTED FROM BAGHDAD SUNDAY NIGHT THAT INFORMED SOURCES SAID IRAQI AUTHORITIES ARRESTED THE BROTHER OF SENATOR ROBERT F. KENNEDY'S ACCUSED ASSASSIN MONTHS AGO ON CHARGES OF SPYING FOR ISRAEL.

"MENA QUOTED THE SOURCES AS SAYING SOLIMAN SIRHAN, BROTHER OF SIRHAN BISHARA SIRHAN, WAS AN ENGINEER WORKING FOR A PRIVATE COMPANY AND CARRYING A JORDANIAN PASSPORT.

"ACCORDING TO THE SOURCES, SOLIMAN WAS ARRESTED NEAR THE JORDANIAN BORDER WHILE CARRYING MAPS OF IRAQI MILITARY AIRPORTS.

"THE SOURCES SAID SOLIMAN WAS HANDED OVER TO JORDAN AFTER HIS ARREST BECAUSE HE ALLEGEDLY WAS ACONNECTED WITH A SPY RING DISCOVERED IN JORDAN.

"THE MENA DISPATCH SAID IRAQI AUTHORITIES DISCOVERED FIVE SPY RINGS. IT SAID SOLIMAN'S RING WAS STILL UNDER INVESTIGATION

ON JUNE TENTH NINETEEN SIXTYEIGHT, SPENCER DRAYTON, EXECUTIVE VICE PRESIDENT, THOROUGHbred RACING PROTECTIVE BUREAU (TRPB) TWO TWO ZERO EAST FORTY-SECOND STREET, NEW YORK, NEW YORK ADVISED SAC JOSEPH PONDER THAT LIFE MAGAZINE WAS GOING TO RUN AN ARTICLE ON SIRHAN SIRHAN AND THAT LIFE MAGAZINE SAID THAT PHIL LEE CLEVINGER; DAVID MYERS; RONALD HOLEN (ALL OF FLAGSTAFF, ARIZONE AND ASSOCIATED WITH HORSERACING) AND FRANK DANAMERA (PHONETIC) OF CORONA, CALIFORNIA ALSO ASSOCIATED WITH HORSERACING WERE ALL INSOME WAY ACQUAINTED WITH OR KNEW OF SIRHAN AND THAT LIFE WANTED TO KNOW WHAT TRPB HAD ON THESE FOUR. DRAYTON SAID TRPB RECORDS NEGATIVE AS TO FIRST THREE. LIFE SAID THAT SIRHAN SIRHAN AND DANAMERA, AKA RAMISTELLA AKA DONNARUMA KNEW EACH OTHER AT TRACK AT CORONA.

AS TO ~~FRANK DANAMERA~~ (PHONETIC) DRAYTON STATED THAT HE WAS ACTUALLY HENRY RONALD RAMISTELLA AKA FRANK DONNARUMMA, DATE OF BIRTH MARCH TWENTY FIFTH, NINETEEN THIRTY TWO, OR MARCH TWENTY FIFTH NINETEEN HIRTY FOUR, SOCIAL SECURITY NUMBER TWO SIX SEVEN FIVE ZERO ZERO FOUR SEVEN FIVE, FBI NUMBER THREE SIX FIVE SIX NINE SEVEN C. TRPB RECORDS CONTAIN INFORMATION THAT RAMISTELLA WAS USING NARCOTICS. AN INVESTIGATION FAILED TO REVEAL SUCH. IN NINETEEN FIFTY THREE, IT WAS ALLEGED THAT HE WAS FIXING RACES. THIS WAS NOT SUBSTANTIATED.

IN NINETEEN FIFTY FIVE IT WAS FOUND THAT A HORSE HE RODE HAD BEEN STIMULATED. HE DENIED SUCH BUT RACING OFFICIALS FOUND THAT HE HAD GIVEN THE HORSE AN UNSATISFACTORY RIDE. DURING THIS INVESTIGATION RAMISTELLA WAS FOUND TO BE NOT TELLING THE TRUTH AS TO CERTAIN TELEPHONE CALLS.

HE WAS SUSPENDED FOR FORTY FIVE DAYS.

IN NINETEEN FIFTY THREE HE WAS FINED FIFTY DOLLARS FOR FAILING TO MAINTAIN HIS POSITION AFTER LEAVING THE GATE.

IN NINETEEN FIFTY THREE HE WAS SUSPENDED FOR TEN DAYS FOR CROSSING OVER SHARPLY AND CAUSING ANOTHER HORSE TO FALL.

IN NINETEEN FIFTY FOUR HE WAS SUSPENDED FOR THE REMAINDER OF THE MEET FOR CARELESS RIDING.

DURING FALL NINETEEN FIFTY FIVE AND SPRING OF NINETEEN FIFTY SIX THERE WERE TELEPHONE CALLS BETWEEN RAMISTELLA'S HOME AND A SUSPECTED BOOKIES HOME.

IN OCTOBER, NINETEEN FIFTY SIX HE WAS ARRESTED AND IN NOVEMBER NINETEEN FIFTY SIX PLEAD GUILTY IN NASSAU COUNTY, NEW YORK TO POSSESSION OF MARIJUANA. HE RECEIVED SIXTY DAY SUSPENDED SENTENCE.

IN SEPTEMBER, NINETEEN FIFTY SIX HE WAS ARRESTED FOR POSSESSION OF MARIJUANA IN JAMAICA, NEW YORK. THE CHARGE WAS DISMISSED.

SUBSEQUENT TO THE ABOVE ARRESTS THE STEWARDS AT THE NEW YORK TRACKS BARRED RAMISTELLA FROM EMPLOYMENT HOWEVER NO FORMAL RULING TO THAT EFFECT WAS ISSUED.

IN JULY NINETEEN FIFTY SEVEN RAMISTELLA AND ONE FRANK ACCETTA, BOTH DESCRIBED AS UNDESIRABLES WERE INVOLVED IN THE PURCHASE OF A HORSE.

IN JULY, NINETEEN FIFTY SEVEN RAMISTELLA WAS ARRESTED WITH TWO ADMITTED NARCOTICS ADDICTS AND CHARGED WITH PETTY LARCENY. IN MINEOLA, NEW YORK THE CHARGE WAS THROWN OUT OF COURT BECAUSE OF THE UNAVAILABILITY OF WITNESSES.

L IN JANUARY NINETEEN SIXTY SIX RAMISTELLA WAS FINGER-PRINTED AT SANTA ANITA RACETRACK UNDER THE NAME OF FRANK DONNARUMA. DETECTIVE HARRY BRADY, NYC PORT AUTHORITY PD ADVISED NYO THAT AMERICAN AIRLINES AT APPARENT INSTRUCTIONS FROM LOS ANGELES PD TELEPHONICALLY CONTACTED HIS OFFICE STATING THAT AN INDIVIDUAL ("TAMARA CAROBICH") AKA TAMARA CAROBICH NO FURTHER IDENTIFYING DATA, REPORTEDLY ABOARD AMERICAN AIRLINES FLIGHT FOUR ENROUTE TO JFK AIRPORT, NYC HAD "INFORMATION ABOUT ASSASINATION". BRADY MET THIS FLIGHT WHICH ARRIVES ONE TEN AM HOWEVER CAROBICH NOT ABOARD. ONE (JAFFER J. Z. ZAKI) AKA (JAFFER A AL (DIAGONAL) ZAK) QUESTIONED AT JFK AIRPORT WHEN FLIGHT FOUR ARRIVED SINCE HE "LOOKED SUSPICIOUS".
