DJEREDJIAN TRAVEL DATES COINCIDE WITH DATES REPORTED BY HIM IN REFERENCED OKLAHOMA CITY TELETYPE.

MRS. DJEREDJIAN STILL INSISTS IT WAS SHE WHO MADE THE STATEMENT RE SEN. ROBERT F. KENNEDY BEING ASSASINATED AS SET OUT IN REF PHOENIX TELETYPE. MRS. RODAK ADVISES DJEREDJIAN MADE THE STATEMENTS PREVIOUSLY REPORTED IN REFERENCED PX TELETYPE.

MRS. DJEREDJIAN ADVISED THAT DJEREDJIAN RECEIVED SUN BURN APPROXIMATELY MAY TWENTY NINE LAST IN PHOENIX AFTER HIS RETURN FROM LOS ANGELES. SHE OBTAINED A PRESCRIPTION FOR HIM FROM BLAINE'S PHARMACY ON JUNE THIRD LAST, SINCE DJEREDJIAN HAD SUFFERED SEVERAL DAYS FROM THE PAIN.

MRS. RODAK ADVISED SHE HAS NEVER CLAIMED TO ANYONE THAT DJEREDJIAN WAS MAKING APPROXIMATELY SEVENTY THOUSAND DOLLARS PER YEAR OR THAT HE WAS BRINGING IN DOPE, BUT DID ADVISE THAT DURING DJEREDJIAN'S EARLY MONTHS OF MARRIAGE WITH HER DAUGHTER, SAID MARRIAGE NOT KNOWN TO MRS. RODAK AT THE TIME, SHE BELIEVED THAT HE HAD HER DAUGHTER UNDER THE INFLUENCE OF DRUGS BECAUSE HER DAUGHTER WOULD NO LONGER LISTEN TO ANY OF HER ADVICE.

MR. BLAINE COOPER, PHARMACIST, BLAINE'S PHARMACY, THIRTY ONE HUNDRED EAST BELL ROAD, PHOENIX ADVISED INSTANT DATE, THAT HIS RECORDS INDICATE THAT ON JUNE THIRD LAST ONE S. DJEREDJIAN OBTAINED PRESCRIPTION NUMBER SIX EIGHT FIVE NINE TWO, FOR A LOCAL ANESTHEZIA FREQUENTLY USED TO RELIEVE PAIN OF SUN BURN. THE INITIALS BSK INDICATES PRICE OF ONE DOLLAR AND NINETY FIVE CENTS.

MR. COOPER FURTHER ADVISED THAT MRS. DJEREDJIAN PICKED UP ABOVE PRESCRIPTION.

CLEVINGER RECEIVED LETTER FROM MOTHER, PRISCILLA CLEVINGER, APT. TWO, THREE FOUR SIX ONE ANDY, LONG BEACH, CALIF., ADVISING FBI AGENT JOE CHEFALO HAD CONTACTED HER STATING HE WANTED INFORMATION FROM PHILIP CLEVINGER CONCERNING WHETHER A HITCHHIKER HE HAD PICKED UP ABOUT TWO YEARS AGO WAS IDENTICAL WITH SIRHAN SIRHAN.

IN MAY, NINETEEN SIXTYSIX, WHILE CLEVINGER WAS ENROUTE TO CALIF., VIA AUTOMOBILE, HE PICKED UP TWO HITCHHIKER IN TEXAS, EXACT LOCATION RECALLED. WHEN THEY REACHED FLAGSTAFF, ARIZ., HE WAS STOPPED BY ARIZONA HIGHWAY PATROL AND A CHECK MADE OF THE VEHICLE HE WAS DRIVING. HIGHWAY PATROL BOOKED THE TWO HITCHHIKERS IN FLAGSTAFF ON MAY TWENTYSIX, NINETEEN SIXTYSIX FOR VAGRANCY.

CLEVINGER DOES NOT KNOW THE IDENTITIES OF HITCHHIKERS BUT UNDERSTANDS FROM AN ARTICLE WHICH APPEARED IN LIFE MAGAZINE AND AN END PAGE ONE
