KEITH YOUNG, FOUR ZERO ZERO SOUTH MYRTLEWOOD STREET,

ELITE MOTOR SERVICE, TWO FIVE TWO NINE EAST FOOTHILL
BOULEVARD, PASADENA, CALIFORNIA, WHILE WORKING AT THIS
LOCATION, YOUNG ADVISED HE FIRST CAME INTO CONTACT WITH
SIRHAN BISHARA SIRHAN, WHO ALSO WORKED AT THIS SAME LOCATION
AND HE RECALLS ON ONE OCCASION THAT ~~BOTH HE AND SIRHAN WERE~~
~~WORKING NIGHTS~~, SIRHAN TELLING HIM HE, SIRHAN, WAS FROM JORDAN

YOUNG STATED HE ASKED SIRHAN IF JORDAN WAS A GOOD COUNTRY TO LIVE IN AND SIRHAN TOLD HIM JORDAN WAS ONE OF THE BEST PLACES IN THE WORLD.

HE ADVISED THAT SIRHAN THEN ASKED HIM WHAT HE, YOUNG, THOUGHT ABOUT UNITED STATES AND HE TOLD SIRHAN THAT UNITED STATES WAS NO DOUBT BEST COUNTRY IN THE WORLD. YOUNG STATED HE RECALLS SIRHAN STATING "LIKE HELL IT IS." YOUNG STATED THAT AT THIS TIME HE DISCONTINUED HIS CONVERSATION WITH SIRHAN AND THEY NEVER HAD ANY FURTHER DISCUSSIONS.. YOUNG STATED THAT FROM THAT DATE ON HE NEVER HAD ANY FURTHER POLITICAL DISCUSSIONS.WITH SIRHAN. YOUNG STATED SIRHAN DID NOT HAVE ANY FRIENDS AND HE NEVER MET ANY OF SIRHAN'S RELATIVES OR SAW HIM WITH ANY GIRLS. HE ADVISED WHEN SIRHAN WAS NOT WORKING, HE WOULD SOMETIMES DROP BY AT STATION BUT NEVER SEEMED TO TALK TO ANYONE.

YOUNG STATED HE DID NOT KNOW OF ANYONE THAT WOULD HAVE BEEN CLOSE TO SIRHAN AND BEST WAY HE COULD DESCRIBE HIM WAS AS BEING A LONER. YOUNG STATED DURING TIME HE KNEW SIRHAN, HE NEVER OBSERVED SIRHAN WITH ANY TYPE OF WEAPON AND WAS UNDER IMPRESSION SIRHAN WOULD NOT BE TYPE OF PERSON TO PARTICIPATE IN ANY TYPE OF VIOLENCE.

ROGER GLEN MOORE, CURRENTLY RESIDING IN DUARTE, CALIFORNIA, ADVISED HE WORKED AT JACK DAVIS' GARAGE ON FOOTHILL BOULEVARD, PASADENA, CALIFORNIA, AND WHILE THERE CAME TO KNOW SIRHAN BISHARA SIRHAN, WHO WAS WORKING FOR PROPRIETOR JACK DAVIS IN SERVICE STATION SECTION OF THIS BUSINESS. MOORE STATED SIRHAN WAS A PART DASH TIME EMPLOYEE WHILE ~~HE WAS~~ ATTENDING PASADENA CITY COLLEGE. MOORE STATED HE NEVER BECAME PARTICULARLY FRIENDLY WITH SIRHAN DURING TIME THEY WERE BOTH EMPLOYED AT THIS BUSINESS NOR DID THEY SOCIALIZE. ON OCCASION HE AND SIRHAN MAY HAVE HAD A BEER IN STATION BUT THEY NEVER WENT OUT TOGETHER.

MOORE STATED AS BEST AS HE COULD RECALL, SIRHAN DID NOT SOCIALIZE WITH ANYONE AND ~~THE~~, SIRHAN, DID NOT HAVE FRIENDS COME BY STATION TO VISIT HIM.

MOORE STATED HE AND SIRHAN NEVER HAD ANY POLITICAL DISCUSSIONS AND HE CANNOT RECALL SIRHAN EVER HAVING MADE ANY REMARKS WHATSOEVER WHICH CAN BE CONSTRUED AGAINST THE UNITED STATES. HE SAID HE DID NOT EVEN RECALL ~~HIS~~ NATIONALITY *OF SIRHAN*.

RE: PAUL W. GRIECO

PAUL W. GRIECO, WOODBURY COLLEGE, STUDENT, ADVISES WAS IN KITCHEN AREA, AMBASSADOR HOTEL, TEN TO FIFTEEN MINUTES BEFORE KENNEDY WAS SHOT. GRIECO ADVISED HE WAS

IN TIGHT CROWD APPROXIMATELY TEN TO TWELVE FEET BEHIND KENNEDY BUT HIS VIEW WAS BLOCKED AND HE DID NOT SEE SIRHAN BISHARA SIRHAN SHOOT KENNEDY.

GRIECO ADVISED HE HEARD SEVERAL SHOTS IN RAPID ORDER. AFTER FIRST PANIC OF CROWD HE OBSERVED KENNEDY LYING WOUNDED ON FLOOR AND HE KNELT AND ATTEMPTED TO STOP BLEEDING OF KENNEDY'S HEAD WITH HIS HAND. ACCORDING TO GRIECO, KENNEDY ASKED HIM, "IS PAUL ALRIGHT. IS EVERYBODY ALRIGHT." THEN APPARENTLY KENNEDY LAPSED INTO UNCONSCIOUSNESS^{SCIOUSNESS}. GRIECO STATED HE DID NOT OBSERVE SIRHAN UNTIL AFTER ATTEMPTING TO COMFORT KENNEDY WHEN SIRHAN WAS BEING RESTRAINED. GRIECO DID NOT SEE MURDER WEAPON AND HE DOES NOT RECALL SEEING SIRHAN IN KITCHEN AREA PRIOR TO KENNEDY APPEARANCE AND SHOOTING.

JUDY MARIE ROYER, PRIVATE SECRETARY TO FORMER CALIFORNIA GOVERNOR, PAT BROWN, ADVISED SHE WAS AT AMBASSADOR HOTEL ON NIGHT JUNE FOUR LAST WORKING WITH SENATOR KENNEDY CAMPAIGN STAFF. STATED SHE PROCEEDED SENATOR KENNEDY AS HE LEFT EMBASSY ROOM AFTER HIS SPEECH AND WALKED TOWARD COLONIAL ROOM TO MEET WITH PRESS. ROYER STATED SHE DID NOT OBSERVE SHOOTING; HOWEVER, SHORTLY AFTER SHE HEARD SHOTS SAW ROOSEVELT GRIER HOLDING INDIVIDUAL SHE RECOGNIZED AS INDIVIDUAL SHE HAD SEEN APPROXIMATELY ONE TO TWO HOURS BEFORE SENATOR KENNEDY'S

MUNIR STATED HE AND MYERS WERE TRAVELING TOGETHER AND OBTAINED RIDE WITH OTHER TWO INDIVIDUALS. HAD NOT SEEN THEM BEFORE THAT DATE. MUNIR STATED HIS BROTHER, SIRHAN, WAS IN NO WAY ACQUAINTED WITH ABOVE INDIVIDUALS.
