GEORGE SOLOMONIDES, Manager, Lautrec Restaurant, Ambassador Hotel, 3400 Wilshire Boulevard, Los Angeles, California, advised he resides at 10279 Casanes Avenue, Downey, California, and his home telephone number is 862-8254.

SOLOMONIDES advised he reported for work at about 11:00 AM, June 4, 1968. Shortly after 2:30 PM, same date, as SOLOMONIDES stood at the front entrance of the Lautrec, he observed the following described person:

SOLOMONIDES stated the above described person carried some white loose leaf or possibly newspapers under one arm as he wandered around the fountain in front of the Palm Room located in the main lobby. SOLOMONIDES recalled he only observed this individual for about two minutes, for he was then summoned from inside the restaurant. SOLOMONIDES stated he did not observe the above described individual again. He viewed a photograph of SIRHAN B. SIRHAN and stated it was a close resemblance to the above described person, but could not positively state it was SIRHAN.

SOLOMONIDES advised later on June 4, 1968, at about 10:30 PM, as he stood at the pantry door of the Lautrec Restaurant, the following described individual attempted to walk through the pantry door:

SOLOMONIDES told this individual that he could not enter the rear door of the restaurant, that he would have to proceed to his destination through the lobby. The above described person smiled, said nothing, then walked out the front entrance. About ten minutes later, this same person again attempted to enter the pantry door, however, SOLOMONIDES again stopped him. As before, no conversation took place, as this person again exited the front door.

SOLOMONIDES stated he did not have any further contact with either of the above described individuals, and he closed the restaurant at about 11:15 PM. SOLOMONIDES immediately went home where he learned of the shooting of Senator ROBERT F. KENNEDY on television. SOLOMONIDES could furnish no information of value in this investigation and advised the second described person positively was not SIRHAN B. SIRHAN. SOLOMONIDES stated that if the first described individual was SIRHAN, June 4, 1968 was the first time he saw him.

RAMON RODRIGUEZ, JR., part-time waiter, Ambassador Hotel, 3400 Wilshire Boulevard, Los Angeles, advised he resides at 2248 Parkside Avenue, Los Angeles, and has home telephone number 223-0303.

RODRIGUEZ advised he has worked on a part-time basis at the Ambassador Hotel for the past six weeks and is currently employed by the "Los Angeles Times" in the capacity of a press room clerk. He stated he has worked for the "Los Angeles Times" for the past ten years.

RODRIGUEZ advised at about 12:20 a.m., June 5, 1968, he was in the kitchen located approximately 40 feet from the entrance into the Service Pantry, ordering a sandwich when he heard what sounded like a gun shot. About one second later he heard a second shot, then after two or three seconds he heard a burst of approximately four shots. He hastily ran out of the kitchen and into the kitchen employees' dining room and observed through the entrance way into the Embassy Room Service Pantry, a white male in a dark colored suit lying on his back. At this point an unidentified female Caucasian ran up to him and asked if he knew who the person was lying on the pantry floor. RODRIGUEZ stated that he did not; however, at this time JESUS PEREZ approached him and advised that Senator ROBERT F. KENNEDY had been shot and that PEREZ shook hands with the Senator just prior to the time he was shot.

RODRIGUEZ did not enter the Embassy Room Service Pantry where he was directed to stay clear of the area. About ten minutes later, policemen were attempting to clear a path to the service elevator; however, due to the large number of people crowded into the area, he was unable to observe any further events.

"I, Andrew Divyak, Chief Steward, Ambassador Hotel, 3400 Wilshire Boulevard, Los Angeles, California, voluntarily furnish the following signed statement to Special Agent of the Federal Bureau of Investigation, JC Fishbeck, Jr., who has identified himself by display of his credentials.

"I reside at 758 South Ardmore Street, Apartment 602, Los Angeles, California, and have no home telephone. I am single and have never been married. I have been employed by the Ambassador Hotel since 1950, except for a short period of time from late 1965 until April, 1966. From 1950, until late 1965, I was employed as Purchasing Agent, and since April, 1966, I have been Chief Steward at the Ambassador Hotel.

"I was born January 30, 1918, in Hibbing, Minnesota and have resided in Los Angeles, California since 1943. I am five feet eleven inches tall, weigh 170 pounds, and have been issued Social Security Number [REDACTED]

"I recall the following events that occurred in the Ambassador Hotel during the late evening hours of June 4, 1968, and the early morning hours of June 5, 1968:

"Shortly before twelve o'clock midnight on June 4, 1968, I was sitting in the kitchen employees' dining room adjacent to the Embassy Room Service Pantry. I was sitting with Jesus Perez, hotel employee, and a hotel security guard whose name I do not recall. As we sat at the table, I saw Senator Robert F. Kennedy and other persons walk through the dining room and proceed to the Embassy Room.

"I remained at the dining table figuring my work schedule when at about 12:15 a.m., June 5, 1968, I heard what sounded like three firecracker explosions. About two seconds later, I heard a burst of about six more firecracker explosions. As best I can recall, there was about one second delay between the first and second explosion, and about the same length of time between the second explosion and series of about six bursts. I looked up to see what made these noises and saw small lines of smoke coming from the Embassy Room Service Pantry.

"Immediately I arose from the table, ran into the pantry, and stood next to a metal tray stand across from a row of chrome steam tables. I saw two white male Caucasians wearing Kennedy campaign sportcoats and top hats standing on each side of a slender built male who appeared to be of Cuban descent standing against the steam tables. This person waved a pistol with his right hand, thus I yelled out to the effect, let's get him. The two men in the Kennedy campaign clothes grabbed the person waving the pistol before I did, and in the confusion, someone jumped ahead of me before I could reach him. However, I was able to observe his face and the pistol he held in his hand.

"By this time, several persons had shoved the above person against the steam tables, and had him sprawled over the table; but he was still waving

the pistol. I ran around to the other side of the steam tables in attempt to get the gun but too many people blocked my path. As I turned, I observed Senator Robert F. Kennedy lying on the floor of the Embassy Room Service Pantry. I ran to the Room Service desk to call for an ambulance; however, the phone was being used. I then ran to the Room Clerk's Office in the main lobby, but his telephone was also in use. Unable to locate an unused telephone, I ran back to the Embassy Room Service Pantry.

"Senator Kennedy was still lying on the floor; however, the person waving the gun had been moved down to the east end of the Service Pantry and was being held against the steam tables. I walked down toward where the individual was being held and saw Karl Eucher, Maitre D'Hotel, and Eddie, last name unknown, Assistant Maitre D', along with a tall heavy Negro in a maroon sportcoat, holding this individual against the steam tables.

"Eddie asked me to go get some rope in order that they could tie this individual up. I turned to go find some rope, however, I saw some Los Angeles Police Department officers enter the pantry. From that point, I assisted the police department and ambulance crews load the wounded individuals (total of four including Senator Kennedy), onto the service elevator and out of the hotel.

"I did not observe the police officers take the above individual who waved the pistol from the Embassy Room Service Pantry; however, as stated, I did observe him when I ran into the Pantry after hearing the above described explosions. The following is a physical description of that person:

"After assisting the police and ambulance crew with the last person to be taken to the hospital, I secured my work schedule and waited until about 1:50 a.m., at which time I gave a Los Angeles Police Department officer my name and address for future reference.

"I have been shown a photograph of Sirhan B. Sirhan and positively identify it as that of the above described person whom I saw waving a pistol in the Embassy Room Service Pantry about 12:15 a.m., on June 5, 1968, and who I attempted to apprehend together with several other persons in the room. I have seen Sirhan B. Sirhan's photograph in the newspapers and it is also the same person I have previously described on page five of this statement.

ALFELD stated these two classes were the California Cadet Corps and another elective which ALFELD could not recollect. ALFELD stated he did not associate with SIRHAN at any time, but recalled SIRHAN was quite active in Student Government, seemed to be withdrawn socially and did not impress him as being very aggressive. Further, ALFELD advised SIRHAN complied with the regulations of the California Cadet Corps, however, only participated to the extent of fulfilling the course requirements.

ALFELD could not recall any of SIRHAN's former or current companions, nor did anything come to his attention to indicate that the shooting of Senator ROBERT F. KENNEDY would take place.

ALFELD advised he reported for work at 6:00 PM on June 4, 1968, and finally left the building around 3:00 AM on June 5, 1968. ALFELD observed a photograph of SIRHAN B. SIRHAN and stated that it was the photograph of the same individual with whom he attended John Muir High School in the school year 1963 - 1964.

Immediately after hearing the series of shots, he ran through the kitchen employees' dining area and as he approached the entrance way into the Embassy Room Service Pantry, he observed one JUAN ROMERO, a hotel employee, holding Senator ROBERT F. KENNEDY in his arms. He recalled that Senator KENNEDY was lying on his back; however, he was unable to furnish any other details concerning that immediate area.

CARRILLO started back toward his office to call an ambulance, at which time he observed a tall heavy Negro man, whom he later learned was ROOSEVELT GRIER, leaning against a steam table with his hands against his head saying, "Oh no, oh no", several times. About six feet away from GRIER were three or four persons wrestling with an unidentified person. All CARRILLO could see was this unidentified person's arm waving a pistol with the surrounding persons attempting to grab the gun. At this time, many people began to converge on the area from the main lobby of the hotel and the Embassy Room.

CARRILLO finally ran back to his office, and as he arrived there someone was using his telephone. Therefore, he ran back to the Embassy Room Service Pantry

and observed several individuals, including KARL UECKER, Maitre d', EDDIE MANASIAN Assistant Maitre d', and ROOSEVELT GRIER attempting to protect the individual who was waving the pistol several minutes before. At this time, NIWA YOSHIO, cook at the hotel, told CARRILLO that he should go get some rope in order that the above individual could be tied up. He ran to his office and obtained a segment of rubber extension cord and returned to the pantry. An unidentified person took the cord from him, then due to the fact that he was very nervous, CARRILLO returned to his office.

About three to five minutes later, he returned to the pantry and observed three uniformed Los Angeles Police Department officers escort the individual CARRILLO observed waving the pistol in the Embassy Room Service Pantry out of the pantry and into the Colonial Room located adjacent to the east end of the pantry.



RICE said he, himself, at that time resided at 1880 East Villa, Pasadena, California, and that he believes SIRHAN lived in the vicinity of Washington Street; however, he did not know the specific residence address, having visited the residence on only one occasion.

RICE stated that SIRHAN was of assistance to him in his study of the Arabic language and that they had only a slight social association other than contacts at school. RICE said he considered SIRHAN to be a serious, intelligent, "student type" person, that he did not have any knowledge concerning his political interests, background or associates. RICE said that he met SIRHAN originally through one JOHN STRATHMANN and that he could suggest no other associates or acquaintances of SIRHAN. RICE commented that his last contact with SIRHAN was in August or September 1966, that he has no current knowledge concerning him, his activities or associates. He further stated that from limited knowledge of SIRHAN, he would have no basis to pass judgement or form opinion, which might bear in his being a suspect in the KENNEDY assault. RICE said that he could suggest no motivation or reason and that he would have no knowledge of any type of conspiracy which SIRHAN might have been a part of.

RICE advised that prior to entering Pasadena City College in 1966, he had been discharged from the U.S. Army, where he served from 1964 to 1966, Army Serial Number 55766560.

Mr. ROBERT WINANDY, Los Angeles County Juvenile Probation Department, 433 South Vermont Avenue, advised he previously had under his supervision [REDACTED] and that [REDACTED] is currently considered a runaway from the Manhattan Project Residence (MPR), 602 South Van Ness Avenue, Los Angeles, California on May 2, 1968. [REDACTED] had been placed with the MPR for residence by the Probation Department. The MPR is under the supervision of the Salvation Army. Mr. EDWARD BOYLE of the Family Service Section of the Salvation Army is responsible for the general supervision of these residents. A Mr. KEN BAKER was at one time in charge of the residence when [REDACTED] resided there.

[REDACTED] first came to the attention of the Probation Department following his arrest by the Los Angeles Police Department on October 24, 1967. At that time he was taken into custody by the Los Angeles Police Department in the vicinity of Zonal and Mission Road in Los Angeles and charged with violation of Section 601 of the Welfare and Institutions Code (transient). According to the police report he was found wandering without a settled place of abode, no visible means of existence or proper guardianship within the Los Angeles jurisdiction. Upon questioning by arresting officers, he was found to be dirty and his clothes wrinkled and told officers he did not know the whereabouts of his parents; had no money; had no way to support himself and had not eaten in two days. When questioned by investigators he made conflicting and "inconsistent" statements. He was evasive and refused to answer some questions. At first he stated he was from Bolivia, South America having left there about three weeks prior to his arrest. He later stated he was from Colima, Mexico. He stated his parents came to Los Angeles leaving him at home and he stole 800 pesos from them and came to Los Angeles. He claimed not to know where his parents were and that he had an uncle living in Los Angeles. He furnished the name of ARTURO BRISENO and a telephone number 754-7202, which number proved to be nonexistent and no one by the name of BRISENO was located. Since there was no known person to whom he could

be released and he was in need or protective custody, this matter was submitted to the Juvenile Court. The court ordered he be made a ward of the Juvenile Court and was retained in Los Angeles County Juvenile Hall. Attempts by the juvenile officers to locate his parents resulted in receiving a letter from his father, [REDACTED], dated November 19, 1967. According to Mr. WINANDY, [REDACTED]'s father resides at 353 General Nunez, Colima, Mexico.

The following is an English translation of the letter received from [REDACTED], the original having been written in Spanish:

"Colina - November 19, 1967

"Mr. Howard E. Brook
Los Angeles, California

"Sir:

"I received your letter dated November 10, informing me that my son was detained on October 24 and that you wish to know what should be done with him. First of all I want you to know that I was glad to have news about my son, and I want to tell you a few things about him.

"Last year I sent him to secondary school here in Colina, but because he becomes angry easily he did not get along with his school companions and he only made enemies in school. He left from school without my permission and went to my sister's in Mexico- Cuernavaca. He constantly took things from the house like: key (estilson?) remnants of cashmere, an electric shaver, and things of that kind. I know that he got to Cuernavaca asking for rides. When I found out

"where he was I went to Cuernavaca to get him and he promised me that he would behave and it was arranged so that he would return to school and not loose the school year. Five or six months afterwards he started behaving the same way as before and started taking things out of the house. For the second time his mother went to Cuernavaca and it was then that his mother and myself decided to take him to Los Angeles, California, to see if we could get him into a school there. His mother took him to Los Angeles and it was decided that he would go to a school located on Figueroa Street, in Los Angeles -- and I think that he was even going to live there -- but he did not want to go to that school and took \$70. from his mother's purse and escaped to San Francisco. You probably know already, from his record, that the Probation Department of San Francisco took hold of him, and that his mother also, when he took the seventy dollars, went to the Probation Department of Los Angeles where I believe they also keep his record. The Probation Department of San Francisco returned him to Cuernavaca. When his mother found out that he was in Cuernavaca she went there after him. He wanted to continue studying, but his mother insisted that he didn't finish the year because she said that he was making too much fun of the school teachers. He went to see the Director of Public Education of the state and he was excused and accepted again in school, but his mother was against it and she ordered that I would take him to my Rancho and teach him how to work in the field to see if in that way he could change his manner of thinking. Mr. Howard, according to the information I have here, in school he is a very intelligent boy, the only thing wrong was the lack of guidance and control. I brought him to the Rancho to work with me and for four or five

"months he helped me very much like anyone else would have done. When I finished my harvest I didn't have any more work and then I had to leave for the United States accompanied by my wife. I asked my son if he wanted to come with us in order to work, or if he would rather stay and study. He said that he wanted to stay and study, but his mother did not approve and asked me to take him with us. I didn't want to take him with me because I wanted to give him the last opportunity. I came to United States with his mother and he went back to school. I know that he only studied for about two weeks and then he started getting things from the house again. He broke the lock of the desk and took my pistol and other things of little value. This was the manner in which he left this place. I sent 90 dollars for the support of my sons to the girl who was taking care of them. She had spent only about 300 pesos and the rest of the money she kept in the wardrobe -- that I think were about 800 pases --. Well, my son broke the lock of the wardrobe, took the money with him when he left here. Only today, I know about his whereabouts, thanks to you, Mr. Howard. I am very grateful for this courtesy that I don't deserve.

"No, Mr. Howard, with reference to what I want to do about my son, I want you to know that right now I am doing the harvesting of my crop and I will not finish doing so probably in the a month, since I have only five or six men helping me. It is impossible for me to hire more men because I have a lot of corn, and too many people will not do the work right since it is impossible for me all by myself to control them. This is the reason why it will take me a long time to finish with the harvest. I also wish to tell you that it is impossible for me to leave right now in order to get my son because

"my economic situation is critical. I invested a lot of money in my land because I had to get it ready (cultivated). I owe the Bank about \$40,000 (forty thousand pesos). I think that I will get twenty or twenty five from my harvest. I had in mind to go to the United States after the harvest in order to work and pay the balance of the debt. Mr. Howard, I would like for you to help me with reference to my son only until I finish with my harvest, so that you can deliver him to me then and I can have him work with me, or maybe you can help me put him in a Military college. Mr. Howard, I beg of you for the sake of what you love most, don't release my son, by himself, since God has been taking care of him until now so that he does not get into serious difficulty.

"Please excuse my long letter. I am,

According to Mr. WINANDY on December 8, 1967 a telegraph was sent to the parents of [REDACTED] requesting them to sign a notarized letter permitting him to travel and a copy of his birth certificate. No reply was received to that request.

privately operated residence authorized by the Juvenile Court to accept juveniles for residence and Los Angeles County pays for their expenses. He remained there until January 22, 1968 when he ran away and was picked up by the San Bernardino Police Department on that same date as a runaway juvenile. He was returned to the custody of the Los Angeles County Juvenile Hall

where he remained until March 22, 1968, when he was permitted to take up residence at the above mentioned MPR. On March 29, 1968 he ran away from the MPR and on April 1, 1968 voluntarily surrendered himself to the custody of Juvenile Authorities. On May 21, 1968 he again ran away from his residence at MPR; his whereabouts since that time until June 17, 1968 were unknown and a warrant has been issued for his arrest as a runaway juvenile.


On June 17, 1968 at approximately 10:30 a.m. Mr. WINANDY received a collect telephone call from [REDACTED] from El Paso, Texas. At that time [REDACTED] desired to know what would happen to him if he should return to Los Angeles, California. WINANDY advised [REDACTED] that a warrant was out-

a Los Angeles "connection", a restaurant called the Mexico Lindo, 2829 Washington Street, Venice, California. WINANDY has not attempted to verify the foregoing but did report it to a Sergeant RALPH ZAPPEY, Los Angeles Police Department, Narcotics Detail. In the telephone conversation [REDACTED] WINANDY [REDACTED] within six hours from the time of the telephone call. WINANDY has received no further contact from or in behalf of [REDACTED] since that telephone call.

During the period of time he was a resident at the MPR, he attempted, on two occasions in May, 1968, to commit suicide by cutting his wrists. One of those occasions resulted in his hospitalization at the Los Angeles County General Hospital on or about May 8, 1968. He attempted another subsequent suicide by cutting his wrists sometime between May 14 and 22, 1968. On that occasion he leaped onto the roof of a nearby building threatening suicide and considerably upsetting other members of the MPR.

There is no indication in his file that he has associated or was acquainted with anyone by the name of SIRHAN. WINANDY advised that while residing at the MPR he was not considered reliable and frequently engaged in conduct and/or activities which could be characterized as fantasy. He is further described as a white male, born November 10, 1951 weighing 119 pounds, is 5'7" tall and has dark wavy hair. There is no indication in the file of any known associates of his in the Los Angeles area.

She further advised DOROTHY only lived with ROBERTSON a few months and then moved in with a cousin, JANET WHITE, in the Whittier area. In May, 1968, DOROTHY was arrested and spent ten days in jail. from jail until the end of May or the first of June, 1968, she had no contact with DOROTHY. She noted she takes care of DOROTHY's two older children and that DOROTHY has the baby with her.

MANNING stated she again saw DOROTHY around the first of June, 1968, and DOROTHY told her mother she was going to get an apartment and a job in the Norwalk area. DOROTHY visits the children on Sundays and occasionally drops by during the week. MANNING stated DOROTHY last visited her on Friday, June 7, 1968.

MANNING advised she did not know a JIM WILSON and that DOROTHY was presently going with an EDDIE NESS.

MANNING denied knowing where DOROTHY was residing or employed, and stated she had no way to get in touch with her. She claimed DOROTHY did not have an automobile but was driving an old Oldsmobile, not further described, when she visited her.
