MARYAM KOUSHAN, 1215 Ocean Avenue, Santa Monica, California, Apartment 206, telephone EX 3-0227, who was previously interviewed on June 11, 1968, advised the following:

MARYAM had previously advised that she had observed a person, who, based on a photographic identification, was SIRHAN SIRHAN. She had observed this individual when entering the Los Angeles Campaign Headquarters of Senator ROBERT F. KENNEDY, 5615 Wilshire Boulevard, Los Angeles, around 2:30 PM on June 2, 1968.

MARYAM had also previously examined a 1963 photograph of a brother of SIRHAN SIRHAN, SHARIF SIRHAN. She had stated that the photograph of this brother closely resembled an individual she had seen at the KENNEDY Campaign Headquarters around 3:00 PM on June 4, 1968. This person had been one of the volunteer drivers.

MARYAM was shown a current photograph of SHARIF SIRHAN. She voiced the opinion that the current photograph also strongly resembled the person she had seen in the KENNEDY Headquarters as a volunteer driver.

MARYAM also further examined a photograph of SIRHAN SIRHAN and said she still had the same opinion as previously given, that she had seen this person in the campaign headquarters on June 2, 1968. She also examined photographs of SIRHAN SIRHAN's other brothers, MUNIR and ADEL. She said she had no recollection of ever seeing either MUNIR or ADEL at any time.

MARYAM added that she had not attended the Senator KENNEDY Campaign Party at the Ambassador Hotel on the evening of June 4, 1968, and the morning of June 5, 1968.

as a volunteer worker. This is the English spelling of her name, however, she is sometimes referred to under the American spelling of her name MIRIAM KUSHAN. She also said that approximately six months ago when she was thrown from a horse while riding in Griffith Park in Los Angeles and had been taken to the Los Angeles General Hospital by KHAIBAR KHAN with whom she was riding, she had been booked in the hospital under the name of ROSE KHAN. This had been done in view of the fact that she and Mr. KHAN are Iranian nationals and Mr. KHAN was the leader of the opposition to the Shah of Iran among Iranians in the United States. It was a security measure as Mr. KHAN was apprehensive of political and possibly physical reprisals as a result of his opposition to the Shah of Iran.

[REDACTED] is the [REDACTED] of [REDACTED] an Iranian national who had worked at the Los Angeles Campaign Headquarters for Senator KENNEDY during the early part of June 1968. [REDACTED] had been previously interviewed by the FBI regarding any knowledge he may have had of SIRHAN SIRHAN and his brothers.

[REDACTED] said that [REDACTED] had not worked as a volunteer worker at the Senator KENNEDY Campaign Headquarters as some of [REDACTED] brothers and [REDACTED] had done. The only time that [REDACTED] went near the headquarters was when [REDACTED] drove [REDACTED] to the headquarters at 5615 Wilshire Boulevard, Los Angeles, on the early afternoon of June 3, 1968.

[REDACTED] said, after viewing photographs of SIRHAN SIRHAN and his brothers, ADEL SIRHAN, MUNIR SIRHAN and SHARIF SIRHAN, that he had no recollection of ever seeing these individuals at any time and had never heard of SIRHAN SIRHAN or his family until the recent publicity given them.

RICHARD L. COHEN, also known as Richard Rosen, 11030 Aqua Vista, Studio City, California, voluntarily appeared at the Los Angeles Office of the FBI at which time he furnished the following signed statement:

"Los Angeles, California  
July 12, 1968

"I, Richard L. Cohen, known as Rick Rosen, 11030 Aqua Vista, Studio City, California, furnish the following signed statement to Richard P. Doucette, who has identified himself to me as a Special Agent of the Federal Bureau of Investigation. No threats or promises have been made to me and I furnish this statement of my own free will.

"On June 4, 1968, I was at the Ambassador Hotel, 3400 Wilshire Boulevard, Los Angeles, California, when Senator Robert F. Kennedy gave his victory speech following the California primary election. At the time Senator Kennedy gave his speech, I was standing on the steps of the podium, in the Embassy Room, from which he gave his speech.

"After Senator Kennedy finished his speech, Jack Gallivan, Mr. Uno, manager for the hotel, and I started to lead the way toward the Colonial Room where Senator Kennedy planned to thank the members of the press. As we were passing through the kitchen area I heard a loud pop, like a firecracker, from my rear and I turned around to see what caused the noise. Senator Kennedy was starting to fall to the floor and I saw a man holding a black gun; the gun was going off and I could see fire coming out the back. Almost at the same time men were grabbing for the gun. I remember that a total of five shots were being fired. By the time the last shot was fired, the man holding the gun was subdued by several men, including Rosie Grier, Rafer Johnson and Jack Gallivan.

"I immediately went to the swing doors, near the restrooms, which lead into the Embassy Room, and asked two security guards, who had heard the shots and were coming into the kitchen, not to allow any more people in. The guards took out their guns and tried to calm the crowd.

"After awhile, I saw the man who had fired the shots being taken out of the area. I have since seen photographs of this man and he is known to me as SIRHAN BISHARA SIRHAN.

"After Senator KENNEDY had been taken to Central Receiving Hospital, I remained at the hotel until 8:00 AM when I went to school at Valley College, Van Nuys, California.

"I have read the foregoing statement consisting of this and one additional handwritten page. I now sign it because it is true to the best of my knowledge.

JUNE ISACKSON, Headquarters Office Manager, Kennedy Campaign Headquarters, 5615 Wilshire Boulevard, advised that due to the large number of individuals who worked at the Kennedy Campaign Headquarters, she is unable to specifically recall any of the individuals assigned to conduct telephone soliciting. She stated that in this regard, possibly MARY GILLESPIE, who resides at 1643 North Dillon Street, Los Angeles, could furnish information concerning the individuals who worked as telephone solicitors as GILLESPIE supervised the telephone soliciting program.

ISACKSON advised that individuals who worked at the Kennedy Campaign Headquarters came from two categories, one category being volunteer workers and the other being paid workers furnished by two Los Angeles employment firms. She identified the employment firms as The Peakload Company, 3057 Wilshire Boulevard, and Olsten of Los Angeles, Incorporated, 3735 Wilshire Boulevard.

ISACKSON advised that she recalled a volunteer worker by the name of KAIBAR KHAN, also known as "Goody", and advised he was responsible for bringing in some 15 to 20 volunteer workers prior to election day. She stated that all of these workers were individuals of Middle Eastern descent. ISACKSON described Goody as being a cordial, mannerly person and a willing worker but who did things which appeared to her to be strange. She explained that Goody insisted that all of the volunteer workers he brought in list their addresses as 10554 $\frac{1}{2}$  Wilshire Boulevard, which was the address Goody listed as his. Goody also related conflicting stories concerning his ancestry, first indicating that he was of Turkish descent and then stating he was Persian. He also claimed to be a good friend of the KENNEDY family and a supporter of Senator KENNEDY and made several statements indicating that he knew Senator KENNEDY was going to win the election, but, for several unexplained reasons, ISACKSON felt that Goody was not sincere and that he was a phony.

JOHN PAWLUK, 643 Date Street, advised that his father is ALEC P. PAWLUK, employed by Marquardt Industrial Products, Pomona, California, and that his father is traveling on a vacation trip somewhere in Oregon, expected to return about July 8, 1968.

He said his uncle is JOHN BENJAMIN LAWRENCE who lives and works in New York City, and believes he practices law. His uncle has not been in the Los Angeles, California, area for about three to five years.

His father has a sister, Mrs. OLGA BELL, 849 Nottingham Drive, Redlands, California, and her husband is a minister of the Redlands Baptist Church, telephone number PY 2-5793.

ALEX P. PAWLUK was interviewed at his place of employment, Marquardt Industrial Products, 9271 Arrow Highway, and advised that he is the brother of JOHN M. LAWRENCE, also known as John Lawrence Pawluk. He said that he is a retired Air Force Warrant Officer. He advised as follows:

His brother has been living in New York City for about four years, and he assumes his brother has changed his name legally to JOHN M. LAWRENCE. His brother attended college in the Los Angeles area for several years, place not known, but did not graduate. His brother has a brilliant mind and has a law background, achieved through self study of the law, and is considered as competent as an attorney but has no degree nor license. He often works as a legal secretary or researcher. His brother always had a concern for the "underdog" and has been a crusader of causes. He often tests the constitutionality of laws and therefore often runs afoul of the law. He has had numerous arrests for misdemeanors but has no prison record.

He said an outstanding example of one of his brother's crusades occurred in about 1964 in Colorado when he fought against a local tax on a water project. As a result, the State of Colorado had him committed to a mental institution, where he remained for several months. Mr. PAWLUK said, when he learned his brother was in custody, he arranged for his release, and they returned together to Pomona, California.

His brother stayed four to six months with him in Pomona, and he said he observed that his brother was not insane. His brother worked at some legal office locally, but after a few months, he returned to New York City.

He said his brother is not a violent man. He recalled having a heated argument with him several years ago

and his brother told him that he was opposed to violence and would never get into a physical fight over an issue.

He said, if his brother is anti-Israel, he is no doubt supporting the "underdog" and that this conviction is contrary to his family background, as his family was raised in the Baptist church, where his father is a minister.

He said he knew nothing of an organization named Federated Americans Against Israeli Racism and did not know of any of his brother's organizational affiliations.

Concerning the question of funds, he said his brother is always soliciting money for his pet projects from anybody who will donate.

He recalled that his brother's wife telephoned him about six months ago saying that his brother was in local custody at Danbury, Connecticut, and she asked for money.

He added there is no reason to believe his brother had any connection with SIRHAN BISHARA SIRHAN.

Women's Apparel Style Books reflecting record and description of all dresses previously manufactured under the various labels used by Del Monte Sportswear were made available by JACK WEINGARTEN, President, Del Monte Sportswear, 1407 South Maple Avenue.

The style books covering a period from summer 1962 to summer 1963 were reviewed by SA JOHN F. MORRISON. It was ascertained that the books contained no record or description of a junior petite 3/4 sleeve polka dot dress, having black dots with a white background and further described as having a bib front accentuated with black piping, with a distinctive black bow at the neck.

JACK WEINGARTEN, President, Del Monte Sportswear, 1407 South Maple Avenue, advised his firm are manufacturers of women's wearing apparel under the label of Jodette of California, and this label is distributed to four thousand outlets throughout the United States. He said his firm also manufactures and distributes women's wearing apparel under numerous other trade style names (label).

Mr. WEINGARTEN verified, after a review of the current company style book, that his firm manufactures a junior petite, sleeveless, polka dot dress. He further identified the dress as having black dots with a white background, with a bib front, accentuated with black piping, and having a distinctive black bow at the neck. He said the dress is identified in the company style book as being Style Number 4364, Lot Number 7023. He explained a junior petite dress is a dress size description ranging from size 5 to size 11.

Mr. WEINGARTEN said his firm does not currently manufacture a polka dot dress described above and having a 3/4 length sleeve. He said he has a record of all dresses manufactured by his firm dating back to the summer of 1962.

RICHARD DAVID GILES contacted the Pomona Resident Agency, telephonically. When questioned about the notations on a piece of paper regarding SIRHAN SIRHAN found in his possession at the time of his arrest on a drunk charge, GILES advised that he had been reading about SIRHAN in the newspapers and that this writing had been made by him in the form of doodling and had no significance whatsoever. He stated that he knew nothing of SIRHAN SIRHAN except what he had read in the papers and heard on news media of him.

In the event it is necessary to contact him in the future, he said that he could be contacted either at Jackson Lumber Yard in Claremont or at the Thompson Plating Company in Pomona, where he does part-time work.

Mrs. MARY SIRHAN, 696 East Howard Street, advised that the only time her son SIRHAN B. SIRHAN has been away from home was during the latter half of 1966, when he worked on a horse ranch near Corona, California, for several months.

She said he lived with someone near the ranch, name and address not recalled, but came home every week to ten days. She said she used to have a phone number, believed to be at the ranch, where she could reach him if she should become anxious about him, but he asked her not to call him there because he said it made him appear to be "like a baby" if his mother kept such close contact with him.

She said he once wrote her and gave her his address and asked her to "look after his mail". He enclosed ten dollars with the letter, but he did not ask her to forward his mail to him, in fact he returned home the next day after she received his letter and picked up only one piece of mail which had come for him, which she believed was a pamphlet from the Rosecrucians.

She said she never forwarded mail to him.

She said she once had his address near Corona written on a piece of paper, but gave it to the police recently along with the phone number written on a card, and could not from memory recall what it was or the phone number she once had for her son, SIRHAN. She had no idea what, if any, significance the word "hotel" followed by the number 9781 had.

She was unable to furnish any information regarding the possible identity of any one named ROGER or ROGERS as appears in the notebook of her son, SIRHAN B. SIRHAN.

ADEL BISHARA SIRHAN was interviewed at his residence, 696 East Howard Street, regarding notations made in the notebook which bears on the cover, "Pasadena City College" belonging to his brother, SIRHAN B. SIRHAN and he furnished the following information:

In Item Q1, pages 9, 11, 33, 67 there are written what appears to be aimless practice writing in the Arabic language, which has no significance.

He stated that also Items Q5-E and Q5-F contain fragmentary Arabic writing of incomplete thoughts relating to the Koran and parts of the words to a love song.

He advised that Item Q7 appears to be several pages of a test in the Russian language, on the last page of which is written in Arabic, "this examination is very difficult".

He stated that throughout this notebook, there are names of race horses, such as Sol Sonjuanino, Jet Spec, Fiona, Laguna Doll and Dona Donaruma, and possibly others, which he is not certain of.

He stated that the names TYRONE CHAPMANN, JOHN STRATHMANN and Mrs. B. GALE JOHNSTON are unknown to him.

He advised that the number 91104 on Items Q1-32 is a zip code number of his own address.

He stated that the name PEGGY OSTERKAMP is the name of a girl his brother, SIRHAN, knew, but he, himself, had never met her. He stated that in Item Q1-14 there appears Arabic writing of words to a song contained on a record, which they play in the home.

He advised that Item Q5-F also contains words in Arabic of a love song. He stated that he has no information as to the meaning of the number 95114 contained on Item Q1-27.

He advised that Item Q9 is a strip of three photographs of his brother, SIRHAN B. SIRHAN, taken at a coin operated amusement park type photographic booth approximately six to eight months ago located in a department store on Colorado Boulevard in Pasadena. He stated that he recalled that he accompanied SIRHAN and his other brother, MUNIR, to a shoe store nearby, where the photograph was taken.

Q10 This is a copy of the May 23, 1968 edition of the Christian Science Monitor paper, which is thrown on their lawn and the lawns of other houses in their neighborhood periodically.

He stated that Item Q11, the mimeographed student publication titled, "The Opinion", is unknown to him.

Item Q12 is a throw away flyer, either mailed to their residence directed to the occupant, or thrown on their lawn and is a campaign flyer announcing the appearance of Senator EUGENE MC CARTHY in Pasadena on May 31st.

Q13, a pamphlet entitled, "Mental Projection" is the sort of material his brother, SIRHAN B. SIRHAN, read; he has no idea as to the origin of this publication.

Item Q3-124 contains at the bottom of the page in Arabic a repetition of the sentence in English immediately above which begins, "Workers of the world unite, you have nothing to lose but your chains".

He identified the material shown to him as being written in the handwriting of his brother, SIRHAN B. SIRHAN.

SAIDALLAH BISHARA SIRHAN was interviewed at the home of his mother at 696 East Howard Street, Pasadena, California for information concerning notations made in the notebook of his brother, SIRHAN SIRHAN, which bears on its cover, "Pasadena City College". SIRHAN furnished the following information:

Q1-9 and Q1-11 contain Arabic writing that appears to be unrelated practice writing.

Q1-12 He was unable to determine the identities of TYRONE CHAPMANN; JOHN STRATHMANN, LAGUNA DOLL, or Mrs. B. GALE JOHNSTON. He believes LAGUNA DOLL possibly referred to a race horse.

Q1-14 The Arabic writing on this page is part of the words to a song. The family possesses a record in which this song is sung in Arabic.

Q1-27 He was not aware of what the number 95114 referred to unless it referred possibly to a zip code.

Q1-32 The number 91104 is the Post Office zip code for the address of 696 East Howard Street, Pasadena, California.

Q1-33 appears to contain practice Arabic writing of unrelated phrases repeated over and over.

Q1-56 He stated that the names DONA DONARUMA and DONARUMA FRANK are meaningless to him and could possibly refer to the names of race horses.

Q1-67 This appears to be practice writing in Arabic.

Q1-68 The words FORDS and ROHN are unknown to him. The words CLETE ROBERTS refer to a newscaster in the Los Angeles area.

Q1-69 The word GHATTAS is a family name not used by any member of the family. He said the name PEGGY OSTERKAMP is a girl he heard SIRHAN mention, Jet Spec is the name of a race horse, and LAWRENCE WELK is the nationally famous band leader, none of which has any particular significance in context.

Q1-71 The names T. DEUTSCH and JOHN DAYS are unknown to him. The names GWEN, GUM and PEGGY OSTERKAMP are names of girls known by SIRHAN.

Q1-72 The name GARNER TED ARMSTRONG is unknown, but possibly has some connection with the Christian Science Monitor publication.

Q1-73 appears to be a diagram graphically depicting the pedigree of the race horse, Jet Spec.

Q1-74 The name MAWLEDENOOR is believed to be the name of a race horse.

Q1-75 The name Prince Khaled is believed to be the name of a race horse, as is the name Fiona.

Q5-A The Arabic writing on this page says, African music used by the Negroes in the United States originated in the United States, but not in Africa.

Q5-E This page contains Arabic writing which appears to be aimless doodling relative to the Koran.

Q5-F The Arabic on this page appears to be practice writing of unrelated ideas, part of which says United States of America, and part of which is words to a love song.

Q7 The last page of this item contains words in Arabic stating to the effect "this examination is very difficult".

Q2-p28 contains Arabic doodling.

He advised that from what he could see of all the handwriting exhibited to him, it was all in his brother, SIRHAN B. SIRHAN's handwriting.

SAIDALLAH BISHARA SIRHAN, 1559 North Lake Avenue, Apartment 7, advised that the English translations of the foreign writing contained in the notebooks of his brother, SIRHAN B. SIRHAN, appear to him to be just "scribbling". He said the most he can make out of the writings is that SIRHAN was just practicing writing words and phrases in Arabic, as most of the writing does not contain a complete thought or sentence. Many places he just stopped in the middle of a sentence and repeated a word over and over without ever finishing the thought. At best, he said he would consider the Arabic writing as words written at random or just "doodling".

He said, for instance, the word "BASEM" written in English on item Q1-38 means "smiling" in Arabic. On the same page are Arabic words "Waheeduddeen" and "Wajieduddien", the same word spelled two different ways, which means an artist, such as a musician or singer or great star - a very talented and prominent performer.

On Q1-33 appears the word "Shener" in English which is meaningless to him in the context it appears, unless SIRHAN was attempting to write the Arabic work "shenar" (phonetic), which means "a wild chicken".

He said the Arabic writing on Q2-28 are the beginning words of an Arabic love song and is nothing more than aimless "doodling".

He said the names ELLEN GRUDER and Kallellen on item Q1-32, written in English, are meaningless to him, and he has never heard SIRHAN mention those people. He said also that he has no idea as to whom the name ROGLER or ROGERS refers to.

MUNIR BISHARA SIRHAN was interviewed at his residence, 696 East Howard Street, Pasadena, California.

He entered the residence toward the end of the interviews with his brothers, ADEL and SAIDALLAH, and the material covered with the latter two was not reviewed with him completely.

MUNIR did, however, review the photographic copies of Item Q2, a small notebook and stated that page one contains the names of two attorneys, HOLLOPETER and MARCOS. He advised that Q2-p3 contains five items which appear to relate to the time he was arrested for narcotics, for which he is currently on probation. He stated that Item 1, which says "see Mrs. Thurber", is probably a notation made by his brother, SIRHAN B. SIRHAN to contact Mrs. LILLY THURBER, who was, during that time, MUNIR's superior at Nash's Department Store. He stated that Mrs. THURBER left that store in June, 1967 for a visit to Holland, but has since returned, and he has no idea as to her current whereabouts in Pasadena.

He stated that the other four items on that page were apparently things his brother, SIRHAN, did or intended to do in the way of helping MUNIR while he was being held in jail.

Q2-p5 contains the notation, "Gilbert VS Hollopeter" and "Van Downie's testimony". He stated that GILBERT is the name of a Pasadena Police Officer, HOLLOPETER is a Pasadena attorney, and VAN DOWNIE is also a Pasadena Police Officer, but he had no idea as to the significance of these notations made in the notebook owned by SIRHAN.

Item Q2-p7 contains the name JAMES and the number 64. He stated that there is a police officer named JAMES, first name unknown, in the Detective Bureau of the Pasadena Police Department and this could be a reference to him.

MUNIR SIRHAN was arrested on a vagrancy charge in Flagstaff, Arizona, in May of 1966, along with three or four other individuals. He and DAVID MYERS had left Los Angeles, California, together on a hitchhiking trip. They had been acquainted with each other only two or three weeks before their departure. MUNIR SIRHAN's brother, SIRHAN BISHARA SIRHAN, was not acquainted with MYERS in any manner.

The other individuals who were arrested at the same time were not known to MUNIR SIRHAN prior to the date of the arrest. It was pointed out to Mr. SIRHAN that apparently the Flagstaff, Arizona, Police records indicate he was acquainted with PHILLIP LEE CLEVINGER and RONNIE EDMON HOULEN who were arrested at the same time. Mr. SIRHAN advised that this was inaccurate, as, in fact, he and MYERS were traveling together, and they obtained a ride with the others. He had not seen them before that date.

Mr. SIRHAN stated, without any qualification at all, that his brother, SIRHAN BISHARA SIRHAN, was in no way acquainted with any of the above individuals.

SHERMAN LIVINGSTON was interviewed at his residence, 2555 Vista Laguna Terrace. Mr. LIVINGSTON advised as follows:

Mr. LIVINGSTON is an official of the Ancient Mystical order of Rosae Crucis. He does not attend meetings regularly at any particular temple. On May 28, 1968, he attended the weekly Tuesday evening meeting of the Pasadena Chapter. This was somewhat of a special event in that the chapter presented Mr. LIVINGSTON with a ring for past services performed by him.

He arrived at the temple, 2031 East Villa, Pasadena, California, at approximately 7:45 p.m. on May 28, 1968. When he arrived, it was pointed out to him that a new member was present. This individual was introduced to Mr. LIVINGSTON as SIRHAN BISHARA SIRHAN.

Mr. LIVINGSTON chatted briefly with SIRHAN who advised him this was the first time he attended a meeting of the order. SIRHAN advised that he had been a member of the order for approximately one year, but he had not attended a meeting before. He indicated to Mr. LIVINGSTON that he would like to talk to Mr. LIVINGSTON at length. Inasmuch as it was time for the meeting to begin, Mr. LIVINGSTON told SIRHAN that he would enjoy the opportunity to talk to him following the meeting.

When the meeting was over, Mr. LIVINGSTON noticed SIRHAN standing alone and looking at some literature, but Mr. LIVINGSTON was occupied in other conversations and did not have the opportunity to talk to SIRHAN again. The next time he looked for SIRHAN, SIRHAN had already departed.

Mr. LIVINGSTON had noted that SIRHAN's address was at 696 East Howard in Pasadena, and he had planned to give him a ride home; however, he was unable to locate Mr. SIRHAN to accomplish this.

Mr. LIVINGSTON did not attend the meeting held the following week, on June 4, 1968, at the Akhraton Chapter.

Mrs. ELEANOR JOHNSON, 1255 Morada Place, Altadena, California, was interviewed approximately 10:30 a.m., Sunday June 9, 1968, regarding the present whereabouts of MAJED GUSSOUS. Mrs. JOHNSON had no knowledge of GUSSOUS and indicated that no Arab students had lived at this address since some time prior to her moving to this address in 1964.

She said her name was TOSTI or TASTI or TOSTO (phonetic). She first said she was a friend of SIRHAN then amended this to say she had worked with him in a health food store at one time. She then said the purpose of her call was to locate ABDEL MAJED BASS, a Jordanian who knew SIRHAN and who used to live at this address. The woman said that she wanted to ask BASS what he knew about SIRHAN. Mrs. JOHNSON thought the woman's behavior was rather strange. Prior to leaving, the woman gave Mrs. JOHNSON a telephone number, SY 8-2719, where she could be reached.

JONES immediately threw himself on the floor behind the steam tables and crawled around to the other end where he saw that Senator KENNEDY had been shot.

JONES stated that he did not see the shooting take place as there were many people in front of him and only realized something had happened when he heard the shots. He further advised that during the time he was in the kitchen, he had talked to the Security Guard positioned at the doorway into the Embassy Room but recalls nothing suspicious taking place prior or during Senator KENNEDY's entrance.

JOHNNY LORENZO WILLIAMS, also known as John Williams, 4335 Don Diablo Drive, Baldwin Hills, California, phone AX 4-2443, advised that he is a Negro free lance announcer and owner of a wig shop called the Black Foxe, Ltd., 1603 South La Brea Avenue, Los Angeles, California. He furnished the following information with respect to his knowledge of the events of June 4 and 5, 1968 at the Ambassador Hotel where Senator ROBERT F. KENNEDY was shot.

On June 4, 1968, at approximately 10:00 P.M. he went to the Ambassador Hotel to participate in a rally for Senator KENNEDY since he, WILLIAMS, is a member of an organization called "New Images", which he described as a Negro organization formerly dedicated to the support of Senator KENNEDY for the Democratic Presidential nomination. At approximately midnight he heard the Senator speak in the Embassy Room. Following the speech, he observed that Senator KENNEDY was pressed by the large crowd as he started to turn to his, KENNEDY's, right. The Senator then turned to his left and proceeded behind the curtains at the rear of the stage. A few minutes later he heard some rapid sounds which sounded like balloons popping but which he later learned were gun shots. He then observed a female Caucasian, who he later learned was ELIZABETH EVANS, proceed from the direction of the kitchen area of the ballroom with some blood on the side of her head.

He stated that he was approximately in the center of the ballroom when the shooting occurred and did not get any closer to the scene due to the large number of people there. He did not see anyone in a polka dot dress nor can he recall seeing SIRHAN BISHARA SIRHAN while at the hotel at any time. He advised that BOOKER GRIFFEN, President of the "New Images" and publicity director for the Negro Industrial Economic Union was on the platform with Senator KENNEDY during the Senator's speech. He also stated that GEORGE GREEN, Vice President of "New Images" was also in the ballroom. He further recalls seeing WILLARD MURRAY, Mayor YORTY's assistant in charge of liaison with the Los Angeles Negro community, in the ballroom.

STEVEN B. WAGNER, 12237 Califa Street, telephone number 769-1294, who was a volunteer worker for Senator ROBERT F. KENNEDY furnished the following information with respect to his knowledge of the shooting at the Ambassador Hotel on June 5, 1968:

At approximately 10:30 p.m. on June 4, 1968, he went to the Ambassador Hotel and tried to gain entry to the Embassy Room but the fire marshals had closed it. He also tried to get into the Colonial Room; however, he could not gain access to that room since he did not have the proper badge. He then heard and saw the Senator speak on the television monitors which were set up on the patio outside the Embassy Room. He was in this area when the shooting occurred. He first realized that something unusual had happened when he heard screams and someone say that the Senator was shot. He then saw a flood of people exit the Embassy Room. Standing with him was TIFFANY JONAS. They saw an injured person being carried out of the Embassy Ballroom whom he thinks was IRWIN STROLL, and many people followed immediately after him.

Also with him was another volunteer worker, VICKI CUCCIA, 730 South Kingsley Drive, and she appeared very upset over the shooting so he decided to walk her home, which is a short distance from the hotel. When they were approximately one and one-half blocks from the hotel on Normandy Avenue, he observed a man in a white uniform similar to the uniforms worn at the Ambassador Hotel climb into a blue and white Ford which was parked on the east side of Normandy, facing north. He stated there were two blue and white cars parked one behind the other and that one was a 1957 Ford and the other was a 1967 or 1968 Ford. He does not recall which automobile this individual drove off in. He cannot further describe this individual and did not observe in which direction the car went after leaving its parking space.

Mr. THEODORE STEVENS, 586 Pulman Street, Los Angeles, advised that he is the Master of the Chapter, "Ancient Mystical Order Rosae Crucis" (AMORC), having regular Tuesday weekly meetings in the Pasadena area.

Mr. STEVENS advised that he is familiar with the name SIRHAN BISHARA SIRHAN as being a member of his organization who attended a meeting on May 28, 1968, at the Pasadena Chapter. Mr. STEVENS stated that he definitely remembers SIRHAN's arriving on the evening of May 28, 1968, at approximately 7:30 p.m., his signing the guest registration, and his attendance at the meeting which broke up shortly after 9:00 p.m. STEVENS stated that this was the only meeting ever attended at his Chapter by SIRHAN. Mr. STEVENS stated that he himself did not converse with SIRHAN, but he advised that SIRHAN may possibly have spoken to one or two members of his organization.

Mr. STEVENS was exhibited photographs of six male individuals by SA PAUL CHAMBERLAIN, JR., and from these photographs Mr. STEVENS picked the photographs of SIRHAN BISHARA SIRHAN as being identical with the individual in question.

STEVENS stated that he could find nothing in the concepts of his organization, which is a mystical, philosophical and fraternal organization, that would have influenced SIRHAN to take action against Senator KENNEDY.

STEVENS stated further that his order teaches that drastic changes are not permanent changes and that, therefore, changes must come through evolution. He advised that AMORC is definitely not anti-Semitic and, in fact, has many Jewish members.



Mrs. OLGA BELL, 849 Nottingham Drive, Redlands, California, wife of the Reverend IVAN B. BELL, advised that she is a sister of JOHN LAWRENCE PAWLUK. She said that he uses the name of JOHN LAWRENCE exclusively and resides at 57 West 10th Street, Apartment 3-C, in New York City. She said that he is a graduate of John Garfield High School in Los Angeles, and to the best of her knowledge, never went beyond that in school. Except for one very brief visit in a car in front of her home several years ago, Mrs. BELL said she has not seen her brother, JOHN LAWRENCE, since she visited him in New York City in 1952.

Mrs. BELL said she is not fond of her brother and that he seemed over the years to contact her only to tell her that he was in trouble. Mrs. BELL indicated that she did not care to document her knowledge or association of her brother very positively. She said that she wanted to avoid any reference to him in her thinking because he had generally been argumentative and had been opposed to any respect for the Christian religion. She pointed out that since her husband is a Baptist Minister in Redlands, JOHN LAWRENCE had called her husband about one month ago and talked to her husband briefly since he read about SIRHAN SIRHAN having worshipped in a Baptist Church. In view of this, JOHN LAWRENCE thought it would be appropriate if the Reverend BELL would contact a fellow Baptist minister of the Reverend's own choosing and urge that minister, preferably from the Pasadena, California, area, to establish contact with SIRHAN SIRHAN. The Reverend BELL did not comply with the request.

In early 1968, the Reverend BELL had been in New York and had a brief visit with JOHN LAWRENCE. At that time LAWRENCE gave the Reverend BELL a book written by SAMI HADAWI entitled "Bitter Harvest" (Palestine 1914 - 1967), published by the New World Press.

Mrs. BELL said that her husband had read from the book but had not commented about its contents. She said it favored the Arab view point in its struggle with Israel. She added that she felt as if she had disowned JOHN LAWRENCE and did not wish to be contacted by him. She said he was aware of her feelings.

In further recollection, she said that he was born in December 1921, in Ft. Worth, Texas, and has occasionally called saying he had been arrested, but she did not know where. She thought it was probably in Colorado and in New York City. She said also that he was to have had some psychiatric examination in Denver, Colorado, at the time of a court appearance there. She said further, that his general feelings have been opposing big business and government, but she did not know of any reference indicating violence in his feelings. She said that it seemed strange to her that in 1966 he married a Jewish girl whose first name was MARJORIE, and who was from New York City. Mrs. BELL said she has never seen JOHN's wife and knows nothing about her except that in telephone comments JOHN LAWRENCE indicated that his wife was now also pro-Arab in her political views. They have no children.

Regarding employment, she stated she did not know where he was employed but that he usually obtained employment in researching public court records for attorneys, but to the best of her knowledge, he never had any formal legal training himself.

MARY SIRHAN, 696 East Howard Street, mother of SIRHAN BISHARA SIRHAN, advised as follows:

She has never heard of anyone by the name of FRANK QUARTUCCI. She does not believe that her son, SIRHAN, knew an individual by this name. From her knowledge of SIRHAN, she does not believe that SIRHAN received money from anyone to kill Senator ROBERT KENNEDY. She visited SIRHAN at the Los Angeles County Jail on July 11, 1968, and at that time SIRHAN assured her that no one else was involved with him in the killing of Senator KENNEDY.

MARY SIRHAN said that all the money SIRHAN had in his possession at the time he was apprehended came from an insurance settlement earlier this year. She noted that she has furnished full details regarding this insurance settlement during previous interviews. She added that she had been holding \$1,000.00 from this settlement for SIRHAN and shortly before the assassination she gave SIRHAN \$300.00 from this money. At the time she gave SIRHAN the \$300.00 he had additional money in his possession, exact amount unknown.

MUNIR BISHARA SIRHAN (MUNIR), 696 East Howard Street, was asked to account for his whereabouts during the morning and afternoon hours of June 4, 1963.

MUNIR stated that he left his residence at 696 East Howard Street, Pasadena, California, to go to work at approximately 8:30 a.m. Shortly thereafter, he boarded a bus at Lake and Howard Streets, and riding south on Lake Street and crossing Washington Street, he observed his brother, SIRHAN BISHARA SIRHAN (SIRHAN) buying a newspaper at a market located on the corner of Lake Avenue and Washington Street.

MUNIR stated that he arrived at work at approximately 9:00 a.m., and he worked the entire day, leaving his employment at approximately 6:00 p.m. MUNIR noted that he is employed as a stockboy at the F. C. Nash and Co. Department Store, 141 East Colorado Avenue, Pasadena.

MUNIR stated that he went directly home from work and that he spent the evening of June 4, 1963, at his residence until he retired at approximately 10:30 p.m.

MUNIR related that his brother, ADEL BISHARA SIRHAN owns a 1961 Volkswagen, light tan in color. MUNIR acknowledged the fact that he drives this vehicle on occasion.

VIRGINIA WITHROW, Personnel Manager, F. C. Nash and Co. Department Store, 141 East Colorado, advised that the time card of MUNIR BISHARA SIRHAN (MUNIR) shows that MUNIR reported for work at 3:54 a.m. on June 4, 1963. The time card shows that MUNIR worked until 6:00 p.m.

WITHROW noted that the time card does not show that MUNIR took a lunch period and explained this by saying that during the day MUNIR went to the Whittier store to do some work in the company of VERNON MOST, who is the manager of the Houseware Department.

Mrs. WITHROW stated that she recalls seeing MUNIR at the store in Pasadena at approximately 6:00 p.m. on June 4, 1963, as at that time MUNIR was acting as the Security Officer, and he checked her out of the store.

VERNON MOST, manager of the Houseware Department, F. C. Nash and Co. Department Store, 141 East Colorado, advised that he is the supervisor of MUNIR BISHARA SIRHAN (MUNIR).

MOST stated that he can account for MUNIR's activities on June 4, 1963, between approximate hours of 9:00 a.m. to 6:00 p.m. MOST stated that MUNIR worked at the Pasadena store from approximately 9:00 a.m. to about 11:00 a.m., at which time MOST and MUNIR left the Pasadena store and proceeded to the F. C. Nash and Co. Department Store, 1112 Quad Way, Whittier, California, where they worked until approximately 1:20 p.m. They left the Whittier store and returned to the Pasadena store, having lunch in East Pasadena en route.

MOST stated that MUNIR worked at the Pasadena store from the time he returned from the Whittier store until approximately 6:00 p.m., at which time MUNIR departed the store.

LAVERNE BOTTING, also known as, Bobbie, was contacted at Democratic Headquarters, 101 West Huntington Drive. BOTTING stated that she resided at 359 Mount Olive, Bradbury, California.

BOTTING related that up until June 5, 1968, this office was used as the campaign headquarters by the late Senator ROBERT F. KENNEDY and that this office covered the entire San Gabriel Valley. She recalled that on May 30, 1968, she was sitting at her desk at campaign headquarters and during the afternoon three individuals entered the headquarters. Two of the individuals stayed outside a counter and the other walked by the counter and walked up to her desk and inquired whether or not KENNEDY was expected to visit the headquarters. She recalled this individual was told that KENNEDY was not scheduled to make any additional appearances in the San Gabriel Valley. She is not certain, but she believes the individual said that he was from Kennedy Headquarters in Pasadena, and that they were wondering if Senator KENNEDY was planning a visit to the area. BOTTING stated that she did not take the names and addresses of any of these individuals.

BOTTING noted that during her conversation with this individual ETHEL CREHAN was sitting in her presence with her back to the counter.

Mrs. BOTTING stated that the individual who approached her closely resembles SIRHAN BISHARA SIRHAN. A photograph of SIRHAN, Los Angeles County Sheriff's Office No. 495 139, was exhibited to BOTTING and she said from this photograph, she believes that the individual was SIRHAN, or a person who very closely resembles SIRHAN. She added that there is a reasonable doubt in her mind that the individual was SIRHAN; however, she believes that she could definitely say one way or the other whether the individual was actually SIRHAN, if she had the opportunity to view SIRHAN in person.

She stated that some of the things about the individual that she definitely recalls is that his face had the appearance that at one time he had a problem with acne. The individual had a foreign look about him; however, he spoke in excellent English. She stated that when the individual first entered the headquarters she thought he was MARIO AGUAYO, a campaign headquarters' worker; however, as it turned out the individual was much shorter than AGUAYO, but did have certain facial resemblances to AGUAYO. She noted that AGUAYO resided at 405 East Second Street, Azusa, California.

BOTTING stated that the two individuals, who entered the headquarters with the person she thinks is identical to SIRHAN, stayed behind a counter and she described them as being a male and female. She did not observe the male, but she furnished the following description of the female who she believes she could identify if she observed her again:

ETHEL CREHAN, 1001 Fish Canyon Road, telephone number 359-6493 and 334-2811, advised that up until June 5, 1968 she worked at the Kennedy Campaign Headquarters in Azusa, California. During the afternoon and evening of June 5, 1968, she saw pictures of SIRHAN BISHARA SIRHAN ~~SIRHAN~~ on various television programs. At the time she observed these pictures, she had no reactions.

CREHAN stated that at approximately 3 a.m. on June 6, 1968, she awoke from a sound sleep at which time she realized that she had seen SIRHAN at the Kennedy Campaign Headquarters in Azusa, California. She immediately telephonically contacted BOBBIE BOTTING, who was the Campaign Headquarters' Manager and the person whom she recalled talked to SIRHAN at the campaign headquarters. She told BOTTING about the situation and BOTTING agreed that the person, referred to by CREHAN who visited the Kennedy Campaign Headquarters, closely resembled SIRHAN.

CREHAN related that during the afternoon of May 30, 1968, she was working at the Kennedy Campaign Headquarters. An individual entered the headquarters and walked up to Mrs. BOTTING and asked if KENNEDY was scheduled to visit the Azusa Headquarters. He was told that KENNEDY was not scheduled to make any more appearances in the San Gabriel Valley. She believes the individual said that he was from the Kennedy Campaign Office in Pasadena; however, she is not certain of this. She recalled that this individual entered the campaign headquarters with another male and a female, who appeared to be older than the individual she believes was SIRHAN.

CREHAN stated that the three individuals remained in the Kennedy Campaign Headquarters approximately two or three minutes. She recalled that the individual she thought to be SIRHAN, had scar tissue from pock marks on his face and he had an olive complexion. She got the distinct impression that the three were college students interested in the Kennedy campaign.

CREHAN stated that no attempt was made to obtain the names and addresses of the three individuals, as she recalls the individual to say that they were from the Kennedy Headquarters in Pasadena. A photograph of SIRHAN, Los Angeles County Sheriff's Office No. 495 139, was exhibited to Mrs. CREHAN and she stated that she is fairly certain that the individual she referred to above is SIRHAN. She noted, however, that at this time she would not like to have to testify to the fact that this individual and SIRHAN are identical without first seeing SIRHAN in person.

ROLAND GLEN WILLIAMS, who resides at 2428 Sierra Leone, Rowland Heights, California, telephone number 965-1870, and is employed by the Jerseymaid Milk Products, 1040 West Slauson, telephone number PL 3-1231, supplied the following information to SA GEORGE M. KLING and Detective Sergeant MIKE MC GANN, Homicide Division, Los Angeles Police Department (LAPD), after the identities of the interviewing officers were made known.

WILLIAMS advised on June 4, 1968, he and his wife, CLAUDIA, went to the San Gabriel Valley Gun Club, 4001 Fish Canyon Road, Duarte, California, in order to do some target shooting. WILLIAMS stated that neither he nor his wife knew the exact route to take in order to go to the gun range; therefore, they stopped at the Briar Patch Bar where his wife is employed and obtained directions. They continued on towards the gun club and eventually stopped and asked a Deputy Sheriff for further directions. WILLIAMS stated that he did not know the identity of the Deputy Sheriff from whom they had asked directions.

WILLIAMS advised they arrived at the range at approximately 3:50 PM and went to the Range Officer's Building in order to make arrangements for target shooting. He stated that the Range Officer informed them that the range closed for firing at 5:00 PM and, as a result, they would have only about one hour in which to shoot. WILLIAMS stated that he and his wife discussed this at some length and he said in all probability, this discussion could probably be termed an argument by a bystander.

He stated he had recently purchased a 30-30 caliber rifle which he intended to shoot and his wife had received a .22 caliber pistol for Christmas during the year 1966, which she had never fired, and it was her intention to use this gun on the range. WILLIAMS stated that he recalls his wife saying something to the effect that she had had the gun for a long time and she wanted to learn how

to shoot it today. WILLIAMS advised that the Range Officer informed them that they could not fire the pistol and rifle on the same range and that it would be necessary for his wife to go to the pistol range and he to the rifle range. WILLIAMS stated that he paid the admission fee of \$2 per person plus 50 cents target deposit for him and his wife but stated he did not sign a shooter's roster. He advised he did not sign a roster because it was his understanding that the roster was to be signed by shooters who were members of the gun club.

He stated that after paying the admission fee and securing their targets, he went back to his automobile and cleaned excess oil and grease from the weapons prior to shooting. He then returned to the range taking his wife's pistol to her on the pistol range and noticed the Range Officer placing his wife's target into position. WILLIAMS stated that he saw only one other individual on the range at this time and this individual, whom he could describe at that time as only a small and slender individual, was firing around gun positions 11 or 12.

WILLIAMS advised that he then proceeded to the rifle range where he fired for approximately 30 minutes and then returned to the pistol range. Upon returning to the pistol range, he noticed the individual whom he had previously seen on the pistol range next to his wife. WILLIAMS stated that to the best of his knowledge, his wife was firing around gun positions 21 or 22. He stated the individual remarked to him that his, WILLIAMS', wife's gun was shooting to the left. He stated that he, his wife and the individual engaged in a short conversation concerning itself entirely with guns.

WILLIAMS stated that he would describe this individual as being about 5'3" to 5'5" in height, in his early 20's, Spanish looking, with dark skin and hair, weighing about 130 pounds and dressed in casual clothes.

WILLIAMS stated that the individual gave him his gun for the purpose of shooting and, just as he, WILLIAMS, was ready to shoot the gun, the Range Officer called time, indicating that there would be no more firing on the range. WILLIAMS advised that he could not describe the gun other than the fact that it was a small blue gun and that the individual was firing Mini Magnum shells.

At this point, WILLIAMS was shown a photograph of SIRHAN SIRHAN and he stated that the photograph looked very much like the individual whom he had seen on the range except that his hair was neater than it appeared in the photograph.

WILLIAMS advised that he and his wife then left the range at a time he estimated to be almost exactly 5:00 PM, and that, at the same time, the individual also left the range. He stated that he recalled the individual going to a pink and white Dodge or DeSoto, model unknown.

WILLIAMS stated that during the time that he was on the pistol range, he saw no one else on the range other than this individual and his wife and that he heard the individual say nothing about any future plans that he might have.

WILLIAMS supplied the following physical description of himself:
