MUSTAFA ALI SANKARI who resides at 942 North Los Robles, Pasadena, telephone number 797-8093, was interviewed at his place of employment at Burroughs Corporation, 460 Sierra Madre Villa, Pasadena. SANKARI advised that he was born on [REDACTED] in Tripoli, Lebanon. He entered the United States at New York on September 9, 1963 and he has not yet become a citizen of the United States. He is described as white male, 5'5", 170 pounds, black hair, brown eyes, small scar on left forehead. On October 7, 1966, he married FAYE WESTBROOK at Pasadena, California.

SANKARI advised that he attended Pasadena City College beginning in September, 1963 and went for five consecutive semesters, ending with the semester of 1965 - 1966. He stated that he first met SIRHAN BISHARA SIRHAN in the first semester of 1963, and that he had not known him prior to coming to this country and attended Pasadena City College. He stated that he first met SIRHAN because he associated with several Arab students at Pasadena City College inasmuch as he did not speak very much English. He stated that, therefore, SIRHAN was one of the several with whom he associated, due to the language problem that he faced.

He said that at no time did he have any close personal association with SIRHAN and that he considered him just a school acquaintance. However, he advised that he did go to the SIRHAN home one time and met SIRHAN's mother and sister. This was just prior to the time that the sister died. He said that after the first semester of 1963 he did not see very much of SIRHAN, even at school, because SIRHAN seemed to avoid the other Arab students who did not speak English as well as he did. He stated that in his opinion SIRHAN was a very quiet, shy individual who seemed very withdrawn and reserved around others. He stated that he never saw SIRHAN lose his temper and would never have thought him to be an individual of a violent nature. He stated further that after the first semester when he associated with SIRHAN at school, usually at lunch time or over a cup of coffee, that he saw him only to greet him as they passed on the campus. He further added that they

never discussed any type of politics or ideologies and that inasmuch as he, SANKARI, wanted to improve his English, he avoided discussion of any type with the other Arab students inasmuch as they almost always spoke to him in Arabic, and he wanted to speak English.

He stated that since he left school in 1966 he has seen SIRHAN only one time and that was approximately nine or ten months ago when he saw him on the street in Pasadena and introduced him to his wife. He further stated that other than SIRHAN's mother and sister the only other member of the family he had met was the brother, SHARIF, whom he met at Bob's Drive-in Restaurant in Pasadena on one occasion.

During the investigation of the KENNEDY assassination and a search of the car belonging to SIRHAN BISHARA SIRHAN conducted by the Los Angeles Police Department, the telephone number SY 7-7302 was found written on a piece of paper in the vehicle. This telephone number was determined to be registered Ed's Auto Wrecking, 346 West Claremont, Pasadena, California, and was billed to ED DE WINTER, address same as above.

DE WINTER advised on July 24, 1968, that he had no idea how his telephone number came to be in the vehicle owned by SIRHAN. He stated that he did not know SIRHAN and that, to his knowledge, he did not ever do any business with him nor was SIRHAN ever in his place of business. He stated that the only time he ever saw SIRHAN was in the pictures on television following the assassination.

ADEL SIRHAN was interviewed and furnished the following information:

He advised he resides with his mother MARY SIRHAN and two brothers, SIRHAN SIRHAN and MUNIR SIRHAN, at 696 East Howard Street, Pasadena, California. ADEL SIRHAN is described as follows:

He stated he last saw his brother SIRHAN SIRHAN at about noon June 4, 1968, when SIRHAN had awakened him for a telephone call. SIRHAN left the home in his car while he was still talking on the telephone. He described SIRHAN's car as a 1956 De Soto, two door, three tone, white pink white.

ADEL described SIRHAN as being kind, helpful, moody, but was of a nervous disposition since he was involved in an accident about two years ago. He stated his brother was employed at a horse ranch near Corona,

California, and fell from a horse causing injury to left side of his head, left eye, and left hip. SIRHAN had a mind of his own and not easily persuaded.

ADEL SIRHAN stated SIRHAN had filed an insurance claim because of these injuries and had recently, exact date unknown, received a check from the Argonaut Insurance Company for these injuries. ADEL stated he did not know the exact amount of the check but thought it would probably have been between \$1,200 and \$1,500. ADEL stated he did not know how much money SIRHAN had or how he spent his money although he did buy parts to repair his 1956 De Soto car. He stated his brother to his knowledge was not in debt to anyone as he was not in the habit of borrowing.

ADEL stated he did not know if SIRHAN had a gun or any type weapon and can't imagine his brother owning or knowing how to use a gun. He said he never saw a gun at the family home.

ADEL SIRHAN said he never saw his brother have any political type literature at home. He stated he never heard his brother express any hatred or dislike toward Senator KENNEDY or any other political figure or to have made any threats to harm anyone either in political or private life. He stated he did not know what would motivate his brother to commit such a crime and could not conceive of his brother shooting anyone.

ADEL stated SIRHAN favored the Arabs in the Arab-Israeli conflicts and did not like to hear any opposition to the Arabs. He was opposed to the United States support to Israel.

ADEL SIRHAN stated SIRHAN did not smoke, use alcoholic beverages, or drugs. ADEL said SIRHAN did not date girls and he did not know any of his brother's friends or associates. ADEL did not know his brother to belong to any organization. He stated he did observe his brother to have literature published by "The Rosecrucians" but did not know if he was a member of the society or if he attended meetings of it.

ADEL SIRHAN advised that SIRHAN SIRHAN had never to his knowledge within the past year been away from home any length of time and had never during that time spent a night away from home until he was arrested after the shooting of Senator KENNEDY.

Mrs. MARY SIRHAN was interviewed and furnished the following information:

She is the mother of SIRHAN BISHARA SIRHAN, resides at 639 East Howard Street, Pasadena, California, with three sons, SIRHAN, 24 years of age, ADEL, 29 years of age, and MUNIR, 19 years of age. She is employed as a nursery school caretaker at the Westminster Presbyterian Church, 1757 North Lake Avenue, Pasadena.

MARY SIRHAN has two other sons, namely SAID, age 35, who resides at 1659 North Lake Avenue, Pasadena, and SHARIEF, age 36, who is employed by Cannon Electric Company in Los Angeles, California, and resides in a room near his employment, exact address unknown.

Her husband is BISHARA SIRHAN who resides in either Jordan or Israel. She stated she also had a daughter AIDA who died about three years ago. She stated none of her sons are married.

MARY SIRHAN stated she lived with her husband and family in the New City of Jerusalem, Palestine, until 1948 when they became refugees and moved to the Old City of Jerusalem. In 1956 arrangements were made for her to emigrate from Jerusalem to the United States. She arrived in New York in 1957 and immediately came to Pasadena, where she has resided continuously. MARY SIRHAN immigrated to the United States with three sons, SIRHAN, ADEL, and MUNIR, and her daughter AIDA. In 1960 her sons SAID and SHARIEF immigrated to the United States.

MARY SIRHAN stated her son SIRHAN attended Eliot Jr. High School and John Muir High School in Pasadena and was a good student. He then attended Pasadena City College for two years. He studied languages, including German, Arabic, Russian, and English, although he was not very ~~successful in these studies. He had ambition to be~~

successful and had indicated the desire to be a teacher but failed in his ambition.

MARY SIRHAN said SIRHAN worked at a ranch near Corona, California, in 1966 and during the course of this employment he fell from a horse, sustained injuries to the left side of his head, left eye, and left hip. He was hospitalized near Corona for six days before returning home. She did not know of this accident until he returned home. During 1967 and until about March 1968 he was employed at Organic - Pasadena, 1380 Lake Avenue, Pasadena. He left this employment because he could not get along with his employer. During the past two months he was unemployed and was at home most of the time.

MARY SIRHAN stated SIRHAN had an old car, the description of which she could not furnish as she is not familiar with the various makes and models of cars, which was broken down and he could not use. Recently, SIRHAN received an insurance claim check for injuries sustained from a fall from a horse while working on a ranch in 1966. She did not know the exact amount of the check. With this money SIRHAN purchased necessary parts to repair his car and purchased clothing. She did not know how much money he spent or how much money he had. She stated that she knew of no debts her son had, if he did have any.

She stated that she returned home each day about 11:30 a.m. or 12:00 noon from the nursery school. On days SIRHAN was not home she was of the opinion that he had just recently left the house since his coffee cup was usually still warm. It was SIRHAN's custom to return home during the period of 4:00 p.m. to 6:00 p.m., and would remain home for the evening. SIRHAN would watch television but was not too communicative. MARY SIRHAN continued that when SIRHAN would leave home he would say he was going to the library or would purchase newspapers and return home.

MARY SIRHAN stated her son SIRHAN did not smoke, did not drink alcoholic beverages, did not have any female associates, and to her knowledge did not have any male companions. SIRHAN stayed much to himself, did not engage in conversations with other members of the family. She stated she did not know her son to use drugs of any nature.

MARY SIRHAN stated she did not know her son SIRHAN to own a gun of any description and did not know if he knew how to use such a weapon.

She related that SIRHAN favored the Arab position in the Arab - Israeli conflicts. When he would watch programs on television and comments would be made favorable to Israel, he would either leave the room or turn off the television. She stated she never heard her son make any statements revealing a dislike of Senator ROBERT KENNEDY or any other political figure or to make any threat to Senator KENNEDY. MARY SIRHAN stated she could not believe her son could have committed such a terrible deed as shooting Senator KENNEDY or any person. She stated that she could think of no reason which would motivate her son to commit such a crime.

MARY SIRHAN stated she last saw her son at about 8:30 a.m., on Tuesday, June 4, 1968, when she left the residence at 639 East Howard Street, Pasadena, to go to work.

MARY SIRHAN advised that SIRHAN SIRHAN had never to their knowledge within the past year been away from home any length of time and had never during that time spent a night away from home until he was arrested after the shooting of Senator KENNEDY.

Miss MARVENE JONES, 2264 Ben Lomond Drive, Los Feliz Hills, Los Angeles, California, voluntarily appeared at the Los Angeles Office of the FBI and was interviewed by SA PAUL CHAMBERLAIN, JR.

Miss JONES reviewed color NBC news film coverage covering the events occurring at the Ambassador Hotel, prior to and immediately after the shooting of Senator ROBERT F. KENNEDY on June 5, 1968. This review was accomplished in the Photo Laboratory of the Los Angeles Office of the FBI.

After reviewing this film, Miss JONES stated that she did not observe any individual who resembled the man who had approached her at the Venetian Room of the Ambassador Hotel during the early a.m. of June 5, 1968.

Miss JONES advised further that upon carefully considering the circumstances surrounding her conversation with this unknown male, she believes that she could not positively identify this man.

Miss MARVENE ESTHER JONES was interviewed at her residence, 2264 Ben Lomond Drive, Los Feliz Hills, Los Angeles, California, by SA PAUL CHAMBERLAIN, who identified himself to her as a Special Agent of the FBI.

Miss JONES advised that she was in the Venetian Room of the Ambassador Hotel on the evening of June 4, 1968. She stated that she was in the Venetian Room in connection with volunteer work performed for the RAFFERTY for Senator Committee.

Miss JONES disclosed that approximately 9:30 p.m. she arrived at the Ambassador Hotel staying in the Venetian Room mingling with the crowd until approximately 10:30 p.m. Miss JONES advised that at approximately 10:30 to 11:00 p.m. she sat down at a desk located at the entrance way to the Venetian Room and commenced manning a direct telephone line to the Registrar of Voters Office in Los Angeles, California. Miss JONES stated that this open line was maintained for the duration of the evening and was being used to receive current voting information.

Miss JONES stated that various other people at different times occupied an additional seat located behind the desk. Their function was to give out RAFFERTY bumper stickers and other advertising type literature as well as giving tickets for free drinks to members of the press. Miss JONES stated that she believed she manned this telephone line for a period of time involving approximately three to four hours.

Miss JONES disclosed that at approximately 12:00 midnight while sitting at this desk she began to notice screams, yells and a great amount of activity coming from the room located directly across the lobby occupied by the Senator ROBERT F. KENNEDY supporters. Miss JONES stated that as the activity increased she could tell from the shouted conversations that Senator KENNEDY had been shot. She advised that she began yelling to people running near the entrance to the Venetian Room in an attempt to find out what exactly had occurred.

Miss JONES advised that at some time approximately five to fifteen minutes after she had first deduced that Senator KENNEDY had been shot, she observed a man walking by her door. She yelled to him words to the effect that she wanted to know what had happened and since she could not leave the telephone would he please sit down and tell her what had occurred.

Miss JONES stated that to the best of her memory the following is the conversation that occurred between herself and this individual.

He "KENNEDY's been shot. I was back there in that area." (Miss JONES advised that she obtained the impression that this statement indicated that he was one of many in the KENNEDY crowd).

He "There was a man with a gun."

Miss JONES disclosed that during this conversation, which lasted approximately one minute, a large surge of people began clustering around her desk attempting to use the telephone which was located in front of her. She stated that due to the force of the crowd and to the excitement in the room she at this point lost contact with this individual and did not observe him again.

Miss JONES stated that the above was the entirety of the conversation and the individual did not have a chance to finish his story.

Miss JONES stated that the following would be her best recollection of the description of the individual in question:

Miss JONES disclosed that this individual had the look of a young junior executive, was a good dresser but average looking in features with no distinguishing marks. Miss JONES stated further that the individual in question spoke to her in a soft and pleasant mannered voice and was apparently not shaken by the events that had occurred.

Miss JONES advised that to the best of her knowledge she has never seen this individual before and she stated that she could not remember anyone she knew who was in the vicinity of her desk when this unknown man appeared there.

Miss JONES stated that she has never observed SIRHAN BISHARA SIRHAN and especially not at any time during the evening in the Venetian Room in the Ambassador Hotel. Miss JONES advised that she had no knowledge of SIRHAN BISHARA SIRHAN appearing in the Venetian Room and tipping anyone with a \$20 bill for a drink purchased.

DANIEL E. HALL, 1300 $\frac{1}{2}$  East Palmer, Glendale, Area Director, Republican County Central Committee, was interviewed at his office at 1326 West Sixth Street.

Mr. HALL advised that on the evening of June 4, 1968 in connection with his employment he travelled to the RAFFERTY for Senator Headquarters located at the Ambassador Hotel, Los Angeles, California, arriving at approximately 8:30 p.m. HALL stated that he immediately journeyed to the RAFFERTY area located on the second floor in the Ambassador Hotel. He stated he stayed until approximately 10:00 p.m. that night. HALL advised that at approximately 10:00 p.m. he met two young ladies, female employees of the RAFFERTY for Senator Committee, KAREN MC SPADDEN and DALE DURETTE. HALL stated that they had come to Los Angeles from Riverside to celebrate the RAFFERTY victory. He advised that shortly after 10:00 p.m. he and the young ladies went to an adjacent anteroom which contained a bar serving champagne cocktails. He advised that after ordering their drinks, and sitting at a table for approximately five minutes, an unknown white male came up to their table and engaged KAREN MC SPADDEN in conversation. HALL advised that somewhat later he sat down at the table and joined the conversation indicating in the period of a few minutes, that he was for RAFFERTY and against KENNEDY and shortly thereafter for KENNEDY and against RAFFERTY. HALL disclosed that this individual had campaign buttons for both RAFFERTY and KENNEDY. HALL stated this man indicated that he liked to get information from people and intended to find out something about HALL and the two girls.

HALL disclosed that as conversation with this individual proceeded it became evident that there was something "strangely wrong" with this man. HALL advised that this individual, who would not furnish his name, but who later in the evening showed identification of some sort to KAREN MC SPADDEN, indicated that he lived in Bel Air, California and was a student at San Fernando Valley State College. HALL advised that he later indicated that he was a student at Santa Monica City College and finally that he was not a student at all.

HALL advised that he questioned the individual as to why he liked to get information from people. The unknown male replied, "I have a brief case here full of information but I have something here (pointing to his briefcase) that's going to make big news tonight. Big news, big news." HALL disclosed that at this time one of the two girls attempted to touch this individual's briefcase but he yanked it roughly from her reach. HALL stated that he asked this man to buy a round of drinks for the table to which he replied, "No, I don't have that kind of money and I don't like people that have money." HALL stated that at this time he noticed a pronounced and definite bulge in this individual's briefcase. HALL stated in his opinion this bulge was possibly made by a gun. He stated that he believed this due to the fact that he formerly had a briefcase exactly like the one carried by this individual, in which he had carried a .22 caliber pistol in connection with his former employment. He advised that his gun in his briefcase made a bulge which he believed to be identical to the one he observed in this unknown man's briefcase.

HALL stated that shortly after this conversation he and the two girls left the anteroom and returned to the Venetian Room. He advised that upon leaving this individual indicated that he was having a big evening tonight and would be there for a long time.

HALL disclosed that he and the two girls were in and around the Venetian Room area and the anteroom area until approximately 11:30 p.m. on the evening of June 4, 1968. HALL stated that during this period of time he and the girls observed this unknown individual on several occasions and in each instance he was walking through the various rooms carrying his briefcase. HALL stated that at 11:30 p.m. he, MC SPADDEN and DURETTE travelled to Michael's Restaurant, located approximately 15 minutes from the Ambassador Hotel, in order that they might eat dinner. He advised that after arriving at Michael's at 11:45 p.m. they ordered their dinner and were watching the election returns on television. HALL revealed that a short time later

he and the two girls were stunned to learn via the television set that Senator ROBERT F. KENNEDY had been shot. He advised that almost in unison the two girls and himself thought of the individual at the Ambassador Hotel thinking that he was possibly connected with the shooting. HALL stated that the three of them immediately left the restaurant, not even bothering to pay their bill, and raced back to the Ambassador Hotel arriving at approximately 12:40 a.m.

HALL stated that he and the girls furnished this information to a police officer at the door and were admitted into the Ambassador Hotel at which time they conducted a thorough search of all of the pertinent areas and were unable to locate this man.

Mr. HALL stated that his best description of this individual in question is as follows:

AUGUSTUS MALLARD, 609 West 94th Street, advised he is employed by the Ace Guard Service, 8720 Woodley Avenue, Sepulveda, California, as a guard and was assigned to the Ambassador Hotel for the evening of June 4, 1968.

MALLARD arrived at the hotel at 6:00 p.m., and was assigned initially to guard the Embassy Room. While on duty in the Embassy Room foyer, MALLARD saw a man dressed in a wind-breaker jacket and dark slacks loitering in the foyer. He later recognized this individual to be SIRHAN. MALLARD advised the individual appeared to be an off-duty waiter or bellhop and was not acting in a suspicious manner.

About 7:00 p.m., MALLARD was assigned to the Venetian Room to guard Mr. RAFFERTY's function, and he remained there throughout the shift. MALLARD took a break about 8:00 p.m. and while walking pass the Le Cafe Lautrec area, MALLARD saw SIRHAN loitering in this area. MALLARD stated this was the last time he saw SIRHAN and added that he never observed SIRHAN talking with anyone, stating that SIRHAN was alone both times he observed him.

After midnight, while on duty outside the Venetian Room, MALLARD observed an individual come crashing through the crowd, pushing people down, and he heard shouts of "Stop that man." Upon hearing these shouts, MALLARD apprehended the individual, who was the source of most of the confusion in the hallway outside the Embassy Room and handcuffed him. MALLARD advised the individual turned out to be a reporter for a Los Angeles paper, who was trying to get to a telephone and that after he turned this individual over to Los Angeles Police Department officers, he went home.

PETER SELFE, 2851 Montrose Avenue, Apartment B 7, La Crescenta, California, telephonically contacted SA PETER L. REDBURN and furnished the following information:

SIRHAN SIRHAN hung out in Shap's Bar, 2565 East Colorado Boulevard, Pasadena, California. Shap's reportedly is a bar where one can place a bet on horse races and due to the fear of having the hand book operation discovered, everyone at Shap's is afraid to talk to law enforcement officers. SELFE stated that SIRHAN usually placed his bets on horse races at this bar.

SELFE continued he met at Shap's through SELFE's brother, one GEORGE BEILICKE, who reportedly is an acquaintance of SIRHAN. BEILICKE is described as a German alien, about 40 years old, 5'8", 170 pounds, dark hair, medium complexion, employed as a machinist at Rogers and Olling on Walnut Avenue in Pasadena, and drives a white Chevrolet sedan, license QAU 483.

SELFE stated that BEILICKE loaned \$75 to one of SIRHAN's Jordanian friends and that the Jordanian will not or cannot repay the loan. BEILICKE approached the Jordanian with the \$75 and the Jordanian told him to leave him alone and threatened him with a knife. For this reason, BEILICKE is frightened and reluctant to talk about his relationship with SIRHAN's friends.

BEILICKE told SELFE that SIRHAN has five close friends he drinks with in Shap's Bar. He described them as two Jordanians, one Cuban, and two Americans. SELFE was unable to learn the names of these friends, but is certain BEILICKE knows them all.

SELFE stated BELLICKE told him the Jordanian friend of SIRHAN, to whom he loaned the \$75.00, is a young man who lives on Howard Street in Pasadena and attends Pasadena City College. SELFE continued GEORGE told him that on the Sunday or Monday preceding the shooting of Senator KENNEDY, SIRHAN had a heated argument with one, several, or all of his five friends at a Denny's Restaurant in Pasadena.

SELFE continued that GEORGE is a German National with a "chip on his shoulder," has strong German loyalty, a complex about being a foreigner, and is hard to get into a conversation.

BEVERLY LEE MONROE, 6376 Yucca Street, Apartment 101, telephone number 463-2151, advised that socially and professionally she is known as BEVERLY COREY, which was her married name. She advised she is now divorced and was given her maiden name in the terms of the divorce. She advised that she is currently employed as a dancer at Little Caesar's Club in Gardena, California.

COREY stated she has known ADEL SIRHAN, the brother of SIRHAN SIRHAN, for a period of about two years. She advised she had never met any other member of the SIRHAN family until June 5, 1968, when she met both SHARIF and SAIDALLAH SIRHAN.

COREY stated that on Tuesday evening, June 4, 1968, she went over to BARBARA ANTOINETTE KHOURY's apartment, located at 5667 Fountain Avenue, Apartment 8, Hollywood, California, at about 8:00 p.m. She said she took her three year old son, [REDACTED], with her in her 1959 Volkswagen bus. She said she and ANTOINETTE left the apartment about 8:30 to 9:00 p.m. and drove over to the International Pancake House on Sunset Boulevard near La Brea. She said they had something to eat and then drove around for a while. She said they decided to go to the Pantages Theatre to see "BOOM." She said they arrived at the theatre about 10:30 p.m. as the feature was just starting and it was listed to commence at 10:30 p.m. She advised that following the ending of the movie, they both drove back to ANTOINETTE's apartment at about 12:30 a.m. June 5, 1968. She said that when they got to the apartment, NABIL KHOURY, ANTOINETTE's brother-in-law, met them at the door and said "Did you know Kennedy had been shot?" She said both of them gave negative answers because there is no radio in her Volkswagen bus.

COREY said the television set was on and the three of them sat down to watch it for quite some time. She said NABIL stated he was going to bed; so the girls took the set

into ANTOINETTE's bedroom and watched the news for the rest of the night. She said that she dozed intermittently but that ANTOINETTE stayed awake all night.

COREY said about 11:00 a.m. ANTOINETTE's mother telephoned the apartment from Riverside, California, to tell ANTOINETTE something about the KENNEDY shooting. She said the conversation lasted about three minutes. ANTOINETTE then told her (BEVERLY ) her mother said that ADEL SIRHAN's brother had shot KENNEDY. ANTOINETTE was stunned by the news her mother had relayed to her. She said they turned the television on and within moments it again confirmed the fact that SIRHAN SIRHAN of Pasadena, California, had been arrested as the suspect in the KENNEDY shooting. She said that ANTOINETTE became very upset and began to weep. ANTOINETTE expressed concern for ADEL SIRHAN and his family because she (ANTOINETTE) has known the family for more than five years.

COREY stated that she put forth the suggestion that they drive over to the SIRHAN residence to see if there was anything that they could do to assist. COREY stated that she had long time personal friends who reside at 680 East Howard Street, which is two doors away from the SIRHAN residence.

COREY stated at approximately 1:00 p.m. ANTOINETTE and she drove over to the SIRHAN residence in Pasadena in ANTOINETTE's 1963 Ford Galaxie and arrived about 1:30 p.m. She said they observed numerous uniformed police officers, detectives, press and spectators around the house. She said they were permitted to drive by the police barricades at the end of the street when she stated they were going to her friends' house and walked to the SIRHAN residence. She said they approached a police officer and asked if he knew whether ADEL SIRHAN was home.

She stated she and ANTOINETTE waited beside ADEL's Volkswagen sedan parked in his driveway until SAIDALLAH SIRHAN arrived home at about 3:00 p.m. She stated ANTOINETTE introduced her to SAIDALLAH. She said she believes SAIDALLAH said that ADEL SIRHAN was either at the Rampart Division or was on his way home. She advised that about 3:15 to 3:30 p.m. SHARIF SIRHAN arrived home and went immediately to the back of the house. SHARIF asked the police to keep the press and spectators away as he would not speak to any of them. She said she and ANTOINETTE accompanied SHARIF to the back of the house and it was at this time she was introduced to SHARIF, whom she had never met before. She stated the police officers, who were with them, did not question SHARIF regarding the whereabouts of the family. She stated the house was locked and SHARIF had no key. She said an officer advised them to enter the house or else leave the premises in view of the fact the press was there with numerous spectators. She said SHARIF did not want to leave as it would cause great concern to his mother.

She said an officer lifted her up so that she could enter a side window which was found to be unlocked. She then went to the back door and let SHARIF and ANTOINETTE into the house. They immediately drew the shades in the house. She stated that within a few minutes two women arrived at the house and SHARIF let them in as they were friends of the SIRHAN family. She said that ANTOINETTE knew both of the women she let in through the back door of the house. She said that the telephone rang many times with both crank calls and calls from sympathetic people. She said she became very upset with the environment of the confusion and drawn shades. She said she took ANTOINETTE's car and drove her son back to her own apartment, as he had been with her all afternoon. She stated that

she obtained a babysitter in her apartment house to care for her son and then she returned to the SIRHAN residence in Pasadena.

COREY stated that ANTOINETTE was in the SIRHAN house alone when COREY returned. She said a policeman told her to drive around the block and park on Ladera Street and he would see that ANTOINETTE would meet her there. She said they then drove over to friends of the SIRHAN family on Sacramento Street, address not recalled. She said that when they arrived there, two patrol cars were parked on the same block near the house where the SIRHANS were staying. She said that SHARIF came out of the house to tell them that ADEL and his mother were in the house being questioned by detectives and that we should not come in the house. ANTOINETTE asked SHARIF to have ADEL call her if he wanted to do so.

COREY stated they then drove to a drive-in nearby in Pasadena and had dinner. She said that following dinner they drove back to ANTOINETTE's apartment and arrived there about 9:00 a.m. She said that about 10:00 p.m. three plain-clothes policemen knocked at the door and were let in. She said they searched ANTOINETTE, NABIL, the maid NELLIE BIANCA, and herself for weapons and placed them under arrest for attempted murder. She said they exhibited badges but no other identification card. She said that she gave them somewhat of a bad time until they had exhibited an identification card. She said that a little later on two other detectives in business suits came into the apartment. The first three officers took ANTOINETTE, NABIL and COREY to the Rampart Division while the other two detectives stayed to search the apartment. The maid, NELLIE, remained to care for ANTOINETTE's child.

COREY stated that they were questioned at the Rampart Division but were never booked on any charge. She stated they were fingerprinted and photographed and then returned to their apartment.
