INFORMATION: (WHO, WHAT, WHEN, WHERE, WHY & HOW)

RONKA WAS THE SAN FERNANDO VALLEY CAMPAIGN CO-ORDINATOR FOR KENNEDY. PRIOR TO THE SPEECH, HE WENT TO THE ANTEROOM BEHIND THE STAGE FOR A CLOSE LOOK AT KENNEDY, WITH ELIZABETH CONWELL (I-549).

WHEN KENNEDY WENT TO THE STAGE, RONKA WENT TO THE NORTH WEST CORNER OF THE EMBASSY ROOM AND WATCHED THE SPEECH ON T.V. HE REMAINED IN THAT GENERAL AREA AFTER THE SPEECH.

A FEW SECONDS AFTER KENNEDY LEFT THE STAGE, RONKA OBSERVED THE CHAND PUSHING TOWARD THE KITCHEN AND HEARD SOME SCREAMS. THEN THE CHAND BEGAN PUSHING OUT OF THE KITCHEN, AND PEOPLE BEGAN RUNNING IN THE BALLROOM. RONKA STOPPED ONE OF THE RUNNING PEOPLE AND WAS TOLD "HE'S BEEN SHOT"

RONKA DID NOT GO INTO THE KITCHEN. HE ATTEMPTED TO CALM SOME OF THE PEOPLE IN THE BALLROOM AND THEN WENT TO A ROOM IN THE S/E WING OF THE HOTEL, AND WATCHED DEVELOPMENTS ON T.V.

RONKA DID NOT SEE SIRHAN WHEN HE WAS IN THE

Royer is Sec. to Ex-Gov. Pat Brown, interviewed in his office.

Royer arrived at Ambassador between 3 & 4 PM. She went directly to staff area (west side Embassy stage-rear). Sometime between 11:45 PM and 12 AM Dick Kline (I-240) told Royer that Sen. Kennedy would be going to the Colonial Room after his speech in the Embassy Room.

During the speech, Royer was in the kitchen area near the double doors on the left side of the Room. At the conclusion of the speech, she started walking toward the Colonial Room; Robert Klase (I-1345) was walking slightly in front and to the right. At the time of the shooting, Royer estimated she was between the 2nd & 3rd table and about in the center of the room walking toward the Colonial Room.

She recalled hearing about 6 shots, without a pause. She turned and looked in the direction of the shots. Royer stated she did not see the Senator, but did see a large crowd. She also observed the struggle with the suspect. Next she recalled being pushed by the crowd (coming from the direction of the Colonial Room) back toward the Senator. When the pushing of the crowd stopped, she recalled the struggle was then going on to her right-rear. At this time she was standing next to Jimmy Breslin (N. Y. Post).

Earlier in the evening, Royer stated she would periodically check the Anteroom & kitchen area to "chase out" people who didn't belong. She stated that an hour or two prior to the shooting, she had told the susp. to leave the Anteroom. There were several people in the room who didn't have press passes. Anyone without a pass was asked to leave. She did not recall the susp. saying anything when asked to leave. When she last saw the susp. he was in the Anteroom walking through the door leading to the Embassy Room. She didn't recall the susp. being with anyone. She was certain this was the same person she later saw in custody of the Police. Royer stated she checked the kitchen area about twice an hour for about 3 hours prior to the shooting. She checked the kitchen at least twice after asking the susp. to leave, (the last time being about 11:45 PM), and did not recall seeing the susp. again. The night of the shooting, Royer was wearing a white suit with a bright green blouse.

This interview was conducted at the informants bus add. at the abv date & time

Informant was a volunteer worker in the Kennedy campaign. On June 4, 1968, she was assigned to the Kennedy Staff room (Anchor Room) to filter the persons XXX attempting to enter the staff room and to keep unauthorized persons from entering it. At approx 10:30PM, she obs Sirhan Sirhan in a group of people standing at the door to the Anteroom, and asked him and the other persons to step back. They did so, and left walking slowly toward the kitchen area.

Informant, prior to, at time of shooting and just after, was in the kitchen area of the Hotel, walking approx 10 to 15 feet ahead of the Senator and the group of people surrounding the Senator. Informant heard the shots, describing them as popping sounds, and as she turned she obs Mr Kennedy on the floor and Rafer Johnson and Rosi Greer struggle with Sirhan.

Informant did not see any one talking with Sirhan before the shooting, nor did she see a girl with a POLKADOT Dress.

I arrived at the Hotel with my husband at the Hotel at 11:55 PM; that is the time that was stamped on our parking ticket. My husband & I knew the Hotel set up as we'd been there before. Rather than go into the Embassy Room & fight the crowd to get close to the stage, we went in through the kitchen area and this way we were able to come out right next to the stage. We entered the kitchen through the door near the Airline desk. This entrance is near the front of the Coconut Grove & at the top of the stairs from the downstairs lobby. When we got to the stage, I recall it was just prior to the Senator making his remark about Mayor Yorty, that was towards the end of the speech. When the speech was over, I went into the Anteroom & saw the Senator walking toward the kitchen. Paul Schrade was right behind him. As they entered the doorway to the kitchen, I was just behind Paul Schrade. The crowd was heavy & pushy in the Anteroom, but once we got inside the kitchen, the crowd opened up & the pushing stopped. The next thing I recall were 3 shots, a pause & then 5 more shots. The first shot I recall thinking were firecrackers. As I look back now, I'm sure I knew the second shot was a shot. It seemed to me that by the third shot Paul Schrade was lying at my feet. I immediately went for the floor and remember pulling a blonde woman down (this blonde woman was probably Valerie Schulte) from Rubin's descr. of her). I did not see the shooting itself because Paul Schrade was in front of me. I remember next that after getting on the floor I crawled backwards & got behind a chair. William Weisel (one of the victims) fell into the chair and I heard say, "I've been hit". I also remember Mrs. Kennedy in a stooping position next to a wall & a man being with her. I worked my way back out of the room. I was very hysterical for some hours after the incident. I did not see the suspect & could not ID him.

When my husband & I were walking through the kitchen to the Embassy Room to hear the speech, I'm sure we saw the suspect, Sirhan. My husband was walking on my right through the kitchen & I remember the suspect being on my left. He was somewhere between the end of the room (doors to Colonial Room) & the ice machine. He was leaning against a table. He was wearing light clothing. The reason he stands out in my mind is that he wasn't dressed like the rest of the workers & he was standing still whereas everyone else in the kitchen was moving around. I saw his picture on TV & in the newspaper & I'm positive that the man I saw is the man who

shot the Senator. The night of the shooting I was wearing a white dress with a red & white coat over it. My hair was quite long that night.

BARBARA RUBIN, also known as Mrs. Lon Bruce Rubin, housewife, 5925 Glade Avenue, Woodland Hills, California, telephone 883-2133, related the following:

She and her husband had gone to the Embassy Room at the Ambassador Hotel, Los Angeles, California, shortly after midnight on June 5, 1968. The purpose was to join the campaign party of Senator ROBERT F. KENNEDY. They were unable to get into the Embassy Room through the main entrance, as it was full. They found that by going through a kitchen area, off this room, they could enter the Embassy Room without being challenged. There were only three people in the kitchen when she and her husband entered. They were all dark complected men, two of whom appeared to be kitchen workers as they were moving about. One was tall and the other short. The third man, slight of build, was just standing against the wall in about the middle of the kitchen. She did not note details of his dress but did note this third man did not appear to be a kitchen worker.

Mrs. RUBIN and her husband went on into the Embassy Room just as Senator ROBERT KENNEDY was finishing his speech. They had arrived at a point a few feet from the podium where Senator KENNEDY was standing when he made some remark about Mayor SAM YORTY of Los Angeles, which ended his speech. Senator KENNEDY then started for the kitchen. Mr. and Mrs. RUBIN followed him. They were separated by the pressure of the crowd near the kitchen door and Mrs. RUBIN followed the KENNEDY party into the kitchen. Mr. RUBIN got trapped and did not get into the kitchen.

Mr. PAUL SCHRADE was right behind Senator KENNEDY and Mrs. RUBIN was behind Mr. SCHRADE when she suddenly heard three shots followed by five quick shots. She realized someone was shooting in her direction but she could not see who it was, as Mr. SCHRADE was taller than she. She, at this point, "hit the floor" along with a young blonde woman, and kept her head down until she felt the shooting had stopped. She saw people go down on the floor and briefly saw Mr. KENNEDY on the floor. When she

got up she ran out of the kitchen to join her husband. She hid behind things until she found her way out as she did not know whether or not there might be more shooting.

The Los Angeles Police Department had questioned Mrs. RUBIN briefly after the shooting, asking her if she had seen the shooting. She replied "no" and was not questioned further.

Mrs. RUBIN had appeared on television but was not interviewed. She was standing near the door of the Embassy Room when the television news cameras picked up an interview being conducted of a Negro doctor who had been at the scene. There had been some comment in news programs and in the press of a couple being sought for interview, exact source not recalled. She was of the opinion the descriptions furnished of the couple being sought and apparently seen in the kitchen area before the shooting generally fit that of her and her husband.

Mrs. RUBIN described herself as a white female, 33 years of age, 5' 5", wearing two-inch heels, olive complexion, 135 - 140 pounds, dark shoulder length hair worn bouffant style, dark eyes. She was wearing a white dress with red belt sash and a bright red and white checkered jacket. She, at times, carried the jacket.

She described Mr. RUBIN as a white male, 6', 185 pounds, 35 years of age, broad shoulders. He was wearing a navy blue blazer and gray slacks.

Mrs. RUBIN furnished a photograph of herself taken in March 1968, which she said could be used for further identification, if desired. The photograph need not be returned.

Following examination of photographs of SIRHAN SIRHAN and his brothers, Mrs. RUBIN was of the opinion that the photograph of SIRHAN SIRHAN resembled the person she had seen in the kitchen

standing against the wall about five to seven minutes before Senator KENNEDY finished his speech. She had not noted the man in question in the kitchen closely enough to make a positive identification. She had no recollection of seeing any of the brothers of SIRHAN SIRHAN at any time.

180; Sandy hair; wearing a blue sport coat, blue turtleneck shirt.
#2, F., C. (light), 21/23, 5'6", 125, brownish hair, wearing a wht. dress
with drk. almost round markings on it. She was also wearing glasses.
Susp. #1 came out first. P/R said his face looked pale and he appeared
frightened. (At this time P/R didn't know what had happened). Susp. #2
then came out. She was yelling something but P/R could not understand
what she was saying. Both susps. ran out the E. exit of the hotel. As
they were running susp. #1 pushed sev. people out of his way. Both
susps. passed within 30 ft. of P/R's unobstructed view. A few secs.
later people began hurrying out of the Embassy Rm. At this time P/R
discovered that somebody had been shot. As he watched he obs. uniformed
police ofcs. escorting susp. Sirhan from the Embassy Rm. and toward the
W. exit of the hotel. P/R followed them. As the ofcs. took the susp. to
a waiting police veh. P/R walked alongside in order to see the susp.
When he stopped to watch P/R noticed that the same man who came running

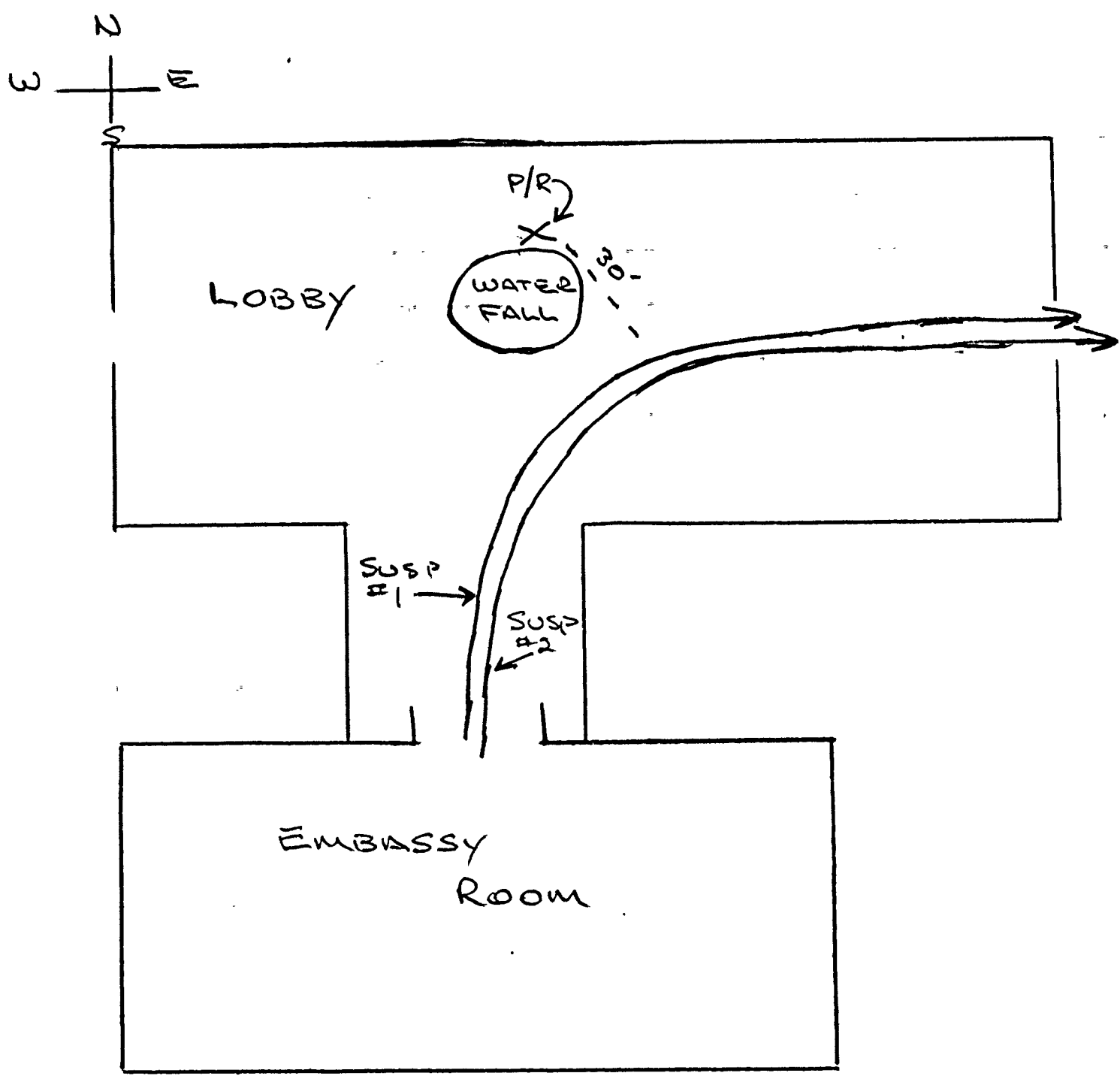

bastard." At this time susp. #1 was the only person noticeably in favor of "getting" the susp. During this time also P/R states that numerous photogs. were taken in his direction. He is positive that he and susp. #1 were in many of them. P/R stated he could identify both susps. if he saw them again. At this time Ofc. showed sever. photogs. to P/R and advised that they were not necessarily susps. in this crime. P/R was also told to be sure of any identification he may make. P/R was unable to identify any of the photogs. of males. However stated that the photog. of Beverly Corey may well be the female susp. The discrepancy was that the susp's hair was "up", or poss. shorter on the night of 6/4/68. The photog. of Bev. Corey shows her with long straight hair.

Telephone interview of Mrs. Rumley, phone #325-0647. Mrs. Rumley called Det. Bob Holmes of Torrance P.D. and stated she had information on the "X" girl. We called Mrs. Rumley at home, and she stated that she was at the Ambassador Hotel and was close to Bobby Kennedy when he was shot, and at the same time she was next to a Mexican woman, when the girl in the "purple and white" or polka dot dress, wearing a blonde wiglett state "We killed him," the Mexican woman stated "you killed who" the blonde said "Bobby Kennedy." Mrs. Rumley stated there was a dirty looking arab with the blonde female, but could only give the desc. of a "dark complected Arab" as being the man with the blonde. She stated the man was a little taller than the female. Later during the interview Mrs. Rumley made comments about the Kennedy Rally in Long Beach, and made reference to some agitators during this rally, and it appears as if she has the two incidents confused.

Gun- The gun was a cheap model 22 cal. with a short barrell. Only a couple blued spots on its barrell & cylinder the rest painted black. It had black plastic grips.

"When he was shooting my gun he was bench resting it and he burnt his finger. I don't remember which finger or on which hand. I don't know if it was very bad or not."

P/R stated that Sirhan brought him over some bullets. They were "mini mags". Hollow points extremely high volicity. He fired P/R's gun and aimed at the wood on the target. He wanted to see how big a hole they would make.

P/R asked him why he was shooting hollow points on a range and Sirhan stated that they were all he had. P/R thought that was strange because he had several boxes of cheaper amo. Hi Standard & some other real cheap stuff. Sirhan stated that he bought his amunition at Lock Stock and Barrell on Rosemead Blvd. below Huntington Drive.

Sirhan said that he paid \$40 for his gun and that he bought it from a friend. He said that he was thinking of trading the gun off for one like the P/R's.

Sirhan & P/R talked about hunting. P/R told Sirhan that he would have a pretty hard time hunting with a 22 pistol. There is not much he could kill with one legally, and Saccoman said you couldn't very well kill them. Sirhan said, "Well, this can kill a dog." And then he changed the subject. P/R asked him where he learned to shoot so well. Sirhan said he had only been shooting for a couple months and that he learned up North.

Sirhan would shoot and then fling his empty casings on the range.

Sirhan would bench rest his gun & fire from a crouch. He fired rapid fire. He only fired slow to check his gun.

Carlon of Kaiser Permanente, 4867 Sunset Blvd., Hollywood, the Hospital where victim Schrade is recuperating, stated that their records show that Schrade was admitted at approximately 2:15 A.M. this date from a Schaeffer Ambulance in the company of Dr. Bernard Arias. Mr. Schrade's Physician of record at the time of interview was Dr. Kasper Fuchs Neuro Surgeon of the Kaiser Hospital Staff. Mr. Schrade's condition was listed as satisfactory, yet he was still in the intensive care unit. It was the considered opinion of Nurse Carlon, based upon the chart of victim Schrade and the communications which she had with Dr. Fuchs that the appearance by victim Schrade at a hearing scheduled for Friday June 7th would be highly unlikely. On above date & time, reporting officers had a conversation with the above person at Pasadena City College. He stated that approximately two to three weeks before the Kennedy shooting, he was introduced ; to Sirhans at the PCC Cafeteria. He does not remember who introduced them/

On the 4th of June, 1968 at 6:35 p.m. Sayegh was sitting at the cafe--teria PCC. There were several other people with him at the table. At approximately 6:40 p.m. Sirhan came into the cafeteria & approached the table. Sirhan was with an Indian ; by the name of Mistri, Sayegh & Sirhan discussed religion for a few minutes, & Sirhan stated that he was a Catholic. They also discussed about coming over to the U. S. from Arabia. Sayegh stated the only person he could remember at the table during this conversation other than Sirhan & Mistri was an Arabian student by the name of Zaid Madanat.

Sayegh stated he is the past president of the Intern'l Club & he has a lot of friends whom he has met through this club. He stated many of them came & went that night. Sayeth told officers that at 6:50 p.m. he left the cafeteria to go to a 7 o'clock class. Several people left at this time. He stated, in his opinion, Sirhan was not nervous & he seemed normal & very friendly on the above meeting.

A check with CII and LAPD Intel. Div showed no rec. or file on this person. Nothing in file with immigration.

Budd Schulberg was contacted at his home address in person. Budd Schulberg arrived at the Ambassador at approx 7:30 PM. He went directly up to the Embassy Room and went into the Anteroom at the west side of the stage. He stayed in the Anteroom until 8 PM at which time he went to the 5th floor suites. He stayed on the 5th floor and talked to Kennedy briefly. When Budd talked to Kennedy, Kennedy told him to wait in the Press Room (Colonial Room) until he gave his victory speech, and after his speech he would talk to him again in the Press Room. Approx. 5 min. before Kennedy went down stairs to give his speech, Budd went down to the Press Room. Budd stayed in the Press Room and watched Kennedy give his speech on the T.V. After Kennedy gave his speech, Budd continued waiting for Kennedy to come to the Press Room as Kennedy had told him to do while they were on the 5th floor. As Budd was waiting he heard a pop and then a commotion in the kitchen area. Budd went into the kitchen area and saw Sirhan standing and then someone grab Sirhan. The person that grabbed Sirhan wrestled with him and as they wrestled, more shots went off. At this time Geo. Plimpton, Rosie Grier & Rafer Johnson grabbed Sirhan and took the gun away. Budd's view was partially obstructed by a few people in front of him, but was still able to see what was going on. He stated he had a very good look at Sirhan as he was held on the table. Budd stated his impression of Sirhan's clothing was a pair of slacks and a cheap sports shirt. Budd was shown a packet of mugs containing three different mugs of Sirhan. Budd was able to pick the mug of Sirhan taken at the time of the initial booking, but not the other two of Sirhan. Budd also picked the mug of the side profile of Adel Sirhan stating that it also looked something like Sirhan Sirhan. Budd stayed in the kitchen area until after Sirhan & Kennedy had been removed. He then went back up to the 5th floor. Budd is certain that he did not see a F/C wearing a polka dot dress.

Budd stated he had not seen Sirhan prior to the time of the shooting. Budd stayed at the Ambassador until approx. 4 AM 6-5-68. Budd stated that no other agency has talked to him regarding Kennedy's death. Life Magazine did contact Budd attempting to confirm Booker Griffin's statements.
