TYRONE CHAPMANN, a jockey, Longacres Race Track, Renton, Washington, residence Four Seasons Apartments, South 176th Street, Apartment 115, Seattle-Tacoma Airport, Seattle, Washington, advised that he does not know how or why his name was among the effects of SIRHAN BISHARA SIRHAN.

He stated he does not know SIRHAN personally and to his knowledge has never met him. CHAPMANN advised that at the time of the KENNEDY assassination, he observed SIRHAN's picture in the newspaper, but it meant nothing to him, and he did not recognize SIRHAN at that time as somebody he knew.

He concluded by stating he has raced at Santa Anita Race Track in California, and it is possible that he has unknowingly come in contact with SIRHAN on the race track. He was unable to provide any information concerning Jordanian nationals or anti-Israeli groups.

Mr. CLETE ROBERTS, Newscaster and co-owner of USTV News, Suite 217, 6922 Hollywood Boulevard, Los Angeles, California, telephone number 469-7789, advised the following:

With respect to the matter of the name CLETE ROBERTS appearing in a notebook found among the possessions of SIRHAN SIRHAN by the Los Angeles Police Department (LAPD), Mr. ROBERTS said that he was aware of this fact.

Major SAMUEL YORTY had, in a telecast, mentioned that CLETE ROBERTS' name had been in a notebook which resulted in YORTY being further interviewed at Sacramento, California, by newsman ROBERT SIMMONS; YORTY being asked to further comment on exactly what had appeared in the notebook with respect to the name CLETE ROBERTS.

All that Mr. ROBERTS had been able to ascertain was that his name and some mention of the City of Eilat had appeared in the book. He mentioned that Eilat, in Israel, was the sister city of Los Angeles, California.

Mr. ROBERTS said that he had visited the Middle East on several occasions. In 1951 and 1956, he had done television and radio shows in Israel. Previously as a war correspondent for the American Broadcasting Company in 1945 he had been in this area.

Mr. ROBERTS was of the opinion that the basis for his name appearing in the notebook in question was a television special aired over Columbia Broadcasting System in this country, which he did on the Middle East war in June, 1967, from Israel. This broadcast had portrayed the position of Israel in the war with the Arab nations. Mr. ROBERTS said that he had not been able to get any information from the Arabian countries which would have stated their position in the war. This was in spite of his attempts to interview certain officials of the Arabian countries involved in the war at that time.

Mr. ROBERTS said that he had not received any threats as a result of his broadcasts on the Middle East war in June, 1967. He said on two occasions he had been approached while eating in restaurants by persons believed to be of Arabian descent who had remarked to him that they did not like the broadcasts he made in June, 1967, as it was one-sided in favor of Israel.

Upon examination of photographs of SIRHAN SIRHAN and his brothers, Mr. ROBERTS said that he had no recollection of ever seeing any of these individuals at any time and had not heard of them until the shooting of Senator ROBERT F. KENNEDY.

Mrs. LILY P. THURBER, Assistant Manager, Haggarty's Department Store, 350 South Lake Street, Pasadena, California, was advised of the identity of the interviewing agent and that she was being interviewed concerning information contained in a notebook of SIRHAN B. SIRHAN (evidence Q-2, page three).

Mrs. THURBER advised, upon reviewing a photograph of SIRHAN B. SIRHAN, that she met him on one occasion for approximately one-half hour. She stated that in about March, 1968 SIRHAN B. SIRHAN and his mother appeared at her office at the F. C. Nash Company, Pasadena, California, where she was then employed. She stated that MUNIR SIRHAN, brother of SIRHAN SIRHAN, had been arrested for a narcotics violation and was incarcerated when his mother and SIRHAN SIRHAN appeared at her office. She stated the purpose of the visit was to intercede for MUNIR so that he could keep his job with Nash's.

She stated that MUNIR's mother and brother were both mannerly and thankful in requesting her assistance

She stated that she knows of no political beliefs of the SIRHAN family and her only knowledge of MUNIR SIRHAN was as a supervisor at work. She stated that MUNIR was an excellent employee and she recommended to her employer that he be maintained as an employee and in addition she wrote a letter to the judge at MUNIR's trial which reflected that he was a very good employee.

She stated that she could furnish no additional information concerning the SIRHAN family.

On July 8, 1968, JOHN JOSEPH DAY was contacted at his residence at 4159 Dover Road, La Canada, California (790-2844). DAY volunteered that he was of the Quaker faith, had just received a discharge from the United States Army as a Conscientious Objector after serving six months, and had just returned to the Los Angeles area.

DAY stated he knew SIRHAN SIRHAN slightly by sight, but stated after he had seen SIRHAN's photograph in the newspapers, he was not sure whether he had seen him or remembered him from Muir High School or from Pasadena City College, both in Pasadena, California. DAY stated he attended Pasadena City College for an irregular period during 1965. He stated he had not associated with SIRHAN, only knew him by sight, and knew nothing about him or other members of his family.

DAY stated he had no knowledge of why SIRHAN might have had the name of JOHN DAY in his possession, and stated he knew nothing concerning him.

CHARLES HOLLOPETER, Attorney, 234 East Colorado Boulevard, Pasadena, California was advised of the identity of the interviewing Agent and that he was being interviewed concerning his knowledge of SIRHAN B. SIRHAN.

He stated that in about July 1965, MUNIR BISHARA SALAMEH SIRHAN, age 19, nationality - Arabian, who resides at 696 East Howard Street, Pasadena, California, appeared at his office with his mother and brother.

MUNIR had been charged by the Pasadena Police Department with possession and sale of marijuana to a State Narcotics Agent.

HOLLOPETER stated that MUNIR appeared at Pasadena Superior Court on July 7, 1966 and December 1, 1966, and claimed that he was ignorant of the nature of marijuana and would acknowledge no wrong doing. MUNIR was tried and found guilty on both counts of possession and sale of marijuana and was sentenced to serve one year in the City Jail.

He stated that MUNIR's family was very bitter with him (HOLLOPETER) and took the case to D. C. MARCUS, Attorney, Los Angeles, California, who succeeded in presenting the case in Juvenile Court on May 27, 1967. He stated his records do not reflect any additional information concerning the case.

HOLLOPETER identified a photograph of SIRHAN BISHARA SIRHAN, as the brother who appeared in his office with MUNIR and his mother.

He stated his only contact with SIRHAN BISHARA SIRHAN was in connection with his brother's case and he knew of no political beliefs of the family.

Dr. IRVIN G. LEWIS, Administrative Dean for Students Personnel Services, Pasadena City College, was contacted for information concerning a partially completed school schedule, bearing the brand name Simpson, obtained from the residence of SIRHAN BISHARA SIRHAN by the Los Angeles Police Department on June 5, 1968, and the schedule was exhibited to Dr. LEWIS, who furnished the following information:

The schedule appears to be a proposed schedule made up prior to the registration of the student preparing it. The room numbers 23C and 35C appear to correspond to room numbers at Pasadena City College and it is usual for students to take physical education classes in the gym twice a week. He does not recognize the schedule as the kind used at Pasadena City College but schedules of this type are often available for students at school book stores and supply centers. The schedule would have to pertain to a junior college rather than a high school since high school classes are generally conducted on a daily rather than a bi-weekly and tri-weekly basis.

A xerox copy of the first page of a publication captioned "Opinion" dated Friday, March 30, 1962, number 11, obtained from the residence of SIRHAN SIRHAN by the Los Angeles Police Department on June 5, 1963 was displayed to Dr. IRVIN G. LEWIS, Administrative Dean for Students Personnel Services, Pasadena City College, Pasadena, California.

Dr. LEWIS stated he had never seen the paper and believed he would have been aware if it had been distributed on the campus as such publications are brought to his attention. He pointed out that in the first paragraph of the second column reference was made on two occasions to seniors, which suggests the paper had been distributed on a high school rather than on a college level.

During the investigation of the KENNEDY assassination and a search of the car belonging to SIRHAN BISHARA SIRHAN conducted by the Los Angeles Police Department, the telephone number SY 7-7302 was found written on a piece of paper in the vehicle. This telephone number was determined to be registered Ed's Auto Wrecking, 346 West Claremont, Pasadena, California, and was billed to ED DE WINTER, address same as above.

DE WINTER advised on July 24, 1968, that he had no idea how his telephone number came to be in the vehicle owned by SIRHAN. He stated that he did not know SIRHAN and that, to his knowledge, he did not ever do any business with him nor was SIRHAN ever in his place of business. He stated that the only time he ever saw SIRHAN was in the pictures on television following the assassination.

MARY SIRHAN, 696 East Howard Street, mother of SIRHAN BISHARA SIRHAN, advised as follows:

She has never heard of anyone by the name of FRANK QUARTUCCI. She does not believe that her son, SIRHAN, knew an individual by this name. From her knowledge of SIRHAN, she does not believe that SIRHAN received money from anyone to kill Senator ROBERT KENNEDY. She visited SIRHAN at the Los Angeles County Jail on July 11, 1968, and at that time SIRHAN assured her that no one else was involved with him in the killing of Senator KENNEDY.

MARY SIRHAN said that all the money SIRHAN had in his possession at the time he was apprehended came from an insurance settlement earlier this year. She noted that she has furnished full details regarding this insurance settlement during previous interviews. She added that she had been holding \$1,000.00 from this settlement for SIRHAN and shortly before the assassination she gave SIRHAN \$300.00 from this money. At the time she gave SIRHAN the \$300.00 he had additional money in his possession, exact amount unknown.

It was previously reported that on June 6, 1968, JOHN FAHEY, 1030 North Harper Avenue, Apartment 4, Los Angeles, had advised the Los Angeles Office of the FBI that during the day of June 4, 1968 he had been in the company of a blond woman. He had met this woman earlier in the morning of June 4, 1968 in the Arcade area of the Ambassador Hotel, Los Angeles, California. This woman, who identified herself to him as GILDERDINE OPPENHEIMER (ph), reportedly told him that KENNEDY was "no good" and further stated, "They are going to get him", referring to Senator KENNEDY.

FAHEY further advised that he and OPPENHEIMER had breakfast together on June 4, 1968 at the Ambassador Hotel Coffee Shop and, during breakfast, he noticed a man at the entrance to the coffee shop staring at them. He identified subsequently a photograph of MUNIR SIRHAN as looking like the individual staring into the coffee shop, but could not be positive of his identification.

After breakfast, FAHEY told OPPENHEIMER he was going to Oxnard and she asked if she could accompany him, to which he agreed. En route to Oxnard, OPPENHEIMER told FAHEY they were being followed by a dark blue Volkswagen. This Volkswagen subsequently pulled into a parking area off the highway and was not seen again. After spending the day in Oxnard, FAHEY and OPPENHEIMER returned to Los Angeles and he dropped her off at the Ambassador Hotel at approximately 7:30 P.M., June 4, 1968.

as that which has been reported in previous interviews. Upon questioning by SA MC CARTHY, FAHEY admitted to having carried the blond unidentified woman from the car, across the sand, to a ramp, which led up to a deserted life guard stand. FAHEY advised that the conversation again was similar to what has previously been stated and that the woman was still insistent upon wanting his confidence.

The route traced went as far north as the large boulder on Pacific Coast Highway, which has been described in prior interview. At this point, FAHEY advised that he remembers more as to what then transpired and gave the following account:

FAHEY's car was parked facing west towards the ocean and the blue Volkswagen pulled up thirty to forty feet on the right side FAHEY's car, also facing west.
